She stated her question is a procedural one; Commissioner Weeter stated she doesn't know that at any point the Commission asked for public comment and she was wondering if that was because of the nature of the appeal process.

**00:58:24** Chair Vice stated our Ordinance does allow us, at our discretion, to take additional evidence or not. Chair Vice stated it's a public hearing, but not necessarily where testimony is taken; it's an open meeting and our discretion whether we take additional testimony. Chair Vice stated that prior to the meeting we were thinking that because this was an appeal by – the owner got the approval they needed from the ARC so they weren't the appellant. It's sort of an unusual situation; it was a member of the public that was affected that appealed. Chair Vice stated he thinks their mindset was we hear from the applicant and we hear from the owner, it was basically that simple. Chair Vice stated we were

unaware until after the meeting that some of the members of the ARC wanted to speak, and again, given the context of the way that appeal arose, he'd have to say that thinking back that was probably sort of a first impression. Chair Vice stated normally the ARC has denied something and the owner appeals and it's a different environment. Chair Vice stated that after the meeting one of the ARC members did come up and express interest in speaking and he said we weren't aware of that frankly because of the way it came up, but we'll certainly look to that in future appeals to make sure we cover that. Chair Vice stated that two of the members of the Commission are on the ARC; one of them was here and spoke about the ARC's proceeding and we had the ARC's record. Chair Vice stated that on the one hand, again, that's within our discretion because we do have a record before us and we had the applicant and the owner speaking, but certainly we value the participation of the ARC members on the ARC's, and in situations where they want to participate, if they do, we would want to hear from them. Chair Vice stated that candidly, it just wasn't on the radar in the context of that appeal.

**01:00:30** Commissioner Weeter stated she agrees with everything Chair Vice said. Commissioner Weeter stated she wonders if that particular point, if we don't need to make sure that that point gets in the minutes specifically; just the procedural nature of the dynamic.

**01:00:58** Commissioner Weeter stated her point is that rather than just a statement in the next minutes that reflect this meeting that say there was a general discussion of the public hearing held on October 20<sup>th</sup>, I wonder if we couldn't go into just a tiny bit more detail. Commissioner Weeter stated she's talking about this discussion, not what happened on October 20<sup>th</sup>.

**01:01:23** Bob Keesaer asked Commissioner Weeter what she would like to have put on the record.

Commissioner Weeter continued by saying she fully supports, but her sense is that Deborah Stewart and perhaps others felt that there should have been an opportunity for them to speak and they did not get that opportunity and we don't have to go back and revisit that, but she thinks there needs to be a little bit of explanation in the record.
