



RESOLUTION NO. 057, SERIES 2014

A RESOLUTION ANNOUNCING THE STATUTORY REQUIREMENTS AND RELEVANT ISSUES METRO COUNCIL WILL CONSIDER WHEN EVALUATING COMMERCIAL AND INDUSTRIAL ANNEXATION REQUESTS. (AMENDMENT BY SUBSTITUTION)


WHEREAS, KRS 67C.111(3) delegates authority to Metro Council, as the legislative council of the consolidated local government, to decide whether or not a proposed annexation by a city in Jefferson County should be approved; and

WHEREAS, Kentucky law grants Metro Council broad discretion in determining the "facts and conditions under which annexation may take place" in Jefferson County; and

WHEREAS, Metro Council understands and agrees with the public policy adopted in KRS 81A.510 that "to encourage the location of new industries and the expansion of existing industries in Kentucky" the law prohibits "unfair and unreasonable annexation by municipal corporations of industries now or hereafter located in unincorporated areas. . . . [while not] prohibit[ing], restrict[ing] or hamper[ing] normal expansion of municipal boundaries if such normal development and expansion extends to and embraces such industrial properties."

BE IT RESOLVED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT (THE COUNCIL) AS FOLLOWS:

SECTION I: It is important to Metro Council members that property owners of a territory to be annexed are adequately advised of anticipated additional taxes and the municipal services the city will provide and have the opportunity to attend a public hearing regarding the proposed annexation. Metro Council further expects that notice be sent



to the property owners by certified mail with a copy to be filed with the Louisville Metro

Council Clerk so that Metro Council members may attend the public hearing(s).

SECTION II: If all of property owners of a territory to be annexed give prior consent as set forth in KRS 81A.412, Metro Council shall consider the annexation proposal without asking the city proposing annexation to hold a public meeting.

SECTION III: Metro Council will evaluate the following criteria when considering a proposal for annexation: (1) the number of properties that exist in the territory to be annexed; (2) is the industrial territory "within a broad, comprehensive plan of annexation" of the city as required by KRS 81A.510; (3) is the city proposing annexation capable of adequately providing municipal services to the industrial area to be annexed; (4) will the proposed annexation result in a substantial burden to property owners and/or residents to the newly annexed territory; and (5) is the proposed industrial territory to be annexed compact and contiguous to the city's boundaries as required by KRS 81A.510?

SECTION IV: Pursuant to the authority granted by Kentucky law, Metro Council will consider all statutory and legislative issues surrounding annexation proposals brought before the legislative body and hold one or more public hearings to consider whether proposed annexation ordinances have complied with the law.

SECTION V: This Resolution shall take effect upon its passage and approval.

CITY OF ST. MATTHEWS ORDINANCE NO. 17-01 AN ORDINANCE ANNEXING 28 HOMES ON ORMOND AND FLINT ROADS INTO THE CITY OF ST. MATTHEWS

WHEREAS, the City of St. Matthews hereby finds that it serves the public interest of the citizens of the City of St. Matthews to annex 28 homes on Ormond and Flint Road, because 100% the residents living there have signed consents asking to be annexed so they can get city services;

AND WHEREAS, annexing this residential area would be a natural extension of city services such as garbage collection and road maintenance, to area residents who need them and the tax burden in providing such services will not be burdensome to the residents to be annexed,

AND WHEREAS, pursuant to KRS 81A.410 and KRS 67C.111, St. Matthews is both stating its intention to so annex and also asking the permission of Louisville Metro to annex,

NOW THEREFORE, BE IT ORDAINED BY THE CITY OF ST. MATTHEWS, KENTUCKY.

- 1. It is hereby found, determined, and declared that:
 - (a) The area to be annexed is contiguous to the current boundaries of the City of St. Matthews.
 - (b) The area to be annexed is urban in character and completely residential and the City of St. Matthews can provide the area needed city services including, garbage collection, road maintenance, snow removal and street lighting.
 - (c) 100% of the residents in the area to be annexed have signed a consent form asking the City to annex their home.
 - (d) The annexation is a normal extension of residential City services by the City of St. Matthews, which the City finds is in keeping with the City's mission.
 - (e) The area to be annexed is subject to the KRS 67C.111; which requires the approval of Metro Louisville, prior to the initiation of this Annexation.
 - (f) The City of St. Matthews has obtained a written consent from each and every homeowner and therefore, under Metro Louisville Resolution 056, Series 2014, no public hearing was held.
- 2. It is the intention of the City of St. Matthews to annex the 28 homes located on Ormond and Flint Roads, which territory is more particularly described in the attached Exhibit One.
- 3. It is hereby declared to be the intention of the City of St. Matthews to annex the territory described in (2) above. The City of St. Matthews Commission hereby officially asks permission from Louisville Metro, pursuant to KRS 67C.111, to so annex this territory.
- 4. This Ordinance is adopted pursuant to KRS 81A.410.
