# Biographical Sketch of Rev. Eddie L. White



Reverend Eddie L. White Sr., a minister of the Gospel of Jesus Christ, was born March 5, 1945 in Cocoa, Brevard County, Florida. He attended Metropolitan Baptist Church in Cocoa, was active in Sunday school, the Usher Board, BTU, and various other ministries. He always envisioned himself as a leader.

At age 19, after a most memorable experience, he accepted the call to the Gospel Ministry. He was licensed in 1965 and ordained in Cocoa in 1968 under the pastorate of the late Dr. Hugh F. Brockington Sr. of Metropolitan Baptist Church, Cocoa. Rev. White served for 1½ years as assistant pastor to Rev. Brockington.

When Rev. White came to Louisville, Kentucky to study at Simmons Bible College (now Simmons College of Kentucky) he joined Eastern Star Baptist Church, under the pastorate of Rev. J. R. Gant, where he served as Junior Church Pastor. Later Rev. White was asked to assist Pastor M.H. Gant Sr. at Ebenezer Baptist Church. While at Ebenezer the church extended an invitation for Rev. White to serve as assistant pastor under Dr. M.H. Gant. In 1973, at the retirement of Dr. Gant, Ebenezer extended the call to Rev. White to accept the pastorate full time.

Program; and a Black History Committee that recognizes the accomplishments of Blacks throughout the year.




