

**POWERS** 

Pursuant to the powere granted the Mayor by KRS Chapter 67C, the existing functions, personnel, funds, equipment, facilities and records of the Louisville and Jefferson County Human Relations Commission in its investigation and enforcement of anti-discrimination laws be and the same are hereby transferred to the Louisville Metro Human Relations Commission-Enforcement created herein. The duties, responsibilities and authorities granted to the former Human Relations Commission for the investigation and enforcement of anti-discrimination laws and enumerated in applicable previsions of the Kentucky Revised Statutes, ordinances and resolutions in place pursuant to KRS 67C.115(1), regulations, policies and procedures adopted by the Commission, unless in conflict with the provisions of this ordinance, shall be deemed transferred to the Louisville Metro Human Relations Commission-Enforcement.

REMOVAL

Members are subject to removal by the Mayor at the discretion of the Mayor.
