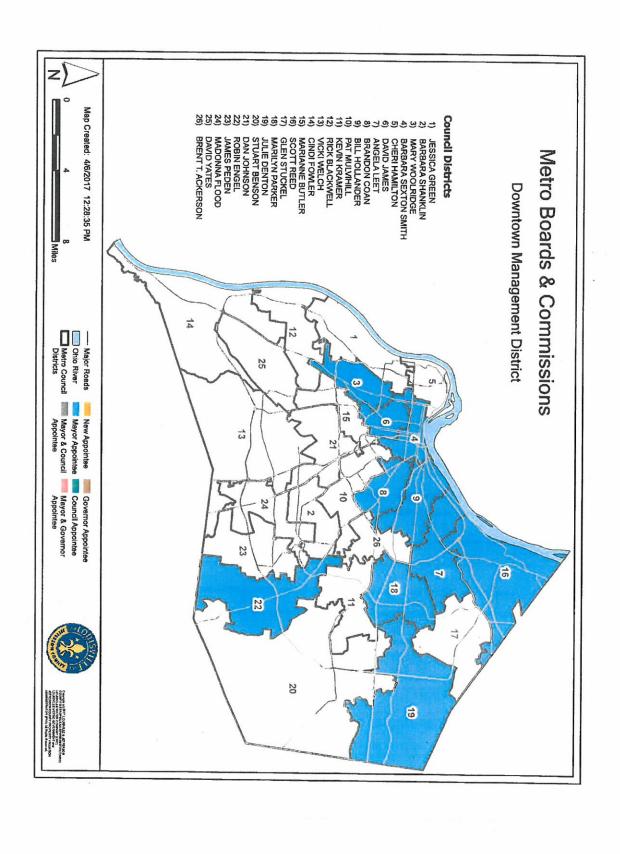

POWERS

The District shall constitute a body corporate, with the power to contract and be contracted with.

- (A) The Board of Directors of the District shall have the right to transact business on behalf of the District immediately after the appointment of its members.
- (B) The Board of Directors shall have full powers to name its organization and to make bylaws and rules for the regulation and management of the affairs of the District not inconsistent with the provisions of this chapter.
- (C) The Board of Directors shall have all powers necessary and proper to conduct the allalia of the District not inconsistent with the provisions of tile chapter, including but not limited to:
- (1) Preparing annually an Economic Improvement Plan and budget;
- (2) Implementing the Economic Improvement Plan;
- (3) Making policy for operation of the District;
- (4) Managing the fiscal allairs of the District:
- (5) Incurring, in the aggregate, short-term and long-term debt in amount not to exceed \$500,000; and
- (6) Such other powers as provided in KRS 91.750 through 91.702.
- (D) The Board of Directors may contract with any person or corporation determined to have the needed expertise to manage and administer the day-to-day operations of the affeirs of the District.
- (E) The Board of Directors may undertake the following economic improvements within the District.
- (1) The planning, administration, and management of development or improvement activities:
- (2) Landscaping, maintenance, and cleaning, of public ways and spaces;
- (3) The promotion of economercial activity or public events:
- (4) The conduct of activities in support of business repruitment and development;

(5) The provisions of security for public areas,

(6) The construction and maintenance of capital improvements to public ways and appears; and

(7) Any other economic improvement activity that specially benefits properly.

REMOVAL

Any momber of the Beard of Directors appointed by the Mayor may be removed by the Mayor for cruse.

Any member of the Board of Directors may be removed by the Mayur for violation of the rules, regulations or operating procedures adopted by the Board of Directors if the removal is recommended by a resjority of the members of the Board of Directors.

A copy of the studit report shall be furnished to the Matro Council and the Dopartment of Finance and Sudgel.

The Board of Directors shall prepare an annual report to the owners of benefited properties within the District evaluating the District's effectiveness and describing

its accomplishments during the proceeding fiscal year. The report shall be sent to the event of each benefited property at such time that the annual economic plan and budget is sent pararant to § 160.02. A copy shall also be provided to the Marra Council.

Upon approval of the annual budg at by the Motro Council, then the Board of Directors shall publish buth it and the economic improvement plan pursuant to KRS Chapter 421 and shall mail by first class mail to each owner of constited property a description of the economic improvement plan, the fair basis of assessment to be utilized, the estimated cost to the property owner, and the ratio limit the cost to each property owner hears to the total cost of the economic laptrovoluncies.

The Board of Directors is divested to submit a report to the Mayor and Mesio Council after the end of each year of the Districts operation, dotabling how it has addressed the directives and principles enumerated in §3 160.20 through 160.25.
