Case Summary / Background / Site Context

The lot is located on River Park Drive west of Amy Ave and east of S. 40th Street. It is surrounded by single-family residential and multi-family residential with commercial properties on the corners. The lot is zoned C-1 in the Traditional Neighborhood Form District (TNFD).

Buyer recently completed a \$500,000 renovation of the adjacent 24 unit apartment building and office building which is currently used as office space for Mirage Properties, LLC.

Staff completed site inspections and found the applicant's current properties in good order with no open maintenance cases, fines, or past due taxes.

The lot is located in the Shawnee Neighborhood.

Staff Conclusions / Proposed Conditions of Approval

Staff recommends approval of the sale to Mirage Properties III, LLC for \$125.00 in accordance with the current pricing policy. The following conditions are also recommended:

1. The applicant will consolidate the lot with their current property at 3813 River Park Drive within six (6) months of the recorded transfer deed.
