WAIVER REQUEST



VARIANCE REQUEST

A variance is requested from Land Development Code Section 5.3.2.C.2.b. to waive the requirement of a 25' Transition Zone Setback along the northwestern property adjacent to the National Letter Carriers Association property.

CONDITIONAL USE PERMIT REQUEST

A Conditional Use Permit is requested from Land Development Code Section 4.2.51 Storage Yard and Contractor's Yard, to allow outdoor storage areas on site.

EROSION PREVENTION AND SEDIMENT CONTROL NOTES

- 1. The approved erosion prevention and sediment control (EPSC) plan shall be implemented prior to any land-disturbing activity on the construction site.
- 2. Any modifications to the approval EPSC plan must be reviewed and approved by MSD's private development review office. EPSC BMP's shall be installed per the plan and MSD standards.
- 3. Detention basins, if applicable, shall be constructed first and shall perform as sediment basins during construction until the contributing drainage areas are seeded and stabilized.
- 4. Actions must be taken to minimize the tracking of mud and soil from construction areas onto public roadways. Soil tracked onto the roadway shall be removed daily.
- 5. Soil stockpiles shall be located away from streams, ponds, swales and catch basins. Stockpiles shall be seeded, mulched, and adequately contained through the use of silt fence.
- 6. All stream crossings must utilize low-water crossing structures per MSD standard drawing ER-02.
- 7. Where construction or land disturbance activity will or has temporarily ceased on any portion of a site, temporary site stabilizaton measures shall be required as soon as practicable, but no later than 14 calender
- days after the activity has ceased. 8. Sediment-laden groundwater encountered during trenching, boring or other excavation activities shall be pumped to a sediment trapping device prior to being discharge into a stream, pond, swale or catch basin. All storm drainage shall conform to MSD standard
- specifications. 9. Construction fencing shall be erected prior to any construction or grading activities preventing compaction of root systems of trees to be preserved. The fencing shall enclose the area beneath the dripline of the tree canopy and shall remain in place.
