PLEASE REFRAIN FROM MAKING DEROGATORY STATEMENTS IN COUNCIL.

REBECCA BERNSTEIN: GOOD EVENING, I'M REBECCA BERNSTEIN AND I LIVE IN COUNCILMAN MULVIHILL'S DISTRICT 10. I'M HERE TO URGE TO ADOPT COUNCIL POLICIES. I GREW UP HERE IN LOUISVILLE AND GREW UP JEWISH. FOR THOSE OF YOU WHO DO NOT KNOW WHAT THAT MEANS, ONE OF THE UNIQUE TEACHINGS OF A JEWISH EDUCATION IS THE REQUIREMENT THAT YOU LEARN OF HISTORY OF EVERY WRONG THAT HAS FALLEN ON YOUR PEOPLE IN DETAIL. THERE IS AN EMPHASIS ON WORLD WAR II. WHEN I SAY EXCRUCIATING DETAIL, I MEAN IT. YOU LEARN EVERYTHING. WHAT THE STAMPS LOOKED LIKE ON THE PAPERS. HOW SPECIFIC FAMILIES WENT INTO HIDING GOT THEIR FOOD EVERY DAY. THE DATES OF DEPORTATION AND THE KIND OF WORK DONE IN LABOR CAMPS.

YOU LEARN YOUR HISTORY IN SUCH A WAY, YOU LEARN
LANDMARKS ON A TROUBLING PATH THUS GIVING YOU AN OPPORTUNITY TO
INTERVENE. I'M HERE SPEAKING TO YOU TODAY BECAUSE THE ALARM
BELLS ARE RINGING SO VERY LOUDLY. SO CALLED "CARRIER PAPERS"

LEGISLATION PASSED WITH FLYING COLORS IN TEXAS. RIGHT HERE IN
OUR CITY IMMIGRANT FAMILIES ARE REFUSING TO LEAVE THEIR HOMES

TERRIFIED OF WHAT THEY MIGHT LOSE IF THEY DO. RAIDS AND

DEPORTATIONS ARE CONSTANT AND COMMUNITY MEMBERS ARE SENT TO

DETENTION CENTERS WHERE IN AT LEAST ONE DOCUMENTED CASE NEARLY
60,000 DETAINEES WERE FORCED TO WORK WITHOUT PAY, A CRIME WHICH
VIOLATES FEDERAL ANTISLAVERY LAWS.

I'M ASKING THIS COUNCIL TO ESTABLISH AND ENFORCE
POLICIES THAT ENSURES THAT LOUISVILLE IS A CITY OF SANCTUARY,
LESSONS OF HISTORY TELL US WE CAN'T DO OTHERWISE. I KNOW THAT

THIS IS SIMILAR IN TROUBLING WAYS THAN IN EUROPE IN WORLD WAR II
AND PROBLEMS HAVE A WAY OF GROWING WHEN IGNORED. THE ISSUE OF
SANCTUARY CITIES IS URGENT. LOUISVILLE CANNOT ACCEPT TAXES
WITHOUT ENSURING ECONOMIC OPPORTUNITY AND PEACE OF MIND. I URGE
YOU TO CHOOSE BOLD, COMPASSIONATE ACTION. ESTABLISH CITY OF
SANCTUARY POLICIES FOR THE CITY OF LOUISVILLE, THANK YOU.

LANDON LAUDER.

LANDON LAUDER: THANK YOU, METRO COUNCIL MEMBERS FOR ALLOWING ME AND MEMBERS OF THE COMMUNITY TO SPEAK TO YOU TODAY.

I'M LANDON LAUDER AND I RECENTLY GRADUATED FROM THE UNIVERSITY OF LOUISVILLE AS A NONPARTISAN SCHOLARSHIP PROGRAM. I HAD THE PRIVILEGE OF HEARING FROM INTERNATIONAL AND NATIONAL LEADERS AROUND THIS. I'D LIKE TO TALK ABOUT AN ENCOUNTER. THERE WAS A SEMINAR LEADER WITH WHOM WE DISCUSSED THE POLITICAL ECONOMIES OF CITY. DURING THE Q AND A, I ASKED AN OFFICIAL ABOUT THE DEVELOPMENT HERE IN LOUISVILLE. HAVING COMBED THROUGH LAST YEAR'S BUDGET IN ADDITION TO COUNTLESS NEWS AND ARTICLES SPANNING DECADES HERE IN LOUISVILLE, I WANTED TO ASK HIM THE RECENT WAVE OF THE DEVELOPMENT HERE IN LOUISVILLE. I ASKED ABOUT THE CASE OF AUTOMOBILE, THE PROPOSED SITE A -- [INAUDIBLE] BILLION THE SITE IN THE AREA. HIS RESPONSE WAS "THOSE PEOPLE HAD NO IDEA THEY NEEDED A WALMART." I WAS STRUCK BY THE CITY'S

OFFICIAL ASSUMPTION THAT THE PEOPLE WHO LIVE IN THE VERY COMMUNITIES THESE PROJECTS WERE PROPOSED SOMEHOW HAD NO GRASP ON WHAT THEIR NEEDS ARE. THE CITY OFFICIALS DECKED IN THEIR FINELY TAILORED SUITS LEFT THE SEMINAR EARLY TO ATTEND A DINNER ON BEHALF OF THE LIQUOR COMPANY. THIS SHOWED HE THOUGHT HE KNEW MORE ABOUT THE NEIGHBORHOODS THAN THE PEOPLE WHO LIVED THERE. WITH THE BUDGET DEADLINE RIGHT AROUND THE CORNER, I HOPE THIS IS NOT THE SENTIMENT OF THIS COUNCIL TO LITERALLY STEAMROLL OVER THE WISHES. NEEDS AND VOICES OF THE PEOPLE WHO LIVE IN THESE COMMUNITIES IS UNDEMOCRATIC AND DISRESPECTFUL. I ENCOURAGE THIS COUNCIL TO THINK ABOUT WHO BENEFITS FROM THIS TYPE OF DEVELOPMENT. ARE WE LOOKING TO EMPOWER THE COMMUNITY MEMBERS AND GIVE THEM AMPLE SEATS AT THE NEGOTIATING TABLE FOR DEVELOPMENT? OR ARE WE FIXATED ON AN OUTDATED BUSINESS RECRUITMENT STRATEGY WHERE WE SEND THEM TO NEGOTIATE WITH OUR ORDINANCES AND TAX DOLLARS. WE MUST TURN TO THOSE WHO KNOW BEST IN THESE MATTERS, THE COMMUNITY MEMBERS THEMSELVES WITHOUT THEIR INPUT FOR WHOM ARE WE DEVELOPING AND BUILDING THIS CITY. [APPLAUSE]

MR. CLERK: SUSIE KEHL. I APOLOGIZE IF I MISPRONOUNCED YOUR NAME.

SUSIE KIEHL: GOOD EVENING, I'M SUSIE KIEHL IN

COUNCILMEMBER JOHNSON'S DISTRICT. I WANTED TO TALK ABOUT A

MEMORIAL BENCH FOR OFFICER NICK RODMAN. I'VE SUBMITTED THE PLANS

FOR YOU ALL ON YOUR DESK. AND THE BRANCH OF THE PUBLIC LIBRARY

REACHED THIS ON THEIR GROUNDS. THEY FEEL THEY'LL GIVE A SIT

TRIBUTE TO HIM AND HIS FAMILY. JOHNSON -- THERE ARE A FEW OTHER OPTIONS THAT THE FAMILY CAN ADD LIKE A QR CODE TO PUT DIFFERENT PICTURES ON THERE. U OF L AND HOLY CROSS THEIR APPROVAL TO HAVE THEIR LOGOS ON THE BENCH. BECAUSE THEY'RE CLOSE TO THE RODMAN FAMILY.

WE'RE WAITING ON PERMISSION FROM THE RODMAN FAMILY TO GO AHEAD WITH THE BENCH PLANS. I'VE REACHED OUT TO COUNCILMAN JAMES TO REACH OUT TO THE FAMILY BECAUSE THEY HAVE TO GIVE THEIR PERMISSION TO THE BENCH FOR THE PROJECT TO HAPPEN. I WANTED TO LET YOU ALL KNOW WHAT WAS IN THE WORKS AND WHAT IS PLANNED ON OFFICER RODMAN. THANK YOU. [APPLAUSE]

MR. CLERK: CONNIE MARSHALL. CONNIE MARSHALL.

CONNIE MARSHALL: MY NAME IS CONNIE MARSHALL. MY
WEBSITE IS WWW.JUSTICEFORALLCITIZENS.COM. A LAWSUIT WAS FILED
AGAINST THREE POLICE OFFICERS AND CHIEF CONRAD REORGANIZED THE
POLICE DEPARTMENT. FIVE MAJORS ARE REASSIGN AND THREE ARE
LEAVING. ONE MAJOR WAS OVER THE DIVISION IF MY DISTRICT. FOR
FIVE YEARS I'VE BEEN SPEAKING BEFORE METRO COUNCIL BEGGING FOR
ASSISTANCE REGARDING BEING ASSAULTED BY THE LOCAL METRO POLICE.
I HAVE A BOOK ON THE CRIMES SUBMITTED TO THE FBI AND D.O.J. IT
INCLUDED 30 OF THE 60 HATE E-MAIL SENT TO ME BY THE POLICE AND
USING THE "N" WORD AND THEY OWN THE COUNTRY ETC. FOUR PLEADINGS
WITH MY FORGED SIGNATURE ONE ACCUSING A FEDERAL JUDGE TAKING
BRIBES. USING MY NEIGHBORS AND DAUGHTERS AS SENDERS. PICTURE
REFERENCES ME OF A WOMAN'S BLOODY TORSO. A WOMAN BEING SMASHED

IN THE STREET BY A GARBAGE TRUCK AND A MAN SAYING "WE'RE WATCHING YOU," AND A FABRICATED E-MAIL WITH MY FORGED SIGNATURE THREATENING TO KILL HIM. TWO DAYS BEFORE IT WAS SENT, I POSTED ON MY WEBSITE ILLEGAL ACTS AGAINST ME BY THIS MANAGER. TWO DAYS LATER THE POLICE WERE BANGING ON MY DOOR ACCUSING ME OF SENDING THE E-MAIL, THIS SUGGESTS COLLUSION OF THE MANAGER AND POLICE. YOU'LL SEE EVIDENCE OF COLLUSION BETWEEN THE POLICE ON THE MORNING OF JUNE 20TH, 2016 I PUT MALONE STAFFING ON THE DOCKET FOR UNEMPLOYMENT. I GOT MY UNEMPLOYMENT. THAT NIGHT THE LOCAL METRO POLICE WERE BANGING ON MY DOOR. TO DATE I DON'T HAVE A COPY OF THE E-MAIL, I WAS TOLD THE POLICE DIDN'T HAVE A COPY. I KNOW THE POLICE HAVE WORKED AS SECURITY FOR ONE OF THE WAREHOUSES. THIS WOULD EXPLAIN THE FALSE ACCUSATIONS AGAINST ME BY MALONE STAFFING. IN THIS BOOK, YOU'LL FIND A WHITE MAN THAT LOOKS LIKE AN OFFICIAL THAT TRIED TO BREAK INTO MY TUB WHILE I WAS IN THE TUB AND THE POLICE CALLED ME THE "N" WORD.

EVERYTHING I STATED IN THIS BOOK WHICH HAS THE LINKS

TO VIDEOS AND PICTURES ETC., CAN BE FOUND ON MY WEBSITE. I'LL

PUT MY YOUTUBE AND PULL UP MY VIDEOS. I LEFT A COPY OF THIS BOOK

AND I'LL -- WOULD I LIKE TO LEAVE ANOTHER COPY, IF I MAY. THIS

WAS SENT TO THE FBI AND U.S. D.O.J. THANK YOU. [APPLAUSE].

MR. CLERK: BEVERLY DUNCAN.

BEVERLY DUNCAN: GOOD EVENING, I'M BEVERLY DUNCAN AND I
LIVE IN COUNCILMAN JOHNSON'S DISTRICT AND I ATTEND BAPTIST
COMMUNITY. WE'RE PROUD THAT OUR EFFORTS RESULTED IN \$29 MILLION

FOR AFFORDABLE HOUSING INCLUDING \$14.5 MILLION THIS YEAR WITH \$2.5 MILLION GOING TO THE AFFORDABLE HOUSING TRUST FUND. TONIGHT I'M HERE TO EXPRESS CLOUT'S SUPPORT FOR THE REQUEST THAT HAS BEEN MADE BY SEVERAL COUNCILMEMBERS TO TRANSFER \$7.5 MILLION FROM LOUISVILLE CARES TO THE TRUST FUND. THIS WOULD ENSURE THAT THE CITY FOR THE FIRST TIME FUNDS THE TRUST FUND AT THE LEVEL PROMISED WHEN IT WAS CREATED IN 2008. IT WOULD ENSURE A FAIRER DISTRIBUTION OF THE CITY'S FUNDING FOR AFFORDABLE HOUSING. CURRENTLY, ONLY 17% OF THAT FUNDING IS GOING TO THE TRUST FUND. THE BEST TOOL WE HAVE TO SERVE OUR LOWEST INCOME HOUSEHOLDS. THIS WOULD INCREASE THE AMOUNT TO 43%. WE UNDERSTAND THAT THE \$12 MILLION ALLOCATION TO LOUISVILLE CARES IS PART OF A \$68 MILLION BOND TO FUND OTHER PROJECTS LIKE ROADWAYS, BIKE LANES, SIDEWALKS, THE KENTUCKY WIRE PROJECT, THE NORTHEAST REGIONAL LIBRARY AND CITY VEHICLES AND EQUIPMENT. IT CAN PROVIDE A GREATER RETURN BECAUSE 91 CENTS OF EVERY DOLLAR THAT GOES TO THE TRUST FUND IS USED FOR PROGRAMMING AND EVERY DOLLAR DISTRIBUTED BY THE TRUST FUND WOULD LEVERAGE APPROXIMATELY \$6 IN DEVELOPER INVESTMENT. ALSO, NEW CONSTRUCTION MADE POSSIBLE BY THE TRUST FUND WOULD PROVIDE A POSITIVE RIPPLE EFFECT ON NEIGHBORHOODS AND JOBS TO BOOST THE LOCAL ECONOMY AND GENERATE MORE REVENUE FOR THE CITY.

WE ALSO UNDERSTAND THIS IS NOT A LONG TERM SOLUTION.

BUT ALLOCATING THE FULL \$10 MILLION THIS YEAR WOULD ALLOW THE

TRUST FUND TO FURTHER ESTABLISH ITS TRACK RECORD FOR MEETING THE

HOUSING NEEDS OF PEOPLE AT ALL INCOME LEVELS IN OUR COMMUNITY.

IT WOULD ALSO ALLOW CLOUT AND THE TRUST FUND'S A ADVOCACY

COMMITTEE TO FOCUS ON BUILDING STAKEHOLDER SUPPORT TO IDENTIFY

AND ESTABLISH THE DEDICATED FUNDING SOURCE THAT THE TRUST FUND

TRULY NEEDS. DEDICATED FUNDING IS A KEY ELEMENT IN THE SUCCESS

OF HOUSING TRUST FUNDS ALL ACROSS OUR COUNTRY. IF TRANSFERRING

FUNDS FROM LOUISVILLE CARES IS CURRENTLY THE BEST AND ONLY

OPTION CONSIDERED BY COUNCIL TO GET THE ALLOCATION TO \$10

MILLION, THEN WE SUPPORT THAT AND WE URGE THE BUDGET COMMITTEE

TO KEEP THIS YEAR'S TOTAL ALLOCATION FOR AFFORDABLE HOUSING AT

\$14.5 MILLION. THANK YOU. [APPLAUSE].

MR. CLERK: RAYMOND BRUCE. RAYMOND BRUCE.

RAYMOND BRUCE: MY NAME IS RAYMOND BRUCE SENIOR. I LIVE IN MISS GREEN'S DISTRICT. MY WIFE AND I HAVE BEEN MARRIED FOR ALMOST 37 YEARS AND RAISED ALL SIX OF OUR CHILDREN IN THIS AREA AND THEY'RE NOW GROWN AND ARE ALL LAW-ABIDING CITIZENS. I RETIRED FROM THE DUPONT PLANT ABOUT 10 YEARS AGO IN LOUISVILLE. I ONCE LIVED ON RIVER PARK DRIVE.

NOW ME AND MY WIFE DECIDED TO MOVE INTO A SMALLER HOME
OVER 3032 GRAND AVENUE. RIGHT NOW THIS WILL IS THE FIRST TIME
THAT I HAVE EXPERIENCED ANYTHING LIKE THIS WITH PEOPLE PARKING
THEIR CARS IN YOUR NEIGHBORHOOD WITHOUT LICENSE OR INSURANCE.
FINALLY I WOULD LIKE TO SAY THAT I HAVE -- I HAVE FILED THREE
COMPLAINTS AGAINST THIS CONCERNING UNLICENSED VEHICLES,
UNINSURED VEHICLES PARKED IN MY NEIGHBORHOOD. NOTHING WAS DONE

UNTIL LAST COMPLAINT BY THE THIRD AND FINAL COMPLAINT, THERE WAS A VEHICLE WITH FOUR FLAT TIRES, NO LICENSE TAG AND PEOPLE WERE RUNNING INTO IT AND BUMPING IT AND FINALLY WHEN THE POLICE CAME OUT, AFTER I HAD CALLED 6-1-1 AND THEY CAME OUT AND CHECKED THE VEHICLE AND FINALLY TOWED THIS PARTICULAR VEHICLE IN. THERE ARE OTHER VEHICLES THAT ARE STILL ON THE STREET. THERE IS ONE FAMILY OF A WIDOW WOMAN OVER 80 YEARS OLD AND HER SON WHO IS A MILITARY VET THAT IS DISABLED. AND THEY HAVE FOUR MOTORCYCLES, THEY HAVE ONE SUV, THEY HAVE ONE DODGE CAR VAN, THEY HAVE ONE CAR PARKED IN THE BACK, AND THEY ALSO HAVE ANOTHER CAR PARKED IN THE FRONT THAT THEY TOOK THE LICENSE TAGS OFF THE ONE PARKED IN THE BACK AND PUT IT ON THE CAR THAT THEY DRIVE. ALL TIME. WE'RE NOT ASKING FOR ANY SPECIAL FAVORS, ONLY THAT THE LAWS AND ORDINANCES IN THE CITY BE ENFORCED. WHY WOULD A FAMILY OF THIS MAGNITUDE HAVE THIS MANY VEHICLES? DOESN'T IT SOUND STRANGE? AND I'M ASKING IN BEHALF OF THE CITY TO START DOING SOMETHING ABOUT THIS TO BECOME MORE PROACTIVE AND MORE PREVENTIVE THAN ALL THE PROBLEMS THAT WE FACE ARE A RESULT OF BEING REACTIVE. THANK YOU.

MR. CLERK: CHRIS FINZER.

CHRIS FINZER: GOOD EVENING. MY NAME IS CHRIS FINZER.

MY FAMILY AND I LIVE IN COUNCILMAN KRAMER'S DISTRICT 11 AND

ATTEND THE CATHOLIC CHURCH IN DISTRICT SIX. I SEARCH AS THE

CO-CHAIR OF CLOUT'S MENTAL ADDICTION COMMITTEE. CLOUT IS HERE TO

SUPPORT FULL FUNDING FOR THE LIVING ROOM PROPOSAL TO PROVIDE

BADLY-NEEDED CRISIS STABILIZATION SERVICES FOR PEOPLE WITH MENTAL HEALTH PROBLEMS. LOUISVILLE'S EMERGENCY ROOMS AND ARE JAILS ARE OVERCROWDED BECAUSE OF THE SIMPLE REASON THAT PEOPLE IN CRISIS HAVE NOWHERE ELSE TO GO. THOUSANDS OF PEOPLE NEED THESE SERVICES. TODAY I WANT TO TELL YOU ABOUT ONE OF THEM, THE DAUGHTER OF A CLOUT LEADER WHOM WE'LL CALL ANDREA. ANDREA WAS DIAGNOSED WITH BIPOLAR DISORDER WHEN SHE WAS 16. BEFORE THE DIAGNOSIS, SHE WAS A HAPPY, HEALTHY AND THRIVING YOUNG PERSON. SHE WAS IN THE ADVANCED PROGRAM AT SCHOOL, A CHEERLEADER, PLAYED VIOLIN IN THE SCHOOL ORCHESTRA AND SHE WAS INVOLVED IN CHURCH ACTIVITIES AND THE YOUTH CHOIR. BUT SHE BEGAN TO SELF-MEDICATE BY ABUSING DRUGS. OVER THE YEARS, SHE'S HAD A NUMBER OF ENCOUNTERS WITH THE POLICE AND EMERGENCY ROOM THAT DID NOTHING TO HELP. RECENTLY ANGELA'S MOTHER WAS AT HER APARTMENT WHEN ANDREA BECAME AGITATED AND THREATENED TO HURT HERSELF. WHEN HER MOTHER CALLED THE POLICE FOR HELP, THE OFFICER NEVER CAME INSIDE THE APARTMENT AND ASKED HER MOTHER, HOW DO I KNOW YOU ALL HAD A FIGHT AN WANT US TO ARREST HER BECAUSE YOU WERE MAD AT HER. NOBODY SERVED ANDREA WELL THAT NIGHT AND HER MOTHER WAS HELPLESS TO PROVIDE HER THE TREATMENT SHE NEEDED. SHE NEEDED A LIVING ROOM PROGRAM. IF THAT OFFICER

HAD THE AUTHORIZATION TO TAKE HER TO SUCH A PROGRAM, THINGS
WOULD HAVE BEEN DIFFERENT. WHAT CENTER STONE IS ASKING FOR IS A
COMMITMENT FROM METRO COUNCIL TO SAVE LIVES AND THE CITY WILL
SAVE MORE MONEY THAN IT COSTS. THAT'S WHY WE'RE HERE TO TAKE
THIS STEP TO FUND THE CENTER STONE LIVING ROOM PROPOSE THIS WILL

THOUGHT IT WOULD BE ANOTHER LANDSCAPE FILLED WITH HOUSES OR

APARTMENT COMPLEXES. WHEN KENNETH DELCOUR BOUGHT THE PROPERTY,
HE HAD OTHER PLANS. TURNING THE LAND BACK TO A WORKING FARM. BY

LATE FALL OF 2014, THE FIRST INHABITANTS WERE MOVING IN, THREE

PREGNANT ANGUS COWS AND A BULL CALF. TODAY THEY BOAST OF 13 BEEF

CATTLE, A HENHOUSE FULL OF LAYERS AND PROTECTED TREES AND STEEP

SLOPES. THE COWS ARE HAPPY AND GRAZE ON LUSH PASTURES. THE

NEIGHBORS ARE HAPPY WITH THE ATTRACTIVE BLACKBOARD FENCING AND NEIGHBORS THAT MOO.

AND THE CREEK THAT RUNS THROUGH MR. DELCOUR'S AREA IS A LOT CLEANER BECAUSE OF HIS CONSERVATION EFFORTS ON THE 30-ACRE FARM. FOR HIS EFFORTS IN KEEPING TO IMPROVE WATER QUALITY IN THE FARM CREEK WATERSHED BY EMPLOYING GOOD SOUND PRINCIPLES, THE JEFFERSON COUNTY SOIL AND WATER CONSERVATION DISTRICT PRESENTS KENNETH DELCOUR WITH THIS AWARD. I BELIEVE THEY'RE HERE TO PRESENT.

MISS YOU. BUT WE LOVE YOU. HUSBAND, YOU HEAR ME OUT THERE AND WIFE YOU HEAR ME BACK HERE. ALL RIGHT.

ALL WORKED UP HERE. BUT JIMMY HAS DONE SO MUCH FOR OUR CITY AND

NEEDED HIM. ALL WE HAD DO WAS CALL, AND THAT MIGHT BE AT 2:00 IN

HE'S BEEN THE BEST MAJOR OUT OF PROBABLY A DOZEN THAT WE'VE HAD

GOING THROUGH THE THIRD DIVISION. IN THE 11 YEARS THAT I'VE BEEN

THERE. WHEN I FOUND OUT HE WAS FROM PORTLAND, IT GOT TO MY

MAJOR HARPER WAS ON THE GROUND WITH -- HARPER WAS ON THE GROUND
WITH MEMBERS OF THE COMMUNITY AND CLERGY TELLING MY KIDS THAT
EVERYTHING WOULD BE. MAJOR HARPER SPENT TIME TALKING WITH MY
CHILDREN AND PUTTING THEM AT EASE. IT'S A SAD DAY IN LOUISVILLE
WHEN BEING A DAMNED GOOD OFFICER DOESN'T GET THE RESPECT HE
NEEDS. YOU'RE THE BEST.

>> WHERE EVERYBODY IS OFF-THE-CUFF, BUT I HAVE TO
WRITE MY REMARKS OUT. COLLEAGUES AND MR. PRESIDENT, I'D LIKE TO
ASK FOR YOUR INDULGENCE BECAUSE IT'S AN HONOR AND PLEASURE TO BE
ABLE TO PARTICIPATE IN THIS RECOGNITION AND TO HAVE THE
OPPORTUNITY TO BE ABLE TO PUBLICLY THANK AND PERSONALLY
ACKNOWLEDGE JIMMY HARPER FOR HIS DEVOTED LEADERSHIP, SERVICE AND
SACRIFICE TO LMPD AND THE LOUISVILLE COMMUNITY. I'VE ALWAYS BEEN
FASCINATED BY THE SAYING SIX DEGREES OF SEPARATION, THE IDEA
THAT ALL LIVING THINGS AND EVERYONE IN THE WORLD ARE SIX OR
FEWER STEPS AWAY FROM EACH OTHER SO THAT I A CHAIN OF A FRIEND
OF A FRIEND STATEMENTS CAN BE MADE TO CONNECT ANY TWO PEOPLE IN

A MAXIMUM OF SIX STEPS. ON THE SURFACE, IT PROBABLY WOULDN'T BE READILY APPARENT THAT JIMMY HARPER AND I WOULD ADHERE TO AT THAT AXIOM, BUT IN FACT, WE HAVE ONLY ONE DEGREE OF SEPARATION AS I WOULD FIND OUT. ONE DAY ERIKA, JIMMY'S BEAUTIFUL WIFE -- COME ON UP HERE -- MENTIONED THAT JIMMY PLAYED

FOOTBALL IF MY DISTRICT AND SMILED PROUDLY WHEN SHE SAID HE HAD BEEN THE QUARTERBACK OF THE TEAM. I'VE HEARD HARPER SAY THAT HIS COACH SAVED HIS LIFE. I NEVER ASKED WHAT HE MEANT BY THAT, BUT I DID WONDER WHO THIS COACH WAS AND WHEN HE HAD DONE. ONE DAY I LEARNED HIS NAME WAS COACH GREEN. A BIT LATER LEARNED THAT HE WAS IN FACT SOMEONE I KNEW. DON'T BE READING MY NOTES.

JIMMY GREEN OR JELLY BEAN GREEN AS I HAD KNOWN HIM, AND THERE IT WAS OUR ONE DEGREE OF SEPARATION. JELLY AND I WERE BORN AND SPENT OUR EARLY CHILDHOOD LIVES LIVING TWO DOOR AS PART IN THE RUSSELL NEIGHBORHOOD ON JEFFERSON STREET. HIS OLDER BROTHER AND SISTER WERE FRIENDS AND PLAYMATES WITH MY OLDER BROTHER AND SISTER AND JELLYBEAN WAS PROBABLY MY FIRST CHILDHOOD FRIEND AND PLAYMATE. KNOWING HOW MUCH COACH GREEN MEANT TO HIM AND WHAT HE HAD CONTRIBUTED TO MAKING JIMMY HARPER INTO BECOMING WHO HE IS AND THE LEADER WE LOVE AND RESPECT, I KNEW HOW MUCH IT MEAN TO HARPER TO HAVE HIS FORMER COACH HERE TONIGHT. THERE WAS ONLY ONE PROBLEM, I DIDN'T KNOW JELLY'S REAL NAME! AND NO ONE I CONTACTED COULD REMEMBER EITHER. IF THEY EVER KNEW HIS FIRST NAME, ALL EVERYONE COULD TELL ME THEY JUST KNEW HIM AS JELLY. AND THAT HE HAD RETIRED FROM COACHING. I KNEW I WASN'T GOING TO BE ABLE TO FIND A JELLY GREEN IN THE PHONE BOOK SO I FINALLY HAD TO ASK HARPER HIMSELF WHAT WAS JELLY'S REAL NAME AND HE TOLD ME, WILLIAM, HERE WE ARE. ONE DEGREE OF SEPARATION AND FAST FRIENDS AFTER HAVING KNOWN AND WORKED TOGETHER FOR ONE YEAR AND ARE CONFIDENT WE ARE CONNECTED FOR LIFE. I SEE THAT JIMMY HARPER'S

BACKGROUND GROWING UP IN PORTLAND, HIS PORTLAND PRIDE SHINES
THROUGH AND HIS EXPERIENCES AT SHAWNEE HIGH SCHOOL AS A
QUARTERBACK AND LEADER, HE TREATED EVERYONE THE SAME. NOW I KNOW
WITH HE KNOWS SO MANY PEOPLE ON THE WEST END AND WHY HE WAS SO
HAPPY TO COME BACK HOME AS MAJOR IN THE SECOND LAST YEAR.

THE PEOPLE IN THE WEST END AND SECOND DIVISION ARE PEOPLE HE GREW UP WITH, RESPECTS AND CAN RELATE TO AND UNDERSTAND. THE LEADERSHIP TRAINING IN HIGH SCHOOL AND IN THE ARMY, AND ALL HIS LIFE EXPERIENCES HAVE INSTILLED IN HIM THE WISDOM AND COMPASSION TO ENCOURAGE AND LEAD A TEAM THEN AND NOW. THAT'S WHAT TOO MANY YOUNG BOYS AND TEENS ARE MISSING TODAY. JIMMY HARPER A MAN WITH AN UNCOMMON COMMON SENSE WHO CONTINUES TO LEAD BY EXAMPLE FOR OTHER MEN AND WOMEN IN BLUE. HARPER KNOWS AND BELIEVES THAT LEADERSHIP MATTERS. HE MADE A DIFFERENCE IN THE SECOND DIVISION IN A SHORT PERIOD OF TIME. I'M SURE HARPER LEARNED HOW TO LEAD AND MOTIVATE A TIME ON THE FIELD AND OFF AND THAT'S WHY HE'S BEEN ABLE TO BE SO SUCCESSFUL IN HIS NINE YEARS AS A MAJOR WITH LMPD AND GOTTEN SUCH POSITIVE RESULTS

IN EVERY POSITION AND AT EVERY LEVEL HE HAS SERVED IN WITH LMPD. HE ACCEPTS EVERY CHALLENGE AND ASSIGNMENT INCLUDING THIS PRESENT ONE EVENTUALLY WITH A POSITIVE CAN-DO SPIRIT. HE'S EVEN MANAGED TO MAKE A NEW TEAM, UNITING MY SECOND DIVISION COUNCILMEMBER COLLEAGUES WITH THE MEN AND WOMEN AND OFFICERS IN HIS COMMAND AND OTHER OFFICERS IN LMPD. THE THREE P'S, WE CALL IT, PEOPLE, POLITICIANS AND POLICE ARE ALL ON THE SAME TEAM. WHAT A THOUGHT! BECAUSE WE'RE ALL A TEAM AND KNOW THAT WE'RE ALL CONCERNED AND DEVOTED TO PUBLIC SAFETY AND IMPROVING THE QUALITY OF LIFE FOR THE RESIDENTS AND GOOD PEOPLE WE HAVE ALL TAKEN AN OATH TO SERVE IN THIS COMMUNITY AS A TEAM -- I'M ALMOST FINISHED -- WE SAY THANK YOU JIMMY HARPER, THANK YOU FOR YOUR LEADERSHIP AND SERVICE THANK YOU FOR YOUR PASSION AND FRIENDSHIP. THANK YOU FOR YOUR INTEGRITY AND TRANSPARENCY. THANK YOU FOR MAKING A DIFFERENCE IN OUR COMMUNITY. AND THE UNDENIABLE RESULTS YOU ACHIEVED AT EVERY COMMAND YOU LED ESPECIALLY LAST SUM WEATHER WE WENT TWO STINTS WITHOUT A HOMICIDE AND THANK YOU FOR SPEAKING TRUTH AND POWER. I'D LIKE TO PAUSE AND WELCOME MY OLD FRIEND COACH JELLYBEAN GREEN TO SAY A FEW WORDS AT THIS TIME.

>> OH, WOW! IT'S AN HONOR SEEING HIM. HE'S BEEN SO

MUCH -- MEANT SO MUCH TO ME. I NEED TO SAY A FEW WORDS HERE

ABOUT JIMMY. WHEN I TOOK OVER THE FOOTBALL PROGRAM AT SHAWNEE

HIGH SCHOOL -- BEFORE I TOOK IT OVER, THEY HADN'T WON A GAME IN

FIVE YEARS. FIVE YEARS! AND THEY HAD FALLEN ON HARD TIMES. WHEN

I CAME IN, NOBODY WANTED TO PLAY. WE HAD A FEW BLACK KIDS THAT WANTED TO PLAY. BUT AT THE TIME, WE COULDN'T GET THE WHITE KIDS IN PORTLAND TO PLAY. WE KNEW IF WE WERE GOING TO BE SUCCESSFUL, WE HAD TO GET THOSE KIDS OUT OF PORTLAND TO PLAY, BUT THEY DIDN'T WANT TO PLAY. ONE TIME -- ONE TIME WE RUN ACROSS THIS LITTLE SKINNY, FRAIL KID FROM PORTLAND. IT WAS JIMMY HARPER WALKING THE STREETS TRYING TO FIND SOMEBODY TO PLAY. HE WANTED TO PLAY. HE AND -- HE WAS OUR STARTING OUARTERBACK. I DIDN'T THINK HE COULD PLAY BECAUSE HE WAS SKINNY AND SLOW, BUT HE WORKED EXTREMELY HARD. TO MAKE A LONG STORY SHORT, WE END UP BEING SUCCESSFUL. WE ENDED UP BEING SUCCESSFUL BECAUSE HE WAS A LEADER. HE'S THE ONLY ONE THAT CAME OUT AND BECAUSE OF HIM, ALL THE REST OF THE WHITE KIDS CAME OUT. AND AS A RESULT, WE HAD A COHESIVE TEAM. WE HAD BLACK KIDS, WHITE KIDS. AND THE TEAM WAS COHESIVE. WHEN I LEFT, WE WERE IN OUR DISTRICT, WE WERE THE TEAM OF THE YEAR. I WAS COACH OF THE YEAR. AND IT WAS ONLY BECAUSE JIMMY'S LEADERSHIP AND DEDICATION TO SHAWNEE HIGH SCHOOL AND WHAT HE WAS TRYING TO DO AND WHAT HE WANTED TO ACCOMPLISH. I WAS SO PROUD OF HIM -- I WAS SO PROUD OF HIM WHEN HE GRADUATED, HE DID A HECK OF A JOB AND I'M SO EXCITED ABOUT JIMMY AND GLAD TO SEE HIM. I HAD TO COME BACK AND SEE JIMMY. THANK YOU.

>> I PROMISE YOU ALL -- I'M NOT GOING TO CRY. TO MY FAMILY AND FRIENDS LAST WEEK I SENT THAT LETTER TO THE METRO COUNCIL. AND IN TYPICAL FASHION AFTER I HIT SEND, I ASKED MY

WIFE IF IT WAS OKAY. JUST SO YOU ALL KNOW SHE SAID IT'S TOO LATE NOW. TO FAMILY AND FRIENDS AND COUNCIL FRIENDS AND BRAVE MEN AND WOMEN HERE, I CAN'T THANK YOU ENOUGH FOR THE AMAZING WORDS OF SUPPORT AND I HAD THAT GEORGE BAILEY MOMENT, THE MOMENT FEW IN LIFE EVER GET DESPITE THE UPS AND DOWNSTAIRS, GOOD AND BAD, IT'S A WONDERFUL LIFE WORTH LIVING. I KNOW I'VE RIDDEN ON THE BACK OF MY FAMILY AND COMMUNITY AND EVERYONE IN BETWEEN. I'M SPEAKING TODAY BECAUSE WHILE I'M HAVING THAT MOMENT, WE KNOW THAT MANY IN OUR COMMUNITY IN THIS CITY ARE NOT. SOMETHING THAT I'VE BEEN COMMITTED TO.

WE DO NOT BELIEVE AND RECOGNIZE THE TRUCE OF WHERE WE ARE NOW AND FAIL TO TAKE ACTION FOR CHANGE. A WISE MAN FROM LOUISVILLE WAS QUOTED SAYING "A PERSON WHO VIEWS THE WORLD THE SAME AT 50 AS HE DID AS 20 HAS WASTED 30 YEARS OF HIS LIFE.

THERE IS A LOT TO BE SAID ABOUT THIS ESTIMATE FOR AWFUL US AS A COMMUNITY, POLICE DEPARTMENT AND GOVERNING BODY BECAUSE WE AS A UNIFIED CITY CANNOT AFFORD TO WASTE 30 YEARS OF LIFE. I FULLY REALIZE I STAND HERE TODAY AND IT DOESN'T MEAN I'VE MADE

MISTAKES ALONG THE WAY I'VE ALWAYS BEEN IN THE SERVICE OF MY COMMUNITY BUT HAS ANYONE EVER NOT EXPERIENCED WHAT I EXPERIENCED? MY IDEAS ARE NOT PERFECT AND DO I NOT WANT ANYONE TO THINK I'M TELLING ANYONE WHAT THEY SHOULD DO. THE POTENTIAL OF OUR POLICE DEPARTMENT ARE LIMITLESS. TOO OFTEN WE'RE QUICK TO PLACE TITLES ON WHAT POLICE OFFICERS DO WITHOUT REALIZING IT'S GOOD POLICE WORK. WE TOSS AROUND WORDS SUCH AS COMMUNITY

ORIENTED POLICING AND 21ST CENTURY POLICING WHEN IN REALITY GOOD OFFICERS DID DISCRETION DO THIS EVERY DAY AND ARE WILLING DO MORE. THEY'RE THE FORMER DETECTIVES I WORKED WITH IN THE GANG SQUAD THAT CHOSE INSTEAD OF DOING POLICE WORK TO BREAK OUT CHAIRS FROM THE TRUNKS OF THEIR CARS AND SIT IN THE MIDDLE OF THE BLOCK. ONE OF THE BUSIEST BLOCKS IN CITY FOR DRUG TRAFFICKING. NOT TO ARREST ANYONE, BUT TO SIT THERE BECAUSE THE COMMUNITY ASKED FOR IT AND NEEDED IT.

WE FOUND OUT ALONG THE WAY THAT A 70-YEAR-OLD WOMAN HAD NOT BEEN OUT OF HER HOUSE IN THREE WEEKS. EXCEPT TO GO TO THE STORE BECAUSE SHE WAS SO SCARED. SHE WAS BRINGING US ICE WATER OUT. NOW I'M GOING OFF SCRIPT. THERE ARE PATROL OFFICERS THAT DO THIS ALL THE TIME. THEY DID IT AT RIVER PARK. SOME ARE HERE TODAY SAT IN THEIR CHAIRS AND WALKED THE STREETS AND TAUGHT ME ALONG THE WAY, WE GET THIS. THEY TAUGHT ME A LESSON OF WE CAN DO IT WITHOUT YOU. THERE ARE PATROL OFFICES THAT ARE COME TO OUR BOSSES TELLING US, HEY, BOSS, WE HAVE TO DO SOMETHING ABOUT THIS VACANT HOUSE. IS THERE A CRIME IN THERE? ARE THEY SELLING DRUGS? NO, BUT THE OLD WOMAN LIVING NEXT DOOR IS SCARED THAT IT WILL LEAD TO SOMETHING MORE IF WE DON'T FIX IT. THERE IS THE OFFICER SEEN ON A VIDEO THAT MANY OF YOU SAW STOOPING DOWN TO TALK TO A FEW YOUNG KIDS LAST YEAR TO A SURE THEM THAT EVERYTHING WOULD BE OKAY AND MAKE SURE THEY'RE NOT EXPOSED TO MORE THAN WHAT THEY'VE SEEN. THEN THERE IS THAT OFFICER THAT CAME ACROSS A KID LAST SUMMER AND FOUND OUT THAT A BOMB POP COST \$3 RATHER THAN A

DOLLAR LIKE IT DID IN 1980. THAT WAS ME. I WAS SHOCKED. IT'S GOOD POLICE WORK, SOMETHING I'VE HAD A FRONT ROW SEAT. THEN THERE IS OUR COMMUNITY. 99.99% OF OUR COMMUNITY THAT ARE GOOD PEOPLE AND WANT THE SAME BECAUSE NO MATTER IF YOU'RE A GOOD PERSON LEADING A GOOD LIFE IN THE WEST END, YOU WANT THE SAME THINGS THAT THE EAST END WANTS. SAFETY AND SECURITY WITH A OUALITY OF LIFE FREE FROM BECOMING A VICTIM OF A CRIME OR WITNESS A CRIME IN THEIR COMMUNITY. ABSOLUTELY OUR COMMUNITY CARES OR THEY WOULDN'T SHOW UP TO A COMMITTING WITH 100 BLOCK WATCH CAPTAINS. YES OUR COMMUNITY CARES OR THEY WOULDN'T SHOW UP IN FORCE LIKE THEY DO IN THE BLOCK GROUPS SHAWNEE, CALIFORNIA, PARK DUVAL NOR WITH OVER A HUNDRED PEOPLE SHOW UP LIKE THEY DID THIS PAST MONDAY NIGHT TO TALK ABOUT COMMUNITY. A MEETING THAT WAS GROUNDBREAKING LIKE MANY OF YOU ON THIS COUNCIL TONIGHT, NOT BECAUSE YOU HELD THE MEETING, BUT BECAUSE YOU UNITED TOGETHER FROM ACROSS THE CITY TO LISTEN TO ONE COMMUNITY'S CONCERNS. WHILE WE NORMALLY TAKE MONEY EFFORT AND TIME, WE HAVE A COMMUNITY THAT HAS A WILL TO DO IT. THEY PROVE IT EVERY DAY. THERE IS A BLACK MAN THAT TRANSFORMED A CORNER THAT DIDN'T LOOK LIKE IT HAD MUCH HOPE INTO A COFFEE SHOP WHERE HE INVITED PEOPLE IN TO READ POETRY AND BOOKS. NO DR. SEUSS. THERE WAS A STREET PREACH THAT ARE ASKED FOR MORE ATTENTION FROM THE POLICE AND A FEW DOLLARS TO BEAUTIFY THE MOST VIOLENT INTERSECTION IN OUR CITY. THERE IS THE ELDERLY LADY WHO ASKED ME AT A COMMUNITY MEETING FIX THIS ONE HOUSE, THE BLOCK IS PRISTINE BUT ONE HOUSE.

NOT BECAUSE SHE'S TRYING TO COMPLAIN, BUT SHE CARED. SHE KNOWS WHAT CAN HAPPEN. THERE IS A MAN SPONSORS LITTLE LEAGUE SPORTS TEAMS. KIDS AND FAMILY DELAY TO CREATE A STRONGER BOND FOR ALL OF US. THERE IS A NEIGHBORHOOD PATROL OUT AT 2:00 A.M. LOOKING OUT FOR THEIR NEIGHBOR. THANK GOD I REALIZED THAT HE WAS WHAT THEY WERE. THERE ARE THOSE THAT EXPRESS THE EXCITEMENT OF WHAT THEY WERE ALLOWED TO DO WHEN THE GREATEST TOOK THE LAST RIDE THROUGH THE STREETS OF HIS HOMETOWN. I STOOD THERE AND LISTENED AND IT WAS AMAZING. THEN THERE IS A GOVERNING BODY REPRESENTING ALL OF OUR COMMUNITIES, THE VOICES FOR ALL OF US THAT I CAN PERSONALLY SAY ARE ON THE CLOCK 24 HOURS A DAY 7 DAYS A WEEK BECAUSE YOU LIVE IN THE VERY PLACES YOU REPRESENT. I'VE SEEN IT. YOU THE REPRESENTATIVES OF OUR COMMUNITY REPRESENTING THEM NO MATTER OF THEIR CULTURE ECONOMIC SITUATION OR COLOR OF THEIR SCREEN BUILDING THE MOMENTUM NEEDED TO CREATE THE SYSTEM OF UNITY BETWEEN YOU, OUR COMMUNITY AND OUR PUBLIC SAFETY PROFESSIONALS. WE ALL GET IT. THE SYSTEM OF UNITY IF APPLIED THE WAY IT SHOULD, SHOULD BE A QUALITY OF LIFE WE ALL DESERVE IN EVERY CORNER OF THE CITY WHERE THE COMMUNITY SHARES IN THE RESPONSIBILITIES THROUGH LEADERSHIP AND TEAMWORK. OUR RESIDENTS AND POLICE OFFICERS, FIREFIGHTERS, PUBLIC EMPLOYEES AND YOU THE COUNCIL ARE THE EXPERTS THAT SHOULD CONSULT TOGETHER AND DETERMINE OUR DIRECTION. WE JUST SEEM TO COME TO THE REALIZATION THAT THE TIME TO TAKE ACTION IS NOW. WE HAVE A SYSTEM AND HAD TO PUT ASIDE OUR PERSONAL AGENDAS SO THAT OUR CITY DOESN'T FALL AS A SAFE AND SECURE OUALITY OF LIFE. WE THE PEOPLE CANNOT BE WILLING TO ACCEPT FAILURE OR BARRETT BURDEN OF MEDIOCRITY. AT THE END OF IT ALL -- SHOCKED ME. AT THE END OF IT ALL, AND I HAVEN'T MISSED ONE NAME -- AT THE END OF IT ALL, THERE IS A KID IN THE WEST END -- SORRY -- THIS SUMMER GETTING THAT FREE LUNCH IN THE PARK AND CLOTHES FROM THE SHELTER AT A THRIFT STORE. HE DIDN'T EXPECT TO ACHIEVE ANYTHING, NEVER MET HIS DAD AND LIKELY TO SUCCUMB TO THE CASUALTIES OF THIS INVOLVEMENT. A 31-YEAR-OLD AFRICAN-AMERICAN FOOTBALL COACH BY THE NAME OF WILLY JELLY GREEN CHOSE TO COME AND FIND HIM KNOWING HE WASN'T 36 THE GREATEST ATHLETE BUT SAW SOMETHING ELSE WHO DIDN'T THINK TWICE TO TELL HIM, SON, YOU'RE BETTER THAN THAT.

IMPACTED A LIFETIME. A GESTURE THAT WE ALL MUST UNITE TOGETHER

AND WHEREAS BILL WILSON WAS THE LOVING SON OF THE LATE RICHARD AND EDA FIG WILSON. HE WAS THE DEVOTED HUSBAND OF SANDY WILSON, FATHER OF FIVE DAUGHTERS: MICHELLE, MELANIE, YVETTE, TONY, AND LISA. HE WAS THE ADORING AND PROUD GRANDFATHER OF

EIGHT GRANDCHILDREN, AND HE ALSO LEAVES BEHIND A LOVING AUNT AND RELATIVES AND FRIENDS.

AND WHEREAS BILL WILSON GRADUATED FROM CENTRAL HIGH SCHOOL IN 1963, AND HE ATTENDED THE UNIVERSITY OF LOUISVILLE.

AND WHEREAS BILL WILSON WAS AN ESTEEMED MEMBER OF THE LOUISVILLE AND JEFFERSON COUNTY COMMUNITY, AND AN ACTIVE AND INVOLVED CITIZEN. OF NUMEROUS AWARDS, INCLUDING THE PRESTIGIOUS ADDY AND CRITICAL
ACCLAIM 1974 TO 1986. AND HE WAS ALSO THE HOST PRODUCERS OF RAP

ON WDRB TELEVISION, AND HE RESEARCHED, WROTE, PROFILED, AND HOSTED A WEEKLY PUBLIC AFFAIRS TELEVISION PROGRAM THAT EXPLORED THE CONCERNS OF THE AFRICAN-AMERICAN COMMUNITY.

ONE OTHER THING, HE WAS ONE OF MY FATHER'S FAVORITE PEOPLE. THEY WERE ASSOCIATED WITH EACH OTHER AT THE PARK DUVALL MEDICAL CENTER BACK IN THE DAY. THE PLANNING COMMISSION OF LAND USE REGULATIONS TO ADDRESS SUCH

FACILITIES (AS AMENDED).

READ IN FULL.

PRESIDENT YATES: MAY I HAVE A MOTION AND SECOND, PLEASE.

>> SO MOVED.

>> SECOND.

PRESIDENT YATES: PROPERLY MOVED AND SECONDED.

COUNCILMAN STUCKEL.

COUNCILMAN STUCKEL: YES. THANK YOU, PRESIDENT YATES.

THIS IS AN ORDINANCE IMPOSING A TEMPORARY MORATORIUM ON

SINGLE-FAMILY SUBDIVISIONS IN ORDER TO STUDY WHETHER CURRENT

PERMITTED USES IN RESIDENTIAL DEVELOPMENTS SHOULD BE INCLUDED

WITHIN CONDITIONAL UNITS. AN AMENDMENT WAS ADOPTED THAT

SPECIFIED THAT ONLY NEW SUBDIVISIONS APPLIED AND REDUCED THE

NUMBER OF MORATORIUM DAYS FROM 180 TO 90. AND THIS PASSED OUT OF

OUR COMMITTEE AND WAS SENT TO OLD BUSINESS. AND COUNCILMAN COAN

IS THE SPONSOR, AND I KNOW HE WANTS TO ADDRESS IT AND EXPLAIN

IT.

PRESIDENT YATES: THANK YOU, COUNCILMAN.

COUNCIL MEMBER COAN, WOULD YOU LIKE THE FLOOR?

COUNCILMEMBER COAN: THANK YOU, MR. PRESIDENT. FIRST
I JUST WANT TO CLARIFY THIS IS NOT ANY NEW SINGLE-FAMILY
SUBDIVISIONS. THAT'S WHAT I THOUGHT I HEARD COUNCIL MEMBER
STUCKEL SAY. IN ESSENCE THIS IS AN ORDINANCE THAT SEEKS TO
REQUIRE A CONDITIONAL USE PERMIT FOR CERTAIN PRIVATE
INSTITUTIONAL USES THAT ARE CURRENTLY LISTED AS PERMITTED USES
IN THE LAND DEVELOPMENT CODE IN SINGLE-FAMILY RESIDENTIAL ZONING
DISTRICTS. THE FOLKS HERE PROBABLY KNOW AND THE PEOPLE ON TV
MIGHT WISH TO KNOW WE COULDN'T JUST PASS AN ORDINANCE CHANGING

THE LAND DEVELOPMENT CODE. THERE IS A PROCESS THAT REQUIRES US
TO GO THROUGH THE PLANNING COMMISSION TO DO THAT.

AND SO THIS ORDINANCE IS ASKING THE PLANNING COMMISSION TO DETERMINE WHETHER OR NOT A CONDITIONAL USE PERMIT SHOULD BE REQUIRED, AND I BELIEVE IT SHOULD BE, FOR WHAT I'M CALLING SOME OF THESE PRIVATE INSTITUTIONAL USES. AND SO THIS CASE ARISES OUT OF AN INCIDENT, OR A CASE IN DISTRICT EIGHT EARLIER THIS YEAR WHERE A PRIVATE NON-TRADITIONAL SCHOOL TRIED TO OPEN ON ALTA VISTA ROAD IN THE SENECA GARDENS NEIGHBORHOOD IN A FAIRLY LARGE HOUSE. AND WHAT I LEARNED DURING THAT MATTER WHICH NEVER CAME BEFORE METRO COUNCIL OR ANY DISCRETIONARY BODY IN ANY WAY, SHAPE, OR FORM, IS THESE PERMITTED USES, INCLUDING THIS SCHOOL WHICH WOULD BE A DRAMATIC CHANGE FROM THE CURRENT SINGLE-FAMILY RESIDENCE AND WOULD HAVE HAD UPWARDS OF 200 PEOPLE THERE DAILY AND CONCERNED PEOPLE WITH THE REGULAR LAND USE CONCERNS -- NOISE, TRAFFIC, ETC. -- THERE WERE NO REGULATIONS IN THE LAND DEVELOPMENT CODE GOVERNING SCHOOLS OR EVEN DEFINING WHAT A SCHOOL IS. THERE IS NO NOTICE REQUIREMENT OR OPPORTUNITY FOR THE PUBLIC TO COMMENT OR HAVE ANY INPUT ON PERMITTED USES. AND THERE WAS NO DISCRETIONARY VIEW.

THIS WOULD HAVE BEEN AN APPROVAL THAT REQUIRED ONLY STAFF REVIEW AND BUILDING PERMITS TO BE ISSUED. SO THE ISSUE CAME TO A HEAD WHEN NEIGHBORS FOUND OUT ABOUT IT AND SORT OF CONFRONTED THE DEVELOPERS OR THE SCHOOL FOUNDERS IN A REALLY SORT OF KNOCKDOWN DRAG-OUT ADVERSE FASHION THAT WAS GOING TO

COME DOWN TO A LEGAL ISSUE. AND I THOUGHT THAT IT WAS A
PROBLEMATIC THING THAT SUCH A SEVERE CHANGE IN USE DIDN'T HAVE
ANY REGULATION, ANY NOTICE OR OPPORTUNITY FOR PUBLIC INPUT, OR
ANY DISCRETIONARY VIEW, WHEREAS AT THE SAME TIME MANY OF US SEE
THAT A VERY COMMON LAND USE ISSUE LIKE A VARIANCE OR A WAIVER
THAT REALLY DOES NOT AFFECT MANY PEOPLE, PEOPLE HAVE TO GO
THROUGH THE COST AND TIME AND EXPENSE OF REVIEWING THAT WITH THE
BOARD OF ZONING ADJUSTMENT. AND SO I HAVE ASKED THE PLANNING
COMMISSION TO STUDY THIS ISSUE AND COME BACK AND DECIDE, AND I
HOPE RECOMMEND A CONDITIONAL USE PERMIT FOR CERTAIN PRIVATE
INSTITUTIONAL USES THAT ARE ENUMERATED IN THE ORDINANCE.

CURRENTLY, THERE IS A PROCESS CALLED A COMMUNITY

FACILITIES REVIEW FOR PUBLIC SCHOOLS THAT HAVE TO GO THROUGH

THIS, BUT IT IS ONLY A LOOPHOLE FOR PRIVATE INSTITUTIONAL USES,

AND THAT IS WHAT WE ARE TRYING TO REMEDY. I WORKED WITH THE

BUILDING INDUSTRY ASSOCIATION AND THE GREATER LOUISVILLE

ASSOCIATION OF REALTORS ON THIS ORDINANCE IN ORDER TO PROVIDE

CLARITY TO IT AND BE CLEAR IT IS NOT PROHIBITING ANY EXISTING

PRIVATE INSTITUTIONAL FACILITIES FROM EXPANDING OR DOING

ANYTHING EDUCATIONAL. IT IS MERELY PAUSING ANY NEW INSTITUTION

THAT WANTS OR ATTEMPTS TO SECURE A PERMIT BEFORE THEY CAN

RECOMMEND THE CHANGES, AND THIS BODY HAS THE ABILITY TO ADOPT

THEM. THINGS ARE BEING FAST-TRACKED BY EMILY LU IN THE PLANNING

DEPARTMENT. THE STAFF REPORT IS GOING TO BE HEARD TOMORROW

MORNING IN THE PLANNING COMMITTEE, AND THE PUBLIC HEARING IS ALREADY RECOMMENDED TO BE SET FOR JUNE 29TH.

SO THE MORATORIUM HAS BEEN SHORTENED TO AN EXTREMELY MODEST 90 DAYS WITH AN OBLIGATION FOR EMILY TO COME BACK TO REPORT TO THIS COUNCIL WITHIN 60 DAYS SO WE CAN ACT, AND THAT IS DOWN FROM 180 DAYS ORIGINALLY, THE TYPICAL PRACTICE THAT HAS HAPPENED BEFORE THIS BODY. SO WE ARE NOT SEEKING TO DOWNZONE ANYONE'S PROPERTY OR TO REMOVE ANY OF THESE PRIVATE INSTITUTIONAL USES AS BEING POSSIBLE USES IN SINGLE-FAMILY ZONING DISTRICTS. I JUST THINK IT IS IMPORTANT THAT THE PUBLIC HAS SOME PROCESS AND THAT A DISCRETIONARY BOARD LIKE THE BOARD OF ZONING ADJUSTMENT HAS SOME OVERSIGHT OF THIS. SO I'M HAPPY TO ANSWER IF I QUESTIONS OR ENTERTAIN DISCUSSION ON IT, BUT OTHERWISE -- I'LL MENTION FINALLY THAT A HAPPY RESOLUTION TO OUR CASE IS THAT THE SCHOOL ULTIMATELY YIELDED ITS ORIGINAL LOCATION AND HAS FOUND A MORE SUITABLE LOCATION IN A DISTRICT THAT IS NOT ZONED SINGLE FAMILY AND IT WILL ACTUALLY BE A TENANT IN A COMMERCIAL BUILDING, WHICH I THINK IS AN APPROPRIATE USE BECAUSE EVERYBODY IS HAPPY ABOUT IT. I'M HAPPY TO TALK AND I ASK YOUR SUPPORT.

COUNCILMAN JAMES.

COUNCILMEMBER JAMES: THANK YOU, MR. PRESIDENT. THIS IS

A RESOLUTION TO AUTHORIZE THE AUDITOR OR DIRECT THE AUDITOR TO

DO AN AUDIT OF THE METRO CORRECTIONS IN ORDER TO FIND OUT ABOUT RELEASES OF INMATES AND MOVEMENT OF INMATES TO SEE IF WE ARE DOING THOSE CORRECTLY AND SEE IF THERE ARE ANY NEW PROCESSES THAT CAN BE FOUND. IT WAS PASSED UNANIMOUSLY IN COMMITTEE AND I SUGGEST ITS PASSAGE.

SOME AMENDMENTS THAT HAVE BEEN LOADED ON HERE. AS YOU KNOW, WHEN

THIS FIRST CAME UP SOME TIME AGO, WE DID A RESOLUTION ASKING THE

AUDITOR WHILE SHE WAS DOING THIS TO EXPAND HER AUDIT FURTHER TO

FIND OUT IT CAME FROM. NOT ONLY ARE THEY DOING IT CORRECTLY. ARE

THEY HANDLING THE CLIENT CORRECTLY. BUT WHERE IT CAME FROM, HOW

IT ARRIVED TO CORRECTIONS, BECAUSE THERE ARE MULTIPLE WAYS. WE

HEARD IT WAS STUFF GETTING LAID ON SEATS AND TABLES. WE WANT TO

CAPTURE MORE ARE THEY HANDLING THE INMATE CORRECTLY AND HOW IT

WAS SUPPOSED TO DO BUT WAS IT SAVED AT THE SAME TIME AND WHAT IF

THERE WERE THINGS THEY COULDN'T READ THE JUDICIAL ORDER OR HAD

TO GET CLARIFICATION. WE WERE ASKING FOR A LITTLE MORE TALLIES

ON A SHEET. EVERYONE APPROVED THAT.

SINCE THAT TIME WORKING WITH THE AUDITOR ON THIS, WE HAVE BEEN GOING BACK AND FORTH, AND SHE RECENTLY SENT AN E-MAIL WHICH IS ATTACHED, IF YOU LOOK ONLINE, IT IS UNDER THE FAM

PROPOSED AMENDMENT, AND IT IS THE LAST PAGE. SHE SENT A MESSAGE TALKING TO ME TALKING WITH THE METRO COUNCIL AND PRESIDENT YATES, HE HAS TWO PRIMARY CONCERNS, THE COMPREHENSIVE TEXT OF THE AUDIT AND DUE TO THE LEGAL EXPERTISE REQUIRED TO COMPLETE THE REVIEW IA IS UNABLE TO PERFORM THE TASK AS OUTLINED. THEN SHE GOES ON A LITTLE MORE. THEN SHE ALSO AT THE SAME TIME WANTS IT TO GO TO A THIRD PARTY BECAUSE OF THIS. AND THEN SHE ALSO ASKED WHETHER IT WAS A GOOD USE OF THEIR TIME TO ADMINISTER THIS CONTRACT.

SO I HAVE BEEN WORKING WITH THE COUNTY ATTORNEY'S OFFICE. THEY BELIEVE IT IS A GOOD TIME TO DO THE CONTRACT, BECAUSE IT IS STILL AN AUDIT OF AN AGENCY, EVEN THOUGH A THIRD PARTY IS DOING IT. WHAT I HAVE ARE A COUPLE WHEREASES, FOUR OF THEM ACTUALLY. AND THEN A LINE IN THE BODY TO PERTAIN TO THE THIRD-PARTY AUDIT, SINCE SHE FEELS HER DEPARTMENT DOESN'T HAVE THE LEGAL EXPERTISE TO DO A LEGAL REVIEW.

SO I'M PROPOSING A WHEREAS, RESOLUTION 25 SERIES 2017
METRO COUNCIL REQUESTED AN EXPANDED AUDIT OF METRO CORRECTIONS
CONCERNING THE RELEASE OF INMATES. AND WHEREAS AS EVIDENCE IN
THE ATTACHED ENGAGEMENT LETTER, THE INTERNAL AUDITOR STATED THAT
SHE DID NOT HAVE THE LEGAL EXPERTISE TO CONDUCT THE REQUESTED
AUDIT AND WOULD OUTSOURCE TO A THIRD PARTY WHO WOULD HANDLE THE
COMPLEXITY OF THE AUDIT. AND WHEREAS THE INTERNAL AUDITOR DOES
NOT HAVE THE LEGAL EXPERTISE TO HANDLE METRO CORRECTIONS INMATE
RELEASE AUDITS. THE AUDIT OUTLINED IN EXHIBIT A SHOULD BE

OUTSOURCED TO A THIRD PARTY CHOSEN TO CONDUCT THE AUDIT IDENTIFIED IN RESOLUTION NUMBER 25 SERIES 2017.

AND WHEREAS BY OUTSOURCING BOTH INMATE RELEASE AUDITS

METRO COUNCIL CAN ECONOMICALLY AND EFFICIENTLY USE AN EXPERT WHO

HAS THE REQUISITE KNOWLEDGE AND SKILLS TO ADEQUATELY AUDIT

LOUISVILLE DEPARTMENT OF CORRECTIONS INMATE RELEASE PROCEDURES.

AND THEN IN SECTION ONE, AFTER REQUEST INTERNAL

AUDITOR, STRIKE CONDUCT IN AND PUT OUTSOURCE THE AUDIT. AND THEN

AT THE END OF THE PARAGRAPH ADD TO THE THIRD PARTY AUDITOR

CHOSEN TO CONDUCT THE EXPANDED AUDIT REQUESTED IN RESOLUTION

25-2017.

I MOVE THAT MOTION RIGHT NOW, IF I COULD GET A SECOND. PRESIDENT YATES: DO WE HAVE A SECOND?

>> SECOND.

>> AND THEN IF I CAN TALK FOR A BIT.

PRESIDENT YATES: PROPERLY MOVED AND SECONDED. BACK TO COUNCILWOMAN BUTLER.

COUNCILMEMBER BUTLER: THE RFP FOR THIS AUDIT HAS YET

TO BE PUT OUT. THE AUDITOR HAS BEEN WORKING WITH ALL OF THE

STAKEHOLDERS ON THE RFPS, AND THEN THEY WILL PUT THIS RFP ON THE

STREET AND SELECT THE PERSON TO DO IT. AND AS I SAID BEFORE, IN

LISTENING TO SOME OF THE PUBLIC SAFETY STUFF, I'M NOT ON THAT

COMMITTEE BUT I'LL GO BACK AND WATCH STUFF, AND I WAS JUST

PERPLEXED AT THE NUMBER OF WAYS THEY WERE GETTING THINGS. SOME

WAS HANDWRITTEN AND THEY COULDN'T READ IT SO THEN THEY WOULD

BY DOING THIS IT IS SOMETHING THAT WE CAN BUILD ON AND USE THE DATA SO A PILOT CAN HAPPEN IN JEFFERSON COUNTY AND THE SUPREME COURT RECENTLY DID AN AUDIT OF THE JEFFERSON COUNTY DISTRICT COURT JUDGES AND THE COURT SYSTEM ITSELF.

WHILE I KNOW IT IS NOT READY TO BE RELEASED -- IT IS
STILL IN DRAFT FORM -- SOME OF THEM TOLD ME THE DATA FROM THIS
WILL HELP THEM BECAUSE THAT STRONGLY SUGGESTED THE USE OF
TECHNOLOGY AS OPPOSED. BECAUSE THEN EVERYTHING IS TIMESTAMPED.
IT HELPS REDUCE THE NUMBER OF PROBLEMS THAT YOU HAVE WHEN
EVERYTHING IS TALLIED DOWN ON PAPER. SO I ASK YOUR SUPPORT OF

COUNCILMAN JAMES: THANK YOU, MR. PRESIDENT. I WOULD AGREE WITH COUNCILWOMAN BUTLER WE NEED TO DO THE AUDITS THAT

HAVE BEEN REQUESTED. HOWEVER, THE AUDITOR DID NOT SAY THAT SHE DIDN'T HAVE THE LEGAL EXPERTISE NOR DID NOT WANT TO DO THE AUDIT THAT WE HAD THE RESOLUTION BEFORE US TODAY. IT IS FOR THE RESOLUTION THAT COUNCILWOMAN BUTLER HAD PRESENTED LAST MONTH AND THAT WE ALL VOTED TO APPROVE. I AM OKAY WITH ANY LANGUAGE THAT WOULD HELP WITH HER GETTING A THIRD PARTY VENDOR TO DO HER AUDIT, BUT MY AUDIT'S JUST FINE AND IT DOES NOT NEED TO BE DELAYED OR SENT TO A THIRD PARTY. AND I WOULD ASK THAT THIS AMENDMENT NOT BE VOTED IN A FAVORABLE FASHION.

PRESIDENT YATES: COUNCILMAN STUCKEL.

COUNCILMEMBER STUCKEL: COUNCILWOMAN BUTLER, WHAT IS THE PROJECTED COST OF THE AUDIT?

COUNCILMEMBER BUTLER: IF I CAN, MR. PRESIDENT.

PRESIDENT YATES: COUNCILWOMAN BUTLER.

COUNCILMEMBER BUTLER: WE HAD IDENTIFIED SOME MONEY

OVER HERE AT COUNCIL, BUT IN THE MEANTIME I ALSO HAVE LEARNED

THAT SOME OTHER DEPARTMENTS WILL HAVE SOME MONEY AS WELL. WE

DON'T KNOW WHAT THE EXPECTED IS UNTIL THE RFP COMES BACK, BUT

WHAT WE ARE LOOKING AT IS SOMETHING THAT MULTIPLE AGENCIES CAN

USE AS THEY MOVE FORWARD TO GET TECHNOLOGY.

>> SO IT IS GOING TO BE FUNDED BY THE METRO COUNCIL AND OTHER AGENCIES?

COUNCILMEMBER BUTLER: YES, SIR.

PRESIDENT YATES: THAT IS MY UNDERSTANDING.

COUNCILMEMBER BUTLER: BUT WE DON'T KNOW WHAT THE TOTAL WILL BE.

>> -- -- (OFF MIC).

>> OKAY.

PRESIDENT YATES: MY UNDERSTANDING, AS OF NOW THE COUNCIL'S COMMITMENT WAS \$25,000 AND OTHER AGENCIES BECAUSE THEY GAINED TO BENEFIT FROM THE EXPANSION OF THE AUDIT AND WOULD BE PUTTING IN MUCH MORE. COUNCILWOMAN BUTLER.

COUNCILMEMBER BUTLER: THANK YOU. THE REASON THAT BOTH OF THESE AUDITS ARE PUT TOGETHER IS BECAUSE THE AUDITOR IS LOOKING AT THE EXACT SAME JUDICIAL REVIEWS AS SHE IS DOING BOTH OF THEM. IT IS NOT LAKE THEY ARE SEPARATE REVIEWS COMING IN. EACH REVIEW THAT IS RECEIVED BY CORRECTIONS FROM AOC, THEY ARE THE SAME, NOT DIFFERENT. I'M JUST ASKING FOR A FEW MORE TALLY MARKS AT THE END. THE AUDITOR WILL BE LOOKING AT THE SAME THING.

IN COUNCILMAN JAMES' SITUATION, THERE ARE A FEW THEY WILL DRIVE DEEPER DOWN INTO. THAT WON'T IMPACT THE REST OF THE STUFF THEY GET. IT WILL BE SOMETHING THEY GET AS THEY LOOK THROUGH THE STUFF. BUT DOING IT TOGETHER WILL BE AN ECONOMY OF SCALE FOR US AND GET SOMETHING THAT IS CLEAR ACROSS THE BOARD.

PRESIDENT YATES: COUNCILWOMAN LEET.

COUNCILMEMBER LEET: THANK YOU, MR. PRESIDENT. I WAS

JUST TRYING TO CLARIFY, BECAUSE I GUESS ANYONE THERE WAS GOING

TO BE AMENDMENTS TONIGHT ON THIS. WHEN WERE THESE

AMENDMENTS -- WERE THESE JUST GENERATED TODAY?

PRESIDENT YATES: COUNCILWOMAN BUTLER.

COUNCILMEMBER BUTLER: I HAVE BEEN WORKING WITH THE
COUNTY ATTORNEY'S OFFICE, AND THEY WERE UPLOADING IT TODAY.

EVERYTHING WAS FINALIZED TO. WE WERE STILL LOOKING AT WHETHER OR
NOT WE SHOULD BE MOVED TO ANOTHER DEPARTMENT. BUT ULTIMATELY
THEY DECIDED NOT. AND I KNOW THAT NICK LOCOCO AND SARAH MARTIN
ARE HERE IF YOU HAVE ANY QUESTIONS FOR THEM ABOUT WHY THEY ARE
SUGGESTING WE DO IT THIS WAY.

>> SURE. I WOULD LOVE TO HEAR FROM THEM ABOUT WHY WE ARE DOING IT THIS WAY.

PRESIDENT YATES: I THINK THERE IS A QUESTION FROM COUNCILWOMAN LEET TO THE COUNTY ATTORNEY'S OFFICE.

NICK LOCOCO: NICK LOCOCO WITH THE COUNTY ATTORNEY'S OFFICE. JUST LIKE ANY MATTER THAT COMES TO THE COUNTY ATTORNEY'S OFFICE, WE GO THROUGH THE LEGAL ASPECTS OF IT AND DRAFT THE LANGUAGE AS WE SEE FIT AS REQUESTED BY THE COUNCIL MEMBERS.

>> BUT I GUESS I'M TRYING TO UNDERSTAND WHAT -- I
THOUGHT WE WERE JUST TRYING TO DEFINE THE SCOPE AND MOVE
FORWARD, BUT IT SEEMS LIKE WE HAVE BEEN WORKING ON THIS FOR A
WHILE, HAVEN'T WE? A FEW MONTHS. I'M JUST WONDERING WHY WE
DELAYED. WE VOTED FOR MONEY FOR IT TWO COUNCIL MEETINGS AGO,
THAT IS CORRECT? TWO COUNCIL MEETINGS? I'M JUST TRYING TO
UNDERSTAND WHAT IS COMING AWAY WITH THIS.

PRESIDENT YATES: YOU DIRECTED YOUR QUESTION TO WHO?

>> WHOEVER CAN ANSWER THIS.

PRESIDENT YATES: COUNCILWOMAN BUTLER.

COUNCILMEMBER BUTLER: I HAVE BEEN TRYING, AND COUNCIL MEMBER JAMES MAY ANSWER. IF YOU REMEMBER AT THE TIME THAT I DID THIS, WE ALSO ASKED COUNTY ATTORNEY TO CLARIFY HOW AUDITS ARE REQUESTED. SO AT THAT TIME WHEN IT WAS CLARIFIED FOR US, COUNCILMAN JAMES AND THE AUDITOR DECIDED THAT HE NEEDED TO DO A RESOLUTION AS WELL TO MAKE EVERYTHING THE WAY IT SHOULD BE DONE AND KOSHER. SO THAT IS WHY YOU ARE SEEING HIS COME BACK UP AGAIN, BECAUSE HE NEVER WENT THROUGH THE RESOLUTION PROCESS.

>> RIGHT. I UNDERSTOOD WHY WE DID THAT AND I REALIZED
WE VOTED SEPARATELY IN BUDGET TO PROVIDE THE MONIES FOR IT. WE
DID NOT? I GUESS I'M TRYING TO CLARIFY.

>> NO. THAT WAS HANDLED HERE AT THE COUNCIL. YOU MIGHT NOT HAVE BEEN AT THAT COUNCIL MEETING.

>> THANK YOU FOR CLARIFYING.

PRESIDENT YATES: COUNCILMAN JAMES, UNLESS THE COUNTY ATTORNEY'S OFFICE -- I DIDN'T MEAN TO CUT YOU OFF. DID YOU HAVE FURTHER COMMENT? COUNCILMAN JAMES, IF WE NEED TO COME BACK TO YOU.

COUNCILMEMBER JAMES: ARE YOU TALKING TO ME?

PRESIDENT YATES: STILL YOU. JUST WORKING AROUND

EVERYBODY.

COUNCILMEMBER JAMES: I JUST WANTED TO MAKE A COUPLE
CLARIFICATIONS. THE DATA THAT IS BEING USED, SOME OF THE DATA
THAT IS BEING USED FOR COUNCILWOMAN BUTLER'S AUDIT IS BEING USED

IN MY AUDIT. COUNCILWOMAN BUTLER'S AUDIT IS A SAMPLING OF THE FIRST 100 MAIZE EVERY MONTH. THE AUDIT THAT IS BEING USED BY THE AUDITOR FOR MY AUDIT IS KNOWN AS A SAMPLING AUDIT. I'M NOT SURE THE DETAILS OF HOW THAT WORKED, HOWEVER, I JUST WANT TO SAY THEY STARTED THAT AUDIT. THEY STOPPED IT ONCE THEY FOUND THE INFORMATION FROM THE COUNTY ATTORNEY'S OFFICE IS ALMOST FINISHED. SO I WOULD LIKE TO BE GET THAT OUT IN AUGUST, AND I WOULD APPRECIATE YOU NOT VOTING FOR THIS AMENDMENT.

PRESIDENT YATES: IN THE QUEUE NEXT, COUNCILWOMAN BUTLER.

COUNCILMEMBER BUTLER: LIKE I SAID BEFORE, THE PROBLEM WITH IT IS IT IS THE SAME SUBJECT MATTER. SO IF THEY DON'T HAVE THE LEGAL EXPERTISE TO LOOK AT THE SUBJECT MATTER IN THE FIRST 100 SAMPLES, I'M NOT SURE THEY HAVE THE LEGAL EXPERTISE TO LOOK AT THE SUBJECT MATTER HERE. BECAUSE THEY ARE REVIEWING THE SAME JUDICIAL REVIEW. AND WHEN WE GET AN AUDITOR WHO SAYS I DON'T HAVE THE EXPERTISE FOR THIS AND WE NEED TO GO WITH AN OUTSIDE PARTY, I THINK WE NEED TO GO WITH WHAT THEY ARE TELLING US THAT THEY NEED TO GO WITH AN OUTSIDE PARTY TO DO THIS. IT IS THE SAME SUBJECT MATTER AND I WOULD HATE FOR SOMEONE TO PICK UP AN AUDIT LATER AND HAVE IT MUDDIED DOWN OR NOT LOOKED AT IN THE SAME LIGHT BECAUSE OF WHAT WAS SAID PREVIOUSLY. SO I ENCOURAGE YOUR SUPPORT ON THIS JUST TO MAKE SURE THAT IT IS AN AUDIT THAT CAN

PRESIDENT YATES: THANK YOU, COUNCILWOMAN.

COUNCILMAN JAMES.

COUNCILMEMBER JAMES: THANK YOU. I WOULD JUST LIKE TO SAY THAT THESE ARE TWO DIFFERENT TYPES OF AUDITS. NUMBER ONE IS COUNCILWOMAN BUTLER'S AUDIT IS A MUCH MORE EXTENSIVE AUDIT AND LOOKS AT ALL FLOWS IN THE CORRECTIONS DEPARTMENT, THE FLOW OF PAPER, WHAT COMES IN AND WHAT COMES OUT OF THE CORRECTIONS DEPARTMENT. MINE IS VERY SIMPLE. I JUST WANT TO KNOW ARE INMATES HELD TOO LONG, RELEASED ON TIME OR RELEASED EARLY. THIS IS A VERY SIMPLE AUDIT. AND THEY ARE NOT CLOSE TO BEING THE SAME. THANK YOU.

PRESIDENT YATES: COUNCILMAN HOLLANDER.

COUNCILMEMBER HOLLANDER: THANK YOU, MR. PRESIDENT. AND THIS MAY BE A QUESTION FOR COUNCILMAN JAMES. I THINK IN ANSWER TO COUNCILWOMAN LEET'S QUESTION, AND I KNOW VERY LITTLE ABOUT THIS, BUT IT DOES LOOK LIKE MAY 31ST IS WHEN THE AUDITOR SAID SHE DOESN'T HAVE THE LEGAL EXPERTISE TO CONCLUDE THE AUDIT, SO THERE IS NEW INFORMATION WITHIN THE LAST FEW DAYS. HAS THE AUDITOR EVER INDICATED THAT SHE DOES NOT HAVE THE LEGAL EXPERTISE OR DOES HAVE THE LEGAL EXPERTISE TO CONDUCT THE AUDIT THAT YOU HAVE REQUESTED IN THIS RESOLUTION?

COUNCILMEMBER JAMES: THE AUDITOR HAS ADVISED ME THAT SHE HAS THE LEGAL EXPERTISE, WANTS TO DO IT, CAN DO IT, AND WILL DO IT.

COUNCILMEMBER BUTLER: IF I MAY THEN JUST ASK ONE OTHER OUESTION. IF THAT IS TRUE, TO ME THE QUESTION IS -- AND I DON'T

KNOW THE ANSWER -- WHETHER THERE IS DUPLICATIVE. WE ARE CLEARLY GOING TO BE PAYING BECAUSE SHE DOES NOT HAVE THE LEGAL EXPERTISE FOR THE EXISTING AUDIT. WE ARE GOING TO BE PAYING AN AUDITOR OR SOMEBODY TO DO THAT. AND DO WE WANT THE AUDITOR WHEN I WILL SHE IS DOING SOMETHING ELSE, IS SHE DOING DUPLICATIVE WORK? AND I DON'T KNOW THE ANSWER OF THAT.

COUNCILMEMBER JAMES: I WOULD SAY AGAIN THAT SHE HAS

THE MAJORITY OF THE AUDIT ALREADY COMPLETED. SHE JUST NEEDS THE

AUTHORIZATION FROM US TO FINISH IT.

PRESIDENT YATES: COUNCILWOMAN LEET.

COUNCILMEMBER LEET: YES. I JUST WAS TRYING TO FIND OUT PERHAPS IF I UNDERSTOOD. I KNOW ONE OF THE THINGS WE TALKED WAS DOING MORE ELECTRONIC TRACKING BECAUSE GETTING TO A MORE EFFICIENT SYSTEM. I'M WONDERING IF THE INTENTION OF YOUR AUDIT, COUNCILWOMAN BUTLER, IS TO FIGURE OUT WHERE WE CAN STREAMLINE AND GET BETTER AND THEN PERHAPS HAS A DIFFERENT RESULT TO ENSURE EQUAL PROTECTION OF PUBLIC PERSONS WHO ARE IN THE CUSTODY OF THE DEPARTMENT OF CORRECTIONS. I'M JUST WONDERING IF THERE ARE NOT TWO DIFFERENT INTENDED RESULTS AS WELL. SO I GUESS I WOULD ASK EACH OF Y'ALL TO PERHAPS CLARIFY IF ONE SERVES ONE PURPOSE AND ANOTHER DESERVES A DIFFERENT PURPOSE.

PRESIDENT YATES: WHILE THEY ARE DISCUSSING THAT, COUNCILMAN KRAMER.

COUNCILMEMBER KRAMER: MR. PRESIDENT, THIS SEEMS TO HAVE CAUGHT THE SPONSOR A LITTLE BIT BY SURPRISE, WHICH IS A

LITTLE BIT DISTRESSING. AND I'M WONDERING IF IT CAME OUT OF
PUBLIC SAFETY ONE WAY AND THEN IT IS AN AMENDMENT THAT IS BEING
OFFERED, AND AGAIN THERE DOESN'T SEEM TO HAVE BEEN ANY
CONVERSATION WITH THE ORIGINAL SPONSOR. PERHAPS THIS COULD GO
BACK TO PUBLIC SAFETY SO THEY CAN HAMMER THIS OUT AND BRING IT
BACK TO US WHEN THERE IS A CLEARER UNDERSTANDING OF WHAT THE
DEBATE REALLY IS. I MAKE A MOTION TO SEND IT BACK TO COMMITTEE.

>> SECOND.

PRESIDENT YATES: AND I JUST WANTED TO INFORM THE

COUNCIL I DID ASK LISA TO TRY AND CONTACT THE AUDITOR TOO FOR

CLARIFICATION AS WELL. AND I KNOW IT IS LATE. MOTION AND SECOND.

IS THERE A DISCUSSION ON THAT?

COUNCIL MEMBER MULVIHILL.

COUNCILMEMBER MULVIHILL: YES. WE DO HAVE THE AUDITOR

COMING TO GOVERNMENT ACCOUNTABILITY ON TUESDAY, SO I DON'T

KNOW -- IT CAN GO TO PUBLIC SAFETY CLEARLY, BUT SHE WILL BE

PRESENT THERE. I KNOW SHE WILL BE, IF PEOPLE HAVE QUESTIONS. I

DON'T KNOW WHAT HER SCHEDULE IS.

>> I WOULD ACCEPT THAT AS A FRIENDLY AMENDMENT. SEND IT TO GOVERNMENT ACCOUNTABILITY. SHE IS COMING TUESDAY ANYWAY.

COUNCILMEMBER MULVIHILL: SHE IS SLATED TO COME AT 5:00 ON TUESDAY.

>> THAT MAKES GOOD SENSE TO ME.

PRESIDENT YATES: IS THERE ANY OTHER DISCUSSION?

COUNCILWOMAN BUTLER.

COUNCILMEMBER BUTLER: I DO HAVE A QUESTION. YOU HAVE GOVERNMENT ACCOUNTABILITY ON TUESDAY AT 5:00?

COUNCILMEMBER MULVIHILL: YES.

COUNCILMEMBER BUTLER: BECAUSE WE ALSO HAVE BUDGET
HEARINGS SCHEDULED. WE WILL CHANGE OUR BUDGET -- IS THAT THE
ONLY ITEM YOU HAVE?

COUNCILMEMBER MULVIHILL: YEAH. WE WERE GOING TO HAVE
HER COME AND DISCUSS AUDITS AND THINGS THAT SHE IS WORKING ON.
BUT THIS NOW SEEMS LIKE SOMETHING SHE MAY BE WORKING ON AND THAT
SHE MIGHT HAVE ANSWERS FOR.

COUNCILMEMBER BUTLER: WE WILL PUSH BACK THE BUDGET STUFF.

COUNCILMEMBER MULVIHILL: THANK YOU.

PRESIDENT YATES: SO WE HAVE A MOTION TO TABLE, A MOTION TO SEND THIS BACK TO GOVERNMENT ACCOUNTABILITY ON TUESDAY.

>> SEND IT TO GOVERNMENT ACCOUNTABILITY. NOT BACK.

PRESIDENT YATES: TO GOVERNMENT ACCOUNTABILITY. AND I
HAVE A MOTION AND A SECOND. NO FURTHER DISCUSSION? ALL THOSE IN
FAVOR RESPOND BY SAYING AYE. OPPOSED? THE AYES HAVE IT. HOLD ON.
WOULD YOU LIKE A ROLL CALL VOTE?

COUNCILMEMBER JAMES: I WOULD LIKE A ROLL CALL VOTE, PLEASE.

PRESIDENT YATES: ROLL CALL VOTE, PLEASE. WITHOUT OBJECTION, THE VOTING IS CLOSING. THE VOTING IS CLOSED.

MR. CLERK: 14 YES VOTES, SEVEN NO VOTES, FIVE NOT VOTING. THE SEVEN NO VOTES ARE COUNCIL MEMBERS GREEN, SHANKLIN, WOOLRIDGE, BRYANT-HAMILTON, LEET, AND REED.
