So, is your intent to invoke Council Rule 7.12 and suspend Rule 7.01, which requires ordinances to have two readings?

Either way, you are going to have to specify why this meets the emergency threshold (even though you expressly state in your email that this is not an "emergency," but, rather, an accounting issue). As a point of reference, and while not exhaustive, the following matters have been deemed emergencies:

- 1. Funding for debris clean-up and assistance following the hurricane-aided storms of 2008 (Mayoral and Gubernatorial declared emergencies)
- 2. Funding to assist disaster relief efforts in Haiti following the 2010 earthquake
