

## PORTION OF ABANDONED R/W LEGAL DESCRIPTION

BEING A TRACT OF LAND LOCATED IN JEFFERSON COUNTY, KENTUCKY, BEING BOUND ON THE NORTH BY INTERSTATE 264 (VARIABLE RIGHT-OF-WAY), BOUND ON THE SOUTH BY STOWERS LANE (a.k.a. STOWERS AVENUE) (VARIABLE' RIGHT-OF-WAY), APPROXIMATELY 220' EAST OF SAVAGE DRIVE AND BEING MORE PARTICULARLY DESCRIBED AS FOLLOWS:

COMMENCING AT A POINT AT THE SOUTHEAST INTERSECTION OF SAVAGE DRIVE (AS DEDICATED IN DEED BOOK 2331, PAGE 232) AND STOWERS LANE-30' R/W (AS DEDICATED IN DEED BOOK 2505, PAGE 246), SAID POINT ALSO BEING THE SOUTHWEST CORNER OF A TRACT OF LAND CONVEYED TO F.R. BENNETT AS RECORDED IN DEED BOOK 10077, PAGE 80, ALL ON FILE IN THE OFFICE OF THE COUNTY CLERK OF JEFFERSON COUNTY, KENTUCKY; THENCE LEAVING SAID SAVAGE DRIVE AND WITH THE NORTH LINE OF SAID STOWERS LANE, ALSO BEING THE SOUTH LINE OF SAID BENNETT AND THE SOUTH LINE OF A TRACT OF LAND CONVEYED TO WILLIAM COLGATE (TRACT 1) AS RECORDED IN DEED BOOK 10340, PAGE 315 ON FILE IN SAID CLERK'S OFFICE, S 83'45'52" E, A DISTANCE OF 206.24 FEET TO A FOUND 1.5" IRON PIPE, SAID PIPE BEING THE SOUTHWEST CORNER OF SAID COLGATE (TRACT 1); THENCE N 03'54'08" E, A DISTANCE OF 5.00 FEET TO A POINT (TRUE POINT OF BEGINNING) BEING THE SOUTHWEST INTERSECTION OF SAID STOWERS LANE AND AN ABANDONED 25' ALLEY (NO RECORDS FOUND); THENCE LEAVING SAID STOWERS LANE AND WITH SAID COLGATE TRACT 1, N 03°54'08" E' A DISTANCE OF 76.24 FEET TO A POINT, SAID POINT BEING THE NORTHEAST CORNER OF SAID COLGATE TRACT 1 AND BEING IN THE SOUTH RIGHT OF WAY LINE OF THE HENRY WATTERSON EXPRESSWAY (I-264) AS DEDICATED IN DEED BOOK 3842, PAGE 104 ON FILE IN THE CLERK'S OFFICE AFORESAID; THENCE LEAVING SAID COLGATE TRACT 1 AND WITH SAID RIGHT OF WAY OF 1-264, WITH A CURVE TO THE LEFT HAVING A RADIUS OF 2019.86 FEET AND A CHORD BEARING OF S 69'54'29" E AND A CHORD DISTANCE OF 26.03 FEET TO A POINT, SAID POINT BEING THE NORTHWEST CORNER TO ANOTHER TRACT OF LAND CONVEYED TO WILLIAM COLGATE (TRACT 2) OF RECORD IN DEED BOOK 10340, PAGE 315 ON FILE IN SAID CLERK'S OFFICE; THENCE LEAVING SAID 1-264 AND WITH SAID COLGATE TRACT 2, S 03'54'08" W, A DISTANCE OF 70.00 FEET TO A SET 1/2" REBAR WITH A YELLOW PLASTIC IDENTIFICATION CAP STAMPED "BENTLEY #3697" (BEING THE NORTH RIGHT OF WAY OF SAID STOWERS LANE-40' R/W AS SHOWN IN DEED BOOK 6443, PAGE 240) AND BEING THE SOUTHWEST CORNER OF SAID COLGATE TRACT 2, SAID REBAR ALSO BEING THE NORTHEAST INTERSECTION OF SAID ALLEY AND STOWERS LANE; THENCE WITH THE NORTH RIGHT OF WAY OF SAID STOWERS LANE; THENCE LEAVING SAID TRACT 2 AND WITH SAID NORTH RIGHT OF WAY LINE OF STOWERS LANE, N 83'45'52" W, A DISTANCE OF 25.02 FEET TO THE POINT OF BEGINNING.

BEING ALL OF THAT PORTION OF THE ABANDONED RIGHT OF WAY SITUATED BETWEEN SAID WILLIAM COLGATE TRACTS 1 & 2, EXTENDING FROM THE NORTH RIGHT OF WAY OF SAID STOWERS LANE TO THE SOUTH RIGHT OF WAY OF SAID INTERSTATE 264.
