Here were the concerns addressed by those in attendance:

- 1. The patients will leave the facility and rob and kill neighbors
- 2. Move the location to the east end
- 3. Landmark is an out of state private entity with out of state owners who are only concerned about making money.
- 4. Property values will decrease
- 5. Neighbors were not notified of the meeting. They felt Landmark tried to sneak the use past neighbors. Matt confirmed none of the neighbors live at the addresses given by the city to notify.
- 6. Asked if there would be video surveillance at the premises.

Here are a few thoughts for another meeting:

- 1. Notify the ones in attendance that offered their contact information about future meetings.
- 2. Reiterate that many of the patients are doctors, lawyers and professionals, not derelicts off the street.
- 3. Reiterate the private pay of \$17,500 per patient for a 30 day stay and that people are there by choice.
- 4. Bring former patients to share their experience.
- 5. Have a video camera set up (whether it works or not) so that people can't make claims of things that didn't happen or things that weren't said.
- 6. Building was built by Ford, no other uses were successful there (Daymar, church, daycare). Bring UAW in for support.
- 7. Matt offered a tour of Malcolm. Make the same offer again.
