Neighborhood Meeting Summary - 1235 Rufer Ave

The neighborhood meeting was held on Thursday, June 8th, 2017 at 7pm at 1235 Rufer Ave. The owner and host of the house, Richard and Molly Gaines, and five neighbors were in attendance. Neighbors' main concern was parking availability. Owners assured neighbors that the home has its own driveway, so two renters' cars will be parked in the driveway, and if there are ever more than two cars, there are also two street spots available in front of the home.

Second, there were concerns voiced about the potential for disrespectful guests. The owners explained the extensive screening process they use for potential tenants and that they limit the number of people who can stay at one time. Homeowners have also provided their own contact information to the neighbors in the unlikely event of an issue.

Next, a concern about lawncare arose. Homeowners replied that there is already a reliable, local lawn care company who is and will be frequently servicing the lawn. Neighbors were also concerned about who would check on the house since the homeowners live out of state. Owners explained that the house cleaner lives on the block and is readily available if an urgent situation arose.

Then, a neighbor was concerned about the zoning of the home changing. Homeowners explained that the zoning would not be changing. Neighbors also wanted to know about how long renters would be staying in the home. Homeowners responded that stay lengths would vary and that the home would be available for monthly, weekly and nightly stays. Lastly, one neighbor was concerned about the addition of pets in the neighborhood. Homeowners explained that there will be a strict "no pets" policy for tenants.
