PRESIDENT YATES: THANK YOU, MR. CLERK.

WOULD YOU ALSO HAVE THE RECORD REFLECT THAT COUNCIL MEMBERS FOWLER, SHANKLIN, AND PEDEN NEED TO HAVE EXCUSED ABSENCES.

MR. CLERK: SO NOTED.

PRESIDENT YATES: AND COUNCIL MEMBER JOHNSON AS WELL.

MR. CLERK: SO NOTED.

PRESIDENT YATES: COUNCILMAN ENGEL, WOULD YOU PLEASE PRESENT YOUR PAGE?

COUNCIL MEMBER JOHNSON: YES, SIR.

THANK YOU VERY MUCH, MR. PRESIDENT, FOR THIS OPPORTUNITY.

DISTRICT 22 IS HONORED TO HONOR ALEXIS PAIGE ST. CLAIR. SHE IS IN THE EIGHTH GRADE AT NOME MIDDLE SCHOOL. LOVES JOURNALISM, PUBLIC SPEAKING AND THEATER. SHE PLAYS GUITAR AND LIKES TO MAKE UP HER OWN LYRICS. I HAVE TO APPLAUD HER PATIENCE ALSO, COLLEAGUES. LAST YEAR COUNCILMAN DOWNARD CAME AND ASKED IF HE COULD SUB MY PAGE WITH HIS PAGE BECAUSE I THINK HE WAS WINDING DOWN HIS CAREER. SO ALEXIS HAS WAITED A WHOLE YEAR TO DO THIS. BUT I HAVE A PROCLAMATION AND PIN FOR HER, AND SHE IS JOINED BY HER PARENTS STEVE AND VALERIE OUT IN THE AUDIENCE. ALEXIS. THANK YOU. [ APPLAUSE ]

PRESIDENT YATES: COUNCILWOMAN HAMILTON, WOULD YOU PLEASE INTRODUCE YOUR PAGE?

COUNCIL MEMBER BRYANT-HAMILTON: WE HAVE E.J. HE IS SEVEN YEARS OLD AND IN THE SECOND GRADE AT THE WEST END SCHOOL. I ASKED HIM WHAT WAS HIS FAVORITE SUBJECT, AND HE SAID RECESS. AND I SAID, NOT MATH, NOT READING?

HE LIVES IN DISTRICT FIVE WITH HIS MOTHER AND SISTER. HIS MOTHER IS JESSICA PRINCE AND HIS FATHER IS ERIC RICARDO. WHEN I ASKED HIM WHAT HE LIKED TO DO, HIS GRANDMOTHER TOLD ME HE LOVES TO TUMBLE AND ALL HE COULD TALK ABOUT WAS WRESTLING. HE WANTS TO BE A WRESTLER. HE NAMED A WHOLE BUNCH OF WRESTLERS. HE SAID DON'T YOU KNOW, DON'T YOU KNOW?

I SAID, NO, I NEVER HEARD OF THESE PEOPLE. HE REALLY FOLLOWS
THEM. I ASKED HIM IF HE HAS EVER BEEN TO A MATCH, AND HE HASN'T YET, BUT
HE HAS SEEN THEM ON TV. I THINK HE IS EXCITED WRESTLING IS COMING BACK TO
LOUISVILLE. HE ATTENDS ANTIOCH BAPTIST CHURCH AND HE IS HERE WITH HIS
GRANDPARENTS RUTH AND ANTHONY PRINCE. AND WE THANK HIM FOR BEING HERE.
COLLEAGUES, WOULD YOU PLEASE WELCOME EJ FITZPATRICK?

[ APPLAUSE ]

PRESIDENT YATES: COUNCILMAN JAMES, YOU MAY INTRODUCE YOUR GUESTS.

MR. CLERK, DO WE HAVE ANY ADDRESSES TO THE COUNCIL?

MR. CLERK: WE DO, SIR.

PRESIDENT YATES: LET ME REMIND THOSE ADDRESSING THE COUNCIL TO PLEASE REFRAIN FROM PROFANITY OR MAKING ANY DEROGATORY STATEMENTS TO ANY INDIVIDUAL COUNCIL MEMBERS.

MR. CLERK, WOULD YOU PLEASE CALL UP THE FIRST SPEAKER?

MR. CLERK: DR. FRANK SIMON.

PRESIDENT YATES: I WOULD ALSO ASK EACH SPEAKER TO PLEASE RESPECT THE CLOCK. THERE IS A THREE-MINUTE LIMIT ON EACH SPEAKER. IN THE INSTANCE YOU GO OVER, YOU'LL INFRINGE ON THE NEXT SPEAKER'S TIME. PLEASE BE COGNIZANT OF THE THREE MINUTES.

DR. FRANK SIMON: TWO MONTHS AGO MAYOR FISCHER WAS ASKED TO MAKE LOUISVILLE A SANCTUARY CITY. AND MANY PEOPLE THOUGHT THE PEOPLE WERE COMING TO DESTROY LOUISVILLE LIKE THEY DID DETROIT. THERE ARE MANY WORKERS AND NOT ENOUGH JOBS IN LOUISVILLE. APPARENTLY, SOME PEOPLE THINK GEORGE SOROS DOESN'T REALLY CARE ABOUT THE LOUISVILLE WORKERS AND THE FEW JOBS THAT ARE LEFT THEY WANT TO GIVE TO ILLEGAL IMMIGRANTS AND MUSLIMS WHO COME TO OUR CITY WITH DRUG SMUGGLERS, GANGS, AND OTHER CRIMINALS. HOWEVER, WE IN LOUISVILLE ARE THE TAXPAYERS AND WE ARE ASKED TO PAY THE BILL. SINCE 9/11, 580 PEOPLE HAVE BEEN CONVICTED OF TERRORIST-RELATED CHARGES IN AMERICA AND 380 WERE FOREIGN-BORN. DO YOU KNOW WHO THIS IS?

THIS COULD BE YOUR DAUGHTER, GRANDDAUGHTER, OR SISTER. IN SAN FRANCISCO, 32-YEAR-OLD KATE S. WAS SHOT BY AN ILLEGAL IMMIGRANT NAMED JUAN SANCHEZ. SAN FRANCISCO, CALIFORNIA, WAS A SANCTUARY CITY AND STILL IS. THE ILLEGAL IMMIGRANT JUAN WAS A FELON, HAD A RECORD OF BEING A FELON AND HAD BEEN DEPORTED FIVE TIMES TO MEXICO. IF I HAD KNOWN THAT HE WAS BACK IN TOWN -- IF I.C.E. HAD KNOWN HE WAS BACK IN TOWN THEY WOULD HAVE REMOVED HIM AND KATE WOULD BE ALIVE TODAY. THIS COULD HAPPEN IN OUR CITY. DO YOU WANT THAT TO HAPPEN TO US?

WE HAVE HERE OVER 3,000 SIGNATURES ON THIS PETITION TO OPPOSE
MAKING LOUISVILLE A SANCTUARY CITY. THERE ARE THOUSANDS AND THOUSANDS MORE
SUPPORTERS IN LOUISVILLE WHO ALREADY DEVOTED TO SAVE OUR CITY FROM
DETROIT'S FAITH AND MAKE LOUISVILLE GREAT AGAIN WITHOUT THE MURDERERS, THE
FAILING SCHOOLS, THE DRUGS THAT CAUSE THESE POLICIES. WHY SHOULD WE FILL
OUR CITY WITH PEOPLE WHO HATE US AND OUR VALUES AND ARE JUST WAITING FOR A
CHANCE TO MURDER AND RAPE OUR CHILDREN AND EVERYONE THEY CAN?

IT SHOULD BE OBVIOUS TO ALL THAT THIS POLICY HAS NOT WORKED IN EUROPE. WHY SHOULD WE MAKE THE SAME MISTAKE THAT EUROPE HAS MADE?

WHY SHOULD WE FILL -- OKAY. WE ARE ALSO OPPOSED TO MAYOR FISCHER
'S SIGNING OF THE DOCUMENT AS MAYOR OF LOUISVILLE WHICH SAYS WE ARE STILL
IN. THIS SUPPORTS THE 2015 PARIS CLIMATE CHANGE --

PRESIDENT YATES: THE TIME HAS ENDED. YOU MAY FINISH YOUR SENTENCE.

DR. FRANK SIMON: OKAY. WELL, I THINK WE NEED TO WORK TOGETHER TO MAKE LOUISVILLE GREAT AGAIN. THANK YOU.

MR. CLERK: ASHLEY CAMPBELL.

ASHLEY CAMPBELL.

DAVE COOPER.

DAVE COOPER: GOOD EVENING. MY NAME IS DAVE COOPER, AND FIRST OFF I WOULD LIKE TO SAY THANK YOU TO THE LOUISVILLE METRO COUNCIL FOR ALLOWING ME TO SPEAK THIS EVENING. I GREATLY APPRECIATE THIS OPPORTUNITY. IN HIS BACKPACK HE PLACES HIS JACKET, HAT, SHIRT, SEVEN PHOTOS AND A THOUSAND MEMORIES. HE PACKS AWAY HIS DESIRE TO STAY AT HOME, BECOME THE KIND OF MAN HE WISHES HE COULD BE. HE SAYS GOOD-BYE WITH A FACE THAT DIES BY A SMILE. HE TURNS TO THE CRUCIFIX ON HIS WALL AND PLEADS WITH GOD TO WATCH OVER HIS FAMILY, AND THEN HE LEAVES AND HE CROSSES THE BORDER. VERY ROUGHLY TRANSLATED, THESE ARE THE OPENING LYRICS TO A SONG THAT BECAME VERY POPULAR IN MEXICO AND CENTRAL AMERICA A FEW YEARS AGO. THE NAME OF THE SONG IS EL MOJADO, THE WETBACK. IT ILLUSTRATES THE HARD TRUTH, MANY WHO COME INTO THE COUNTRY WITHOUT DOCUMENTATION DO NOT DO SO TO CREATE CRIME, BUT OUT OF NECESSITY. IF THEY ARE NOT FLEEING THE GANG VIOLENCE AND THE DRUG CARTELS, THEY ARE FLEEING ABSOLUTELY CRUSHING POVERTY.

IN FACT, ONE OF THE LARGEST SOURCES OF INCOME IN MEXICO IS FROM PEOPLE WHO COME TO THE UNITED STATES, WORK, AND SEND MONEY BACK HOME TO THEIR FAMILIES. FOR THE PAST 15 YEARS, I HAVE WORKED WITH THE HISPANIC COMMUNITY OF FAITH AND I HAVE HEARD STORIES OF PEOPLE RISKING THEIR LIVES WALKING FOR DAYS THROUGH THE BRUTAL ARIZONA DESERT IN ORDER TO FIND WHAT THEY CALL A BETTER LIFE, WHICH I CONSIDER TO BE SOMEWHAT OF A EUPHEMISM, A SURVIVABLE LIFE WOULD BE MORE ACCURATE. WHEN YOUR FAMILY IS GOING HUNGRY, SUDDENLY THE BORDER LAWS OF ANOTHER COUNTRY DOESN'T SEEM THAT CRITICAL.

MAKE NO MISTAKE. THOSE WHO ARE HERE WITHOUT DOCUMENTATION ARE REFUGEES

JUST AS MUCH AS THOSE ESCAPING THE CIVIL WARS IN SYRIA AND SOMALIA. I HAVE A QUESTION FOR YOU. WE OFTEN REFER TO LOUISVILLE AS A COMPASSIONATE CITY, AND I ASK YOU WHAT DOES THAT MEAN?

IS IT JUST A MEANINGLESS CATCH PHRASE OR DO WE AS A COMMUNITY REALLY DESIRE TO HELP THOSE IN SUCH NEED?

I LOVE THIS CITY. I HAVE LIVED HERE MOST OF MY LIFE. AND TONIGHT I ASK THAT YOU CONSIDER DESIGNATING LOUISVILLE A SANCTUARY CITY. I ASK THIS IN ORDER TO REDUCE THE CONSTANT FEAR OF DEPORTATION AND FAMILY BREAKUP AMONG THOSE WHO ARE IN OUR CITY WITHOUT DOCUMENTATION. THEN PEOPLE WOULD BE MORE WILLING TO REPORT CRIMES TO THE POLICE, USE HEALTH SERVICES AND SEVEN ROLL THEIR CHILDREN IN SCHOOL. I WOULD LIKE TO CLOSE BY SAYING THAT THESE ARE OUR BROTHERS AND SISTERS, OUR PARENTS, HUSBANDS, AND WIVES, AND THEY DESERVE OUR COMPASSION. THANK YOU.

[APPLAUSE].

MR. CLERK: CLARA RUPLINGER. CLARA RUPLINGER

CLARA RUPLINGER: HELLO. MY NAME IS CLARA ANNA RUPLINGER AND I'M
A LIFELONG RESIDENT OF LOUISVILLE, KENTUCKY. WHILE I CURRENTLY LIVE IN

COUNCIL MEMBER COAN'S DISTRICT MY FAMILY AND I HAVE LIVED MUCH LONGER IN GLEN STUCKEL'S DISTRICT. I'M HERE ON BEHALF OF LOUISVILLE FOR RACIAL JUSTICE AND MI GENTE IN SUPPORT OF MAKING LOUISVILLE A SANCTUARY CITY, WHATEVER NAME THAT COMES IN. I WOULD LIKE TO FIRST REITERATE THE WORDS OF JESUS IBANEZ TO CLARIFY WHAT IS A SANCTUARY CITY. WE CALL FOR FUNDING TO BE SHIFTED FROM OVERPOLICING WHICH HAS NOT BEEN SHOWN TO REDUCE CRIME TO INCREASED FUNDING FOR COMMUNITY PROGRAMS LIKE DRUG TREATMENT. SECOND, WE MUST ADDRESS AGREEMENTS WHEREIN THE FEDERAL GOVERNMENT CAN DEPUTIZE LOCAL LAW ENFORCEMENT TO THE DETRIMENT OF THE COMMUNITY. THIRD, IT MUST ADDRESS DETAINMENT. IF LMPD IS TO HAND OVER ANY PERSON IN THEIR CUSTODY THEY MUST BE UNDER JUDICIAL WARRANT AND NOT ADMINISTRATIVE, AS HAPPENS CURRENTLY. THIS IS AN ISSUE IMPORTANT TO ME BECAUSE I KNOW FIRSTHAND THE PAIN AND DESTRUCTION BROKEN FAMILIES CAN BRING TO A COMMUNITY. I KNOW WHAT IT IS LIKE TO HAVE FAMILY TORN APART AND THE DAMAGE THAT IT DOES, PARTICULARLY TO CHILDREN.

WHILE MY SITUATION MAY NOT HAVE BEEN PREVENTABLE, IT BAFFLES ME
THAT THE STATE WOULD WILLINGLY RIP APART HAPPY AND STABLE FAMILIES SIMPLY
BECAUSE OF ARBITRARY LEGISLATION AND UNJUST FEAR WHICH DOES NOTHING BUT
HARM. ALLOWING I.C.E. TO ENTER INTO ANY HOUSE AND REMOVE CARETAKERS AND
BREADWINNERS OF A FAMILY IS A FUNDAMENTALLY DESTABILIZING ACTIVITY. IT
CREATES AN ATMOSPHERE WHERE RESIDENTS ARE AFRAID TO GET HEALTH CARE,
REPORT CRIME, SEND THEIR CHILDREN TO SCHOOL AND OTHER ACTIONS THAT KEEP A
COMMUNITY, INCLUDING OUR COMMUNITY, EVERYONE'S COMMUNITY, SAFE AND
HEALTHY. BY TAKING PARENTS AWAY FROM CHILDREN, YOU ARE HURTING THE FUTURE
OF OUR COUNTRY AND OUR CITY. IF WE WANT TO GROW AS A COMMUNITY, WE HAVE TO
MAKE IT SAFE FOR EVERYONE TO PARTICIPATE.

WHILE THERE IS MUCH DEBATE OVER THE CONSEQUENCES OF SUCH A MOVE, ESPECIALLY WHEN A STATE GOVERNMENT IS IN OPPOSITION TO OUR GOALS AND THERE ARE THOSE THAT OPPOSE US, I WOULD LIKE TO REMIND COUNCIL MEMBERS THAT WE ARE ALREADY UNDER ATTACK. THERE ARE PEOPLE WHO ARE READY TO BACK YOU UP SHOULD YOU TAKE A STAND AGAINST THESE UNJUSTIFIED AND FEAR-FILLED ATTACKS, BUT WE CAN ONLY DO THIS IF YOU HAVE THE COURAGE TO STAND FOR WHAT IS RIGHT AND SHOW THAT LOUISVILLE IS A TRULY COMPASSIONATE CITY. THANK YOU.

MR. CLERK: PHILIP LLOYD-SIDLE

I APOLOGIZE IF I MISPRONOUNCED YOUR NAME.

PHILIP LLOYD-SIDLE: YOU GOT IT GREAT. MY NAME IS PHILIP LLOYD-SIDLE.

I WORK FOR THE CENTER OF WOMEN AND FAMILIES. BUT FOR THE RECORD I'M NOT SPEAKING ON BEHALF OF THE CENTER. BUT I AM HERE TO TALK ABOUT DOMESTIC VIOLENCE, SEXUAL ASSAULT, AND FOR SANCTUARY. MAYOR FISCHER SPEAKS ABOUT THE PILLARS OF SAFETY AND VIOLENCE REDUCTION. SO LET'S SPEAK TO THE IMMIGRANT COMMUNITY. SINCE JANUARY WITH THE RHETORIC AND POLICY OF THE NEW ADMINISTRATION THE EMPIRICAL EFFECT IN THE LATINO COMMUNITY WITH REGARD TO DOMESTIC VIOLENCE AND SEXUAL ASSAULT IS THE EXACT OPPOSITE OF SEEKING TO ENSURE SAFETY AND VIOLENCE REDUCTION. SINCE JANUARY IN IMMIGRANT COMMUNITIES AROUND THE COUNTRY, CITIES ARE IDENTIFYING UP TO 40% DROPS IN THE REPORTING OF SEXUAL ASSAULT AND DOMESTIC VIOLENCE. THERE ARE EVEN DROPS IN CALLING 911 OR SEEKING MEDICAL SERVICES. SURVIVORS ARE EXPRESSING DEEP MISGIVINGS ABOUT CONTACTING THE POLICE, GOING TO THE COURT, AND SOME ARE DROPPING CIVIL AND CRIMINAL CASES RELATED TO THEIR ABUSE. NOW I KNOW THIS FROM MY WORK. THE UNCERTAINTY AND FEAR IS A CHANGED BEHAVIOR IN THESE COMMUNITIES ARE PALPABLE. BEFORE JANUARY I WAS ABLE TO SAY AS A LEGAL

ADVOCATE I WAS ABLE TO SAY TO AN IMMIGRANT WOMAN YOU CAN FILE FOR AN EPO AND GET A HEARING.

YOU NEED NOT FEAR GOING TO THE COURT. YOUR RIGHTS WILL BE PROTECTED. AND NOW I CAN ONLY RESPOND TO HER SAYING I HOPE LOCAL LAW ENFORCEMENT WILL PROTECT YOU. I HOPE THE JUDGE AND COURT WILL DO THE SAME. BUT I CAN'T GUARANTEE THAT I.C.E. WILL NOT APPEAR IN THAT COURTROOM OR LOBBY. I CANNOT GUARANTEE THAT LOCAL LAW ENFORCEMENT WILL NOT PASS YOUR NAME ON TO I.C.E. (SPEAKING SPANISH).

I HOPE YOUR RIGHTS WILL BE PROTECTED, BUT I CAN NO LONGER
GUARANTEE THAT. BUT THEY KNOW THAT ALREADY. SO VICTIMS AND SURVIVORS STOP
GOING TO THE POLICE, STOP GOING TO THE COURT, AND JUST FEND FOR
THEMSELVES. NOW THAT IS NOT GOOD POLICY. WE ARE UP TO 1,300 OFFICERS AND
COULD HAVE 20,000. BUT IF WE DON'T BUILD TRUST, IF WE DON'T AND THAT LOCAL
LAW ENFORCEMENT AND THE COURTS EXIST TO PROTECT RESIDENTS, HERE'S THE
TAKEAWAY FOR THE IMMIGRANT COMMUNITY. IF WE DON'T CREATE A FIREWALL
BETWEEN LOCAL LAW ENFORCEMENT AND THE COURTS AND I.C.E., DOMESTIC VIOLENCE
AND SEXUAL ASSAULT WILL GO LESS AND LESS REPORTED AND THE HIDDEN TERRORS
AT HOME WILL GO MORE AND MORE UNPROTECTED.

SO WE NEED A BOLD, CLEAR, PUBLIC AND SYSTEMIC COMMITMENT TO THE SAFETY FOR ALL PEOPLE. IF WE NEED TO BUILD A WALL, LET'S BUILD ONE BETWEEN LOCAL LAW ENFORCEMENT AND I.C.E. IT'S A LOT CHEAPER.

MR. CLERK: RUSSELL GREEAR.

RUSSELL GREEAR: I'M NOT HERE TO TALK ABOUT SANCTUARIES. I'M HERE
TO TALK ABOUT CITY COUNCIL BEING INVOLVED -- WE ALSO NEED THESE LANDLORDS
TO START OBEYING THE LAW. I GOT THIS DOCUMENT RIGHT HERE THAT I GOT NOTICE
OF A VIOLATION. TOMORROW MORNING Y'ALL ARE GOING TO GET A COPY OF THIS. I

CAN'T READ IT. ROACHES IN MY APARTMENT, WHICH MY LANDLADY DOESN'T WANT TO DO NOTHING ABOUT IT. SEVEN COUNTIES DOESN'T WANT TO DO ANYTHING ABOUT IT. AND BASICALLY CODE ENFORCEMENT FINED MY LANDLADY, WHICH IS STILL NOT DOING ANYTHING ABOUT IT. SIX WEEKS AND HAS ONLY SPRAYED ONCE. AND BASICALLY IT TOOK HER SIX WEEKS TO CUT MY GRASS. AND THIS IS A HANDICAPPED HOUSING THAT SEVEN COUNTIES -- -- AND SEVEN COUNTIES -- -- WHICH BASICALLY I HAVE TOLD THEM TO GET THIS BOOK, RENTERS RIGHTS SO THEY KNOW WHAT IS GOING ON. AND THE RIGHTS OF THE DISABLED, WHICH IS FOR HOUSING FOR THE DISABLED. AND NOBODY WANTS TO DO ANYTHING ABOUT IT. I ASKED CITY COUNCIL TO GET INVOLVED WITH THE LANDLORDS FOR VIOLATIONS AND I WOULD LIKE FOR CITY COUNCIL TO START APPOINTING TO THE SEVEN COUNTIES BOARD INSTEAD OF LETTING THEM APPOINT THEMSELVES, WHICH THEY DON'T WANT TO LISTEN TO PEOPLE. I WENT TO THE BOARD ABOUT SIX MONTHS AGO AND THEY TURNED ME DOWN.

I HAVE 30 YEARS OF EXPERIENCE AS AN ADVOCATE AND THEY STILL WON'T LET ME BE ON THEIR BOARD. THEY JUST BLOW YOU OFF, AND THEY ARE IN VIOLATION OF FEDERAL AND STATE LAW. AND I'M ASKING YOU GUYS TO -- IN THE ELECTION OF THESE BOARDS, LIKE THE TARC BOARD, SEVEN COUNTIES BOARD AND ANY OTHER BOARDS SO PEOPLE CAN BE HEARD INSTEAD OF GOING UP HERE. PEOPLE'S RIGHTS ARE BEING VIOLATED. SO BASICALLY I'M JUST TRYING TO GET JUSTICE FOR THE CLAIMS OUT HERE WHICH ARE IN THE BEING HEARD. THERE IS ROACHES IN THE APARTMENTS WHICH WE CAN'T GET RID OF BECAUSE LANDLORDS DON'T WANT TO DO ANYTHING ABOUT IT. YOU NEED TO START TRIPLING THE FINES ON THE LANDLORDS AND YOU NEED TO START FINING THE SEVEN COUNTIES OR WHOEVER IS IN CHARGE OF THE APARTMENTS AND MAKE SURE THEY ONCE THEY GET FINED THEY KNOW THEY ARE GOING TO GET A FINE AND IT IS GOING TO KEEP ACCUMULATING UNTIL SOMETHING IS DONE. THANK YOU.

MR. CLERK: REVEREND A. RUSSELL AWKARD

REV. RUSSELL AWKARD: GOOD EVENING, EVERYONE. MR. PRESIDENT AND MEMBERS OF LOUISVILLE METRO COUNCIL, I'M REVEREND A. RUSSELL AWKARD.

AND I COME TO YOU AS THE PASTOR OF NEW ZION BAPTIST CHURCH, 1501

LEWIS HOLMAN DRIVE. FOR OVER 90 YEARS NEW ZION HAS BEEN LOCATED IN WAS NEW

CALLED PARK DUVALL AND THE FIRST DISTRICT OF METRO COUNCIL. THE HONORABLE

JESSICA GREEN IS OUR REPRESENTATIVE ON THIS METRO COUNCIL. WE ARE HERE

THIS EVENING TO REGISTER OUR UNQUALIFIED RESPECT AND SUPPORT FOR

MS. GREEN. SHE IS A STRONG ADVOCATE FOR OUR COMMUNITY AND A PASSIONATE

BELIEVER IN JUSTICE AND EQUALITY FOR ALL. WE HAVE BEEN PRAYING FOR HER AS

SHE DEALS WITH THE TRAUMA OF WHAT SHE DESCRIBES AS PHYSICAL AND

EMOTIONAL -- IT IS WELL-KNOWN THAT COUNCILWOMAN GREEN IS A WOMAN OF FAITH,

FULLY QUALIFIED TO SERVE ON THIS PANEL WITH INTEGRITY AND COMPETENCE. SHE

IS ALSO A DEVOTED MOTHER AND REPUTABLE ATTORNEY. OVER THE LAST SEVERAL

WEEKS, WE HAVE BEEN DISTRESSED ABOUT THE WAY HER COMPLAINTS CONCERNING AN

INCIDENT INVOLVING COUNCILMAN DAN JOHNSON HAS BEEN HANDLED. SILENCE AND

INACTION. UNFORTUNATELY, THIS IS NOTHING NEW.

THROUGHOUT OUR HISTORY, THE WOMEN OF OUR COMMUNITY HAVE BEEN SUBJECTED TO SHAMEFUL AND SOMETIMES SORDID TREATMENT. 220 YEARS AGO SOJOURNER TRUTH WAS BORN IN 1797. IT IS A HAUNTING FACT THAT HER NON-RHETORICAL QUESTION IS STILL BEING ASKED TODAY. AIN'T I A WOMAN?

WE ARE HERE TODAY TO SAY THAT THIS QUESTION NEEDS TO BE ANSWERED IN THE AFFIRMATIVE IN 2017. METRO COUNCIL MEMBERS, WE WANT YOU TO KNOW THAT NEITHER SHE NOR ANY WOMAN SHOULD HAVE THEIR ACCUSATIONS OF COWORKER'S SEXUAL IMPROPRIETY TO BE TAKEN LIGHTLY, AND WE CALL FOR FULL AND SWIFT

ACTION BY THIS BODY TO PROVE THAT YOU ARE DEALING HONORABLY AND EQUITABLY WITH HER AS SHOULD BE THE CASE FOR ALL YOUR MEMBERS. THANK YOU VERY MUCH.

[APPLAUSE].

MR. CLERK: MRS. LIZZIE MILLER

MRS. LIZZIE MILLER: MY NAME IS MRS. LIZZIE MILLER.

I'M A MEMBER OF THE NEW ZION BAPTIST CHURCH LOCATED IN THE FIRST DISTRICT. EARLIER TODAY MY MEDICAL DOCTOR FITTED ME WITH A HEART MONITOR AND ADVISED ME TO TAKE IT EASY AND AVOID ALL STRESSFUL SITUATIONS. BUT I HAVE COME TO THIS CHAMBER TONIGHT TO EXPRESS MY SUPPORT FOR MY FIRST DISTRICT COUNCILWOMAN, THE HONORABLE JESSICA GREEN. I DID NOT WANT TO MISS THIS OPPORTUNITY TO SHOW MY SUPPORT FOR HER IN THIS TRYING MOMENT. ALSO, I AM 89 YEARS OLD. THAT'S MORE THAN MOST WOMEN LIVE. I FEEL THAT THE INSULT AND HARASSMENT THAT MS. GREEN HAS FELT OVER THE PAST SEVERAL WEEKS SHOULD MOVE THIS ASSEMBLY TO ACT. SHE SHOULD BE GIVEN THE SAME RESPECT AND CONSIDERATION THAT EVERY OTHER MEMBER OF METRO COUNCIL WOULD EXPECT.

LET'S BE FAIR AND PROTECT HER DIGNITY AND HER POSITION. AS A RETIRED EMPLOYEE OF THE FEDERAL GOVERNMENT HERE IN LOUISVILLE, I PERSONALLY HAVE FELT THE DISRESPECT OF MY PEERS. I KNOW WHAT IT MEANS TO FIGHT FOR EQUAL TREATMENT AND RESPECT AMONG MY COWORKERS. JESSICA GREEN IS AN OUTSTANDING YOUNG WOMAN. I KNEW HER AND I KNEW HER PARENTS. SHE IS A DEVOTED MOTHER AND HIGHLY REGARDED PUBLIC SERVANT WHO REPRESENTS DISTRICT ONE WITH THE RESPECT OF INFLUENCE ON THE METRO COUNCIL, NOT JUST NOW, BUT FOR AS LONG AS SHE SERVES IN THIS OFFICE, THANK YOU FOR YOUR CONSIDERATION OF MY SPEECH.

[APPLAUSE].

MR. CLERK: ROSELYN KELCY

ROSELYN KELCY: MR. PRESIDENT AND MEMBERS OF METRO COUNCIL, GOOD EVENING. MY NAME IS ROSELYN KELCY

I LIVE IN DISTRICT 11. MY HUSBAND AND I OWN A HOME IN DISTRICT ONE. I ATTEND NEW ZION BAPTIST CHURCH IN DISTRICT ONE. AND I HAVE FAMILY AND FRIENDS IN DISTRICT ONE. I AM HERE TODAY WITH OTHERS TO LET THIS COUNCIL AND COUNCILWOMAN JESSICA GREEN KNOW THAT SHE HAS OUR SUPPORT. SEXUAL HARASSMENT IS NOT TO BE TOLERATED AT ANY VENUE, AND ESPECIALLY NOT IN THE WORKPLACE. WE AS WOMEN ARE EXPECTED TO DRESS APPROPRIATELY AND PROFESSIONALLY ON OUR JOBS. WHEN WE LEAVE OUR HOMES, WE LIKE THE WAY WE LOOK. AND WE DESERVE TO BE RESPECTED. MEN SHOULD KEEP THEIR HANDS OFF. I FEEL COUNCILWOMAN GREEN HAS A RIGHT TO FEEL HARASSED AND DISRESPECTED BY COUNCILMAN JOHNSON AS AN INVASION OF HER PRIVACY. SHE IS MATURE ENOUGH TO KNOW WHEN SHE HAS BEEN PHYSICALLY AND MENTALLY ASSAULTED.

MANY WOMEN DON'T WANT TO SHARE PERSONAL UNPLEASANT EXPERIENCES
IN PUBLIC. WE COMMEND MS. GREEN FOR EXPOSING THIS INCIDENT. IF THIS KIND
OF ABUSE IS NOT REPORTED AND HANDLED APPROPRIATELY, IT WILL CONTINUE TO
OCCUR, AND THIS WOULD NOT ONLY BE A DISGRACE TO THIS LEGISLATIVE BODY, BUT
TO OUR CITY AS WELL. I AND MANY OTHER CITIZENS ARE OFFENDED THAT
COUNCILMAN DAN JOHNSON THOUGHT IT WAS OKAY TO TOUCH HIS FELLOW COUNCIL
MEMBER INAPPROPRIATELY. IT WAS NOT OKAY. AND SHOULD BE HANDLED AS A
VIOLATION THAT MERITS SERIOUS DISCIPLINE BY THIS METRO COUNCIL. THEREFORE,
WE CALL FOR AN APPROPRIATE AND IMMEDIATE DISCIPLINE FOR COUNCILMAN DAN
JOHNSON. WE BEG YOU TO DO THE RIGHT THING. THANK YOU FOR LISTENING TO MY
APPEAL.

[APPLAUSE].

MR. CLERK: ASHLEA CHRISTIANSEN

ASHLEA CHRISTIANSEN: HI. THANK YOU ALL SO MUCH FOR TAKING YOUR TIME. I AM A LOCAL ATTORNEY. I DON'T LIVE IN JEFFERSON COUNTY, FULL DISCLAIMER, BUT I HAVE FOR A LONG TIME. BUT I WANTED TO COME AND TALK TO YOU FOR A FEW MINUTES ABOUT MARSEY'S LAW. FIRST OF ALL AS A COURTESY AND SECOND OF ALL TO ASK FOR YOUR SUPPORT. THIS IS A MEASURE THAT WE ARE GOING TO PASS THROUGH THE LEGISLATURE DURING THE NEXT LEGISLATIVE SESSION AND I WANTED TO MAKE SURE THAT YOU ARE ALL AWARE OF IT. IT IS A VICTIMS RIGHTS MEASURE. WE ARE TRYING TO ELEVATE VICTIMS RIGHTS TO BE CONSTITUTIONAL IN NATURE. RIGHT NOW YOU'LL KNOW THAT VICTIMS HAVE STATUTORY PROVISIONS, STATUTORY RIGHTS IN PLACE IN KENTUCKY, WHEREAS MANY, MANY OTHER STATES, ALL BUT 15, HAVE CONSTITUTIONAL PROTECTIONS FOR VICTIMS. KENTUCKY IS ONE OF ONLY 15 THAT DOESN'T.

THIS IS SOMETHING THAT WE NEED TO WORK ON. SO WE ARE PREPARED TO DO THAT. WE ARE IN A GOOD POSITION TO GET THIS PASSED IN THE LEGISLATURE IN THE LEGISLATIVE SESSION. BUT WE NEED AS MUCH SUPPORT AS WE CAN GET, AND THAT'S WHY I WANTED TO COME HERE AND TALK TO YOU ALL. SOME OF THE RIGHTS THAT I'M REFERRING TO ARE THE RIGHT TO BE PRESENT IN THE COURTROOM. THE RIGHT TO NOTIFICATION. THE RIGHT TO BE HEARD AT SPECIFIC HEARINGS. AND WHEN I SAY SPECIFIC, I MEAN A BAIL HEARING OR SENTENCING HEARING. THE RIGHT TO NOTIFICATION IF AN OFFENDER IS RELEASED OR ESCAPES. AND SOME OF THESE THINGS YOU ARE PROBABLY THINKING, WELL, DON'T THOSE ALREADY HAPPEN?

IN MOST CASES, YES, THEY DO. BUT IN SOME CASES IT DOESN'T

ALREADY HAPPEN. SO THAT IS WHERE WE NEED TO GIVE CRIME VICTIMS THE ABILITY

TO HAVE STANDING IN THOSE CASES. AND THAT IS WHAT IS REALLY LACKING. SO IT

IS TWO THINGS. MARSEY'S LAW WILL GIVE VICTIMS CONSTITUTIONAL-LEVEL

PROTECTIONS. THAT IS PART ONE. AND PART TWO IS IT WILL GIVE VICTIMS

STANDING TO ASSERT ANY VIOLATION OF THEIR RIGHTS. SO THANK YOU SO MUCH FOR YOUR TIME. AND WE APPRECIATE ANY SUPPORT THAT YOU CAN PREVIEWED US -- THAT YOU CAN PROVIDE US.

MR. CLERK: MR. PRESIDENT, THAT CONCLUDES THE ADDRESSES TO COUNCIL.

PRESIDENT YATES: COUNCILWOMAN GREEN, WOULD YOU LIKE A POINT OF PERSONAL PRIVILEGE?

COUNCIL MEMBER GREEN: YES, THANK YOU, MR. PRESIDENT. I WANTED TO TAKE THE TIME TO EXPRESS MY EXTREME GRATITUDE TO PASTOR AWKARD, THE OTHER SPEAKERS AND ALL THE MEMBERS OF NEW ZION BAPTIST CHURCH AS WELL AS THE HUNDREDS OF INDIVIDUALS ACROSS THE CITY OF LOUISVILLE WHO HAVE CALLED ME, TEXTED ME, E-MAILED ME, AND STOPPED ME IN THE GROCERY STORE AND JUST SAID THAT THEY WERE PRAYING FOR ME. IT IS NOT ALWAYS EASY OR COMFORTABLE TO SPEAK UP, BUT I FELT THAT IT WAS THE RIGHT THING TO DO, AND IT WARMS MY HEART, AND I KNOW THAT I AM BLESSED TO HAVE THE PEOPLE OF GOD STANDING WITH ME. SO THANK YOU SO MUCH, AND GOD BLESS YOU ALL.

[APPLAUSE.]

PRESIDENT YATES: COUNCILMAN HOLLANDER, WOULD YOU PLEASE INTRODUCE YOUR GUESTS?

COUNCIL MEMBER HOLLANDER: THE LITERACY PROJECT IS A PROJECT
FUNDED WITH EAF DOLLARS IN PART. CAROL GUNDERSEN, THE EXECUTIVE DIRECTOR
OF THE PROGRAM, WHO IS BACK HERE, IS ACTUALLY A RESIDENT IN MY DISTRICT IN
DISTRICT 9. I BELIEVE ERIN IS AS WELL. THE FARM WHERE THIS ACTUALLY
HAPPENS IS IN COUNCILWOMAN PARKER'S DISTRICT. THE FOOD LITERACY PROJECT
PROVIDES FARM-BASED EXPERIENTIAL EDUCATION AND ENTREPRENEURIAL YOUTH
DEVELOPMENT PROGRAMS THAT BRING THE FIELD EXPERIENCE TO LIFE FOR LOCAL

YOUTH. IN A TIME OF GREAT CONCERN ABOUT THE SAFETY OF FOOD SOURCES, RISING OBESITY, AND DIABETES RATES AS WELL AS A CULTURAL DISCONNECTION BETWEEN OUR FOOD AND THE EARTH, THE FOOD LITERACY PROJECT OFFERS EDUCATIONAL PROGRAMS THAT FOSTERS HEALTHIER CHILDREN, COMMUNITIES, AND INCREASED RESPECT FOR THE LAND. ONE OF THE PROGRAMS AND THE ONE WE ARE GOING TO TALK ABOUT TONIGHT THAT IS OFFERED BY THE FOOD LITERACY PROJECT IS THE YOUTH COMMUNITY AGRICULTURAL PROGRAM WHICH CULTIVATES A NEW GENERATION OF LEADERS BY ENGAGING YOUTH IN GROWING AND COOKING AND MARKETING FRESH FOODS, EXPLORING THE FOOD SYSTEM AND BUILDING FOOD JUSTICE IN THE COMMUNITY.

THE PROGRAM INSPIRES YOUNG PEOPLE TO TAKE AN ACTIVE ROLE IN
THEIR FOOD SYSTEM AND CREATE A HEALTHIER COMMUNITY, AND ERIN HARGROVE, IF
YOU WANT TO INTRODUCE YOURSELF TO THE MEMBERS OF THE BODY.

ERIN HARGROVE: THANK YOU SO VERY MUCH FOR HAVING US. WE HAVE SEVERAL TEAMS TONIGHT THAT ARE HERE AND READY TO SHARE SOME OF THEIR EXPERIENCES WITH YOU THIS SUMMER ON THE FARM, AS COUNCIL MEMBER HOLLANDER MENTIONED. THIS IS A FIRST FOR ALL OF US. AS COUNCIL MEMBER HOLLANDER MENTIONED, THIS PROGRAM IS MEANT FOR THEM TO HAVE FULL EXPERIENCE OF LEARNING WHAT IT IS LIKE TO GROW FOOD ON THE FARM, HARVEST IT, PREPARE IT IN A KITCHEN, EAT IT, TALK ABOUT THE NUTRITION, BUT ALSO BUILD JOB SKILLS AND DEVELOP AS PEOPLE SO THEY CAN TAKE THESE SKILLS THEY HAVE ON THE FARM, WHETHER THAT IS AGRICULTURAL ENDEAVORS OR OTHER WORK. SO I HAVE THREE OF OUR 12 MEMBERS HERE TONIGHT. AND I'M GOING TO LET THEM INTRODUCE THEMSELVES. SO WE HAVE TEJA UP FIRST.

TEJA LEWIS: HI. MY NAME IS TEJA LEWIS AND THIS IS MY SECOND
YEAR. I LIVE IN THE SOUTHERN NEIGHBORHOOD BY U OF L. I LEARNED A LOT AT

CAMP. I LEARNED ABOUT NUTRITION AND HOW TO EAT A BALANCED MEAL, HOW TO KEEP ME FULL UNTIL MY NEXT MEAL SO I WOULDN'T SNACK. I ALSO LEARNED HOW TO PREPARE FOOD IN RESTAURANTS. I ALSO LEARNED WHEN YOU COOK SOMETHING IT DOESN'T HAVE TO BE PERFECT. SO IF IT DOESN'T TURN OUT WELL, THAT IS OKAY.

>> HELLO. I LIVE AROUND THE PARK HILL NEIGHBORHOOD. THIS IS MY FIRST YEAR WORKING AT YCAP. WORKING AT YCAP, I EXPERIENCED A LOT OF NEW THINGS. I ATE A LOT OF VEGETABLES AND LEARNED HOW TO COOK WITH THEM, GROW THEM. WORKING IN A TEAM. AND I MET NEW PEOPLE.

>> HI. MY NAME IS (INAUDIBLE) AND THIS IS MY FIRST YEAR IN YCAP.

I HAVE LEARNED A LOT IN YCAP THIS YEAR EVEN THOUGH IT IS MY FIRST YEAR.

WHAT I HAVE LEARNED THIS YEAR IS THAT, ONE OF THE THINGS, FRESH STOP AND

FARMERS MARKETS, FRESH STOP IS LIKE A FARMERS MARKET. PEOPLE WHO DON'T

HAVE ACCESS TO FRESH FOOD CAN GO TO FRESH STOP. IT IS LIKE A MARKET. AND I

WOULD LIKE TO THANK THE CREW MEMBERS AT THE FARMS. THEY ARE NOT ONLY OUR

TEACHERS BUT THEY ARE ALSO A FRIEND TO US. THEY ARE REALLY NICE AND THE

STAFF ARE REALLY NICE, AND I WOULD LIKE TO THANK ALL OF YOU GUYS WHO SET

THIS PROGRAM UP FOR US.

>> YEAH. JUST TO SAY ONE MORE THING. LIKE I SAID, THAT IS THREE OF THE 12 MEMBERS. ALL OF YOU GUYS ARE INVITED TO THE COMMUNITY MEALS.

NEXT FRIDAY THESE GUYS ARE PART OF THE SUMMER WORKS PROGRAM, SO THEY ARE PAID 30 HOURS A WEEK TO WORK ON THE FARM. NEXT FRIDAY IS THEIR LAST DAY.

IF YOU WOULD LIKE TO COME OUT AND SEE THE FARM AND MEET ALL THE REST OF THE CREW, WE WOULD LOVE TO HAVE YOU OUT. THANK YOU VERY MUCH FOR HAVING US.

COUNCIL MEMBER HOLLANDER: THANK YOU, COLLEAGUES, AND MR. PRESIDENT.

PRESIDENT YATES: THANK YOU, COUNCILMAN.

COUNCILWOMAN LEET, WOULD YOU PLEASE INTRODUCE YOUR GUEST.

AS INDIVIDUALS EXIT THE CHAMBERS, PLEASE DO SO QUIETLY SO THE NEXT COUNCILPERSON CAN INTRODUCE THEIR GUESTS.

COUNCIL MEMBER LEET: IT IS MY HONOR TO INTRODUCE CIVIL AIR

PATROL CADET REBECCA KRAMER. SHE WILL TRAVEL TO ISRAEL JULY 18TH THROUGH

AUGUST 2ND, A LITTLE UNDER A WEEK FROM TODAY TO JOIN OTHER TEENAGERS IN AN

EFFORT TO PROMOTE GOODWILL AND FRIENDSHIP BETWEEN FUTURE LEADERS. REBECCA

JUST RECENTLY GRADUATED FROM DUPONT MANUAL HIGH SCHOOL AND JOINED THE

CIVIL AIR PATROL WHEN SHE WAS 12. AFTER SPARKING AN INTEREST THROUGH THE

AVIATION CLUB AT BARRETT MIDDLE SCHOOL. REBECCA IS ONE OF ONLY 36 YOUNG

PEOPLE IN THE UNITED STATES TO BE SELECTED FOR THIS YEAR'S EXCHANGE. THE

SELECTION PROCESS IS VERY COMPETITIVE AND BEING SELECTED MEANS THAT

REBECCA HAS SHOWN MATURITY FAR BEYOND HER AGE AND THAT SHE IS A TRUE

LEADER IN OUR COMMUNITY.

IN FACT, IN ORDER TO EVEN APPLY FOR THE PROGRAM, APPLICANTS MUST HAVE EARNED THE AMELIA EARHART AWARD IN THE CIVIL AIR PATROL CADET PROGRAM, WHICH LESS THAN 5% OF ALL CADETS COMPLETE. THE INTERNATIONAL AIR CADET EXCHANGE WAS STARTED AFTER WORLD WAR II TO PROMOTE GOODWILL AND FRIENDSHIP BETWEEN YOUNG MEN AND WOMEN WHO WOULD GO ON TO BECOME LEADERS IN THE COUNTRY. BUT IT IS A LONGTIME ALL-VOLUNTEER U.S. AIR FORCE

CONSISTS OF THE REGULAR AIR FORCE, AIR NATIONAL GUARD AND AIR FORCE
RESERVE ALONG WITH AIR FORCED RETIRED MILITARY AND CIVILIAN EMPLOYEES.

THE CIVIL AIR PATROL OPERATES A FLEET OF 550 AIRCRAFT AND PERFORMS ABOUT 90% OF CONTINENTAL U.S. INLAND SEARCH AND RESCUE MISSIONS AS TASKED BY THE AIR FORCE RESCUE COORDINATION CENTER SAVING AN AVERAGE OF 78 LIVES ANNUALLY. THE CIVIL AIR PATROL'S 56,000 MEMBERS MAKE THESWIDE ALSO PERFORMS HOMELAND SECURITY, DISASTER RELIEF, AND MISSIONS AT THE REQUEST OF FEDERAL, STATE, AND LOCAL JURISDICTIONS. THEY PLAY A LEADING ROLE IN AEROSPACE EDUCATION AND SERVE AS MENTORS TO THOUSANDS OF YOUNG PEOPLE SERVING IN THE AIR PATROL CADET PROGRAM. THIS IS AN ENORMOUS HONOR FOR REBECCA AND A TRUE TESTAMENT TO HER COMMITMENT FOR SERVICE BEFORE SELF. SHE WILL ATTEND THE ROSE HOLMAN INSTITUTE OF TECHNOLOGY AND PLANS TO STUDY CIVIL ENGINEERING. YAY, CIVIL ENGINEERING.

HER GOAL IS TO BECOME AN OFFICER IN THE UNITED STATES AIR FORCE. CONGRATULATIONS TO REBECCA, HER PARENTS, AND HER GRANDPARENTS AND SISTER ARE HERE. WE HAVE LOTS OF FAMILY AND COULDN'T HAVE DONE IT WITHOUT HER FAMILY'S SUPPORT. WE HAVE A PROCLAMATION FOR YOU TODAY AS WELL AS A LAPEL PIN TO COMMEMORATE SO YOU CAN WEAR IT IN ISRAEL AND THEY WILL KNOW WHERE LOUISVILLE IS. THANK YOU SO MUCH FOR YOUR SERVICE AND FOR YOUR LEADERSHIP IN OUR COMMUNITY.
