Application is hereby made to Louisville Gas and Electric Company to extend or modify its system as described below, in accordance with its standard Rules, Regulations, and Practices.

Location and Nature of Project: 17709 DIXIE HWY

LG&E to perform 1 bore, hang 3 overhead transformers and replace pole per customer's request.

Applicant understands that the estimate of the portion of the cost for which applicant is responsible is determined as follows. Applicant further understands that unless this application is made on or before <u>Aug 28, 2017</u> these costs are subject to change by Company.

Total Applicant's cost \$ 4.923.00

Applicant agrees to pay the above portion of the cost <u>as estimated</u> and will pay the amount of \$**4,923.00** UPON RETURN OF THIS APPLICATION.

Where rock is encountered which cannot be removed with convention trenching equipment, the Applicant shall pay to the Company an additional charge of \$176.00 per cubic yard of rock removal or the actual additional charges which the Company pays to its contractor for such rock removal, whichever is the lesser. This charge will be billed as the costs are incurred by Company with final billing after completion of the work.

It is understood that all work is subject to delays due to shortage of labor and material or to other causes beyond the control of the Company.

Applicant further understands that the performance of Company's undertaking is contingent upon its obtaining all necessary easements, rights-of-way and any other permits.

Upon acceptance by Company, this application shall become a contract between Applicant and Company and shall be subject to the Rules and Regulations of the Public Service Commission of Kentucky and to any others or directives of said Commission or of other governmental body having jurisdiction in the premises.
