PRESIDENT YATES: THE REGULAR LOUISVILLE METRO COUNCIL MEETING OF SEPTEMBER 14, 2017, WILL PLEASE COME TO ORDER. PLEASE RISE FOR THE PLEDGE OF ALLEGIANCE TO THE FLAG.

CLERK WILL ROLL CALL, PLEASE.

MR. CLERK: [ROLL CALL.]

MR. PRESIDENT, WE HAVE 23 IN ATTENDANCE, AND A QUORUM.

PRESIDENT YATES: THANK YOU, MR. CLERK.

>> I HAVE THE PLEASURE OF INTRODUCING MALCOLM OLIVER ISAAC -- SOME OF HIS FAVORITE STUDIES ARE SOCIAL STUDIES, ENGLISH, AND ART. HE LOVES TO READ AND PLAY BASEBALL. HE PLAYED AT LINDEN SINCE HE WAS SIX YEARS OLD. HE ALSO LIKES TO PLAY VIDEO GAMES. HIS CURRENT FAVORITE HAVE A GAME IS UNTURNED. HE ALSO LIKES TO DESIGN THINGS ON THE COMPUTER AND HE LIKES TO PLAY BASEBALL. MALCOLM OLIVER HAS LIVED IN DISTRICT 9 ALL OF HIS LIFE. HE ATTENDED CHENOWETH ELEMENTARY AND NOW ATTEND MIDDLE SCHOOL WITH ISAAC. CURRENTLY, HE WAS CONSIDERING A CAREER IN INTERNET OR ENGINEERING TECHNOLOGY.

HE VOLUNTEERS WITH ADULTS WITH DISABILITIES, SO WE MUST HAVE BEEN NICE TO MALCOLM'S OLDER BROTHER. HE WAS ALSO A PAGE FOR THE 9TH DISTRICT, AND HIS BROTHER DECIDED HE WANTED TO COME BACK AND DO IT, ALSO. WELCOME, ISAAC AND MALCOLM.

PRESIDENT YATES: MR. CLERK, ARE THERE ANY PEOPLE WHO WISH TO ADDRESS THE COUNCIL.

MR. CLERK: YES, THERE ARE.

PRESIDENT YATES: LET ME REMIND YOU TO RESPECT THE COUNCIL AT ALL TIMES AND THERE IS NO USE OF PROFANITY. CLERK PLEASE CALL THE FIRST SPEAKER.

MR. CLERK: LISA WEAVER. FEEL FREE TO ADJUST THE MIC.

LISA WEAVER: I THANK THE COUNCIL FOR LETTING ME SPEAK THIS EVENING. I APOLOGIZE. I HAVE A COLD, SO I MIGHT NEED TO TAKE A PAUSE AND JUST BREATHE. I'M HERE TO TALK TO YOU ABOUT THE COMMUNITY MUSIC PARTNERSHIP, ALSO KNOWN AS THE CMP FUND. I'VE GIVEN YOU A RED FOLDER THAT I'VE PUT TOGETHER THAT HAS SOME INFORMATION IN IT ABOUT THE CMP. I KNOW SOME OF YOU ALREADY KNOW ABOUT THE CMP AND UTILIZE IT QUITE A BIT, AND WE APPRECIATE IT, BUT SINCE IT'S BEEN A FEW YEARS THAT SOMEONE FROM THE MUSICIAN FUND HAS COME TO SPEAK TO YOU, I THOUGHT I WOULD COME AND SPEAK TO YOU. THE FUND IS A SEPARATE FUND OF \$30,000 DIRECTLY TO PROVIDE MUSIC TO THE CITIZENS OF LOUISVILLE COUNTY. IT IS STRICTLY SET ASIDE JUST FOR FREE MUSIC WITHIN THE COMMUNITY. THE MONEY WAS DIVIDED EQUALLY AMONG BETWEEN THE 26 DISTRICTS. THAT MEANS EACH OF YOU HAS ABOUT \$1153 AND CHANGE EACH YEAR TO SPEND.

OKAY. IN THE PACKET THAT I'VE GIVEN YOU, THERE'S A BRIEF HISTORY OF THE CMP, JUST TO FAMILIARIZE YOURSELF. ALSO, THERE'S A LIST OF DIFFERENT COMPANIES THROUGHOUT THE CITY THAT HAVE UTILIZED THE CMP TO HAVE FREE MUSIC PROVIDED AT THEIR EVENT. ON THE RIGHT SIDE OF THE PACKET IS THE PAPERWORK USED TO GET MUSIC FROM THE CMP, JUST IN CASE YOU'VE NEVER SEEN IT. THE YELLOW BROCHURE IS ALL THE MUSICIANS AND BANDS THAT WILL PARTICIPATE IN THE CMP. THE CMP USES A PUBLIC SERVICE SCALE, SO THESE MUSICIANS HAVE ALL AGREED TO PLAY AT A REDUCED RATE BECAUSE IT'S A

COMMUNITY SERVICE THAT THEY OFFER, AND THAT BROCHURE, LIKE I SAID, IS ALL THE DIFFERENT GROUPS THAT WE HAVE. YOU CAN SEE WE HAVE EVERYTHING FROM JAZZ AND EASY LISTENING TO ROCK AND FUNK AND, YOU KNOW, COUNTRY; EVERYTHING.

OKAY. ANY ORGANIZATION IN THE CITY CAN APPLY FOR CMP FUNDING. THE ONLY CRITERIA IS THAT THEIR EVENT MUST BE -- OR AT LEAST THE MUSIC PORTION OF THE EVENT MUST BE FREE AND OPEN TO THE PUBLIC, AND IT MUST BE WITHIN RURAL JEFFERSON COUNTY. THE WAY THAT IT WORKS IS AN ORGANIZATION FILLS OUT THE REQUEST FORM THAT'S ON YOUR RIGHT SIDE, AND TURNS IT INTO THE COUNCIL MEMBER OF THE DISTRICT FOR WHICH THE EVENT IS TAKING PLACE. I HOPE THAT WHEN YOU SEE THESE FORMS COME THROUGH, THAT YOU WILL CONSIDER ALLOCATING FUNDING. ON THE BACK, ON THE RIGHT SIDE -- DOES THAT MEAN MY TIME IS UP?

PRESIDENT YATES: FINISH YOUR SENTENCE.

LISA WEAVER: OKAY. ON THE RIGHT HAND THERE IS A FORM THAT IS GOING TO SHOW YOU WHAT IS WHAT IT'S GOING TO COST FOR EACH BAND. I JUST WANT TO SAY, IN CLOSING, THAT I HAVE LEFT MY CARD, AND IF YOU HAVE ANY QUESTIONS, PLEASE FREE TO CALL ME.

MR. CLERK: NADA LOUTFI.

NADA LOUFTI: I APPRECIATE YOU LETTING ME SPEAK AGAIN. I WAS HERE LAST YEAR TO SPEAK, AND I APPRECIATE YOU THE OPPORTUNITY TO SPEAK AGAIN. MY LIFE IN LOUISVILLE HAS BEEN DEDICATED TO BRINGING MUSIC TO EVERYONE. IT'S IMPORTANT. I'M AN EDUCATOR, AND I VOLUNTEER, INCLUDING TO MY OWN ORGANIZATION, AND I HAVE DISTRIBUTED A PAPER TO ALL OF YOU THAT IS DESCRIBING OUR NEXT PROJECT. SOME OF US REQUESTED MUSIC FROM THE CMP FUND LAST YEAR. WE WERE IN DISTRICT 8, AND WE DID RECEIVE SOME REPORT. WE ARE

NOW IN DISTRICT 5, AND WHAT I PLAN TO DO IN DISTRICT 5 IS ONE OF THE THINGS THAT WE ARE INTENDING TO ORGANIZE THIS NEW PROJECT. IT WOULD BE AWESOME BECAUSE IT IS OPEN TO EVERYONE, AND THE THING THAT I FEEL PERSONALLY TOO IMPORTANT IS TO BRING HIGH QUALITY ARTISTIC QUALITY -- OF COURSE I AM A CLASSICAL MUSICIAN, BUT CLASSICAL MUSIC TO ME IS THE HEART OF THE SONG. MUSIC IS THE CLASSIC UNIVERSAL LANGUAGE THAT PEOPLE CAN TALK AND FEEL.

I VOLUNTEER, AND AS THE SECRETARY OF SOMEBODY WHO LOVES MUSIC, I WANT TO ASK THE COUNCIL MEMBERS TO PLEASE CONSIDER SUPPORTING OUR BIG PROJECT THIS YEAR AT THE FAULKNER GALLERY IN DISTRICT 5, WHICH WILL BE BRAHM'S CONCERTO NUMBER 2. WE NEED MONEY FOR THAT, AND IT'S FREE, IT'S OUR END OF YEAR CONCERT. THAT WILL HAPPEN ON DECEMBER 29TH, SO I HAVE REQUESTED FROM ALL OF YOU. I HAVE ALREADY SENT MY MATERIAL, AND I HOPE YOU WILL CONSIDER SUPPORTING ME. WE HAVE A LOT OF FUNDRAISERS, AND I AM ASKING FOR SOME GRANTS AS A MATTER OF FACT, BECAUSE AS YOU CAN SEE ON THE REVERSE PAGE THAT I GAVE YOU, THIS IS GOING TO COST US A LOT, SO WE ARE ALREADY SECURING SOME FUNDS, AND I HOPE THAT YOU WILL MAKE LOUISVILLE A STRONGER PLACE BY HELPING THE ARTS AND HELPING THE GREAT CLASSICAL MUSIC THAT WE NEED TO SPREAD MORE, ESPECIALLY WHEN AN UNDER SERVED AREA LIKE WHERE THE FAULKNER GALLERY IS LOCATED, AND I THINK THE WEST OF LOUISVILLE, TO BRING MORE MUSIC, I THINK IT WILL BE GREAT.

WE WILL, AND I KNOW LAST YEAR, WE ALREADY DID, ATTRACT PEOPLE FROM ALL OVER THE KENTUCKIANA, BECAUSE I AM A D.J., AND AS A RADIO D.J., I ANNOUNCED ALL OF MY EVENTS, AND I KNOW THIS YEAR, IT'S ALREADY IN THE PAPERS, AND I KNOW WE WILL DO A GREAT JOB OF ATTRACTING PEOPLE FROM

EVERYWHERE, SO I HOPE WE WILL HAVE YOUR SUPPORT AGAIN. I GUESS MY TIME IS UP. THANK YOU VERY MUCH.

MR. CLERK: CHRISTINE CALACSAN. YOU CAN ADJUST THE MIC.

CHRISTINE CALACSAN: THANK YOU. BEFORE I BEGIN, I WOULD LIKE TO GIVE THE COUNCIL AND PRESIDENT YATES SOME LETTERS. MY NAME IS CHRISTINE CALACSAN, AND I LIVE IN DISTRICT 8. I AM A SECOND YEAR LAW SCHOOL AT THE UNIVERSITY OF LOUISVILLE, AND I WILL BE SPEAKING IN FAVOR OF SANCTUARY CITIES. [INAUDIBLE] IN REGARDS TO WHAT STATE AND FEDERAL GOVERNMENT CAN AND CANNOT DO. THIS IS WHY IT IS ESPECIALLY IMPORTANT THAT WE INTERPRET NEW LAWS WITH EXTRA PRECAUTION, ESPECIALLY THEY INVOLVE THE INFRINGEMENT OF INDIVIDUAL RIGHTS PROTECTED BY THE CONSTITUTION. IF WE DECIDE NOT TO TAKE ACTION AND COMPLY -- FORCED TO COMPLY WITHOUT REASON, WE CAN TEAR FAMILIES APART OUT ANY JUSTIFICATION, AND VIOLATE INDIVIDUAL RIGHTS. FOR EXAMPLE, THERE IS NO SINGLE LEGAL DEFINITION OF SANCTUARY CITIES OR SANCTUARY JURISDICTION. THE EXECUTIVE ORDER 13768 WAS -- [INAUDIBLE] -- 1373, AUSC 1373(A) ONLY LIMITS STATE LAWS THAT LIMIT THINGS ABOUT INFORMATION OF IMMIGRATION OF INDIVIDUALS OR INDIVIDUALS' STATUS. -- [INAUDIBLE] -- WHICH IS DIFFERENT FROM CITIZENSHIP OR IMMIGRATION STATUS AND IS NOT MENTIONED IN THE STATUTES AT ALL. THIS IS FURTHER REINFORCED OF A CASE IN WHICH A U.S. CITIZEN WAS WRONGFULLY DETAINED AFTER BEING ARRESTED AND WAS SUPPOSED TO BE RELEASED, BUT THE COUNTY BELIEVED IT WAS MANDATORY TO KEEP HIM THERE UNTIL ICE FURTHER INVESTIGATED. HERE WE SEE A VIOLATION OF HIS FOURTH AMENDMENT RIGHTS, DUE PROCESS, AND WHICH THE COURT DETERMINED THERE WAS NO FURTHER CAUSE FOR HIM TO BE DETAINED IN THE FIRST PLACE.

THESE DETAINER WERE NOT STATES AT MANDATORY BUT IT WAS SIMPLY A REQUEST. ADDITIONALLY -- [INAUDIBLE] -- ARE EXERCISING THEIR ABUSED CONSTITUTIONAL AUTHORITY -- [INAUDIBLE] -- ALMOST 600 COUNTIES ACROSS THE COUNTRY ENFORCE SOME TYPE OF SANCTUARY POLICY. CITY COUNCILS AROUND THE COUNTRY RECOGNIZE THAT LOCAL RESOURCES, CITY POLICE, DISTRICT ATTORNEYS SHOULD NOT BE PUTTING THEIR LIMITED RESOURCES BEHIND FEDERAL IMMIGRATION ENFORCEMENT AND ENSURE THAT PEOPLE FEEL SAFE AND CAN TRUST LOUISVILLE LAW ENFORCEMENT. -- [INAUDIBLE] -- I HOPE TO SEE THAT I HONOR THIS REQUEST AND VOTE IN FAVOR OF MAKING LOUISVILLE A SANCTUARY CITY, AND IN CLOSING, I WOULD LIKE TO RECOMMEND EVERYBODY HERE TO PARTICIPATE AND KNOW YOUR RIGHTS AS -- [INAUDIBLE] -- AND UNDERSTAND WHY THIS ORDINANCE IS NECESSARY FOR LOUISVILLE.

MR. CLERK: RUSS READ.

RUSS READ: GOOD EVENING. MY NAME IS RUSS READ, AND I'M THE FOUNDER OF THE KENTUCKY HARM REDUCTION COALITION. COUNCIL MAN YATES AND HONORED COUNCIL MEMBERS, I'M HERE TO TELL YOU A LITTLE BIT ABOUT THE BEACON HOUSE THAT PROVIDES THINGS TO HELP ABOUT 50 MEN RECOVER FROM ADDICTION AND TREATMENT. AS I MENTIONED I'M ALSO THE FOUNDER OF THE KENTUCKY HARM REDUCTION COALITION, AND WE ARE TO ENGAGE, AND EMPOWER THE COMMUNITY WITH HARM REDUCTION TECHNIQUES, INCLUDING THE TRAINING AND DISTRIBUTION OF NALOXONE AND NARCAN.

THANK YOU FOR RECOGNIZING THAT ADDICTION IS A DISEASE, THAT IT MUST BE TREATED AS SUCH, AND THAT IT AFFECTS THE ENTIRE COMMUNITY. THANK YOU FOR YOUR SUPPORT OF THOSE MEASURES THAT HELP FIGHT THE DISEASE OF ADDICTION IN OUR COMMUNITY. THANK YOU FOR KNOWING THAT ADDICTION TOUCHES THE LIVES AND WELL-BEINGS OF ALL: FAMILIES, FRIENDS, CO-WORKERS, BROTHERS,

SISTERS, MOMS, DADS, REGARDLESS OF ETHNICITY, RELIGION, CULTURE, SOCIAL STATUS, EDUCATION, OR CAREER. ADDICTION IS PREVALENT IN ALL PARTS OF OUR COMMUNITY AND HOLDS NO BIAS TO ANY PART OF OUR TOWN. THANK YOU TO ALL THOSE WHO HAVE SPONSORED A NALOXONE OR NARCAN TRAINING IN YOUR DISTRICT. YOU HAVE HELPED TO SAVE LIVES.

THE PURPOSE OF MY APPEARANCE HERE TODAY IS TO INTRODUCE THE ROLE OF BEACON HOUSE TO THE COUNCIL. WE TEACH OUR MEN THE NECESSARY LIFE, RELATIONSHIP AND RECOVERY SKILLS TO ENABLE THEM TO TRANSITION INTO A SELF-DIRECTED AND INDEPENDENT LIFE IN LONG-TERM RECOVERY. OUR MEN LEAVE AFTER EIGHT TO 12 MONTHS KNOWING EXACTLY WHERE THEY ARE GOING TO GO, WHAT THEY ARE GOING TO DO, AND HOW THEY ARE GOING TO DO IT. OUR PROGRAM REDUCES OR ELIMINATES THE FEAR THAT DRIVES MOST PEOPLE IN ADDICTION BACK TO DANGEROUS PEOPLE, PLACES, AND THINGS. WE HAVE DEVELOPED A SUCCESSFUL MODEL TO HELP MEN IN RECOVERY THROUGH A RECENT STRATEGIC PLAN AND FEASIBILITY STUDY WE HAVE IDENTIFIED A RECENT TREATMENT RAMP IN OUR COMMUNITY. THERE IS NO TREATMENT FACILITY FOR WOMEN IN LOUISVILLE, TO ENABLE THEM TO TRANSITION INTO A PURPOSEFUL AND PRODUCTIVE LIFE FOR THEMSELVES AND THEIR FAMILIES. THEREFORE, WE INTEND TO LAUNCH A TRANSITIONAL CAMPAIGN TO OPEN A FACILITY FOR WOMEN.

WE HOPE WE CAN COUNT ON THE LOUISVILLE METRO COUNCIL IN HELP WITH OUR PLANS. WE WILL PROVIDE A COMPREHENSIVE ADDICTION TREATMENT FOR THOSE WITH THIS DISEASE. I APPRECIATE THE TIME I'VE SPENT WORKING WITH YOU TO HELP FIGHT THIS DISEASE OF ADDICTION. THANK YOU.

MR. CLERK: MARGARET SITES.

MARGARET SITES: HELLO. I ALSO HAVE -- [INAUDIBLE] --

GOOD AFTERNOON. THANK YOU FOR YOUR TIME. MY NAME IS MARGARET SITES. I LIVE IN METRO DISTRICT 7, AND MY COUNCIL MEMBER IS ANGELA LEET. I'M HERE TO SPEAK IN FAVOR OF DECLARING GLOBAL SANCTUARY CITIES, AND SPECIFICALLY ASK FOR A TANGIBLE WRITTEN COMMITMENT THAT LOUISVILLE METRO COUNCIL GOVERNMENT WILL NOT SIGN ANY -- [INAUDIBLE] -- AND LOCAL AND STATE POLICE DEPARTMENTS THAT ALLOW ICE TO DELEGATE AUTHORITY WITHIN THE JURISDICTION TO DEPUTIZE LOCAL POLICE. IN THE CURRENT FEDERAL CLIMATE THERE HAS BEEN AN INCREASE IN 287 G. AGREEMENTS, BUT WE SHOULD NOT FOLLOW IN THIS DANGEROUS PATH ALLOWING THE FEDERAL GOVERNMENT TO COME IN AND TAKE OVER OUR LOCAL POLICE FORCE THAT OWES THE DUTIES FIRST AND FOREMOST TO THE LOCAL COMMUNITY. JUST ONE WEEK AGO ON SEPTEMBER 7TH, WHICH -- [INAUDIBLE 1 -- FORMAL AGREEMENT.

IF YOU HAVE NOT READ THE KENTUCKY CENTER FOR INVESTIGATIVE REPORTING ON THE ISSUE, I ENCOURAGE YOU TO DO SO. IN ONE HEARTBREAKING INSTANCE -- [INAUDIBLE] -- WHILE HIS TWO YOUNG DAUGHTERS CRIED. THIS IS NOT THE JOB OF LMPD. THOSE ARE CIVIL OFFENSES AND SHOULD BE ENFORCED BY THE PROPER CIVIL AGENCIES. [INAUDIBLE] -- BUT A WRITTEN COMMITMENT BY THE METRO GOVERNMENT NOT TO SIGN 287 D AGREEMENTS IS A TANGIBLE STEP THAT THE COUNCIL CAN TAKE -- [INAUDIBLE] -- AND INDEPENDENT OF UNNECESSARY FEDERAL ICE OVER SIGHT IS CRUCIAL TO ENSURING OUR LOCAL POLICE IS PROTECTING OUR COMMUNITY IN A LARGER AND RESPECTFUL WAY. WE ALREADY KNOW THAT POLICE RELATIONS ARE STRAINED, AND WHEN PEOPLE LIVE IN FEAR THAT LMPD IS AN AGENT OF ICE, A FEW THINGS HAPPEN.

FIRST OF ALL, CRIME GOES UP, AND WHEN PEOPLE LIVE IN FEAR OF NOT REPORTING A CRIME FOR FEAR THEY MIGHT BE DEPORTED, THEY DON'T CALL IN THE CRIME -- [INAUDIBLE] . IT IS TIME FOR US TO ACCOUNT A. THIS ISN'T A BLACK

OR BROWNISH. WE, ESPECIALLY THOSE THAT LIVE IN THE CITY, HAVE TO SHED OUR FEARS, AND OPEN OUR EYES AND RECOGNIZE OUR RESPONSIBILITY -- [INAUDIBLE] -- IN A MILLION DIFFERENT WAYS, OUR NEIGHBORS, CLASSMATES, CO-WORKERS, FRIENDS AND FAMILY, WE HAVE TO -- WE HAVE TO SAY, WE SUPPORT YOU, WE ARE HERE FOR YOU, AND DO WHAT WE NEED TO DO TO FULFILL THAT RELATIONSHIP IN OUR HOMES AND IN OUR COMMUNITIES. THANK YOU.

MR. CLERK: CONNIE MARSHALL.

CONNIE MARSHALL: MY NAME IS CONNIE MARSHALL, MY WEBSITE IS WWW.JUSTICEFORALLCITIZENS.COM. MY TOPIC IS HATE CRIMES -- [INAUDIBLE] -- BY LOUISVILLE GAS AND ELECTRIC COMPANY AND STAFFING. OVER FIVE YEARS, I HAVE BEEN BEGGING LOUISVILLE METRO COUNCIL -- [INAUDIBLE] -- I ALSO PROVIDED METRO COUNCIL WITH COPIES OF A BOOK I COMPILED WITH EVIDENCE OF THE CRIME. THE BOOK WAS ALSO SENT BY REGISTERED MAIL TO THE F.B.I. AND BY CERTIFIED MAIL TO THE D.O.J. THE BOOK CONTAINED 16 OF THE 30 DEATH THREATS, DEE GRADATION BY E-MAIL, CALLING ME THE N WORD, CALLING PAST PRESIDENT OBAMA THE N WORD, CALLING ME A SLAVE, TELLING ME I WILL BE KILLED -- [INAUDIBLE] FOUR FABRICATED PLEADING WITH MY FORGED SIGNATURE -- [INAUDIBLE] -- 25 CALLS, CALLING ME THE N WORD, ETCETERA -- [INAUDIBLE] -- PICTURES REFERENCING ME OF A WOMAN'S BLOODY TORSO, AND A PERSON BEING SMASHED IN THE STREET BY A GARBAGE TRUCK. ALSO, A FABRICATED E-MAIL WITH MY FORGED SIGNATURE WAS SENT TO A GENTLEMAN AT LOUISVILLE GAS AND ELECTRIC, THREATENING TO KILL HIM. WHAT'S INTERESTING IS TWO DAYS BEFORE THIS WAS SENT, I POSTED ON MY WEBSITE AND YOUTUBE ILLEGAL ACTS AGAINST ME.

TWO DAYS LATER, THE POLICE WERE BANGING ON ME DOOR, ACCUSING ME OF SENDING THIS E-MAIL. [INAUDIBLE] -- THERE IS ALSO EVIDENCE OF

COLLUSION OF LOUISVILLE STAFF OF THE METRO POLICE -- [INAUDIBLE] -- WHICH I DID EVENTUALLY GET. LAST NIGHT, THE POLICE WERE BANGING ON MY DOOR ACCUSING OF SENDING AN E-MAIL TO LOAN STAFFING, WHICH I DID NOT PROVIDE. -- WHOM THE POLICE STATED -- MY EVIDENCE PROVES THAT THE POLICE HAVE ATTEMPTED AT LEAST SEVEN TIMES TO SET ME UP AND WAS THWARTED BECAUSE I VIDEOTAPED, RECORDED -- [INAUDIBLE] -- THEY DECIDE TO ACCUSE ME OF? ANSWER: I'LL TELL YOU WHY BECAUSE THEY ARE INVOLVED IN PRODUCING THESE FABRICATED DOCUMENTS AND COMMITTING THE CRIMES. THEY FAILED, AND THEY DON'T NEED TO INVESTIGATE THE CRIMES THAT THEY HAVE ACCUSED ME OF COMMITTING. IN CLOSING -- [INAUDIBLE] -- COMMITTED BY THE LOCAL METRO POLICE. THANK YOU.

MR. CLERK: SOPHIA CALLEJA.

SOPHIA CALLEJA: HELLO. BEFORE I BEGIN, I ALSO HAVE SOME LETTERS FOR COUNCIL AND PRESIDENT YATES FROM -- [INAUDIBLE]. HELLO, COUNCIL MEMBERS. MY NAME IS SOPHIA CALLEJA. I LIVE IN THE 6TH DISTRICT, AND MY COUNCIL MAN IS DAVID JAMES. I'M A LAW STUDENT AS WELL AS A GRADUATE STUDENT AT THE KENT SCHOOL OF SOCIAL WORK. I'M ALSO ONE OF THE 6,000 PEOPLE IN LOUISVILLE THAT HAVE BENEFITED UNDER THE PROTECTION OF DACA. I HAVE NOT, NOR HAVE I EVER BEEN ELIGIBLE FOR FEDERAL AID, AND BY HARD WORK, I'VE MANAGED TO GET THROUGH THE UNIVERSITY OF KENTUCKY, AS WELL AS TWO YEARS OF GRADUATE-LEVEL EDUCATION SET FREE. HAVING DACA ALLOWED THIS TO BE POSSIBLE BY ALLOWING ME TO FUND MY EDUCATION.

LAST YEAR, WHEN PRESIDENT TRUMP -- [INAUDIBLE] -- DACA, IT FELT LIKE MY WORLD WAS CRASHING DOWN. I COME TO AN INSTITUTION THAT HAS PROVIDED AN ENORMOUS AMOUNT OF SUPPORT. HOWEVER, NOT EVERYONE HAS THIS PRIVILEGING TO FEEL SAFE IN THE ENVIRONMENT. MY COMMUNITY IS HURTING, AND

FAMILIES ARE AFRAID. THEY'RE BEING TORN APART. CHILDREN ARE BEING TRAUMATIZED, NOT ONLY BY THE POISONOUS RHETORIC THAT'S THREATENING THEIR EXISTENCE AND THEIR FAMILIES AND LOVED ONES, BUT ALSO FAR FOR LOSING THEIR KIDS, PARENTS, AND FAMILY MEMBERS. [INAUDIBLE] -- I CARE ABOUT THE POLICIES THAT THE CITY OF LOUISVILLE IS GOING TO IMPLEMENT TO ENSURE THAT FAMILIES ARE SAFE AND UNTOUCHED. [INAUDIBLE] -- AS A COMPASSIONATE CITY, OTHERWISE, THEY ARE EMPTY WORDS.

I STAND HERE BEFORE YOU TODAY IN A VULNERABLE STATE -- ENSURE THAT THE POLICE DEPARTMENT IS FULFILLING THEIR DUTY TO SERVE AND PROTECT EVERYONE DESPITE THEIR IMMIGRATION STATUS. THE COLLABORATION OF LMPD WITH ICE BLURS THOSE LINES AND MAKES POPULATIONS THAT IS ALREADY VULNERABLE MORE LESS LIKELY TO REPORT CRIME AND AVOID LAW ENFORCEMENT. WE CANNOT AFFORD THAT. IT IS NOT JUST AN IMMIGRANT ISSUE, IT AFFECTS EVERYONE, AND THOSE DEMOCRATIC MEMBERS NOT WILLING TO STEP UP AND FAVOR A POLICY THAT WILL SAVE FAMILIES, YOU HAVE ALREADY LOST, AND I ASK YOU, WHAT DO YOU STAND FOR? ONE THING IS FOR SURE, MY COMMUNITY IS HURTING, BUT THEY'RE NOT BROKEN. WE ARE RESILIENT PEOPLE, AND WE WILL KEEP FIGHTING FOR OUR RIGHT TO EXIST AS I MY PARENT FOUGHT FOR MINE. ARE YOU GOING TO CONTINUE TO FIGHT FOR OUR RIGHTS OR CONTINUE TO STAND ON THE SIDE OF THE OPPRESSOR. THANK YOU.

MR. CLERK: PAUL LENZI.

PAUL LENZI: PRESIDENT YATES, MEMBERS OF THE METRO COUNCIL, THANK YOU FOR THIS OPPORTUNITY TO ADDRESS YOU TODAY. MOST OF YOU ARE FAMILIAR WITH ME. I'VE BEEN COMING HERE ABOUT THIS TIME EVERY YEAR, ASKING FOR SUPPORT OF OUR PROGRAMS. PROFESSIONAL MUSICALS THAT WE SUPPORT. THIS YEAR, I'M HERE TO SPEAK FOR OUR GROWING PRODUCTION OF RED RIDING HOOD.

I'M HERE WITH -- [INAUDIBLE] -- AND I'M DELIGHTED SHE'S TALKING THE HELM OF THESE PRODUCTIONS. AS YOU KNOW, OUR SHOWS -- OUR RED RIDING HOOD IS SET IN LOUISVILLE IN THE 20'S. ALL THE MUSIC IS JAZZ, BLUES, AND INSTEAD OF RED GOING THROUGH THE WOODS TO GET GRANNY, OUR RED HAS TO GO THROUGH OUR CENTRAL PARK. ALONG THE WAY, SHE MEETS A TIRED VAUDEVILLE PERFORMER, MR. WOLFY. YOU KNOW EXACTLY HOW THE STORY IS GOING TO TAKE PLACE. WE DON'T MESS WITH THOSE, BUT THE HERO OF THE PIECE IS OFFICER O'MALLEY, A COP ON THE BEAT, SO THIS YEAR, WE'RE REALLY PLEASED TO BE PARTNERING WITH LMPD, AND WITH ALL OF OUR PRODUCTIONS, WE'RE GOING TO HAVE POLICE OFFICERS FROM THE COMMUNITY COME SPEAK TO THE KIDS AFTER THE SHOW, AND IN SOME CASES, THEY'LL BE COMING BACK FOR DAYS AFTER TO GO IN THE CLASSROOM TO TALK TO THE KIDS, TO START TO BUILD THAT RELATIONSHIP.

WE HEAR IT ALL THE TIME IN THE NEWS, THAT PEOPLE ARE AFRAID TO COME FORWARD. THOSE RELATIONSHIPS HAVE BEEN LOST, AT SOME POINT. ANY WAYS, THE POLICE DEPARTMENT HAS REALLY EMBRACED THIS. WE HOPE YOU, AS WELL. TWO OF THE MAIN THEMES ARE, FIRST OF ALL, DON'T TALK TO STRANGERS. VERY IMPORTANT. REMEMBER, THIS IS A SHOW FOR YOUNG CHILDREN. WE DON'T GO TO GREAT DETAILS, BUT WE DO MAKE THAT POINT. THE OTHER MESSAGE IS TRUST YOUR LOCAL POLICE OFFICERS. HE OR SHE IS THERE TO HELP, AND AS I SAID, WE'RE DELIGHTED -- MANY OF YOU HAVE ALREADY SIGNED ONTO SUPPORT PERFORMANCES.

WE HOPE OTHERS WILL JOIN IN, AS WELL, AND IF SOME OF YOU -- FOR AN UNBIASED RECOMMENDATION, COUNCIL MAN STUCK WILL HAS SEEN THE SHOW WITH HIS SON ABOUT 15 YEARS AGO, THE COUNCIL MAN SHARED WITH ME A COUPLE OF TIMES IT HELPED -- IT SAVED HIM FROM FALLING -- [INAUDIBLE] SO WE HOPE YOU'LL WORK WITH US. IF YOU HAVE ANY QUESTIONS, PLEASE GIVE ME A CALL, AND I'D LOVE TO TALK TO YOU ABOUT IT. THANKS AGAIN.

MR. CLERK: MR. PRESIDENT, THAT CONCLUDES THE ADDRESSES TO COUNCIL.

PRESIDENT YATES: COUNCIL MEMBERS BLACKWELL, COUNCIL MEMBERS AUBREY WELCH, AND COUNCIL MEMBER FOWLER, PLEASE INTRODUCE YOUR GUESTS.

>> FYI, WHILE THEY'RE ON THE WAY OUT, IF YOU WOULD LIKE TO ADD A SCHOOL OR ANYTHING FOR FOUL UP, MR. LENZI, CONTACT US.

>> IF YOU DIDN'T KNOW, COUNCILMAN STUCKEL WAS THE BIG BAD WOLFE BEFORE HE SHAVED.

>> I WANT TO KNOW FOR THREE YEARS, I GOT TO BE IN THE BIG BLUE APPLE ON BROADWAY, SO I WAS ACTUALLY CONTRIBUTING MONEY FOR THE PLEASURE OF EMBARRASSING MYSELF.

>> FOR THE RECORD, HE WAS THE BIG BAD WOLF IN A PRODUCTION OR JUST IN GENERAL?

>> IN CENTRAL PARK. OH, THERE YOU GO.

>> STEVE, WOULD YOU MAKE YOUR WAY FORWARD, PLEASE.

>> ALMOST FORGET THE CHIEF. HE IS AN IMPORTANT PART OF THIS. WE ARE -- ACTUALLY, WE HAVE TO MAKE A MOTION. I WOULD SAY WE'RE HAPPY TO HAVE THE CHIEF WITH US TONIGHT, BUT THAT WOULD BE A LIE BECAUSE THE REASON THAT WE HAVE THE CHIEF WITH US TONIGHT IS BECAUSE THE CHIEF HAS RETIRED, AND SO WE'RE VERY -- VERY CONCERNED ABOUT THAT ONE, BUT VERY HAPPY FOR HIM. CHIEF -- CHIEF HAS BEEN WITH THE FIRE DEPARTMENT FOR SOME 36 YEARS -- THE LAST 13 HAS CHIEF, AND SO HE'S DONE A NUMBER OF THINGS. HE THOUGHT IS IT WOULD BE A REALLY GOOD IDEA FOR BRINGING DOWN A RESPONSE TIME. IT WAS STILL A GOOD IDEA, EVEN THOUGH WE WEREN'T ABLE TO IMPLEMENT IT. HE'S BEEN A -- A GREAT PARTNER WITH US FOR ALL EVENTS IN OUR AREA, AND ONE OF THE THINGS, IF YOU'VE GOT SOMETHING, IN RIVER VIEW PARK, FOR EXAMPLE, YOU HAVE

TO SIGN OFF ON ALL THOSE PAPERWORK, AND -- [INAUDIBLE] -- THE WORK THAT THEY DO WITH ALL OF OUR COUNCIL MEMBERS IS -- IT'S BEEN WONDERFUL, AND WHOEVER TAKES HIS PLACE, GOOD LUCK, BECAUSE THEY HAVE SOME VERY, VERY BIG SHOES TO FILL. SO WE HAVE A PLAQUE TONIGHT SO IT JUST SAYS, LOUISVILLE METRO CITY COUNCIL, TELL YOU THAT LOCAL METRO COUNCIL HERE BY RECOGNIZES THIS CHIEF ON THE SUCCESS OF THE OCCASION OF HIS RETIREMENT FROM LOUISVILLE FIRE -- [INAUDIBLE] -- RECOGNITION WITH ALL THE RIGHTS, PRIVILEGES, AND -- [INAUDIBLE].

>> WELL, THANK YOU FOR HAVING ME HERE TONIGHT, IT IS AN HONOR AND A PLEASURE TO BE ABLE TO COME DOWN. PRESIDENT YATES, A COUPLE OTHER PEOPLE I'D LIKE TO THANK THAT REALLY HAVE HELPED ME AS CHIEF, AND THAT IS MADONNA FLOOD. SHE WAS ALSO VERY SUPPORTIVE OF THE LOUISVILLE METRO FIRE DEPARTMENT. JAMES HAS ALWAYS BEEN VERY SUPPORTIVE, NOT ONLY HIM, BUT THE JEFFERSON COUNTY FIRE DEPARTMENT, SO IT'S BEEN A PLEASURE. ONE THING I LEARNED BACK IN 1980, WHEN I JOINED THE FOREST SERVICE, TO NEVER GET INVOLVED IN POLITICS, AND I'VE STUCK TRUE TO THAT. I'VE NEVER GOTTEN INVOLVED IN POLITICS, BUT WHAT I HAVE SEEN IS WHAT AN AMAZING POSITION THAT THE METRO COUNCIL IS PUT IN ROUTINELY.

I MEAN, IT HAPPENS ALL THE TIME. I JUST WANT TO TELL YOU THAT YOU MEN AND LADIES DO NOT GET THE RECOGNITION THAT YOU DESERVE TO RUN THIS CITY. YOU ALL DO AN OUTSTANDING JOB, AND MOST OF THE TIME, LIKE BEING A FIRE CHIEF OR IN THE PUBLIC SAFETY, VERY SELDOM DO YOU HEAR THANK YOU, SO I JUST WANT TO GO ON RECORD, THANK YOU FOR ALL THAT YOU DO FOR THE LOUISVILLE METRO. IT'S AMAZING. THANK YOU FOR THE AWARD, AND NOW, I GET TO SPEND SOME TIME WITH MY 1.5-YEAR-OLD AND THREE-YEAR-OLD GRANDDAUGHTER. I WAS AT A CHIEF'S MEETING YESTERDAY, AND I WAS A LITTLE BIT LATE, AND THEY

TOLD ME -- I TOLD THEM I WAS ON FATHER PATROL LAST NIGHT, BUT I GOT HERE ON TIME TONIGHT, SO THANK YOU VERY MUCH.

PRESIDENT YATES: THANK YOU, CHIEF.

PRESIDENT YATES: THANK YOU, MR. CLERK. MAY I HAVE A MOTION AND SECOND FOR APPROVAL?

>> MOTION.

>> SECOND.

>> THANK YOU. I OPEN THE PODIUM.

>> WHILE WE'RE MAKING THE VOTE, I RECOGNIZE THE DISTINGUISHED GUESTS, AND I THINK COUNCIL MEMBER BARBARA SEXTON SMITH WOULD LIKE TO MAKE A MOTION OF SPECIAL -- [INAUDIBLE].

>> IT'S DR. KEVIN COSBY OF SIMMONS COLLEGE OF KENTUCKY, A BLACK COLLEGE IN KENTUCKY, AND I WOULD LIKE TO SAY HE'S HOSTING THE NATIONAL BAPTIST CONVENTION OF NATIONAL AMERICA THIS WEEK. 3.5 MILLION MEMBERS, AND HE'S TAKEN TIME OUT, AND I'VE ALSO NOTED FRANK AND THERESA BRIDGEWATER WHO JOINS US THIS EVENING. I THOUGHT WE WOULD BE REMISS IF WE DID NOT TAKE A MOMENT AND THANK THEM FOR BEING HERE ON THIS HISTORICAL MOMENT THIS EVENING. THANK YOU, MR. PRESIDENT.

PRESIDENT YATES: THANK YOU. THANK YOU, COUNCIL MAN. AND WITH THAT, OUR VOTING IS CLOSING.

MR. CLERK: 25 YES VOTES AND ONE NO VOTING.

PRESIDENT YATES: AND WITH THAT, THE RESOLUTION PASSES. OUR NEXT ITEM ON THE AGENDA IS READ BY MR. CLERK, OLD BUSINESS ITEM, NUMBER 35.

MR. CLERK: RECOMMENDATION FROM THE PLANNING/ZONING, LAND DESIGN AND DEVELOPMENT COMMITTEE THAT THE LANDMARKS COMMISSION DESIGNATION OF 609 BLANKENBAKER LANE AS A LOCAL LANDMARK BE REVIEWED BY A PUBLIC HEARING. READ IN FULL.

COUNCIL MEMBER FLOOD: THANK YOU, MR. PRESIDENT. WE'VE DISCUSSED THIS AT THE PLANNING AND ZONING COMMITTEE. IT CAME OUT WITH A FOUR TO THREE RECOMMENDATION. THE THREE VOTING WERE NOT VOTING AGAINST THE PUBLIC HEARING PER SE, WE WERE TOLD IT'S THE RECORD IN AND OF ITSELF. WE WERE TOLD WE HAD CHOICES, BUT IT WAS A FOUR TO THREE VOTE, AND IT'S MY UNDERSTANDING WE WERE GOING TO VOTE FOR THIS AT THIS MEETING HERE AGAIN.

>> THIS VOTE WOULD BE A RECOMMENDATION TO ACCEPT THE RECOMMENDATION FROM THE PLANNING AND ZONING COMMITTEE.

>> THAT WAS THE VOTE?

PRESIDENT YATES: ANY FURTHER DISCUSSION.

>> JUST THAT, YOU KNOW THAT A NO VOTE MEANS IT'S FOR A REVIEW, TO NOT DO ANYTHING, IT'S TO REVIEW THE RECORD BECAUSE THAT WAS OUR ONLY TWO CHOICES.

PRESIDENT YATES: NO VOTE WOULD BE TO REJECT THE RECOMMENDATION FROM THE PLANNING AND ZONING COMMITTEE; THE YES VOTE WOULD BE TO ACCEPT THE RECOMMENDATION EXPLAINED BY THE COUNTY ATTORNEY.

COUNCILMAN COAN.

COUNCIL MEMBER COAN: TO REITERATE, I DON'T THINK ANYBODY IN THE PLANNING OR ZONING COMMITTEE, INCLUDING ME -- [INAUDIBLE] -- I VOTED NO. I THOUGHT WE NEEDED ANOTHER PUBLIC HEARING AND A FULL AND COMPLETE RECORD, AND WE NEED TO MAKE A DECISION BASED ON THE RECORD. I HAVEN'T HEARD ANY ARTICULABLE REASON WHY WE NEED A PUBLIC HEARING, USUALLY, THERE'S A RECORD PRESENTED FOR THAT OR SOME OTHER REASON, SO I WOULD URGE FOLKS TO MOVE TO VOTE AGAINST THIS, VOTE NO, SO THAT WE END UP REVIEWING THIS CASE ON THE RECORD THAT EXISTS, SO WE DON'T SET A PRECEDENT WHERE IF METRO COUNCIL ENDS UP HAVING PUBLIC HEARINGS FOR EVERY LANDMARK CASE THAT GETS REVIEWED -- [INAUDIBLE].

PRESIDENT YATES: THANK YOU, COUNCIL, AND JUST A POINT OF LEGAL CLARIFICATION, WE HAVE ASSISTANT COUNTY ATTORNEY MARTIN HERE. MS. MARTIN, IN THE EVENT THAT THE RECOMMENDATION IS NOT ACCEPTED, WOULD IT GO BACK FOR A SECOND RECOMMENDATION, OR WHAT WOULD BE THE PROPER PROCEDURE FOR THAT, OR WOULD IT SIMPLY GO INTO DEFAULT?

>> YEAH, THE VOTE BEFORE YOU IS A VOTE ON THE RECOMMENDATION BY THE PLANNING AND ZONING COMMISSION TO HAVE A PUBLIC HEARING, SO YOU WOULD BE AFFIRMING THAT VOTE OR REJECTING THAT DECISION TO HAVE A PUBLIC HEARING, SO I THINK THERE WOULD BE A NEED FOR CLARIFICATION, IF THE VOTE IS NO, THAT IT IS FOR A REVIEW OF THE LANDMARK COMMISSION, BUT AS THE RESOLUTION THAT WAS PASSED TWO WEEKS AGO, IT WAS A VOTE FOR COUNCIL TO REVIEW, SO THAT DECISION HAS BEEN MADE, UNLESS COUNCIL DECIDES TO TAKE THAT BACK UP BEFORE THE COMMITTEE, BUT THAT'S NOT THE QUESTION BEFORE THE COMMITTEE, SO A NO VOTE WOULD BE A VOTE TO REVIEW THE COUNCIL'S LANDMARK DECISION.

PRESIDENT YATES: THANK YOU FOR POINTING THAT OUT.

>> YES, THE COMMITTEE DID VOTE FOUR TO THREE TO HAVE A PLANNING COMMITTEE, AND I WOULD ENCOURAGE MY COLLEAGUES TO UPHOLD THAT VOTE AND VOTE YES TO HAVE A PUBLIC HEARING.

PRESIDENT YATES: THANK YOU, COUNCILMAN.

>> WHICHEVER WAY THIS VOTE FALLS TONIGHT, WE HAVE -- [INAUDIBLE] -- I'VE BEEN PREPARING FOR IT EITHER WAY, AND I WOULD JUST LIKE TO SAY THAT IF YOU VOTE FOR A PUBLIC HEARING, PLEASE MAKE SURE THAT YOU DO ATTEND THAT, AND THAT WAY, YOU ARE INFORMED OF WHEN'S GOING ON. IF YOU VOTE FOR IT YES, OR A PUBLIC HEARING, YOU SHOULD ATTEND.

PRESIDENT YATES: FAIR ENOUGH.

>> I JUST WANT TO CLARIFY FOR EVERYONE WHAT MY UNDERSTANDING IS BECAUSE IT SEEMS I'VE HEARD BOTH WAYS. IF YOU VOTE YES FOR THIS, IT'S FOR A PUBLIC HEARING, CORRECT?

PRESIDENT YATES: IT IS AFFIRMING THE PLANNING AND ZONING COMMITTEE'S REQUEST FOR A PUBLIC HEARING. THANK YOU.

COUNCILMAN BLACKWELL.

COUNCIL MEMBER BLACKWELL: YES. DID ANYONE ADDRESS COUNCIL MAN COAN'S QUESTION -- IN THE CASE OF THE PUBLIC HEARING BEFORE, THERE WAS SOME THINGS THAT CAME UP, SOME QUESTIONS IN THE RECORD, MAYBE ABOUT WAS IT THIS WAY OR THAT WAY, SO THERE WAS SOME REASON TO HAVE A PUBLIC -- OR AT LEAST THERE WAS AN ARGUMENT FOR SOME REASON TO HAVE, NOT JUST, LET'S HAVE, IS THERE -- I DON'T KNOW -- I DON'T HEAR THAT WITH THIS ONE. I DON'T HEAR ANY OF YOU ARE GOING TO SAY THERE'S NO -- I DON'T HEAR A RATIONALE FOR WHY WE NEED A PUBLIC HEARING, BUT REVIEWING THAT RECORD, I WOULD LIKE SOMEONE TO CONVINCE ME WHY WE NEED YET ANOTHER PUBLIC HEARING, OTHER THAN JUST BECAUSE WE DO.

PRESIDENT YATES: AND I HAVE SOMEONE ELSE IN THE QUEUE. UNLESS WE HAVE SOMEONE THAT CAN ANSWER THE QUESTION, I KNOW WE DID DEBATE THIS PRETTY INTENSIVELY LAST COUNCIL MEETING. WOULD SOMEONE LIKE TO ANSWER THAT QUESTION FOR COUNCIL MAN BLACKWELL?.

>> I WOULD JUST LIKE TO MAKE A COMMENT. I'VE BEEN SITTING HERE FOR THE PAST FEW YEARS, AND I'VE BEEN HEARING THE SAME THINGS OVER THE PAST FEW YEARS -- [INAUDIBLE] -- I GUESS SOMEBODY NEEDS TO TELL ME, WHICH IS IT OKAY AND WHICH IS IT NOT OKAY, BECAUSE I HAVE A ZONING COMING UP, AND I NEED TO KNOW, WHEN IS IT GOING TO BE OKAY.

PRESIDENT YATES: AND I'M GOING TO -- BECAUSE IT WAS DIRECTED TO COUNSEL, IF YOU'D LIKE TO ADDRESS THAT, AND THEN --

>> BARBARA, ON ZONING ISSUES, YOU HAVE TO HAVE FINDINGS OF FACT TO OVERTURN -- YOU HAVE TO HAVE FINDINGS OF FACT. YOU CAN OVERTURN, BUT IT'S NOT A SIMPLE YES OR NO VOTE. YOU HAVE TO HAVE FINDINGS OF FACT

CONTRARY TO WHAT THE PLANNING COMMISSION SAID, AND I BELIEVE IT'S A 14 MAJORITY TO OVERTURN THE PLANNING COMMITTEE.

>> THIS VOTE IS NOT TO OVERTURN ANYTHING. THIS VOTE IS SIMPLY SO SAY YES OR NO ABOUT HAVING A PUBLIC HEARING TO REVIEW THE RECORD, SO I JUST WANTED TO MAKE SURE EVERYONE WAS CLEAR THAT VOTING YES FOR THIS OR NO FOR THIS DOES NOT HAVE ANYTHING TO DO WITH OVERTURNING OR UPHOLDING. IT HAS EVERYTHING TO DO WITH WHETHER YOU WANT TO HAVE A PUBLIC HEARING. ONE OF THE THINGS I'VE HEARING FROM COUNCILMAN COAN IS -- [INAUDIBLE] THIS WAS ONE OF THOSE SITUATIONS WHERE SOMEBODY WANTED TO FILE THIS AS BEING A LANDMARK TO PREVENT DEVELOPMENT.

WHETHER THAT'S TRUE OR NOT, I DON'T KNOW, BUT I THINK THAT WAS THE REASON FOR HAVING THE HEARING, WAS TO TRY TO FIND OUT, WHAT WERE THE FACTS IN THIS CASE, AND IS THIS TRULY SOMETHING THAT NEEDS TO BE DESIGNATED AS A LANDMARK PROPERTY AND BUILDING.

PRESIDENT YATES: THANK YOU, COUNCILWOMAN, AND JUST FOR CLARIFICATION, I WANT TO MAKE SURE WE GET THE RECORD STRAIGHT. THE VOTE IS -- TODAY IS DIRECTED TO WHETHER OR NOT TO ACCEPT THE RECOMMENDATIONS FROM THE PLANNING AND ZONING COMMITTEE, EITHER YES OR NO.

COUNCILMAN REED.

COUNCIL MEMBER REED: THANK YOU, MR. PRESIDENT. ANSWERING MR. BLACKWELL, THE REASON IN MY MIND FOR A PUBLIC HEARING IS THAT THE LANDMARK COMMISSION DID NOT ACTUALLY GO OUT TO THE HOUSE; AND TO ME, IF YOU'RE GOING TO BE USURPING SOMEONE'S PRIVATE PROPERTY, YOU SHOULD, AT THE VERY LEAST, GO OUT AND TAKE A LOOK AT WHAT IT IS THAT YOU'RE PLANNING TO LANDMARK.

PRESIDENT YATES: THANK YOU, COUNCILMAN.

COUNCILWOMAN WOOLRIDGE.

COUNCIL MEMBER WOOLRIDGE: THANK YOU, MR. PRESIDENT. I WOULD LIKE SOMEONE TO JUST TELL ME, WHAT IS THE DIFFERENCE BETWEEN A REVIEW AND A PUBLIC HEARING, AND MAYBE THAT WILL HELP ME TO DECIDE ON HOW I'M GOING TO VOTE ON THIS.

PRESIDENT YATES: COUNCILMAN COAN IS IN THE CUE, BUT BECAUSE IT'S COUNCIL MAN FLOYD IS ON THE COMMITTEE, I'LL GO TO HER, UNLESS SHE WANTS TO DEFER TO --

>> I WILL GO AHEAD AND DEFER.

>> THANK YOU. I THINK I HEARD COUNCILMAN -- [INAUDIBLE] -- I JUST WANTED TO MAKE CLEAR TONIGHT, WE ARE GOING TO HAVE A PUBLIC HEARING TO REVIEW THE RECORD, AND THAT IS NOT RIGHT. WE DON'T HAVE TO HAVE A PUBLIC HEARING TO REVIEW THE RECORD, A PUBLIC HEARING IS A WHOLE TRIAL LIKE TO MAKE A NEW RECORD. WITHOUT EVER HAVING TO CALL PEOPLE BACK IN AND WITNESSES AND THAT KIND OF THING. THERE IS A RECORD. I WANT TO MAKE SURE THERE'S NO CONFUSION. THAT'S THE DIFFERENCE BETWEEN A REVIEW OF THE RECORD AND A PUBLIC HEARING TO CREATE A NEW RECORD. AGAIN, I DON'T I'M WAITING TO HEAR A REASON, AND I HAVEN'T HEARD ONE STATED. IF COUNCIL MAN REED'S REQUEST FOR A PUBLIC HEARING IS BECAUSE THE LANDMARK COMMISSION DIDN'T GO OUT AND INSPECT THE BUILDING? ARE WE GOING TO GO OUT AND MAKE A NEW RULE IF THEY DON'T GO OUT AND INSPECT THE HOUSE AND BUILDING?

AS A COMMISSIONER WHO VOTED ONE AWAY OR ANOTHER IN THIS CASE, I'M NOT AGAINST THE PEOPLE FILING AN PEAL TO FORCE THE LANDMARK COMMISSION UNDER THEIR RIGHT. I'M JUST SAYING A PUBLIC HEARING IS A BAD CHOICE. THAT SETS A TERRIBLE PRECEDENT, AND I HAVEN'T HEARD ONE LEGITIMATE REASON TO HAVE IT, AND I HOPE THAT ANSWERS THE QUESTION.

>> MR. PRESIDENT, I'M NOT QUITE SURE -- THAT'S A GOOD EXPLANATION, BUT IT'S STILL SOMETHING THAT'S A LITTLE NAGGING HERE. ARE WE SAYING IN THE PLANNING THAT WE NEED TO HAVE THIS PUBLIC HEARING, AND I'M HEARING MY COLLEAGUE HERE EXPLAINING THAT MAYBE WE DON'T NEED TO HAVE THIS? SO...

PRESIDENT YATES: JUST SO THE PROCEDURAL HISTORY, A PREVIOUS COUNCIL MEETING, IF IT WAS BROUGHT TO A VOTE, AND ON -- WHETHER OR NOT TO SEND THIS BACK FOR REVIEW FOR A PUBLIC HEARING. COUNCILMAN KRAMER HAD MADE AN AMENDMENT ON IT THERE. I THINK I ACTUALLY HAVE THE LANGUAGE... I DO NOT, BUT HE DID HAVE SOMETHING TO THE EFFECT THAT IT SHOULD GO BACK TO THE PLANNING AND ZONING -- THE REPORT BACK TO COUNCIL ON THE RECOMMENDATION. THE PLANNING AND ZONING COMMITTEE VOTED AND MADE THE RECOMMENDATION TO HAVE A HEARING; AND NOW, IT IS BEFORE THIS COUNCIL WHETHER OR NOT TO ACCEPT THE RECOMMENDATION OF THE PLANNING AND ZONING COMMITTEE TO HAVE THE HEARING, OR TO REJECT IT.

>> WELL, I GUESS MY NEXT QUESTION IS, IF WE REJECT WHAT THE PLANNING AND ZONING COMMISSION IS SAYING, WILL WE BE SETTING A PRECEDENT HERE WITH -- MR. COAN, OR WHOEVER WANTS TO ANSWER THIS? IS.

PRESIDENT YATES: YOU CAN MAKE THAT ARGUMENT. I DON'T THINK WE'RE GOING TO BE SETTING A BINDING LEGAL PRECEDENT. I DON'T KNOW IF THE COUNTY ATTORNEY WANTS TO ANSWER THAT. ARE WE CREATING A BINDING -- ARE WE SETTING A PRECEDENT --

>> WELL, EVERY VOTE THAT COMES BEFORE THE METRO COUNCIL IS BASED ON THE VOTES PRESENTED IN THAT PARTICULAR CASE, SO IF IT DOES, IT SETS A PRECEDENT, BUT OTHER THAN THAT, EACH VOTE SUBMITTED TO THE COUNCIL IS A NEW ONE, BASED ON THAT INFORMATION.

PRESIDENT YATES: COUNCILMAN ACKERSON.

COUNCIL MEMBER ACKERSON: THANK YOU. I WAS ONE OF THE PLANNING AND ZONING COMMITTEE TO ALLOW IT TO COME BEFORE US PRESENTLY. MY VOTE WAS TO SUPPORT COUNCILMAN REED IN HIS DISTRICT. HE WANTED TO HAVE A PROCESS TO ALLOW THE CURRENT VIEWING OF THE PROPERTY, SO AGAIN, WHILE I DON'T HAVE MY MIND MADE UP ON THIS PROPERTY, IF I'M HEARING, THE COUNCILMAN WANTS TO HAVE A PUBLIC HEARING, I'M DEFERRING TO THAT RATIONALE AND THE BASIS FOR THAT.

PRESIDENT YATES: THANK YOU FOR THAT.

COUNCILMAN KRAMER.

COUNCIL MEMBER KRAMER: THANK YOU, MR. PRESIDENT. I DON'T HAVE A WHOLE LOT TO ADD. JUST AT THE LAST COUNCIL MEETING. WE DON'T HAVE A VOTE TO REVIEW THIS. THE PLANNING AND ZONING COMMITTEE RECOMMENDED IT, BUT THERE IS A DIFFERENCE, AND I THINK THE REAL DIFFERENCE, FROM MY PERSPECTIVE IS ARE WE LOOKING AT THE RECORD THAT SOMEONE ELSE CREATED AND LIMITING OURS TO DISCUSSION OF THAT RECORD, OR ARE WE GOING TO HOLD A HEARING SUCH THAT THOSE OF US WHO HAVE QUESTIONS BEYOND THE SCOPE OF WHAT THEY CONSIDERED WOULD HAVE AN OPPORTUNITY TO ADD TO THE RECORD? I THINK IN FULL DISCLOSURE, IF WE WANT TO DO THE MOST -- THE BEST JOB WE CAN DO AND BE CERTAIN THAT WE GET IT RIGHT, I WOULD ARGUE THAT WE NEED TO BE ABLE TO ACCESS AS MUCH INFORMATION AS WE CAN AND NOT BE LIMITED TO A PREVIOUS PUBLIC HEARING, ESPECIALLY ONE THAT WAS HELD, YOU KNOW BY THE VERY GROUP DEBATING WHETHER THIS SHOULD IN FACT BE LANDMARKED, SO THE REVIEW PROCESS, I THINK THAT GIVES US MORE FLEXIBILITY, AND I'M ARGUING MORE CONSISTENTLY THE MORE YEARS THAT I'VE BEEN HERE, THAT WE NEED TO MAKE A DECISION ON THE LANDMARK TO BE SOMETHING THAT WE CAN BE PROUD OF. WE VOTED TO REVIEW IT AT

THE LAST MEETING, AND THE PLANNING COMMITTEE CAME BACK AND SAID THIS IS THE BEST WAY TO DO IT. I THINK WE SHOULD SUPPORT THEM IN THEIR CHOICE MOVING FORWARD.

>> THANK YOU FOR THAT, COUNCILMAN.

>> THANK YOU, MR. PRESIDENT. GOING BACK TO COUNCILMAN BLACKWELL ONE MORE TIME, THERE WERE QUESTIONS THAT WERE NOT ASKED IN APPROXIMATE THE LANDMARK HEARING, WHICH IS HOW MANY HAMMOND DESIGNED HOMES ARE IN THE CITY OF LOUISVILLE? THAT IS NOT ASKED, SO IF THERE ARE CERTAIN QUESTIONS THAT I WOULD LIKE ASKED TO GET CLARIFICATION ON THAT INFORMATION. HAMMOND WAS THE PRIMARY ARCHITECT ON THE BUILDING OF THE HOUSE, AND THAT ONE WAS NEVER ASKED -- AND THERE'S OTHERS, AS WELL. THAT WAS ONE OF THE REASONS WHY I WANTED A REVIEW AND A PUBLIC HEARING.

PRESIDENT YATES: COUNCILWOMAN FOWLER.

COUNCIL MEMBER FOWLER: THANK YOU. I JUST HAVE A QUESTION FOR THE COUNTY ATTORNEY. IF WE DO NOT HAVE A PUBLIC HEARING, DOES THAT PREVENT US FROM TOURING THE HOME?

>> SO YOUR QUESTION IS ADDRESSED IN THE ORDINANCE ITSELF. IT'S IN 32260(D), AND I'M JUST GOING TO READ THE INFORMATION. [READING INFORMATION.]

>> IT GOES ONTO SAY, IF A PUBLIC HEARING WILL BE HELD, THE RIGHT TO -- OF THE PUBLIC TO COMMENT AT THE PUBLIC HEARING ON THE PROPOSAL, AND THIS GETS BACK TO YOUR QUESTION. IF THE PUBLIC HEARING IS NOT HELD BY THE COUNCIL OR ONE OF ITS COMMITTEE TO ASSIGNED TO HOLDING THE REVIEW, THE COUNCIL SHALL CONFINE ITS REVIEW TO THE INFORMATION THAT WAS PRESENTED AT THE COMMITTEE.

>> IF WE DON'T HAVE A PUBLIC HEARING, WE ARE ONLY ALLOWED TO LOOK AT THE RECORD.

>> YOU WOULD NOT BE ALLOWED TO TOUR THE PROPERTY. YOU WOULD BE LIMITED TO THE RECORD.

>> OKAY.

PRESIDENT YATES: COUNCILMAN COAN.

COUNICL MEMBER COAN: AND I WON'T BELABOR THIS, UNLESS YOU HAVE A FEW QUESTIONS. I JUST WANT TO BE CLEAR. I GUESS THE QUESTION IS FOR COUNCILMAN REED. I GUESS, ARE WE GOING TO TOUR THE HOME, THAT YOU GAVE THE REASON FOR THE PUBLIC HEARING, OF THE HOME IN THE FIRST PLACE?

>> YEAH. I WOULD HOPE THAT THEY WOULD. I WOULD HOPE THAT WE WOULD, YES, ABSOLUTELY. IF WE'RE GOING TO BE MAKING A DECISION ON SOMEONE'S PRIVATE PROPERTY, I WOULD HOPE SO. THAT'S IMPORTANT. I WOULD HOPE SO, YES, COUNCIL MAN COAN.

PRESIDENT YATES: COUNCILMAN COAN.

COUNCIL MEMBER COAN: NO, THAT'S FINE. I THINK FOR ALL OF THOSE REASONS, IT DOESN'T MAKE SENSE. I ALSO DON'T -- [INAUDIBLE] --

>> I'M NOT TRYING TO FORCE THE NEW ONE TO DO ANYTHING, SIR.

>> NO, I'M JUST TRYING TO THINK THIS THROUGH, BECAUSE AGAIN, YOU'RE SAYING THAT YOUR REASON FOR WANTING TO DO THIS WAS TO TOUR THE PROPERTY, AND AS A LANDMARKS COMMISSION, WE DON'T TOUR ANY OF THESE PROPERTIES. WE NEED TO ADD THESE KINDS OF CASES, SO IN THE FUTURE, WE NEED A REAL CLEAR DIRECTION, IF THE LAND LARK COMMISSION IS GOING TO BE INSTRUCTED TO GO TOUR ALL OF THESE PROPERTIES, IN ORDER TO DO ITS WORK OR OTHERWISE, THAT'S SOME JUSTIFICATION FOR HAVING A METRO COUNCIL PUBLIC HEARING ON THESE CASES, SO YOU KNOW, I JUST THINK THAT'S AN

IMPORTANT -- THE REASON YOU GAVE FOR WANTING A PUBLIC HEARING, IF YOU CAN GIVE AN ANSWER ABOUT THAT, THE FIRST PUBLIC HEARING THAT YOU WANT, THAT WOULD BE EFFECTIVE.

>> WE HAVE SEVERAL PEOPLE THAT WANT TO ADDRESS THAT -- [INAUDIBLE] --

>> THANK YOU, MR. PRESIDENT. THIS IS PROBABLY ONE OF THOSE THING THAT DOESN'T MAKE SENSE. WHEN I FIRST GOT ON THE COUNCIL 14 YEARS AGO, GO TO THE PLANNING AND ZONING CASES, AND I'D ASK SOME QUESTIONS. OH, YOU CAN'T ANSWER THAT QUESTION -- YOU CAN'T ASK THAT QUESTION BECAUSE YOU'RE A JUDGE. YOU CAN'T ASK THAT. I SAID THIS IS REALLY IMPORTANT FOR THIS ZONING CASE. WELL, YOU'RE GOING TO BE IN CONTEMPT. YOU CAN'T DO THAT. I SAID, PUT ME IN CONTEMPT. THE PUBLIC NEEDS TO KNOW THE TRUTH; AND SOMETIMES, NO, NO, NO, WE'RE NOT GOING TO BRING THE TRUTH. HOW IS THE TRAFFIC GOING TO FLOW, AND ALL THE DIFFERENT STUFF THAT GOES ON, AND SO FOR ME, IF THERE'S ANY QUESTION THAT WOULD MAKE THIS REAL IN TRUTH, AND WE CAN'T ASK IT BECAUSE WE CAN ONLY LOOK AT WHAT'S ALREADY BEEN ASKED, THAT'S NORMAL FOR GOVERNMENT. PUT YOUR HEAD UNDER THE TABLE AND SAY, WE DON'T KNOW. AND I THINK SOMETIMES, WE NEED TO KNOW, SO FOR WHAT IT'S WORTH, I HOPE SOMEBODY HERE -- [INAUDIBLE].

PRESIDENT YATES: COUNCILWOMAN LEET.

COUNCIL MEMBER LEET: THANK YOU, MR. PRESIDENT. A COUPLE OF QUESTIONS, AND I DON'T KNOW IF THIS IS FOR THE COUNTY ATTORNEY, BUT IS THERE ANYTHING IN OUR CURRENT ORDINANCE THAT WOULD PREVENT ANYONE AT ANY TIME FROM SEEKING A DESIGNATION FOR A PROPERTY OR DOES IT HAVE TO BE PREEMPTED BECAUSE SOMEBODY HAS DECIDED TO DEVELOP? IS THERE A CAUSAL FACTOR?

>> NO. THERE'S A PROCEDURE SET FORTH IN THE ORDINANCE FOR SOMEBODY TO GET A DESIGNATION.

>> DOES IT REQUIRE SOMEBODY HAS TO HAVE ACCESS -- FOLLOW A TYPE OF DEVELOPMENT PLAN?

>> NO.

>> SO ANY CITIZEN, AT ANY POINT IN TIME, IF THERE IS A PROPERTY NEXT TO THEM THAT THEY BELIEVE SHOULD BE DESIGNATED, CAN GO OUT TOMORROW AND SEEK A DESIGNATION UPON OBTAINING THE APPROPRIATE NUMBER OF SIGNATORS FOR A PETITION, IS THAT CORRECT?

>> THEY HAVE TO COMPLY WITH THE PROCEDURES SET FORTH IN THE LANDMARK --

>> WHICH IS LIKE A PETITION AND ALL THAT KIND OF THING.

>> IN THE ORDINANCE, THERE'S NOTHING THAT HAS TO BE CAUSAL IN ORDER TO GO SEEK THAT DESIGNATION.

>> IT'S NOT DEPENDENT ON A DEVELOPMENT, NO.

>> OKAY. AND THEN, I FIND IT INTERESTING THAT WE'RE TALKING ABOUT WHETHER AN ORGANIZATION WHO IS -- WHO IS TO BE HELD RESPONSIBLE FOR MAKING DECISIONS FOR LANDMARK CASES WOULD NOT SEEK AN ON-SITE INSPECTION OF THIS FACILITY. I WOULDN'T BUY ANY PIECE OF PROPERTY WITHOUT THE APPROPRIATE LEVEL OF INSPECTION AND DUE DILIGENCE, SO I FIND IT REMARKABLE THAT WE WOULD BE DISCUSSING THAT AS A POTENTIAL ISSUE BECAUSE I'M SHOCKED, ACTUALLY, BY THE FACT THAT WE DON'T DO ON-SITE INSPECTIONS, OR THAT THE COMMISSION DOES NOT DO ON-SITE INSPECTIONS BEFORE THEY POTENTIALLY DESIGNATE SOMEONE ELSE'S PRIVATE PROPERTY, SO I WILL BE, YOU KNOW, VOTING IN FAVOR OF A PUBLIC HEARING JUST SO WE CAN MAKE SURE THAT THE RECORD IS FULLY HEARD, AND ALL THE APPROPRIATE QUESTIONS THAT PEOPLE MAY HAVE

OUTSTANDING, HAS THE OPPORTUNITY TO BE CONSIDERED IN THE RECORD. THANK YOU.

PRESIDENT YATES: THANK YOU, COUNCILWOMAN.

COUNCILWOMAN MADONNA FLOOD.

COUNCIL MEMBER FLOOD: I JUST WANT TO STATE, I DON'T KNOW IF WE CAN COMPEL THE OWNER TO LET US IN AT ANY PARTICULAR TIME. IF YOU REMEMBER, BACK ON THE RECORD, THERE WAS ONE PARTICULAR TIME THAT THAT PARTICULAR PROPERTY WOULD BE LOOKED AT. SO WE ARE AT THE MERCY OF THE OBSERVER OF THE PROPERTY WHEN WE GAIN ACCESS TO THAT, AND I BELIEVE THAT WAS NOT SETUP BY THE PLANNING AND ZONING COMMITTEE. SO WE DON'T SET THOSE UP, SOMEONE ELSE WILL HAVE TO DO THAT. SO WE DON'T HAVE TO LET US IN, AND IF YOU GO IN A GROUP, PLEASE MAKE SURE -- UNLESS YOU ANNOUNCE IT TO PROPER AUTHORITIES, LIKE THE MEDIA, YOU CAN'T GO IF YOU AREN'T A QUORUM OF ANY COMMITTEE.

PRESIDENT YATES: THANK YOU, COUNCIL WOMAN. COUNCIL WOMAN --

>> IT'S MY UNDERSTANDING THAT THE COUNCIL MAN WAS INVITED TO VIEW THE SECOND PROPERTY, AND AS FOR US, WE CAN'T BE COMPELLED TO GO TO THE GROUND, BUT IF THE OWNER SO CHOOSES TO INVITE US AT SOME TIME, WE COULD GO AND SEE IT, SO SAYING THAT COUNCIL MEMBER REED TO COMPEL US OR MAKE US GO IS -- IS NOT CORRECT. HE CAN'T MAKE IT DO MUCH OF ANYTHING, AS MUCH AS HE PROBABLY WOULD LIKE TO. ALSO, WHEN TALKING ABOUT THE REASON FOR HIM DOING THIS, IT WASN'T SOLELY BECAUSE THE COMMISSION HADN'T VISITED THE LOCATION. HE SAID HE HAD NUMEROUS QUESTIONS, ONE OF WHICH, HOW MANY MORE OF THESE BUILDINGS WERE IN LOUISVILLE BY THE SAME ARCHITECT, AND THAT INFORMATION WAS NOT GIVEN -- AND IT'S ALSO MY UNDERSTANDING THAT THERE ARE NO PICTURES IN THE RECORD OF THIS PARTICULAR BUILDING. NOW I DON'T KNOW THAT TO BE THE CASE, BUT I'VE BEEN TOLD THAT, SO I THINK THERE'S NO HARM

IN REVIEWING THIS. IT DOESN'T SET A PRECEDENT. WE HAVE DONE THIS BEFORE IN ANOTHER CASE. WE'VE PASSED AN ORDINANCE TO ALLOW US TO DO THIS BECAUSE OF IRREGULARITIES THAT WE'VE SEEN IN THE PAST BASED UPON THIS COMMISSION, AND WE HAVE PREVIOUSLY, BY AN OVERWHELMING MARGIN, THIS BODY APPROVED THAT WE WOULD ASK THIS COMMITTEE TO APPROVE A PUBLIC HEARING SO THAT WE COULD REVIEW THIS AND SEE WHAT'S GOING ON. THIS IS SOMEBODY'S PERSONAL PROPERTY, AND I THINK IT BEHOOVES US, AND WE OWE IT TO THEM, TO GIVE THEM THE DEFERENCE OF AS MUCH TRANSPARENCY OF AS MANY EYES AS POSSIBLE.

THINK ABOUT IF IT WAS YOUR PROPERTY AND SOMEBODY WANTED TO COME IN AND DESIGNATE YOUR PROPERTY THAT GIVES YOU RESTRICTION. I SELL REAL ESTATE. I HAVE PEOPLE ALL THE TIME THAT SAY, DON'T SHOW ME ANYTHING IN A HISTORICAL AREA, BECAUSE I KNOW THEY'RE GOING TO TELL ME WHAT I CAN AND CANNOT DO WITH MY PROPERTY, SO I KNOW HOW THAT WORKS IN THE PRIVATE SECTOR. PEOPLE DON'T WANT THOSE PROPERTIES BECAUSE THEY CAN'T DO WHAT THEY CAN AND CAN'T DO WITH THEIR PROPERTY. YOU HAVE RESTRICTIONS ON YOUR WINDOWS, WHAT YOU CAN DO, HOW YOU CAN -- WHETHER YOU CAN REPLACE THEM OR NOT. YOU HAVE PEOPLE COME IN -- OTHER PEOPLE CAN COME IN AND TELL YOU WHAT YOU CAN AND CAN'T DO WITH YOUR -- YOUR PROPERTY. I DON'T KNOW WHAT THE CORRECT ANSWER IS, BUT I DON'T THINK THERE'S ANY HARM TO GO IN AND TAKE A LOOK TO SEE WHAT THE RIGHT THING IS TO BE DONE WITH THIS PARTICULAR PROPERTY. IF I WERE THE HOMEOWNER, I WOULD APPRECIATE FOLKS COMING IN AND TAKING A LOOK, SO I URGE THE COUNCIL TO VOTE FOR THIS.

PRESIDENT YATES: COUNCIL, I WOULD LIKE TO POINT OUT THAT THERE ARE PICTURES IN THE RECORD, IF YOU WOULD LIKE TO SEE THEM, AND IN THE ABSENCE OF OUR NORMAL DE FACTO ARGUMENT, AND I'M CALLED INTO QUESTION -- I DON'T SEE ANY OBJECTION TO THE QUESTION BEING CALLED. WITHOUT OBJECTION,

MR. CLERK, WOULD YOU PLEASE OPEN THE ROLL CALL VOTE, KNOWING A YES IS A RECOMMENDATION TO THE PLANNING AND ZONING COMMITTEE; A NO VOTE IS TO REJECT. THAT VOTING IS CLOSING. THE VOTING IS CLOSING, THE VOTING IS CLOSED.

MR. CLERK: THERE 22 YES VOTES, THREE NO VOTES, ONE BE NOT VOTING.

PRESIDENT YATES: THANK YOU. THE COMMITTEE IS REVIEWED.

>> I'LL LOOK FORWARD TO ALL 24 COMING TO THE PLANNING AND ZONING YOU COMMITTEE MEETING, AND SPEAKING ON WHAT YOU JUST VOTED FOR.

>> SPONSORSHIP OF ITEM 36 HAS BEEN WITHDRAWN, THEREFORE, THAT ITEM IS WITHDRAWN.

MR. CLERK WILL READ ITEM 37, PLEASE.

MR. CLERK: AN ORDINANCE CHANGING THE ZONING FROM R-4 RESIDENTIAL SINGLE FAMILY TO OR-1 OFFICE/RESIDENTIAL ON PROPERTY LOCATED AT 4011 FERN VALLEY ROAD CONTAINING 0.97 ACRES AND BEING IN LOUISVILLE METRO (CASE NO. 14ZONE1058).

PRESIDENT YATES: MOTION TO APPROVE?

>> MOTION.

>> SECOND.

PRESIDENT YATES: ITEM 37 IS BEFORE US -- MY SCREEN IS SHOWING ITEM 36 -- OKAY. THAT'S FINE. IT'S JUST THE NUMBERING IS OFF ONE ON YOUR MONITOR, BUT THAT'S CORRECT.

COUNCILWOMAN LEET.

COUNCIL MEMBER LEET: THANK YOU, MR. PRESIDENT. THIS IS A CHANGE IN ZONING. THIS IS THE OLD LOG CABIN HOUSE THAT SITTING AT FERN VALLEY

ROAD CLOSE TO FIRST STREET. I THINK IT'S CLOSE TO JANINE DRIVE. IT'S A VERY OLD HOUSE THAT IS BEING TAPPED AS AN OFFICE. IT WILL BE A ONE PERSON OFFICE, FOR THE MOST PART, A TAX OFFICE, BUT AT TIMES, DURING TAX SEASON, THERE COULD POSSIBLY BE MORE PEOPLE HELPING OUT WITH TAXES. THEY'RE PLANNING ON PUTTING IN TEN PARKING SPACES, AND THERE WILL ONLY BE ONE ENTRANCE, OFF FERN VALLEY, FOR THIS PARTICULAR PROPERTY. THERE WERE SEVERAL QUESTIONS, ONE OF WAS HOW MANY PEOPLE WOULD BE WORKING THERE, AND THE SECOND WAS A TREE THAT BORDERED THE PROPERTY, AND THE ONE BEHIND IT, AND THEY DID WORK IT OUT, THAT THE OWNER OF THE NEW PROPERTY WOULD BE WILLING TO MITIGATE THE PROPERTY WITH THIS TREE THAT'S THERE -- AND THIS IS? DR. SHANKLIN'S DISTRICT. SHE MAY WANT TO ADDRESS IT HAD.

PRESIDENT YATES: THANK YOU.

COUNCILWOMAN SHANKLIN.

COUNCIL MEMBER SHANKLIN: THANK YOU. I DID TALK WITH SOME OF THE CONSTITUENTS IN THE AREA. THEY WERE OKAY WITH IT, AS LONG AS IT IS A ONE PERSON RESIDENCE, AND IT DOESN'T EXPLODE -- YOU KNOW, HAVE MORE THAN ONE PERSON IN IT.

PRESIDENT YATES: THANK YOU, COUNCILWOMAN.

IS THERE ANY FURTHER DISCUSSION? IF THERE'S NO FURTHER DISCUSSION, THE CLERK -- WE'LL CONDUCT A ROLE CALL VOTE. CLERK WILL OPEN THE VOTING PRESIDENT YATES: WITH THAT, THE VOTING IS CLOSING. THE VOTE IS CLOSED.

>> SECOND.

PRESIDENT YATES: MOTION TO APPROVE AND A SECOND ARE PROPERLY BEFORE US.

PRESIDENT YATES: THE COUNCIL MEMBER WANTED TO READ IT INTO THE RECORD.

>> THANK YOU, MR. PRESIDENT, AND THANK YOU, MADAM CHAIR. BEFORE READING THIS INTO THE RECORD, I WOULD LIKE JUST TO SAY THAT MR. JAMES ELLIOTT, HE IS A VERY HONORABLE PERSON. HIS CHURCH IS IN MY DISTRICT. HE HAS PASTORED THIS CHURCH FOR OVER 40 YEARS. THEY HAD A 40 YEAR ANNIVERSARY ABOUT THREE WEEKS AGO THAT WAS VERY, VERY NICE, AND AT THAT PARTICULAR TIME, A LOYAL LIGHT KIND OF WENT OFF IN MY HEAD, AND I THOUGHT WHY DON'T WE JUST NAME THIS STREET THAT HIS CHURCH SAT ON, A COUPLE OF BLOCKS THAT HIS CHURCH SAT ON, REVEREND JAMES W. ELLIOTT WAY, SO WE CAME IN, AND WE SAID WE'RE GOING TO DO THIS RESOLUTION, AND I BELIEVE IT'S LONG OVERDUE, SO I'M HAPPY TO DO THIS, AND I'M HAPPY TO READ IT INTO THE RECORD.

SO RESOLUTION HONORING REVEREND JAMES W. ELLIOTT, SR., BY DESIGNATING HILL AVENUE FROM GILL STREET TO BEECH STREET TO BE RENAMED REVEREND JAMES W. ELLIOTT, SR., WAY IN HIS HONOR.

WHEREAS JAMES W. ELLIOTT SENIOR WAS BORN TO CHARLES ELLIOTT SENIOR AND GERTRUED STEEL IN ALABAMA ON SEPTEMBER THE 28TH, 1942 AND GREW UP WITH 12 SIBLINGS,.

WHEREAS REVEREND ELLIOTT GRADUATED FROM HIGH SCHOOL IN ALABAMA WAS HONORED THAT IT INCLUDED TO TUSKEGEE INSTITUTES, THE AMERICAN LESION SCHOLARSHIP.

WHEREAS, AFTER STUDYING AS TUSKEGEE INSTITUTE, REVEREND ELLIOTT WENT IN THE ARMY, WHERE HE SERVED FROM 1962 TO 1968, SPENDING MOST OF THAT TIME AT FORT CAMPBELL, KENTUCKY.

WHEREAS REVEREND ELLIOTT STAYED IN KENTUCKY AFTER THAT, AND STUDIED AT THE UNIVERSITY OF KENTUCKY, WHERE HE RECEIVED HIS BACHELOR'S OF ART.

WHEREAS IN 1977, REVEREND ELLIOTT WAS AS PASTOR AT THE NEW WORLD BAPTIST CHURCH, WHERE HE ENCOURAGES HIS FOLLOWERS TO SPEAK A HIGH QUALITY OF LIFE BY BEING INFORMED IN LIGHT AND BEING INVOLVED IN THEIR COMMUNITY.

WHEREAS REVEREND ELLIOTT WORKED FOR THE CABINET OF FAMILIES AND CHILDREN FROM 1994 TO 2004, DURING WHICH TIME, HE CONTINUED HIS GRADUATE STUDIES AT THE SOUTHERN BAPTIST THEOLOGICAL AND LATER RECEIVED HIS ON-LINE DOCTORATE OF ART IN DIVINITY FROM WESTERN GOVERNOR'S UNIVERSITY.

AND WHEREAS THE KMDA WAS RECOGNIZED BY LOWER METRO FOR THE OPPORTUNITY THAT IT'S PROVIDED FOR THE COMMUNITY, AND IT RECEIVED OVER \$300,000 IN GRANTS DURING ITS TIME 234 OPERATION.

WHEREAS AFTER DISSOLUTION OF THE KMDA, REVEREND ELLIOTT HELPED ESTABLISH ANOTHER ORGANIZATION WHICH WAS ALL ON OUR OWN.

WHEREAS REVEREND ELLIOTT HAD RECEIVED VARIOUS RECOMMENDATIONS AND AWARDS OVER THE YEARS, INCLUDING THE LOWER DISTINGUISHED CITIZEN AWARD.

WHEREAS REVEREND ELLIOTT HAS MAINTAINED MEMBERSHIPS IN VARIOUS ORGANIZATIONS -- [INAUDIBLE] -- THE NAACP, THE URBAN LEAGUE, AND PARKMAN'S DEVELOPMENT CORPORATION.

AND WHEREAS FOR MANY YEARS, REVEREND ELLIOTT HAS BROUGHT GREATER ATTENTION TO MANY NEEDS OF THE CITIZENS OF LOWER METRO AND CONTINUES TO PROVIDE A PATH FOR HIS FOLLOWERS THAT -- [INAUDIBLE] -- IN THEIR OWN LIVES FOR THE GREATER GOOD OF ALL.
