PRESIDENT YATES: THE REGULAR LOUISVILLE METRO COUNCIL MEETING OF SEPTEMBER 28, 2017, WILL PLEASE COME TO ORDER.

PLEASE RISE FOR THE PLEDGE OF ALLEGIANCE TO THE FLAG.

I PLEDGE ALLEGIANCE TO THE FLAG OF THE UNITED STATES OF AMERICA AND TO THE REPUBLIC FOR WHICH IT STANDS, ONE NATION UNDER GOD, INDIVISIBLE, WITH LIBERTY AND JUSTICE FOR ALL.

PRESIDENT YATES: THANK YOU.

MR. CLERK, A ROLL CALL, PLEASE.

[ROLL CALL].

MR. CLERK: MR. PRESIDENT, YOU HAVE 23 IN ATTENDANCE AND YOU HAVE A QUORUM.

PRESIDENT YATES: THANK YOU, MR. CLERK.

LET THE RECORD REFLECT THAT COUNCILMEMBER VICKI AUBREY WELCH HAS AN EXCUSED ABSENCE.

MR. CLERK: SO NOTED.

PRESIDENT YATES: I WOULD LIKE TO WELCOME OUR FRIENDS FROM THE LIBRARY HERE TO JOIN US. OUR INTERNS THAT ARE STAYING LATE AND POLICE OFFICERS IN THE BACK, THANK YOU FOR JOINING US AS WELL IN THE COMMUNITY.

MR. CLERK, DO WE HAVE ANY ADDRESSES TO THE COUNCIL?

MR. CLERK: WE DO, SIR.

PRESIDENT YATES: LET ME REMIND THOSE ADDRESSING THE COUNCIL,
PLEASE REFRAIN FROM USING DEROGATORY LANGUAGE OR STATEMENTS DIRECTED TO
ANY MEMBER OF COUNCIL.

MR. CLERK: PAM GREENEWELL.

PAM GREENWELL: I HAVE MET MOST OF YOU ALL AT CAFE LOUIS, IT'S

GOOD TO SEE YOU AGAIN. I WAS HERE A YEAR AGO TO ASK YOU TO JOIN THE

FRIENDS OF THE LIBRARY. MANY OF YOU HAVE DONE THAT. ONE OF THESE SHOULD BE

SITTING AT YOUR DESK BECAUSE THIS IS OUR 40th ANNIVERSARY, SO EVERYBODY

WHO JOINS DURING THIS YEAR GETS A 40th ANNIVERSARY BOOKMARK AND WE ALL

APPRECIATE YOU CONSIDERING DOING THAT AND COUNCILMEMBER STUCKEL WE

APPRECIATE YOU JOINING ABOUT FIVE MINUTES AGO, THANK YOU, SIR. THE FRIENDS

AT THE LIBRARY DO A LOT OF WORK AT THEIR BRANCHES.

WE REPRESENT ALL 18 BRANCHES. WE SELL BOOKS, WE SELL COFFEE, WE DO ALL KINDS OF THINGS, SO THERE'S COOKIE AT STORY HOUR AND MAGICIANS AT STORY HOUR AND POPCORN AT MOVIE NIGHT. THINGS THAT DON'T SEEM THAT IMPORTANT BUT THESE ARE THINGS THAT BRING PEOPLE INTO THE LIBRARY THAT HELP WITH THE CITY'S GOAL OF LIFE-LONG LEARNING. WE ARE HERE ONE TO GET YOU TO JOIN. TWO, TO SHOW YOU FIVE OF YOUR COLLEAGUES HAVE ALREADY GIVEN US THE INFORMATION WE NEED TO DO THIS.

MR. HOLLANDER, MS. LEET, MR. PARKER, COUNCILMEMBER STUCKEL. I'M MISSING SOMEBODY, FLOOD. THIS IS A BOOK FROM MY CHILDHOOD. THIS IS MINE. WE ARE USING THIS IN A LOT OF WAYS. ON OUR FaceBook PAGE AND WEB PAGE. WE ARE ALSO ASKING IF YOU WOULD CONSIDER DOING THIS, GET US THE INFORMATION AND WE WOULD LOVE IT IF YOU WOULD USE IT IN YOUR COMMUNICATION WITH YOUR CONSTITUENTS.

FIRST OF ALL, WE WOULD LOVE THEM TO JOIN, AND SECOND WOULD HE
LOVE THEM TO KNOW THAT YOU LOVE BOOKS ABOUT SNAKES. COUNCILMAN STUCKEL. IN
ANY CASE, IT'S BEEN A REALLY FUN PROJECT FOR US TO DO. WE ARE GETTING A
LOT OF PLEASURE OUT OF IT. AND WE THINK YOUR CONSTITUENTS WILL BE TICKLED
BY IT AS WELL. THERE'S BEEN SO MANY AMAZING THINGS IN THIS LAST YEAR. WE

OPENED SOUTH CENTRAL, AND THOSE WHO HAVE NOT BEEN THERE, PLEASE MAKE A TRIP. IT'S AN INCREDIBLE LIBRARY. THEY ARE DOING REALLY SPECTACULAR THINGS. CIRCULATION IS UP. AND I'M GOING TO MISS THE NUMBER BUT I THINK IT'S LIKE 175%, THE NUMBER OF PEOPLE WHO ARE COMING IN IS UP DRAMATICALLY. IT'S INCREDIBLE.

MANY OF YOU I KNOW WERE AT THE GROUND BREAKING FOR THE NORTHEAST LIBRARY, AND WOW. WOW. THAT IS GOING TO BE AMAZING. WE ARE GOING TO BREAK GROUND FAIRLY SOON FOR THE St. MATTHEW'S LIBRARY, WHICH YOU ALL KNOW IS THE HIGHEST CIRCULATION LIBRARY IN THE SYSTEM. SO WE HAVE JUST GOT AN AMAZING NUMBER OF THINGS GOING ON. WE WANT TO THANK YOU. BECAUSE THESE THINGS WOULD NOT HAVE HAPPENED WITHOUT YOUR HELP AND SUPPORT. SO THANK YOU VERY MUCH. AND I HAVE ONE SECOND LEFT. BYE. [CHUCKLES].

MR. CLERK: STEPHEN BARTLETT.

STEPHEN BARTLETT: MY NAME IS STEPHEN BARTLETT. I SPEAK TODAY ON BEHALF OF THE MID KENTUCKY PRESBYTERIAN. OUR CHURCH FAITHFULLY OPPOSES THE PERSECUTION AND EXPLOITATION OF IMMIGRANTS. WE HEAR A LOT ABOUT THE LOVE AND COMPASSION OF THE CITY OF LOUISVILLE. HONESTLY, WE DO NOT YET FEEL THAT LOVE FLOWING FROM METRO GOVERNMENT.

RECENTLY ONE OF THE HOUSE CHURCHES OF OUR MINISTRY WAS RAIDED BY I.C.E. THE INHABITANTS DIDN'T OPEN THE DOOR BUT FIVE OF THE SEVEN MEMBERS OF THE HOUSEHOLD WERE SUBSEQUENTLY APPREHENDED WHEN LEAVING THE APARTMENT TO WORK. BEING DETAINED THEMSELVES OR TURNING OVER THEIR HUSBANDS WHO STAYED HOME TO TAKE CARE OF CHILDREN. I.C.E. AGENTS ARRESTED THE FATHERS IN FRONT OF THEIR CRYING CHILDREN. MEMBERS OF THE COUNCIL, THE TRUST OF THE IMMIGRANT COMMUNITY HAS BEEN LOST. L.M.P.D. HAS BEEN SHOWN TO COOPERATE WITH I.C.E. A RAID OF AT LEAST TWICE A WEEK THE LAST FEW MONTHS.

WITHOUT THAT TRUST, CRIMES GO UNREPORTED. MEN, WOMEN AND CHILDREN ARE VICTIMIZED BY TRAFFICKING, DOMESTIC VIOLENCE, THEFT AND EXPLOITATION. BY PERSONS EMBOLDENED BY THE CRIMINALIZATION OF IMMIGRANTS. BY PEOPLE WHO BET THE POLICE WILL NOT BE CALLED. THE IMMIGRANT SYSTEM IS NOT ONLY BROKEN BUT THE ACTION OF I.C.E. DEMONSTRATE AS A TOOL OF SCAPEGOATING. WE MUST OPPOSE IT WITH TRUE COMPASSION AND FOR THE SURVIVAL OF OUR DEMOCRACY. OUR SANCTUARY RESOLUTION PROPOSES THE FOLLOWING. THE ONLY TIME L.M.P.D. SHALL ASSIST I.C.E. WHEN THERE'S A FEDERAL WARRANT. WE AREN'T TALKING ABOUT AN IMMIGRANT WHOSE ONLY MISSTEP WAS RETURNING TO THEIR FAMILY AFTER BEING DEPORTED.

WE NEED A POLICY THAT PROHIBITS L.M.P.D. OFFICERS FROM

COMMUNICATING WITH I.C.E. OFFICERS ON THEIR CELL PHONES. WE NEED TRAINING

FOR 9-1-1 DISPATCHERS TO REFER I.C.E. TO A SENIOR OFFICER ACTING WITH

EFFECTIVE OVERSIGHT. WE NEED SECURE ROOMS IN THE COURTHOUSE WHERE

IMMIGRANTS CAN BE SHIELDED FROM I.C.E. AGENTS. WE NEED PROTOCOLS FOR

JAILERS NOT TO TURN PEOPLE OVER TO I.C.E. UPON BEING RELEASED. WE NEED FOR

LOUISVILLE TO FOLLOW THE EXAMPLE OF CITIES LIKE LOS ANGELES, CHICAGO,

DENVER, CINCINNATI. WE NEED TO SUMMON OUR COURAGE AND DECLARE, IF YOU WANT

TO COME FOR OUR BELOVED NEIGHBORS YOU WILL HAVE TO COME THROUGH US. WE

APPLAUD COUNCILMEMBERS WHO ARE BEGINNING THE PROCESS OF BRINGING SUCH AN

ORDINANCE TO THIS COUNCIL AND WE ASK WHO ELSE WILL JOIN THEM IN MAKING

THIS A SAFE CITY FOR ALL LOUISVILLIANS. THANK YOU VERY MUCH. [APPLAUSE].

MR. CLERK: DR. JEFFREY GOLDBERG.

JEFFREY GOLDBERG: GOOD EVENING, MY NAME IS DR. JEFFREY GOLDBERG
AND I COME BEFORE YOU THIS EVENING TO CALL ATTENTION TO HEALTH HAZARDS TO

VULNERABLE INDIVIDUALS WHO RESIDE NEAR GAS STATIONS AND ADVOCATE FOR AMENDMENTS OF THE ZONING REGULATIONS TO MITIGATE THESE HAZARDS.

RECENTLY HAD THE OPPORTUNITY TO WORK WITH THE CITY REGARDING A ZONING MATTER INVOLVING THE DEVELOPMENT OF HOUSING FOR SENIOR ADULTS. AS A PHYSICIAN, I WAS PARTICULARLY CONCERNED ABOUT THE HEALTH BENEFITS OR RISKS TO THE PROPOSED DEVELOPMENT, SINCE THE RESIDENTS WERE TO BE LOCATED NEXT TO THE BUSY FILLING STATION, I TOOK THE OPPORTUNITY TO REVIEW THE MEDICAL LITERATURE TO DETERMINE WHETHER THIS PROXIMITY POSED ANY KNOWN HEALTH HAZARDS. SOMEWHAT TO MY SURPRISE, THERE WAS IN FACT SIGNIFICANT EVIDENCE THAT INDIVIDUALS WHO ARE CHRONICALLY EXPOSED TO GASOLINE FUMES SUCH AS GAS STATION ATTENDANTS DEVELOP CERTAIN CANCERS AND OTHER HEALTH PROBLEMS AT AN INCREASED RATE.

FOLLOW-UP STUDIES SUGGEST INDIVIDUALS WHO LIVE IN CLOSE

PROXIMITY TO GAS STATIONS ALSO FACE SIMILAR INCREASED HEALTH RISKS.

MULTIPLE OTHER GOVERNMENTAL AUTHORITIES INSTITUTED ZONING RESTRICTIONS TO MITIGATE THESE DOCUMENTED RISKS. MOST NOTABLY THE STATE OF CALIFORNIA ENVIRONMENTAL PROTECTION AGENCY PROMULGATED RECOMMENDATIONS THAT AUTHORITIES PROHIBIT PLACEMENT OF SENSITIVE LAND USES SUCH AS SENIOR HOUSING, SCHOOLS OR DAYCARE WITHIN 300 FEET OF ANY LARGE FUELING STATION.

I HAVE EMAILED THE METRO COUNCIL CLERK A COPY OF THE CALIFORNIA E.P.A. RECOMMENDATIONS FOR YOUR REVIEW. REST ASSURED IN THE INTEREST OF TIME I'M NOT GOING TO REVIEW ALL OF THE SCIENTIFIC LITERATURE NOR GO THROUGH THE LIST OF MUNICIPALITIES AND GOVERNMENTAL AGENCIES THAT HAVE ADDRESSED THESE RISKS.

HOWEVER, I WILL BE HAPPY TO PROVIDE YOU OR YOUR STAFF WITH COPIES OF THE RELEVANT MEDICAL LITERATURE AND I'M HAPPY TO MAKE MYSELF

AVAILABLE TO YOU OR YOUR STAFF IF YOU WOULD LIKE TO DISCUSS ANY ADDITIONAL DETAILS. AS YOU WELL KNOW, AIR QUALITY IS OF PARTICULAR CONCERN TO LOUISVILLE METRO AREA. I URGE YOU TO REFER THIS MATTER TO THE RELEVANT COMMITTEE FOR FURTHER STUDY AND DEVELOPMENT OF APPROPRIATE ZONING REGULATIONS TO PROTECT OUR MOST VULNERABLE CITIZENS. THANK YOU VERY MUCH.

MR. CLERK: DANNY ALVAREZ.

DANNY ALVAREZ: GOOD EVENING. I'M DANNY ALVAREZ. I'M A LOCAL IMMIGRATION ATTORNEY HERE IN TOWN. I'M HERE TO SPEAK TO SOMETHING THAT AFFECTS PEOPLE PROFESSIONALLY AND PERSONALLY, I'M THE SON OF IMMIGRANTS TO FOLKS THAT CAME FROM SOUTH COLUMBIA. THEY CAME HERE FOR A BETTER LIFE FOR BOTH ME AND MY SISTER. WE HOLD OURSELVES OUT IN THIS COMMUNITY AS A COMPASSIONATE, WELCOMING COMMUNITY.

AS ONE THAT HAS AN OPEN-DOOR POLICY FOR ALL WHO COME TO THIS

COMMUNITY AND CONTRIBUTE AND WORK HARD. AND I REPRESENT A LOT OF LATINOS

THAT ARE IN THIS COMMUNITY. SOME THAT ARE DOCUMENTED. SOME THAT ARE

UNDOCUMENTED AND THOSE FOLKS WORK HARD. AND I'M TIRED, I'M VERY TIRED OF

HAVING A 6, 7, 8-YEAR-OLD CHILD COME INTO MY OFFICE BAWLING CRYING BECAUSE

THEIR PARENTS, OR LOVED ONE HAS BEEN RIPPED OUT OF THEIR LIFE. AND IT

HAPPENS DAILY. AND IT IS UNCONSCIONABLE THAT WE AS A COMMUNITY DO NOT

STAND UP. WE SAY WE ARE A COMMUNITY THAT'S OPEN, WE SAY WE ARE A

COMPASSIONATE COMMUNITY. IT'S TIME FOR US TO STAND UP AND SHOW ALL OF US,

INCLUDE ALL OF US IN THIS DEMONSTRATION. IT'S TIME TO TAKE ACTION. AND

SHOW THAT WE ARE, IN FACT, A COMMUNITY THAT CARES ABOUT EVERYONE OF US.

THE VULNERABLE, AND THOSE THAT ARE NOT.

AND SO I ASK, AND I BEG THIS COUNCIL TO STAND UP, JUST LIKE
OTHER COMMUNITIES HAVE ACROSS OUR GREAT COUNTRY. DENVER, THE ONES THAT WE

JUST LISTED, ALL OF THOSE, I KNOW I DON'T HAVE TOO MUCH TIME TO TALK ANY MORE ABOUT THIS. BUT IF WE DO NOT STAND UP, WE ARE ALLOWING VICTIMS OF DOMESTIC ABUSE TO BE FURTHER ABUSED. TO BE FURTHER VICTIMIZED. WE HAVE A CRIME WAVE GOING ON RIGHT NOW. WE HAVE A VIOLENT CRIME WAVE GOING ON. GUNS AND MURDERS AND ASSAULTS ARE HAPPENING IN OUR COMMUNITY. AND WITNESSES THAT MAY BE UNDOCUMENTED TO THESE CRIMES WILL NOT COME FORWARD IF THEY FEAR THEY ARE GOING TO GET DEPORTED. AND WE DON'T, AS A COMMUNITY, WE SHOULD NOT TOLERATE THAT.

WE DO NOT WANT VICTIMS TO NOT APPROACH POLICE FOR FEAR THAT
THEIR STATUS WILL GET THEM DEPORTED. SO I IMPLORE YOU, I IMPLORE YOU WITH
EVERYTHING THAT IS IN MY HEART TO PASS NOT ONLY THIS ORDINANCE THAT'S ON
TONIGHT BUT ALSO PASS SANCTUARY FOR ALL. WE NEED TO STAND UP. WE NEED TO
DECLARE THAT OUR COMMUNITY WILL NO LONGER TOLERATE THE FAILURES OF THE
FEDERAL GOVERNMENT HAS NOT HAD THE POLITICAL COURAGE TO TACKLE. THE
FEDERAL GOVERNMENT HAS FAILED US. AND WE SHOULD NO LONGER, AS A COMMUNITY,
OF LOUISVILLE, NO LONGER AS A STATE TOLERATE THAT AND FOR THOSE REASONS I
ASK AND IMPLORE AND BEG YOU TO PASS NOT ONLY THIS ORDINANCE BUT A
SANCTUARY FOR ALL. THANK YOU. [APPLAUSE].

MR. CLERK: MR. PRESIDENT, THAT CONCLUDES THE ADDRESSES TO COUNCIL.

PRESIDENT YATES: THANK YOU, I ALSO WANT TO RECOGNIZE THAT COUNCILMEMBER PEDEN IS WITH US.

MR. CLERK: SO NOTED.

PRESIDENT YATES: NEXT I WOULD LIKE TO HAVE COUNCILWOMAN DENTON,

IF YOU WOULD PLEASE INTRODUCE OUR SPECIAL GUEST.

COUNCIL MEMBER DENTON: THANK YOU, MR. PRESIDENT. 20 YEARS
TOMORROW STARTED MY FAMILY'S PERSONAL EXPERIENCE WITH THE RONALD MCDONALD
HOUSE. MY NEPHEW WAS BORN, HE HAD SEVERAL ISSUES. MY SISTER, HER HUSBAND
WAS OUT OF TOWN FOR A LONG STINT AND SHE ENDED UP STAYING AT THE RONALD
MCDONALD HOUSE BECAUSE THE BABY WAS THERE FOR QUITE SOME TIME. SHE HAD TO
GO AND NURSE EVERY COUPLE HOURS AND LIVING FAIRLY FAR AWAY FROM NORTON
CHILDREN'S HOSPITAL, IT WAS DIFFICULT FOR HER TO CONTINUE TO FEED THE
BABY, NURSE THE BABY, TO BE ABLE TO SPEND TIME WITH HIM WHILE HE WAS GOING
THROUGH THIS DIFFICULT TIME.

AND I CAN REMEMBER ONE DAY I WALKED BACK TO THE RONALD MCDONALD HOUSE WITH HER, BECAUSE I HEARD OF IT, NEVER SEEN IT, NEVER BEEN IN IT.

AND I CAN TELL YOU, IT WAS A PRETTY DREARY PLACE. IT WAS DARK, IT WASN'T VERY BRIGHT, WARM OR INVITING. BUT IT WAS AT LEAST A PLACE SHE COULD GO AND BE CLOSE TO HER CHILD WHEN HER CHILD MOST NEEDED HER. SO IT COMES FULL CIRCLE SEVERAL MONTHS AGO MY HUSBAND STARTS TALKING ABOUT THE RONALD MCDONALD HOUSE AND HOW HE WAS GOING TO BE ON THE BOARD. I SAID THAT'S INTERESTING. I TOLD HIM THIS STORY, HE SAID I HAD NO IDEA YOUR SISTER HAD THAT KIND OF EXPERIENCE. SO I WENT BACK AND VISITED THE RONALD MCDONALD HOUSE AGAIN. ONLY THIS TIME IT WAS VERY BRIGHT, IT WAS VERY WARM, IT WAS VERY INVITING. IT WAS A PLACE SHE WANTED TO STAY IF YOU COULDN'T BE AT THE HOSPITAL AND IT WAS STILL VERY CONVENIENT.

THEY HAVE OUTGROWN THEIR SPACE. THEY ARE NOW IN THE PROCESS OF PURCHASING THE PROPERTY NEXT DOOR TO THEM, THE OLD U. OF L. MED SCHOOL. THEY WILL START A FUNDRAISING CAMPAIGN IN ORDER TO MAKE THAT A REALITY.

LAST YEAR THEY TURNED DOWN 364 FAMILIES BECAUSE THERE JUST WASN'T ROOM. SO THIS EXPANSION IS WELL NEEDED. THEY SERVE FAMILIES IN OUR COMMUNITY,

THROUGHOUT THE STATE, THE UNITED STATES AND EVEN THE WORLD. SO THEY ARE A NICE WELCOME SIGN FROM LOUISVILLE FOR FAMILIES WHO COME HERE FROM ALL PARTS OF THE WORLD EVEN, TO HAVE THEIR CHILDREN TREATED AT OUR CHILDREN'S HOSPITAL. SO WHAT I WANT TO DO TODAY IN HONOR OF THE SERVICES, AND THE COMMITMENT THAT THE RONALD MCDONALD HOUSE HAS TO THIS COMMUNITY AND THE CHILDREN THAT COME HERE FOR THEIR TREATMENT, I HAVE THE PROCLAMATION THAT RECOGNIZES SEPTEMBER 28th AS THE RONALD MCDONALD HOUSE DAY. AND WITH US TODAY IS THE EXECUTIVE DIRECTOR, MR. HAL HEDLEY.

[APPLAUSE.]

HAL HEDLY: WHAT A GREAT SURPRISE. THANK YOU, COUNCILWOMAN DENTON FOR SHARING YOUR STORY AND INVITING ME HERE THIS EVENING. COUNCILWOMAN DENTON FAMILY'S STORY IS ONE OF THOUSANDS WE HEAR AND WE SERVE EVERY YEAR AT RONALD MCDONALD HOUSE. BUT SHE IS EXACTLY RIGHT IN THAT WE HAVE OUT GROWN OUR SPACE. LAST YEAR OUR OCCUPANCY WAS 94%. WE TURN FAMILIES AWAY AND WE KNOW IT WILL CONTINUE TO GROW. NORTON HOSPITAL ANNOUNCED AN EXPANSION, WE NEED TO GROW ALONG WITH THEM. WHAT WE PROVIDE TO FAMILIES IS BOTH TANGIBLE AND INTANGIBLE. TANGIBLY WE PROVIDE GUEST ROOMS, COMFORTABLE TEMPER PEDIC BEDS TO SLEEP IN AFTER A LONG DAY AT THE HOSPITAL. WE PROVIDE WITH MEALS FROM VOLUNTEERS. SINCE 1984, LAST YEAR OVER 300 VOLUNTEERS SERVED MORE THAN 15,000 HOURS TO US. THAT'S GOING TO CONTINUE THIS YEAR AND NEXT YEAR AND INTO THE FUTURE. WE PROVIDE ALSO THE INTANGIBLE PIECE OF FAMILIES BEING AROUND OTHER FAMILIES OF SERIOUSLY ILL KIDS. I'M VERY FORTUNATE THAT NEITHER OF MY CHILDREN WERE SERIOUSLY ILL OR HAVE BEEN, BUT THESE FAMILIES ARE.

WE SERVE 36 FAMILIES AT A TIME, WHETHER IT'S A BABY BORN
PREMATURELY OR A CHILD DIAGNOSED WITH CANCER, OR A HORRIBLE CAR ACCIDENT

AND FRASER REHAB INSTITUTE AND U. OF L.'S PEDIATRIC NEURO. FROM KENTUCKY, SOUTHERN INDIANA, OTHER STATES TOO. BUT WE NEED TO EXPAND. WE HAVE BEEN VERY FORTUNATE TO HAVE THE OPPORTUNITY TO PURCHASE THE BUILDING NEXT TO OURS WHICH MORE THAN DOUBLES OUR SQUARE FOOTAGE. WE HAVE 36 ROOMS, WE WILL GROW TO BETWEEN 55-60 ROOMS BUT IT WILL COST AT LEAST \$15 MILLION TO DO THAT.

I'M NOT HERE TO ASK FOR ANY MONEY TONIGHT BUT IF YOU KNOW ANYONE WHO HAS \$15 MILLION LAYING AROUND I THINK YOU HAVE MY CONTACT INFORMATION. I WANT TO SAY THANKS FOR THE OPPORTUNITY TO SHARE THE WORD OF WHAT WE DO AT RONALD MCDONALD HOUSE. COUNCILWOMAN BARBARA SEXTON SMITH, THANKS FOR SPENDING TIME WITH US LAST MONTH AND LEARNING ABOUT OUR ORGANIZATION AND EXPANSION PROJECT. WE ARE EXCITED TO STAY AND GROW HERE IN LOUISVILLE. THANK YOU. THANK YOU FOR THIS AS WELL. [APPLAUSE].

DISCUSSION. COUNCILMEMBER CHERI BRYANT HAMILTON.

COUNCIL MEMBER BRYANT HAMILTON: MR. PRESIDENT, THIS ITEM IS UNDER OLD BUSINESS SO COUNCILMEMBER LEET [INAUDIBLE].

PRESIDENT YATES: COUNCILWOMAN LEET, WOULD YOU LIKE TO VOICE THAT ABSTENTION?

COUNCIL MEMBER LEET: AND WE AMENDED BY SUBSTITUTION. I BELIEVE IT WAS THE LAST ITEM BEFORE US LAST WEEK, WHEN YOU HAD TO DO THAT, I'M SORRY. WE AMENDED BY SUBSTITUTION.

PRESIDENT YATES: AMENDED BY SUBSTITUTION. OKAY. IS THERE ANY FURTHER DISCUSSION ON THIS ITEM? HEARING NO DISCUSSION, THIS IS A RESOLUTION ALLOWING FOR A VOICE VOTE. COUNCILWOMAN?

>> SHE JUST REMINDED ME, SORRY. I DIDN'T KNOW THIS WAS UNDER OLD BUSINESS. WE HAD JAY TOWN IN AND COUNTING THEM AS PART OF THE INCENTIVE BUT SINCE THEY ARE NOT IN, LOUISVILLE JEFFERSON COUNTY, THEN WE ARE FUNDING THE FULL INCENTIVE.

PRESIDENT YATES: THANK YOU FOR THAT EXPLANATION. IS THERE ANY OTHER DISCUSSION ON THAT? HEARING NONE, ALL THOSE IN FAVOR RESPOND BY SAYING AYE. THOSE OPPOSED? THE AYE'S HAVE IT, THE AMENDED RESOLUTION PASSES. MR. CLERK, A READING OF ITEM 49.

PRESIDENT YATES: IT'S BEEN PROPERLY MOVED AND SECONDED. IT'S BEFORE US FOR DISCUSSION. COUNCILMEMBER WOOLRIDGE.

MR. CLERK: APPOINTMENT OF E. PHILLIP SCHERER TO THE DOWNTOWN MANAGEMENT DISTRICT BOARD.

TERM EXPIRES SEPTEMBER 28, 2020.

READ IN FULL.

>> THANK YOU, MR. PRESIDENT. THIS PARTICULAR APPOINTMENT WE SPENT MOST OF OUR TIME DISCUSSING BECAUSE HE HAS SERVED ON THIS COMMITTEE BEFORE ON THIS BOARD. BUT AS WE LEARNED IT WASN'T FOR A FULL OF TERM, HE WAS FILLING IN FOR AN UNEXPIRED TERM. WE HAVE THE STATUTE TONIGHT THAT SAYS THAT DOESN'T COUNT TOWARD SERVING A TERM.

>> AS WE LEARNED, I BELIEVE WITH THE APPOINTMENT, I THINK WE
WERE GIVEN INCORRECT INFORMATION HE HAD SERVED NOT ON A FULL TERM AND THEN
COME TO FIND OUT HE HAS IN FACT SERVED ON TWO FULL TERMS BUT THEY WERE NOT
CONSECUTIVE TERMS AND PART OF THE ISSUE THAT WE HAD, AND THE REASON IT
ENDED ON OLD BUSINESS WAS WE HAD QUESTIONS REGARDING -- IBELIEVE THERE
COULD BE SOME OFF THE TABLE, WHICH AT THIS POINT IN TIME, UNLESS THERE'S

FURTHER DISCUSSION, I WOULD LIKE TO MAKE A MOTION TO SEND THIS BACK TO COMMITTEE UNTIL WE ARE JUST TOTALLY FIRM THAT WE HAVE CLEAR INFORMATION, ACCURATE INFORMATION. IT SAYS THE WHOLE PROCESS STARTS OVER.

PRESIDENT YATES: BEFORE MAKING THAT MOTION, WOULD YOU MIND YIELDING THE FLOOR TO THE COUNTY ATTORNEY FOR AN EXPLANATION.

>> WITH REGARDS TO THE NUMBER OF TERMS THAT SOMEONE CAN SERVE ON THE LOCAL METRO DEVELOPMENT DISTRICT, LOUISVILLE DOWNTOWN MANAGEMENT DISTRICT, SORRY, THEY CAN SERVE TWO TERMS. THE ORDINANCE IS WRITTEN DOWN, DOES NOT SPECIFY WHETHER THAT IS CONSECUTIVE OR NOT. SO I THINK A PERSON IS LIMITED TO TWO TERMS, SO IT DOESN'T MATTER IF THERE WAS A BREAK IN THAT SERVICE. SO THAT'S IF THE ORDINANCE IS WRITTEN BUT AS COUNCILWOMAN PARKER STATED, THE LOUISVILLE METRO COUNCIL CONTROLS THE ORDINANCE WHICH DESIGNATES WHAT THE TERMS ARE WITH REGARD TO SERVICE ON THE BOARD. SO AS IT'S WRITTEN, YOU CAN SERVE TWO LIMITS. WE WERE UNDER THE IMPRESSION THERE WERE TWO ISSUES.

ONE WAS WHAT CONSTITUTES THE TERM AND SOMEONE WHO FILLS AN UNEXPIRED TERM NOT CONSIDERED TO HAVE FILLED A TERM. SO IF YOU FILLED TWO YEARS OF THE THREE-YEAR TERM YOU COULD STILL SERVE TWO MORE THREE-YEAR TERMS BECAUSE YOU HAVEN'T SERVED A THREE-YEAR TERM, SO A TERM IS VERY SPECIFIC WITH A BEGIN DATE AND END DATE. BUT WITH REGARDS TO -- PRESIDENT YATES: IS IT THE OPINION OF THE COUNTY ATTORNEY'S OFFICE THAT THE MOMENT IS APPROPRIATE OR VIOLATION BASED ON THE COUNTY ATTORNEY'S READING OF THE RULE.

>> ITEM 49, BASED ON THE INFORMATION THAT I'VE BEEN GIVEN, I
BELIEVE THAT THE INFORMATION I'VE BEEN GIVEN IS HE IS ELIGIBLE. HOWEVER AS
COUNCILMEMBER PARKER STATED WITH REGARD TO 50, I WAS GIVEN DIFFERENT

INFORMATION THIS EVENING WHERE HE STATED HE HAS SERVED TWO FULL TERMS. 49, I BELIEVE AND I DON'T KNOW IF ANYONE FROM THE MAYOR'S OFFICE CAN SPEAK TO, WITH REGARDS TO IF HE SERVES TWO FULL TERMS OR FILLED AN UNEXPIRED TERM. THEN YES HE WOULD BE ELIGIBLE. HOWEVER THAT WAS THE SAME INFORMATION GIVEN WITH REGARDS TO MR. STRAUB. BUT HE SERVED TWO FULL TERMS.

PRESIDENT YATES: THANK YOU.

COUNCILMEMBER JAMES PEDEN.

QUESTIONS ON YOUR THOUGHTS THAT IF YOU SERVE OUT AN UNEXPIRED TERM THAT

DOESN'T COUNT AS A TERM, IS THERE A LIMIT ON THAT? I MEAN, EVEN THE VICE

PRESIDENT OF THE UNITED STATES, IF HE RELIEVES A SITTING PRESIDENT, IT'S

MORE THAN TWO YEARS OF FOUR, HE DOESN'T GET ANOTHER TERM OF HIS OWN.

SURELY THERE'S GOT TO BE SOME LIMIT. SURELY IF I RESIGN TWO MONTHS IN AND

SCOTT TAKES OVER FOR ME, THAT HAS --

>> THERE'S NOT, IF THE VICE PRESIDENT WAS TO TAKE OVER FOR THE PRESIDENT FOR TWO REMAINING YEARS, IF HE DECIDED TO RUN FOR TWO MORE TERMS HE COULD RUN FOR TWO MORE TERMS.

- >> BUT IF IT WAS TWO YEARS AND A MONTH? YES MA'AM.
- >> I HAVE IT. A TERM IS SPECIFIC BASED ON WHAT THE ORDINANCE OR STATUTE SAYS. OUR ORDINANCE SAYS IT IS THREE YEARS. YOU GET A THREE-YEAR TERM. SO ANYTHING LESS THAN THREE YEARS DOESN'T CONSTITUTE A TERM UNDER KENTUCKY CASE.

>> I'M SORRY, I WAS REFERRING TO THE FEDERAL VICE PRESIDENT AND FEDERAL PRESIDENT. I'M SAYING THAT'S PRETTY CONSTITUTIONAL, ANYTHING MORE THAN TWO YEARS YOU DON'T GET ANOTHER TERM.

>> UNDER KENTUCKY CASE LAW AND ALL PERTINENT LAWS A TERM IS A TERM, SO IT WOULD BE THREE YEARS. IF YOU DO NOT SERVE THREE YEARS YOU ARE NOT PREVENTED FROM SERVING WHATEVER THE TERM LIMITS ARE, YOU WILL STILL BE ELIGIBLE TO SERVE. IF IT SAYS YOU CAN SERVE TWO DIFFERENT TERMS, YOU CAN COMPLETE SOMEONE ELSE'S UNEXPIRED TERM AND YOU YOURSELF COULD GET TWO TERMS, IF THAT WAS THE LIMIT.

>> IN A WAY OF MANIPULATING THAT LAW, WHAT IF I RESIGNED ONE

MONTH LEFT ON MY TERM AND THEN ASKED FOR REAPPOINTMENT TWO MONTHS LATER. I

MEAN IS THAT ALL LEGIT BECAUSE I THEORETICALLY HAVEN'T COMPLETED A TERM

YET.

- >> THAT'S NOT THE ISSUE THAT IS HERE SIR.
- >> ACTUALLY THAT IS PART OF THE ISSUE BECAUSE I'M ON THAT COMMITTEE. THERE WAS SOME DISCUSSION ON ONE OF THE CANDIDATES WE ARE TALKING ABOUT, DIDN'T FINISH A TERM BECAUSE THEY WENT TO GO SERVE ON ANOTHER BOARD. THAT WAS PART OF IT.
 - >> IF IT'S MR. STRAUB HE INDICATED HE SERVED TWO FULL TERMS.
- >> I SPOKE TO HIM PERSONALLY ON THE PHONE. BUT WHAT WAS DISCUSSED AT THE MEETING AND WHAT WAS SUPPORTED BY MR. LACOCO, WAS IF YOU DON'T FINISH YOUR OWN TERM IT DOESN'T COUNT.
 - >> THAT IS NOT WHAT I SAID.
 - >> OKAY, AND I'M JUST CLARIFYING.
- >> AND I HAVE MR. LECOCO'S OPINION. IF YOU ARE APPOINTED TO FILL AN UNEXPIRED TERM, YOU ARE STILL ELIGIBLE TO SERVE WHATEVER THOSE TERM LIMITS ARE.

>> OKAY.

>> I HAVE NO RESEARCHED IF YOU RESIGN, SO I'M NOT GOING TO SPEAK
TO THAT, THAT'S NOT THE SAME ISSUE. BUT MR. STRAUB INDICATED THIS
AFTERNOON HE SERVED TWO FULL TERMS. SO THAT'S WHY OF THE OPINION BASED ON
HIS REPRESENTATION HE WOULD BE INELIGIBLE.

PRESIDENT YATES: COUNCILMEMBER?

>> THANK YOU, MR. PRESIDENT. MS. BAKER IS CORRECT. WE GOT A
CONFERENCE CALL WHERE HE GAVE US THE CLEAR UNDERSTANDING OF WHAT HAD TAKEN
PLACE AND HE HAD SERVED TWO BACK-TO-BACK TERMS. LEFT, WENT BACK TO THE
BRIGHT SIDEBOARD. AND FOR THOSE OF US WHO KNOW MR. LEWIS, HE IS A 60-WEEK
BANKER AND ON TOP OF THAT DEDICATED PUBLIC SERVANT TO BRIGHT SIDE AND
OTHER ORGANIZATIONS. MY QUESTION IS THIS, BASED ON WHAT YOU JUST SAID, YOU
MAY NOT HAVE AN ANSWER SO I DON'T WANT TO PUT YOU IN A POSITION OF
PRESSURING YOU. BUT WHAT I THOUGHT I HEARD WAS WHEN YOU FILL IN AN
UNEXPIRED TERM, THAT DOESN'T COUNT. SO I GUESS MY QUESTION IS, MY LIMITED
UNDERSTANDING IS MR. STRAUB IS CURRENTLY SERVING ON THE DOWNTOWN
MANAGEMENT BOARD, IN AN UNEXPIRED TERM. THEY WILL BE HONORING HIM ON
OCTOBER 11th FOR HIS DEDICATION SERVICE TO THE BOARD. SO THE QUESTION IS,
IF AN UNEXPIRED TERM DOESN'T COUNT TOWARD THE COUNTING, DOES MR. STRAUB'S
TWO TERMS WHICH EXCLUDE HIM BUT THE UNEXPIRED NOW CAN HE CARRY IT OUT?

>> I DON'T THINK THAT'S THE SAME ANALYSIS.

>> CAN WE GET A LEGAL OPINION BEFORE WE ESSENTIALLY REJECT OR

AFFIRM THIS GUY. MAYBE THIS IS SOMETHING THAT SHOULD GO BACK TO COMMITTEE

TO GET A LEGAL OPINION ON THAT.

>> YEAH.

>> THANK YOU.

PRESIDENT YATES: WE HAVE SEVERAL PEOPLE IN THE QUEUE. I DID TELL COUNCILMEMBER PARKER WE WOULD GO BACK BECAUSE SHE WAS GOING TO HAVE A MOTION ON THE FLOOR, I KNOW SHE HAS YIELDED TO PEOPLE IN THE QUEUE. COUNCILMEMBER PARKER, DO YOU WANT TO VOICE THAT AGAIN?

>> YES.

PRESIDENT YATES: THIS IS ITEM 49 BEFORE US.

>> I WOULD LIKE TO MAKE IT FOR ITEM 48 AND 49. EXCUSE ME, 49 AND 50.

PRESIDENT YATES: CAN WE MAYBE DO ONE AT A TIME. BECAUSE WE ONLY HAVE ONE BEFORE US. 50 ISN'T BEFORE US AT THIS TIME.

>> I WOULD LIKE TO MAKE A MOTION TO TABLE ITEM 49.

PRESIDENT YATES: THANK YOU. DO WE HAVE A SECOND? PROPERLY MOVED AND SECONDED. DISCUSSION?

>> I MEAN SEND BACK TO COMMITTEE.

PRESIDENT YATES: DO I HAVE A SECOND?

>> SECOND.

PRESIDENT YATES: IS THERE ANY DISCUSSION ON THAT? SEEING NONE, ALL THOSE IN FAVOR, SENDING ITEM 49 BACK TO COMMITTEE SIGNIFY BY SAYING AYE. THOSE OPPOSED?

>> NO, I OPPOSE. ROLL CALL, PLEASE.

PRESIDENT YATES: MR. CLERK, FOR CLARIFICATION, PLEASE ROLL CALL. WITHOUT OBJECTION THE VOTING IS CLOSING. THE VOTING IS CLOSED.

MR. CLERK: THERE ARE 19 YES VOTES, 6 NO-VOTES. NO WOOLRIDGE SEXTON SMITH, COAN, HOLLANDER, MULVIHILL, AND FLOOD.

PRESIDENT YATES: MR. CLERK A READING OF ITEM 50?

PRESIDENT YATES: WE HAVE A MOTION AND SECOND FOR APPROVAL. DISCUSSION?

>> MOTION TO RETURN THIS TO COMMITTEE.

PRESIDENT YATES: IT'S BEEN PROPERLY MOVED AND SECONDED. NOW
THERE'S A MOTION BEFORE US TO RETURN TO COMMITTEE. LET'S GET IT BEFORE US.
WE HAVE A MOTION AND SECOND FOR APPROVAL. NOW WE HAVE A MOTION AND SECOND
TO RETURN TO COMMITTEE. IS THERE DISCUSSION ON THAT?

COUNCILMEMBER COAN.

COUNCIL MEMBER COAN: THANK YOU, MR. PRESIDENT. I JUST WANT TO
TAKE THE OPPORTUNITY TO ASK ONE QUESTION I HAD LEFT OVER FROM THE
DISCUSSION. TO TAKE COUNCILMEMBER PEDEN'S EXAMPLE, I THINK TO THE EXTREME,
NOT THAT THERE IS ANY REASON THERE'S SOME FRAUD OR CORRUPTION IN
APPOINTMENTS GOING ON IN OUR CITY GOVERNMENT BUT IF PERSON A WAS APPOINTED
TO BOARD X AND ON THE VERY FIRST DAY OF A 2-3 YEAR TERM RESIGNED, AND THEN
PERSON 2 WAS APPOINTED THE VERY NEXT DAY, DO THEY GET THE ENTIRE THREE
YEARS AND 364 DAYS AND THEN TWO MORE TERMS SO THAT PERSON COULD
EFFECTIVELY SERVE THREE TERMS INSTEAD OF THE TWO PRESCRIBED BY LAW?

>> [OFF MIC].

>> IS THERE ANY SORT OF, IN THE INCREDIBLY UNLIKELY EVENT THAT HAPPENS IS THERE ANY SORT OF RECOURSE TO ADDRESS THAT.

>> LOUISVILLE METRO COUNCIL CONTROLS THE ORDINANCE THAT SETS THOSE TERM LIMITS.

>> OKAY, THANKS.

PRESIDENT YATES: THERE WAS A MOTION MADE IMMEDIATELY.

COUNCILMEMBER WOOLRIDGE.

COUNCIL MEMBER WOORLRIDGE: THANK YOU, MR. PRESIDENT. BASICALLY WHAT WE HAVE A RULING, WE HAVE A STATUTE FROM THE COUNTY ATTORNEY'S OFFICE. IT STATES AND EVERYBODY ON THE COMMITTEE GOT THIS INFORMATION. VIA EMAIL, AS WELL AS THEIR ASSISTANTS. SO I DON'T KNOW WHY PEOPLE ARE ACTING LIKE THEY NEVER HEARD ABOUT THIS ABOUT THE CASE THE COUNTY ATTORNEY JUST CITED. SHE CITED THE CASE LAW, 316, 317 KENTUCKY, 1929. A TERM IS FOR A DEFINITE, AND A FIXED PERIOD.

THE FILING OF AN UNEXPIRED TERM DOESN'T COUNT FOR SERVING A TERM IN OFFICE. SO I DON'T KNOW WHY WE ARE SENDING THIS BACK TO THE COMMITTEE.

WHAT CAN WE DO IN THE COMMITTEE EXCEPT WHAT WE ARE DOING NOW? WE DID THAT PRETTY MUCH THE ENTIRE HOUR OF THE COMMITTEE MEETING. AND YOU KNOW,

ANOTHER THING I WILL SAY, THIS IS AN EDITORIAL. YOU KNOW, THESE PEOPLE ARE WILLING TO SERVE ON THESE BOARDS. THEY ARE QUALIFIED TO SERVE ON THESE BOARDS. THEY ARE QUALIFIED TO SERVE ON THESE BOARDS. THEY SERVE ON THESE BOARDS AT THE REQUEST OF THEIR EMPLOYER, SO WHAT IS THE PROBLEM? THANK YOU, MR. PRESIDENT.

PRESIDENT YATES: THANK YOU, COUNCILWOMAN.

COUNCILWOMAN PARKER.

COUNCIL MEMBER PARKER: YES, I THINK THE PROBLEM WITH BOTH OF THESE, THEY WERE SIMILAR BUT THERE WERE TWO SEPARATE ISSUES. ONE DID NOT SERVE. OR AT LEAST TO OUR BEST KNOWLEDGE DID NOT SERVE ON COMPLETE TERMS. WE WERE TOLD THAT MR. STRAUB ALSO DID NOT SERVE ON COMPLETE TERMS BUT THAT WAS INCORRECT. THE DATES SEEM TO BE WRONG THAT YOU PULL UP IN THE SYSTEM. THERE WAS NOT ACCURATE INFORMATION THAT WAS GIVEN. AND THEN THERE'S PROBABLY ALSO SOME CLARIFICATION THAT NEEDS TO BE MADE WITH OUR OWN RULES. THE STATUTE THAT WAS PULLED UP BY THE COUNTY ATTORNEY TO REITERATE THAT, THAT GIVES THE STATE THE POWER TO CREATE THIS BOARD.

BUT LIKE OUR COUNTY ATTORNEY SAID, WE MAKE THE RULES. SO WE PROBABLY NEED TO GO BACK AND REVISIT OUR RULES AND JUST MAKE SOME CLARIFICATIONS IN THERE SO THAT WE DON'T HAVE THESE ISSUES TO BEGIN WITH. I DON'T THINK IT'S SO MUCH UNEXPIRED TERMS. I THINK PART OF IT IS HOW MANY TERMS CAN YOU SERVE COMPLETE TERMS. AND IF THERE'S AN INTERIM IN THE MIDDLE, DOES THAT START THE PROCESS OVER AGAIN. BECAUSE THERE WAS SOME DISCUSSION ABOUT THAT AS WELL. WE DON'T HAVE A COMPLETE ANSWER FOR THAT. AT LEAST NOT IN MY MIND. I JUST WANT TO SEE IF THAT HELPS CLARIFY A FEW THINGS.

PRESIDENT YATES: THANK YOU, COUNCILWOMAN.

COUNCILWOMAN FLOOD.

COUNCILWOMAN, WOULD YOU LIKE THE FLOOR? YOUR MICROPHONE IS HAVING SOME ISSUES.

>> WITH REGARDS TO THIS BOARD, I THINK IT'S CLEAR THAT YOU HAVE
TWO TERMS. WITH REGARDS TO OTHER BOARDS IN THE ORDINANCES THERE ARE SOME
THAT SAY CONSECUTIVE TERMS AND IT'S NOT BARRED FROM TAKING A BREAK AND
COMING BACK. SO IT JUST DEPENDS ON WHICH BOARD IS IN FRONT OF YOU, BUT
WITH REGARD TO THIS BOARD TWO TERMS IN THE ORDINANCE AS IT IS WRITTEN NOW.

PRESIDENT YATES: WE HAVE A MOTION AND SECOND BEFORE US TO SEND BACK TO COMMITTEE. ANY DISCUSSION ON THAT? COUNCILWOMAN FLOOD?

COUNICL MEMBER FLOOD: THE ONLY QUESTION, I THOUGHT THIS WAS VERY DIFFERENT THAN THE OTHER ONE. THIS GENTLEMAN HAS ACTUALLY SERVED TWO FULL TERMS. NOT FILLING ANYBODY'S POSITION. HE SERVED TWO TERMS HIMSELF.

- >> THAT IS WHAT HE INDICATED, YES.
- >> THAT MEANS HE WOULD NOT BE ELIGIBLE, RIGHT?

PRESIDENT YATES: COUNCILMEMBER BARBARA SEXTON SMITH?

COUNCIL MEMBER SEXTON SMITH: YES, THANK YOU, MR. PRESIDENT. DID

IT EVER COME UP WHEN HIS FIRST SERVICE BEGAN ON THIS PARTICULAR BOARD?

DOES ANYONE KNOW THAT?

PRESIDENT YATES: I THINK COUNCILWOMAN PARKER IS INDICATING SHE MAY HAVE THAT ANSWER.

COUNCIL MEMBER PARKER: I DID HAVE DATES WRITTEN DOWN. WHAT WAS PULLED UP IN GRANICUS, 12/31/13 TO 3/31/16. THAT WOULD HAVE BEEN THE SECOND TERM. AND THE FIRST TERM WAS FEBRUARY 12th, 2007. TO JANUARY 31ST, 2010. IF THESE REPORTINGS ARE RELIABLE.

PRESIDENT YATES: COUNCILMEMBER BARBARA SEXTON SMITH?

COUNCIL MEMBER SEXTON SMITH: IS IT YOUR UNDERSTANDING THERE WAS A BREAK BETWEEN 2010 AND 2013 OF NO SERVICE? THERE MIGHT HAVE BEEN THREE TERMS. ONE AN UNEXPIRED TERM AND TWO FULL TERMS.

>> NO, IT WAS MENTIONED ONE WAS AN UNEXPIRED TERM. MR. YATES
MENTIONED ONE TERM WAS A PARTIAL TERM AND THE OTHER TERM WAS A FULL TERM.
BUT THE APPLICANT HIMSELF SAID THROUGH OTHER DISCUSSION WITH
COUNCILMEMBERS THEY HAD SERVED TWO FULL TERMS.

>> AND BASED ON THE DATES YOU JUST GAVE US, IT APPEARS IT'S TWO FULL TERMS, IS WHAT THAT APPEARS. THANK YOU FOR THAT.

PRESIDENT YATES: COUNCILMEMBER ACKERSON?

COUNCIL MEMBER ACKERSON: YES, MR. PRESIDENT. I WAS GOING TO SUGGEST ONE HAS BEEN SENT BACK, IS THERE A PROBLEM SENDING BACK, GETTING CLARIFICATION, I HAVE A QUESTION I POSE TODAY MS. BAKER. SO THEY BOTH COME BACK, VERSUS SHOOTING FROM THE HIP TONIGHT.

PRESIDENT YATES: THE MOTION IS BEFORE THE BODY TO SEOND BACK TO COMMITTEE. THAT'S STILL UP FOR DISCUSSION. COUNCILMEMBER WOOLRIDGE?

COUNCIL MEMBER WOOLRIDGE: MR. PRESIDENT, THANK YOU. I CAN'T QUITE UNDERSTAND THIS APPOINTMENT. I AM HEARING PEOPLE SAY THEY HAVE HAD TELECONFERENCE WITH THIS PARTICULAR -- WITH MR. STRAUB. NO ONE HAS TOLD ME. I HAVEN'T BEEN ON A TELEPHONE CONFERENCE WITH ANYONE AND I CHAIR THIS COMMITTEE. SO I CAN'T GO BY WHAT SOMEBODY SAID. NOT THAT THEY AREN'T TELLING THE TRUTH. BUT I CAN'T TAKE YOUR WORD WHEN YOU COME INTO THE CHAMBER AND SAID I TALKED TO SOMEONE ON THE TELEPHONE. THAT'S NOT HOW WE TAKE CARE OF BUSINESS, IN MY ESTIMATION. THANK YOU.

PRESIDENT YATES: THANK YOU, COUNCILWOMAN. I THINK THERE'S A MOTION ON THE FLOOR TO SEND BACK TO COMMITTEE TO HAMMER OUT SOME OF THAT INFORMATION. COUNCILMEMBER KRAMER?

COUNCIL MEMBER KRAMER: THANK YOU, MR. PRESIDENT, THAT WAS GOING TO BE MY PRECISE COMMENT, AS PER COUNCILWOMAN WOOLRIDGE'S CONCERN, SINCE IT HASN'T GONE THROUGH COMMITTEE, IT WOULD SEEM APPROPRIATE IT GO BACK TO COMMITTEE TO HAVE THIS CONVERSATION. IF IN FACT HE ISN'T ELIGIBLE THAT GIVES THE MAYOR A CHANCE TO FIGURE OUT WHAT HE WOULD LIKE TO DO AS WELL.

PRESIDENT YATES: SOUNDS LIKE AN ANSWER. WITH NO FURTHER

DISCUSSION, THE QUESTION BEFORE US, ALL IN FAVOR SENDING THIS BACK TO

COMMITTEE SAY AYE. OPPOSED? THE AYE'S HAVE IT. THIS WILL BE SENT BACK TO

COMMITTEE.
