WE DO HAVE YOUNG PEOPLE IN THE AUDIENCE AND THOSE WATCHING ON TV.

I APPRECIATE THAT COURTESY.

MADAM CLERK, WOULD YOU PLEASE CALL THE FIRST SPEAKER FORWARD.

MADAM CLERK: NATALIE HARRIS.

NATALIE HARRIS: THANK YOU, PRESIDENT YATES AND METRO COUNCIL FOR THIS OPPORTUNITY.

I AM NATALIE HARRIS, THE DIRECTOR OF THE COALITION OF THE HOMELESS AND ALSO THE CHAIRPERSON FOR THE LOUISVILLE AFFORDABLE HOUSING TRUST FUND.

SO I CAME HERE TONIGHT TO DO SOMETHING A LITTLE DIFFERENT AND TO THANK YOU ALL FOR YOUR SUPPORT AND ALL YOU HAVE DONE THIS YEAR.

YOU HEAR FROM ME A LOT ABOUT THE NEED FOR AFFORDABLE HOUSING IN OUR COMMUNITY, BUT TONIGHT I SIMPLY WANT TO SAY THANK YOU.

THANK YOU FOR CREATING LOW-INCOME HOUSING REQUIREMENTS FOR PROPERTIES THAT RECEIVE TAX INCENTIVE FINANCING FOR HOUSING DEVELOPMENT.

THANK YOU AGAIN FOR HOLDING THEM TO THOSE COMMITMENTS WHEN IT WOULD BE EASY TO CAVE IN.

THANK YOU FOR COMMITTING NDF FUNDS TO STAND DOWN AND GIVE A JAM, WHERE WE WILL LEVERAGE OVER \$50,000 OF ADDITIONAL FUNDS TO HELP YOUNG ADULTS WHO ARE PART OF A 100-DAY CHALLENGE WHERE WE ARE TRYING TO HOUSE 100 YOUTH IN OUR COMMUNITY WHO ARE HOMELESS IN 100 DAYS.

AND WE WILL BE SENDING YOU INFORMATION ABOUT THAT IN THE COMING WEEKS.

THANK YOU ALSO FOR ALLOCATING THE LARGEST ONE-YEAR COMMITMENT TO LOUISVILLE'S AFFORDABLE HOUSING MARKET IN HISTORY.

THANK YOU FOR THE WORK OF THAT AFFORDABLE I HOUSING TRUST FUND AND THE FACT THAT SINCE THEY HAVE GOTTEN TOGETHER WITH LOUISVILLE FORWARD THOSE FUNDS ARE ALREADY OUT AND WAITING FOR APPLICATIONS.

THEY HAVE ACTUALLY ALREADY RECEIVED SOME APPLICATIONS.

THIS YEAR WE ADDED NEW INITIATIVES TO CREATE NEIGHBORHOOD DEVELOPMENT PROJECTS AND TO TARGET AREAS OF EMPLOYMENT THROUGH ADVICE WE RECEIVED FROM MEMBERS HERE.

WITH THE NEED FOR OVER 60,000 AFFORDABLE HOUSING UNITS IN THE CITY, WE STILL HAVE MUCH TO DO, AND YOU KNOW THAT I WILL BE BACK TALKING

ABOUT THE NEED FOR A PERMANENT SOURCE OR MULTIPLE PERMANENT SOURCES OF FUNDING FOR THE LOUISVILLE AFFORDABLE HOUSING TRUST FUND.

BUT THIS HAS BEEN AN AMAZING YEAR, BECAUSE WE ARE MAKING PROGRESS.

TODAY, I JUST WANT YOU TO KNOW THAT WE APPRECIATE YOUR EFFORTS AND WE THANK YOU FOR ALL THAT YOU DO.

VANESSA LACKEY: HELLO.

MY NAME IS VANESSA LACKEY.

AND I'M HERE BECAUSE WE LOVE OUR CITY AND NEIGHBORHOOD.

A GOOD NEIGHBORHOOD CONSISTS OF HOMEOWNERS' RESPONSIBILITIES TO BE GOOD NEIGHBORS.

SO NOW WE WANT TO TAKE BACK OUR NEIGHBORHOODS.

UPDATE AND IS REVISIONS TO THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT CODES OF ORDINANCES THAT YOU HAVE A COPY OF, AND AT THIS TIME I WOULD LIKE TO GIVE THREE EXAMPLES.

OF COURSE IT WILL BRING DOWN PROPERTY VALUES ON HOMES.

VACANT HOMES AND VEHICLES, VEHICLES IN THE BACKYARDS FOR 20 TO 25 YEARS.

WHETHER IT IS ON THE GAS OR CONCRETE.

WE HAD AN INCIDENT LAST YEAR IN OUR NEIGHBORHOOD, A YOUNG NEIGHBOR WAS PREPARING DINNER.

THE GRILL WENT UP IN FLAMES, CAUGHT THE HOUSE ON FIRE, THE THREE CHILDREN WERE IN THE HOUSE.

HE WAS RUNNING AROUND THE HOUSE AND HE COULD NOT GET THE KIDS OUT BECAUSE THE FRONT DOOR WAS LOCKED AND THE BACK OF THE HOUSE WAS ON FIRE.

AND SO THAT IS WHY WE ARE REALLY ARE TRYING TO HELP PEOPLE TO UNDERSTAND HOW IMPORTANT IT IS FOR US TO NOT COOK ON THE FRONT PORCH, BACK PORCH WITH OUR GRILLS.

WE ARE ASKING FOR THE 16 ORDINANCES TO BE ENFORCEABLE, THE ONES THAT YOU HAVE A COPY OF, ALONG WITH THE OTHER ORDINANCES ON THE BOOKS.

WE WANT OUR NEIGHBORHOODS TO RETURN TO THE SAFE AND BEAUTIFUL PLACES THAT OUR PARENTS AND GRANDPARENTS CREATED FOR US.

WE WANT TO HELP YOU HELP US TAKE OUR NEIGHBORHOODS BACK.

THANK YOU SO VERY MUCH.

IF YOU HAVE ANY QUESTIONS, I WOULD BE GLAD TO MEET WITH ANY ONE OF YOU TO GO OVER ANY OF THE ORDINANCES THAT WE MAY HAVE AND THAT WE ARE ASKING FOR HELP FOR TO TAKE OUR NEIGHBORHOODS BACK.

JEREMY JONES: I HAVE SOME QUESTIONS ABOUT THE STADIUM PROCESS AND THE SOCCER TEAM IN GENERAL AND I'M GOING TO ASK THEM NOW.

ONE WEEK AGO, TEAM OFFICIALS SAID THEY WERE LOSING \$1 MILLION A YEAR ON THE TEAM.

IN 2015 THEY LOST \$700,000 IN THE TEAM.

THE LOSSES APPEAR TO BE ACCELERATING.

WITH SUCH A SUBSTANTIAL FINANCIAL INVESTMENT WHY AREN'T THE AUDITS OF THE CLUB BEING MADE PUBLIC?

ARE THEY ACCURATE OR MORE OR LESS MISSTATED?

THE STADIUM HAS BEEN PRESENTED AS PART OF APPLYING TO BE A MEMBER OF THE MLS.

THE MLS IS ABOUT TO EXPAND BY TWO CITIES.

OF THE 12 CITIES THAT ARE CANDIDATES, TWO HAVE STADIUMS READY FOR EXPANSION TEAMS AND OF THOSE BOTH NEED TO BE EXPANDED TO FIT MLS SPECIFICATIONS.

SINCE THE EXISTING STADIUM IS NOT PART OF A BID WHY HASN'T THE CURRENT LOUISVILLE CITY PUT IN A BID FOR THE MLS EXPANSION?

WBRB REPORTED THE LAND BEING ACQUIRED WASN'T APPRAISED UNTIL AFTER A PRICE WAS AGREED TO BECAUSE, ACCORDING TO WBRB, A SPOKESPERSON SAID IT WASN'T A PRIORITY.

THE FISCHER ADMINISTRATION WILL ARRIVE WITH A PRICE -- AND WHY WAS THE APPRAISAL ONLY COMPLETED LAST THURSDAY?

WHY WAS THE PERSON WHO WAS CHOSEN TO DO THE APPRAISAL CHOSEN BASED ON THEIR FRIENDSHIP WITH LOUISVILLE CITY FC OWNERSHIP?

AND WHO OWNS THIS LAND AND BENEFITS FROM ITS SALE?

ARE ANY OF THOSE PEOPLE ALSO OWNERS OF THE TEAM?

HOW DID THEY ARRIVE AT THE JUSTIFICATION THAT IN CASE THE TEAM GOES BELLY UP WE CAN RECOUP OUR INVESTMENTS BY SELLING THE LAND IF THEY DON'T ACTUALLY KNOW WHAT THE FAIR MARKET VALUE OF THE LAND WAS UNTIL LAST THURSDAY?

WHEN STADIUM EVENTS ARE HELD AT THE SOCCER STADIUM, WOULD THERE BE EVENTS NORMALLY HELD AT THE YUM CENTER HELD THERE?

HAS A STUDY BEEN CONDUCTED BASED ON WHAT THE YUM CENTER WILL LOSE?

WILL THE CITY HAVE TO INCREASE PAYMENTS ON YUM CENTER DEBT BECAUSE OF THE LOSS IN PROFITS AT THE YUM CENTER?

THE PROCESS IS BEING RUSHED.

THERE ARE MANY QUESTIONS THAT I COULDN'T FIT INTO A THREE-MINUTE PREPARATION THAT ARE NONETHELESS IMPORTANT.

THE GROUP STATED THEY WERE MEETING WITH THE FISCHER ADMINISTRATION FOR OVER A YEAR.

WHAT IS THE HARM IN LETTING THE PUBLIC DEBATE THIS FOR A COUPLE OF MONTHS?

THANK YOU FOR YOUR TIME.

MADAM CLERK: KEILA VENTURA.

KEILA VENTURA: GOOD EVENING.

MY NAME IS KEILA VENTURA.

I AM A CURRENT COLLEGE STUDENT AT JEFFERSON COMMUNITY AND TECHNICAL COLLEGE FOR MY ASSOCIATE'S.

I'M HERE TO DISCUSS SANCTUARY CITIES FOR ALL.

I'M CALLING ON LOUISVILLE TO BE MADE A SANCTUARY CITY ONCE AND FOR ALL, TO STOP LMPD COORDINATION WITH CUSTOMS ENFORCEMENT.

ALTHOUGH I AM A U.S.-BORN CITIZEN, I'M ALSO A SECOND-CLASS CITIZEN IN THESE UNITED STATES.

I COME FROM A MIXED STATUS FAMILY AND IN PASSING THE ORDINANCE YOU'LL MAKE LOUISVILLE A SANCTUARY CITY AND YOU WILL HELP KEEP FAMILIES LIKE MINE TOGETHER.

GROWING UP AT THE AGE OF 11 I LEARNED WHAT I.C.E. RAIDS ARE.

BY DEFINITION, THEY ARE SWIFT RAIDS ENFORCED BY IMMIGRATION AND CUSTOMS ENFORCEMENT TO DETAIN UNDOCUMENTED WORKERS.

AN 11-YEAR-OLD SHOULD NOT LIE AWAKE AT NIGHT WONDERING WHAT WOULD HAPPEN TO ME OR MY FAMILY IF I AM LEFT ALONE IN THE UNITED STATES.

I AM CONSTANTLY AFRAID WHEN A LOVED ONE DOES NOT ANSWER THE PHONE OR EVEN COMES HOME LATE FROM AN EIGHT-HOUR SHIFT AT WORK.

ONE OF MY BIGGEST FEARS IS THAT MY FAMILY WILL NOT SEE ME WALK ACROSS THE STAGE WHEN I RECEIVE MY MASTER'S IN OCCUPATIONAL THERAPY.

I AM NOT ONLY EXPRESSING MY FEARS, BUT THE TRUTH THAT MANY PEOPLE LIVE ON ON A DAY-TO-DAY BASIS.

IMMIGRANTS ARE WHAT MAKE AMERICA GREAT AGAIN AND WHAT MAKE LOUISVILLE WEIRD.

TO THE WOMEN THAT CLEAN YOUR HOMES AND THE UNDOCUMENTED WORKERS WORKING IN THE BACK OF RESTAURANTS AT YOUR FAVORITE RESTAURANTS, WORKING MENIAL JOBS TO GIVE THEIR CHILDREN BETTER OPPORTUNITIES THEY DID NOT HAVE.

IN CLOSING, STOP CLAIMING LOUISVILLE A COMPASSIONATE CITY AND MAKE IT A SANCTUARY ONE INSTEAD.

THANK YOU.

MADAM CLERK: TEENA HALBIG.

TEENA HALBIG: THE UNITED NATIONS ASSOCIATION OF KENTUCKY IS HOLDING THE COMMUNITY EVENT HUMAN TRAFFICKING CONFERENCE ON DECEMBER 6TH AND WE NEED HELP FROM METRO COUNCIL NDF FUNDING TO HELP BRING ABOUT MORE CHANGES.

RIGHT NOW KENTUCKY RANKS 31ST OUT OF 100 CITIES FOR THE CALLS THAT HAVE GONE IN TO THE NATIONAL HUMAN TRAFFICKING HOTLINE NUMBER RESULTING IN TRAFFICKING CASES.

A RECENT SMALL COURIER JOURNAL ARTICLE TOLD OF A MASSIVE 17-STATE STING NETTING 1,020 SEX WORKERS WHO WERE ARRESTED FOR THEIR CRIMINAL ENGAGEMENT.

YES INDEED THESE ARE CRIMES.

WHILE KENTUCKY WAS NOT ONE OF THE 17 STATES, DUE TO THE CHICAGO NOTE WE HAD LAST YEAR, KENTUCKY WILL NOW BE INCLUDED.

SO THANK YOU.

NOW WE ARE SEEKING MORE CHANGES WITH YOUR ASSISTANCE, NEW AND CUTTING-EDGE METHODS ARE BEING DEVELOPED THAT CAN KEEP LOUISVILLIANS AND OTHER CITIZENS IN THE COMMONWEALTH OF KENTUCKY SAFER.

HERE ARE CHANGES THAT COULD OCCUR FROM THE DECEMBER 6TH CONFERENCE.

FIRST OFF, THORN, WHEREBY NEW METHODS OF CYBER WAR FAIR ARE BEING DEVELOPED, SO LAW ENFORCEMENT IS GIVEN THE NEW SOFTWARE PROGRAM.

TWO, ETHICS, PROCTORS, MEN HELPING MEN.

HE BEGAN WITH A FEW MALE VOLUNTEERS WHO SPOKE WITH MEN SEEKING SEX TO INTERCEDE WITH A MESSAGE TO DETER THEIR ENGAGEMENT IN CRIME.

QUICKLY, THIS BECAME AUTOMATED, AND WHEN KEY WORDS WERE SAID THE PERSON CAN GET THE AUTOMATED MESSAGE THAT THIS IS A CRIMINAL OFFENSE PUNISHABLE BY LAW.

PLUS, THEY HAVE ARTIFICIAL INTELLIGENCE TO AUGMENT THEIR EFFORTS NOW.

THIRD, THE ASSEMBLY BILL WHEREBY THE SEX TRAFFICKING BUYER HAS TO PAY A \$5,000 SURCHARGE.

> HALF GOES TO LAW ENFORCEMENT. HALF GOES TO A VICTIM'S FUND.

WHEREBY WE ARE PLANNING TO HAVE A BILL IN THE KENTUCKY GENERAL ASSEMBLY BUT METRO COUNCIL COULD ACTUALLY ACT NOW TO PUT AN ORDINANCE FORTH.

## WHY WAIT?

I FOURTH, WE WILL ALSO HAVE LEGISLATION PUT FORTH BY A SPONSOR ON FEMALE GENITAL MUTILATION, FGM CUTTING.

YES, THIS HAPPENS IN THE UNITED STATES.

ALL WOMEN AND IMMIGRANTS COMING TO AMERICA NEED TO KNOW THIS IS A BARBARIC ACT.

IT IS DONE OUT OF IGNORANCE, CULTURE, AND USED IN TRAFFICKING.

DECEMBER 6TH, THE KEYNOTE IS COMING FROM THE GREATER D.C. AREA.

HELPED VIRGINIA IN 2016 AND HELPED TEXAS THIS PAST JULY 2017 TO PASS LAWS ON FORCED CHILD MARRIAGE.

NOW THIS HARVARD LAW SCHOOL GRADUATE AND SENIOR COUNSEL FROM THE TAJERA JUSTICE CENTER IS POISED TO SPEAK IN THE 2018 KENTUCKY GENERAL ASSEMBLY.

SIX, WE HAVE NUMEROUS DISEASES THAT ARE ENCOUNTERED IN TRAFFICKING THAT CONTRIBUTE TO HEALTH CARE COSTS.

AND THEY ARE RECURRING.

JUST A LITTLE OVER.

SORRY.

I HAVE A LITTLE MORE.

BUT ANYWAY, JUST WANT TO THANK YOU AND HOPE THAT YOU WILL BE ABLE TO GIVE AND HELP THIS YEAR AS WE WORK TO BRING ABOUT MORE CHANGES.

WE WANT THINGS TO HAPPEN.

THANK YOU.

MADAM CLERK: DAN HONG.

DAN HONG: HELLO.

MY NAME IS DAN HONG, AND I RECENTLY MOVED TO LOUISVILLE THIS AUGUST 3RD MONTHS AGO FROM PORTLAND, OREGON.

I'M HERE WITH KENTUCKIANS FOR THE COMMONWEALTH AND RELATED GROUPS TO TESTIFY ABOUT THE CITY'S \$30 MILLION INVESTMENT FOR THE LOUISVILLE FC SOCCER STADIUM.

I BELIEVE THAT CITY DOLLARS SPENT ON THE STADIUM SHOULD LEAD TO EQUITABLE AND AFFORDABLE HOUSING AND GOOD JOBS THAT PAY A LIVING WAGE INSTEAD OF SUBSIDIZING COSTS FOR BIG DEVELOPERS.

I KNOW THE IMPORTANCE OF A LIVING WAGE BECAUSE I EXPERIENCED FIRSTHAND JUST HOW LOW LOUISVILLE'S MINIMUM WAGE IS.

MY FIRST JOB HERE WAS A SERVER AT A RESTAURANT ON BARDSTOWN, WHICH THE LOUISVILLE FC DEVELOPMENT GROUP HAS TALKED ABOUT AS A MODEL FOR THIS DISTRICT.

I WAS PAID JUST \$2.13 AN HOUR BEFORE TAXES, THE FEDERAL MINIMUM WAGE FOR TIP WORKERS.

ONE PAYCHECK PAID ME \$12, WHICH AMOUNTED TO \$0.31 AN HOUR AFTER TAXES.

A MONTH AFTER MOVING IN, I ALREADY FOUND MYSELF STRUGGLING TO PAY FOR RENT, GROCERIES AND UTILITIES.

I HAD TO PICK UP MORE JOBS AND GO INTO CREDIT CARD DEBT TO SURVIVE SEPTEMBER.

I SHARE THIS STORY BECAUSE BIG DEVELOPERS SAY THAT BUILDING THE STADIUM ON THEIR TERMS WILL ATTRACT MORE YOUNG PEOPLE, MILLENNIALS TO THE CITY OF LOUISVILLE.

AS A MILLENNIAL MYSELF I SHARE THIS BECAUSE I SAY THAT GOOD PAYING JOBS IN ALL LEVELS AND ALL SECTORS WILL ATTRACT MORE YOUNG PEOPLE TO LOUISVILLE, NOT SUBSIDIES FOR THE RICH.

WHILE RAISING THE MINIMUM WAGE IS HARD BECAUSE OF THE KENTUCKY SUPREME COURT, LOUISVILLE CAN SET AN EXAMPLE BY REQUIRING ALL JOBS CREATED FROM THE STADIUM'S CONSTRUCTION AND OPERATION BE A LIVING WAGE, LIKE \$15 AN HOUR.

I DEMAND THE CITY ENFORCE THE LIVING WAGE FOR STADIUM JOBS BECAUSE IT IS SHAMEFUL IF ANYONE THERE WILL BE DEPRIVED OF THEIR NEEDS WORKING FOR \$2.13 AN HOUR.

LASTLY, I SUPPORT MI GENTE'S DEMAND THAT LOUISVILLE BECOME A SANCTUARY CITY, BECAUSE IT WILL HELP ATTRACT YOUNG PEOPLE TOT CITY, ESPECIALLY THOSE UNDER DACA.

THANK YOU.

MADAM CLERK: ALEXA BEYER.

ALEXA BEYER: HI.

I'M ALEXA BEYER.

I RECENTLY MOVED TO LOUISVILLE ABOUT A MONTH AND A HALF AGO. I'M FROM LOS ANGELES, LIVED THERE MY ENTIRE LIFE.

WENT TO A LIBERAL ARTS SCHOOL IN THE NORTHEAST AND RECENTLY GRADUATED.

AND WHILE THERE IS A TON OF DIFFERENT ASPECTS OF THE SOCCER STADIUM PROJECT, THE PART I WANTED TO ATTRACT -- THE PART I WANTED TO SPEAK TO WAS THE IDEA OF ATTRACTING MILLENNIALS TO THE CITY.

BECAUSE I THINK I AM VERY MUCH LIKE THE FOOTLOOSE MILLENNIAL THAT WAS LOOKING FOR A PLACE TO CALL HOME THAT CHOSE LOUISVILLE ON

PURPOSE, EVEN THOUGH THERE WERE LIKE FIVE OTHER CITIES THAT COULD HAVE BEEN A MORE LOGICAL OPTION, LIKE NASHVILLE OR PORTLAND OR THAT HAD JOBS I WAS INTERESTED IN, AND I DID IT BECAUSE I LOVED IT.

I ONLY CAME HERE BY WAY OF A PROGRAM, AN INTERNSHIP PROGRAM THROUGH MY COLLEGE.

AND ALL THE STUDENTS THAT WERE IN IT WITH ME LOVED LOUISVILLE JUST AS MUCH AS I DID, THE QUIRKY, INDEPENDENT CULTURE, THE WAY THE COMMUNITY FEELS AND HOW LIVABLE IT IS TO BE HERE.

BASICALLY BESIDES ME AND ONE OR TWO OTHERS OVER MANY YEARS, ALL OF THEM DECIDED NOT TO MOVE HERE AND TO MOVE SOMEWHERE ELSE.

BECAUSE THEY WANT CAREERS DOING INTERESTING AND INNOVATIVE THINGS.

AND WHILE SOME OF THOSE OPTIONS EXIST HERE, FRANKLY A LOT OF THE JOBS FOR COLLEGE GRADUATES ARE WITH PLACES THAT HAVE A PRETTY LOW TOLERANCE FOR RISK, ARE KIND OF MIRED IN BUREAUCRACY, AND INSIST OF USING TWENTIETH CENTURY SOLUTIONS AND STRUCTURES TO SOLVE 21ST CENTURY PROBLEMS.

WE WANT MORE, WE WANT TO INNOVATE.

AND THEY DIDN'T NOT MOVE HERE BECAUSE LOUISVILLE IS LACKING SOME LAUNDRY LIST OF BIG-CITY AMENITIES.

IF YOUR PRIMARY MARKETING STRATEGY TO GET MILLENNIALS TO MOVE HERE IS WE ARE JUST LIKE CINCINNATI BUT CHEAPER, JUST LIKE CHICAGO BUT CHEAPER, THEN YOU ARE GOING TO CREATE THE WALMART PRINCIPLE WHERE THE ONLY REASON ANYONE IS COMING IN IS BECAUSE WE ARE THE CHEAPEST OPTION.

AND THEY ONLY CONTINUE TO VALUE US SO LONG AS WE CONTINUE TO BE THE CHEAPEST OPTION OR UNTIL THE NEXT CITY COMES UP THAT HAPPENS TO BE CHEAPER.

INSTEAD OF ATTRACTING THE TYPE OF PERSON THAT WANTS TO MAKE A COMMITMENT TO THE CITY AND BUILD THE TYPE OF THINGS THAT ARE GOING TO BRING VALUE IN THE LONG TERM AS WELL AS GET CIVICALLY INVOLVED AND MAKE A LIFE HERE.

SO YOU HAVE A LOT OF REASONS YOU ARE ENTERTAINING THIS, BUT DON'T DO IT AS A REASON TO ATTRACT MILLENNIALS, BECAUSE THERE ARE A LOT OF MORE EFFECTIVE AND NOT TO MENTION LESS EXPENSIVE WAYS TO DO THAT THAT ARE GOING TO BRING THE TYPE OF PEOPLE THAT WILL MAKE THIS CITY BETTER.

THANK YOU. >> JESUS IBAÑEZ.

>> GOOD EVENING, EVERYBODY.

MY NAME IS JESUS IBAÑEZ.

I'M WITH MI GENTE LOUISVILLE, A LATIN ORGANIZATION DEDICATED TO DISMANTLING SYSTEMS OF OPPRESSION AND UPLIFTING BLACK AND BROWN AND QUEER LEADERSHIP.

WE ASK OUR ALLIES OVER THE PAST NINE MONTHS HAVE BEEN ADVOCATING FOR A SANCTUARY CITY.

WE STARTED OFF WITH PETITIONS, WENT TO RALLIES, DID A COUPLE CHANTS.

ALSO THE POLITICIANS.

AND OF COURSE THE KENTUCKY INVESTIGATIVE EXPOSE CAME OUT WITH LMPD AND COORDINATION, BECAUSE THE NEED TO PASS A SANCTUARY ORDINANCE SKYROCKETED.

AND NOW OF COURSE WE HAVE AN ORDINANCE.

AND I WOULD LIKE TO THANK THE SPONSORS AND IN PARTICULAR BRENNAN COHEN, WHO WAS ONE OF THE FEW POLITICIANS WHO EMBRACED US FROM THE GET-GO,

EMBRACED OUR IDEAS AND WERE CONCERNED FOR THE UNDOCUMENTED COMMUNITY, AND HE SHOULD BE LAUDED FOR HIS EFFORTS.

AND OF COURSE THE OTHER SPONSORS.

I WOULD LIKE TO THANK ALL OF YOU FOLKS FOR INTRODUCING THE ANTI-287-G LANGUAGE.

I CAN'T STRESS ENOUGH HOW IMPORTANT ANTI-287 LANGUAGE IS.

UNDER THE PROVISION LOCAL LAW ENFORCEMENT CAN CARRY OUT IMMIGRATION DUTIES, INCLUDING DEPORTATION.

THIS SHOULD SOUND FAMILIAR TO EVERYBODY HERE, BECAUSE THAT IS BASICALLY WHAT LMPD AND I.C.E. WERE DOING, OPERATING UNDER A QUASI 287 AGREEMENT.

THANK YOU FOR THAT.

I WOULD LIKE TO MAKE SOMETHING CLEAR RIGHT NOW.

WHILE THIS IS A GREAT POLICY, THE ORDINANCE TO PROTECT

UNDOCUMENTED INDIVIDUALS, IT IS NOT WHAT MI GENTE AND ITS ALLIES HAVE BEEN ADVOCATING FOR.

IT IS NOT A SANCTUARY FOR ALL ORDINANCE.

ONE GLARING OMISSION IN THE ORDINANCE WHICH WAS ALLUDED TO BUT WAS NOT EXPRESSLY STATED IS THE ISSUE WITH DETAINERS.

AND THE LMPD JAILS IN THE LOCAL JAILS.

IT IS A LOOPHOLE, ANOTHER WAY FOR -- I WOULD LIKE TO CLARIFY WHAT SANCTUARY IS, NOT JUST ABOUT UNDOCUMENTED INDIVIDUALS, BUT ABOUT BLACK AND BROWN AND QUEER AND MUSLIM INDIVIDUALS.

WE CANNOT HAVE A SANCTUARY FOR ALL WHEN THE BLACK COMMUNITIES ARE LIVING IN FEAR OF GETTING KILLED BY LMPD.

WE CANNOT BE A SANCTUARY FOR ALL WHEN INDIVIDUALS ARE AFRAID TO COME OUT ON THE STREETS FOR FEAR OF RETALIATION FROM NOT JUST LAW ENFORCEMENT, OF COURSE, BUT FROM THE COMMUNITY AT LARGE.

THE SANCTUARY IS A COMMUNITY EFFORT AND NOT JUST A POLICY EFFORT.

SO SANCTUARY FOR ALL AND JUSTICE FOR ALL.

BLACK LIVES MATTER.

MADAM CLERK: RON RUSSELL.

RON RUSSELL: THANK YOU FOR ALLOWING ME TO ADDRESS THE COUNCIL TODAY ON THE ISSUE OF ADOPTING A SANCTUARY CITY RESOLUTION.

MY NAME IS RON RUSSELL.

I HAVE PRACTICED IMMIGRATION LAW FOR OVER 28 YEARS REPRESENTING PRIMARILY THE UNDOCUMENTED WORKERS IN OUR COMMUNITY AND THROUGHOUT THE AREA.

OVER THE PAST 20 YEARS, I HAVE WITNESSED THE EBBS AND FLOWS OF IMMIGRATION ENFORCEMENT IN OUR COMMUNITY AND OUR NATION.

RECENTLY PRESIDENT TRUMP DECLARED THAT UNDOCUMENTED INDIVIDUALS REPRESENT A SERIOUS THREAT TO OUR NATIONAL SECURITY AND PUBLIC SAFETY.

THIS IRRATIONAL VIEW HAS CREATED A NEW LEVEL OF HYPERENFORCEMENT IN VIOLATION OF CONSTITUTIONAL RIGHTS THAT CURRENTLY TERRORIZE OUR UNDOCUMENTED COMMUNITY.

FOR EXAMPLE, A VERY EARLY MORNING HOUSE ARREST TYPICALLY INCLUDES NUMEROUS I.C.E. OFFICERS WHO INTENTIONALLY MISLEAD AND CLAIM THEY ARE THE POLICE, FORCING ENTRY UPON ANY SLIGHT OPENING OF A DOOR WITH GUNS DRAWN, SCREAMING AND CUSSING AT TERRORIZED OCCUPANTS, INCLUDING CRYING CHILDREN, AND ARRESTING ALL UNDOCUMENTED INDIVIDUALS PRESENT.

RECENT REVELATIONS THAT LOUISVILLE METRO POLICE HAVE PROVIDED ASSISTANCE IN THE RAIDS MAKE US IMPLICIT IN THE ABUSIVE AND UNCONSTITUTIONAL TACTICS.

BEFORE CIRCUIT JUDGE FOUND THE PERSON WAS UNLAWFULLY IMPRISONED IN VIOLATION OF THE 6TH AMENDMENT.

YEARS FROM NOW WHEN THE CURRENT ANTI IMMIGRANT POLICY HAS SUBSIDED AND JUST AND RATIONAL ENFORCEMENT POLICY IS ESTABLISHED WE WILL BE ASKED WHAT DID WE AS A CITY DO TO RESPOND TO THESE MANY OUTRAGEOUS UNCONSTITUTIONAL ACTIONS BY I.C.E. OFFICERS?

WILL WE RESPOND, "WE WENT ALONG TO GET ALONG"?

HOPEFULLY WE CAN RESPOND THAT WE SUPPORT A POLICY TO UPHOLD CONSTITUTIONAL PRINCIPLES AND VALUES AND ACTED AS A COMPASSIONATE CITY WE CLAIMED TO BE AND SUPPORTED SANCTUARY CITY RESOLUTION.

THANK YOU VERY MUCH.

COUNCILWOMAN VICKI AUBREY WELCH AND I WILL CO-PRESENT AND RECOGNIZE KAREN MORRISON WITH GILDA CLUB OF LOUISVILLE IN THE HEART OF DISTRICT 4.

VICKI WILL READ ABOUT THE HISTORY, I WILL TALK ABOUT THE CURRENT EVENTS, WE WILL PRESENT THE PROCLAMATION AND KAREN MORRISON WILL FOLLOW WITH CLOSING REMARKS.

THANK YOU, MR. PRESIDENT.

>> THE REASON I'M INVOLVED WITH FULL DISCLOSURE, MY COUSIN IS THE MARKETING PERSON FOR GILDA'S CLUB AND SHE LET ME KNOW IT'S THEIR 10-YEAR ANNIVERSARY AND WITH ME BEING A REGISTERED NURSE, CANCER SURVIVORS IS SO IMPORTANT.

GILDA'S CLUB WAS FOUNDED IN 1991 BY JOANA BULL, GILDA RADNER DIED OF OVARIAN CANCER IN 1989.

SO ALONG WITH HER PSYCHOTHERAPIST AND HUSBAND GENE WILDER AND SEVERAL OTHER FRIENDS, THEY FOUNDED IN 1991 THE FIRST GILDA'S CLUB.

IT IS NOW A NATIONAL ORGANIZATION WITH 38 AFFILIATES OPERATING IN NORTH AMERICA.

IN 2014 AFTER 8 MONTHS OF EXTENSIVE RESEARCH IN LOUISVILLE TO ENSURE THERE WAS NO SIMILAR LOCAL ORGANIZATION, A DREAM BEGAN TO TAKE SHAPE.

A VISION OF A PLACE FOR FAMILIES AND INDIVIDUALS TOUCHED BY CANCER TO COME TO LEARN, SHARE AND LAUGH.

WITH THE FACE OF NATIONAL CITIBANK, THE VISION OF HENRY POTTER AND ASSOCIATES AND GENEROSITY OF COMMUNITY, THE GILDA'S CLUB LOUISVILLE CLUBHOUSE BECAME A REALITY AS DID THE GILDA'S CLUB PROGRAM HOUSED WITHIN IT.

THE RED DOORS OPENED TO THE PUBLIC IN AUGUST OF 2007.

GILDA'S CLUB OFFERS THE AREA'S ONLY ONGOING SUPPORT TO CHILDREN AND TEENS WHO ARE LIVING WITH CANCER.

AND SOME OF THE THINGS THEY HAVE ARE PEER-BASED SUPPORT GROUPS, CANCER EDUCATION, SOCIAL CONNECTIONS, FAMILY FOCUS, PARENTING WORKSHOPS AND GUIDED DISCUSSIONS AND SCHOOL AND CLASSROOM SUPPORT.

THEY OFFER OVER 150 PROGRAMS A MONTH FOR MEN, WOMEN, CHILDREN AND TEENS AFFECTED BY CANCER.

ALL PROVIDED AT NO COST TO PARTICIPANTS.

SO KAREN MORRISON, THE PRESIDENT AND C.E.O. HAS SPENT 28 YEARS WORKING IN THE NON-PROFIT FIELD.

HER CAREER INCLUDES 17 YEARS WITH THE AMERICAN RED CROSS AND THREE YEARS WITH THE AMERICAN CANCER SOCIETY IN LOUISVILLE.

SHE CAME TO GILDA'S CLUB LOUISVILLE IN 2007, EIGHT MONTHS BEFORE THE CLUBHOUSE OPENED AND CLAIMED SHE HAD WON THE LOTTERY OF JOBS.

SHE CURRENTLY SERVES AS THE CHAIR OF THE CANCER SUPPORT COMMUNITY AFFILIATE COUNCIL, AN ADVISORY GROUP THAT WORKS WITH MORE THAN 50 CANCER SUPPORT GROUPS IN U.S. AND CANADA.

HAVING LEFT FOR 16 YEARS BEFORE RETURNING IN 2004.

SHE IS A GRADUATE OF W.K.U. AND GRADUATE OF LEADERSHIP LOUISVILLE IN 2010.

KAREN AND HER PARTNER AUDREY HAVE THREE DAUGHTERS ALL REGULAR GILDA'S CLUB VOLUNTEERS AND THE OLDEST OF WHOM IS A 12-YEAR CANCER SURVIVOR.

ALL RIGHT.

AND THERE'S ONE OTHER PIECE OF INFORMATION ABOUT KAREN.

KAREN AND I ARE FELLOW ROTARIANS HERE WITH THE DOWNTOWN LOUISVILLE ROTARY CLUB AND SEVERAL OTHER COUNCILMEMBERS ARE FELLOW ROTARIANS AS WELL.

TODAY GILDA'S CLUB CAN LOOK BACK AND REMEMBER THAT THERE WERE A NUMBER OF FACES LOUISVILLIANS THAT HAD THE VISION AND THE DREAM.

I WOULD LIKE TO RECOGNIZE THEM AS WELL FOR A MOMENT.

MANY OF YOU MAY RECOGNIZE THE NAME MS. LINDY STREET, EARL DORSI, MS. SUSAN OR MAN, MS. CUNNINGHAM AND A NUMBER OF OTHERS.

DALE BODEN AS WELL.

THEY BROUGHT THIS TO OUR COMMUNITY AND NOW KAREN LEADS THE WAY.

SO KAREN, I WOULD LOVE TO MENTION, IF I MAY FROM MY COLLEAGUES,

LIVING WITH CANCER IS NOT A CHOICE.

BUT HOW YOU LIVE WITH CANCER IS A CHOICE.

AND WE ARE RIGHT HERE IN THE MIDDLE OF A VERY SIGNIFICANT MONTH.

AND WE ARE ALL EXHIBITING THAT BY THE PURPLE AND THE PINK MANY OF US ARE WEARING NOW AND WILL BE WEARING ALL MONTH LONG.

BUT KAREN AND HER GROUP HAVE REACHED OUT.

THEY HAVE PUT TOGETHER THE WRITING AND VISUAL ART CONTEST SO THAT MIDDLE AND HIGH SCHOOL STUDENTS WHO ARE LIVING WITH CANCER, NOT DYING WITH CANCER, THESE CHILDREN ARE LIVING WITH IT.

AND THEY ARE LIVING LARGE BECAUSE OF GILDA'S CLUB.

THEY HAD A CONTEST AND THERE WERE VIDEOS AND POEMS AND SPOKEN WORDS, AS WELL AS ESSAYS ABOUT WHAT THAT'S LIKE TO LIVE WITH CANCER.

SO WE ARE GRATEFUL TO YOU FOR THE WORK YOU HAVE DONE.

NOW, FOLKS WILL REMAIN NAMELESS AS I MOVE FORWARD.

MANY FOLKS IN THIS ROOM HAVE PARTICIPATED IN THE ANNUAL FUNDRAISER EVENT 1,000 LAUGHS.

SEVERAL FOLKS HAVE TAKEN THE STAGE.

YOU PUT THAT TOGETHER, IT'S A MAJOR FUNDRAISER.

SO THANK YOU FOR LETTING US LAUGH UPON THE JOURNEY AS MANY OF US HAVE EMBARKED A JOURNEY OF CANCER OURSELVES OR WE HAVE LOVED ONE'S THAT ARE ON THAT JOURNEY.

> SO FELLOW COUNCILMEMBERS IT'S A PLEASURE AND HONOR TO RECOGNIZE. AT THIS TIME I WILL READ THE OFFICIAL PROCLAMATION.

CAN YOU STAND FOR A LITTLE BIT MORE?

>> SURE.

>> ALL RIGHT.

HERE WE GO.

LOUISVILLE METRO COUNCIL. TO WHOM ALL THESE LETTERS WILL COME, GREETINGS.

KNOW YE THE LOUISVILLE METRO COUNCIL HERE BY RECOGNIZES AND HONORS GILDA'S CLUB OF LOUISVILLE CELEBRATING THEIR 10TH ANNIVERSARY AND IN RECOGNITION OF THEIR DEDICATION AND COMMITMENT TO ALL PEOPLE AFFECTED BY CANCER IN OUR COMMUNITY HAS AN OPPORTUNITY TO BECOME EMPOWERED BY KNOWLEDGE, STRENGTHENED BY ACTION AND SUSTAINED BY A SUPPORTIVE COMMUNITY.

I DON'T EVEN KNOW WHAT TO ADD TO THAT, IT'S QUITE AN HONOR TO BE

HERE.

I THANK YOU FOR TAKING THE TIME TO HONOR GILDA'S CLUB.

WE HAD OUR GRAND OPENING JUST TEN YEARS AGO THIS MONTH.

AND I REMEMBER WHEN WERE OFFERING 20-25 PROGRAMS TO 100 OR SO PEOPLE AND NOW AS YOU HEARD MORE THAN 7,000 PEOPLE HAVE BEEN THROUGH THE RED DOORS OF GILDA'S CLUB.

FAMILIES LIVING WITH ALL DIFFERENT TYPES OF CANCER, OUR YOUNGEST MEMBER WITH CANCER DIAGNOSED IN UTERO AND OUR OLDEST IS IN HIS 90'S.

CANCER IS BIPARTISAN, CANCER KNOWS NO BOUNDARIES AND UNFORTUNATELY TOUCHES MOST EVERYONE'S LIVES.

SO AS BOTH A PROFESSIONAL WHO HAS BEEN DOING THIS FOR NOW TEN YEARS, ALMOST ELEVEN YEARS, AND AS A MOTHER OF A 15-YEAR SURVIVOR, WE WERE TOLD WHEN SHE WAS 5, SHE HAD 4 WEEKS TO LIVE, AND SHE IS A SENIOR AT STANFORD UNIVERSITY AND WANTS TO COME BACK TO LOUISVILLE AND BE A POLITICIAN.

SOME OF YOU KNOW HER.

I JUST CAN'T TELL YOU THE IMPACT THIS MAKES.

A LOT OF PEOPLE THINK ABOUT PSYCHO SOCIAL SUPPORT AND SOME OF THE PROGRAMS WE DO EXERCISE AND SUPPORT GROUPS AND COOKING CLASSES AND SOCIAL FUNCTIONS AND ART AND MUSIC.

THOSE ARE NICE THINGS BUT THEY MAKE A HUGE IMPACT, NOT ONLY ON THE QUALITY OF LIFE FOR THESE FOLKS LIVING WITH CANCER BUT ALSO ON HEALTH OUTCOMES.

IT DRAMATICALLY IMPROVES THEIR HEALTH OUTCOMES IF YOU TAKE CARE OF THIS PART OF YOU, THE BODY TENDS TO FOLLOW.

AND THE OTHER THING IT LOWERS HEALTH CARE COSTS WHICH IS IMPORTANT TO ALL OF US IN THIS DAY AND TIME AND PROBABLY ALWAYS WILL BE.

BECAUSE, AS YOU HEARD, EVERYTHING WE OFFER IS FREE.

SO I WILL CLOSE WITH THIS.

KIND OF A LITTLE TEASER FOR SOME NEWS TO COME.

THE BAD NEWS IS THAT WE -- GOOD YOU INS IS WE ARE SERVING AND HELPING A LOT OF PEOPLE, BUT BAD NEWS WE ARE STILL NEEDED BECAUSE CANCER IS SUCH A DOMINANT PLAYER IN OUR LIVES BUT THE FURTHER BAD NEWS IS WE ARE OUT OF ROOM AND OUT OF PARKING.

WE CAN NO LONGER ACCOMMODATE THE NUMBER OF PEOPLE COMING AND WE ESTIMATE WE ARE ONLY SERVING ABOUT 10% OF THOSE WHO COULD REALLY USE US.

SO WE ARE ACTIVELY LOOKING FOR NEW, LARGER SPACE.

MORE PARKING.

AND OF COURSE THE FUNDS TO SUPPORT THAT.

SO YOU WILL BE HEARING ABOUT THAT SOMETIME SOON AND AGAIN, THANK YOU FOR THIS AND FOR ALL THAT YOU ALL DO.

[ APPLAUSE].

PRESIDENT YATES: COUNCILWOMAN WOOLRIDGE, AS A FOLLOW-UP, DO YOU HAVE A PROCLAMATION?

I HAVE A PROCLAMATION, A SPECIAL PROCLAMATION PROCLAIMING OCTOBER AS BREAST CANCER AWARENESS MONTH.

AND I WOULD LIKE TO THANK THE LADIES WHO JUST LEFT WITH THE GILDA'S CLUB FOR ALL SHE DOES FOR THIS COMMUNITY.

AT THIS TIME I WOULD LIKE TO READ THIS PROCLAMATION.

AND BEFORE I DO, I KNOW ALL OF US PROBABLY KNOW SOMEONE OR SOMEONE IN OUR FAMILY THAT HAS BREAST CANCER OR HAD A SCARE ABOUT BREAST CANCER.

SO WE ARE GOING TO PRETTY MUCH ADMONISH THEM IN THIS PROCLAMATION TO MAKE SURE THEY GET THEIR MAMMOGRAPHY, GET THEMSELVES TESTED.

> NOWADAYS BREAST CANCER WASN'T AS DEADLY AS IT WAS AT ONE TIME. IF IT'S CHECKED IN TIME WE CAN ALWAYS TAKE CARE OF THAT.

THAT BEING SAID, I WOULD LIKE TO READ THIS PROCLAMATION, IT READS AS FOLLOWS.

PROCLAMATION BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE JEFFERSON COUNTY METRO GOVERNMENT, LOUISVILLE METRO COUNCIL, TO WHOM ALL THESE PRESENTS SHALL COME, GREETINGS.

WHEREAS SINCE 1985, THE UNITED STATES HAS OBSERVED NATIONAL BREAST CANCER AWARENESS MONTH TO PROMOTE EARLY DETECTION OF BREAST CANCER BY ENCOURAGING WOMEN TO HAVE MAMMOGRAM.

WHEREAS OVER THE YEARS THE NUMBER OF ORGANIZATIONS INVOLVED IN PROMOTING BREAST CANCER AWARENESS HAS GROWN SIGNIFICANTLY.

AND IS NOW AS MUCH ABOUT RAISING FUNDS FOR RESEARCH, EDUCATION AND SUPPORT, AS IT IS ABOUT RAISING AWARENESS.

WHEREAS THE INCIDENT RATE OF BREAST CANCER HAS CONTINUED TO DECLINE SINCE 2000, AND THE NUMBER OF DEATHS DUE TO BREAST CANCER HAS DECREASED EACH YEAR SINCE 1989.

THE DECREASES ARE THOUGHT TO BE THE RESULT OF INVESTMENT AND TREATMENT, EARLY DETECTION THROUGH SCREENING AND INCREASED AWARENESS.

WHEREAS SOME OF THE 2017 STATISTICS REGARDING THE PREVALENCE OF BREAST CANCER IN THE UNITED STATES INCLUDE THE FOLLOWING.

ABOUT ONE IN EIGHT WOMEN WILL DEVELOP INVASIVE BREAST CANCER THIS YEAR.

AN ESTIMATED 252,710 NEW CASES OF INVASIVE BREAST CANCER ARE EXPECTED TO BE REPORTED THIS YEAR.

AND 40,610 WOMEN ARE EXPECTED TO DIE.

AN ESTIMATED 63,410 NEW CASES OF NON-INVASIVE CASES ARE EXPECTED TO BE DIAGNOSED IN WOMEN.

AN ESTIMATED 2,470 CASES OF INVASIVE BREAST CANCER ARE EXPECTED TO BE DIAGNOSED IN MEN THIS YEAR.

AND AS OF MARCH THIS YEAR THERE WERE MORE THAN 3.1 MILLION WOMEN WITH A HISTORY OF BREAST CANCER IN THE UNITED STATES, WHICH INCLUDES THOSE CURRENTLY BEING TREATED AND THOSE WHO HAVE COMPLETED TREATMENT.

WHEREAS THE LOUISVILLE METRO COUNCIL WISHES TO PROMOTE BREAST CANCER AWARENESS, TO EDUCATE AND PROMOTE HEALTHY CHOICES IN ITS CITIZENS IN LOUISVILLE METRO AREA.

THEREFORE, THE LOUISVILLE METRO COUNCIL HEREBY PROCLAIMS OCTOBER AS NATIONAL BREAST CANCER AWARENESS MONTH IN THE LOUISVILLE METRO AREA.

FURTHER, THE LOUISVILLE METRO COUNCIL ENCOURAGES THE CITIZENS OF LOUISVILLE METRO AREA TO GET THE FACTS ABOUT MAMMOGRAPHY AND URGE ALL WOMEN 40 YEARS OF AGE AND OLDER TO GET MAMMOGRAMS ON A REGULAR BASIS.

AND FURTHER, THE LOUISVILLE METRO COUNCIL CALL UPON THE CITIZENS OF LOUISVILLE METRO AREA TO PARTICIPATE IN NATIONAL BREAST CANCER AWARENESS MONTH BY PARTICIPATING IN THE APPROPRIATE EDUCATIONAL ACTIVITIES.

BREAST CANCER SCREENING, FUNDRAISERS, BREAST CANCER SUPPORT GROUP AND BY PROMOTING MONETARY CONTRIBUTIONS AS THEY MAY BE WILLING AND ABLE TO DO.

ON THIS 12TH DAY, OCTOBER 2017, BY YOURS TRULY COUNCILWOMAN MARY C. WOOLRIDGE, LOUISVILLE METRO DISTRICT 3.

WHEREAS HE WAS BORN TO REVEREND EARL B -- HAMPTON VIRGINIA JULY 19TH, 1959 DR. WILLIAMS AND HIS WIFE, DR. MICHELLE WILLIAMS HAVE TWO BEAUTIFUL VERY SMART DAUGHTERS.

WHEREAS HE GRADUATED, [READING] EARNED HIS DOCTORATE FROM UNITED TECHNOLOGICAL SEMINARY, DR. WILLIAMS IS COMMITTED TO CHANGING THE LIVES OF THE MARGINALIZED PEOPLE THAT SOCIETY HAS FORGOTTEN.

WHEREAS IN 1986 AFTER SERVING AS AN ASSOCIATE MINISTER, DR. WILLIAMS WAS INSTALLED AS SENIOR PASTOR AT FAITH MEMORIAL BAPTIST CHURCH IN LOUISVILLE, WHICH IS CONSIDERED ONE OF LOUISVILLE'S POOREST NEIGHBORHOOD AND UNDER HIS LEADERSHIP THE CHURCH HAS GROWN EXPONENTIALLY IN MEMBERSHIP AND LEADERSHIP OPPORTUNITIES.

WHEREAS HE IS CHAIRMAN OF THE BOARD FOR BAITS COMMUNITY, BOARD MEMBER OF METRO BANK AND TRUSTEE BOARD OF SIMMONS COLLEGE OF KENTUCKY, FORMERLY SERVED ON THE AFRICAN AMERICAN PULPIT ADVISORY BOARD AND -- FELLOWS GRADUATE.

WHEREAS HE HAS BEEN HONORED IN NUMEROUS WAYS INCLUDING BUT NOT LIMITED TO BEING INDUCTED IN THE WILLIAM H. SHEPHERD EXCELLENCE IN THE COMMUNITY HALL OF FAME IN 2005 AND PRESBYTERIAN HALL OF FAME IN 2007, BEING NOMINATED FOR KENTUCKY CIVIL RIGHTS HALL OF FAME, HAVING HIS SERMON THE MARKS OF IRRESISTIBLE CHURCH SUMMER 2006 EDITION OF THE AFRICAN AMERICAN PULPIT FEATURED IN WHOSE WHO IN BLACK LOUISVILLE AND UNITED

THEOLOGICAL SEMINARY ALUMNI EFFECTIVE MINISTRY AWARD IN 2007, AND THE GREATEST HUSBAND IN LOUISVILLE AWARD, AWARDED IN 2011 AND IN 2014, BEING HONORED BY THE LOUISVILLE PRESBYTERIAN THEOLOGICAL SEMINARY AND LISTED AS ONE OF THE TOP 10 INFLUENTIAL RELIGIOUS LEADERS IN LOUISVILLE.

SO NOW THEREFORE BE IT RESOLVED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE METRO GOVERNMENT AS FOLLOWS, SECTION 1 DR. F BRUCE, HEREBY RECOGNIZED WITH PLACEMENT OF HONORARY STREET SIGN AT CLAY AND LAMPTON IN LOUISVILLE KENTUCKY AND SO DESIGNATED AS DR. F. BRUCE WILLIAMS WAY.

MOVING FORWARD WITH FABRICATION AND INSTALLATION OF HONORARY SIGNS UPON THE PASSAGE OF THIS RESOLUTION AND RECEIPT OF FUNDS TO COVER THE EXPENSES.

COUNCILWOMAN WOOLRIDGE?

COUNCIL MEMBER WOOLRIDGE: THANK YOU, MR. PRESIDENT.

THIS PASSED OUT OF COMMITTEE WITH EVERYONE VOTING IN FAVOR.
