

ORDINANCE NO. 186, SERIES 2017

AN ORDINANCE APPROPRIATING ~~\$12,500~~ \$14,000 FROM NEIGHBORHOOD DEVELOPMENT FUNDS IN THE FOLLOWING MANNER: \$1,000 EACH FROM DISTRICTS 6, 2, AND 5; \$5,000 FROM DISTRICT 3; \$750 EACH FROM DISTRICTS 1 AND 4; AND \$500 EACH FROM DISTRICTS 7, 9, 10, 12, 13, 15, 21, 25 AND 26; THROUGH THE OFFICE OF MANAGEMENT AND BUDGET, TO UNIVERSITY OF LOUISVILLE RESEARCH FOUNDATION, INC. FOR COSTS ASSOCIATED WITH THE "FUTURE OF OUR COMMUNITY" FORUM SERIES. (AS AMENDED)

BE IT ORDAINED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT (THE COUNCIL) AS FOLLOWS:


SECTION I: The sum of ~~\$42,500~~ \$14,000 is hereby appropriated from Neighborhood Development Funds in the following manner: \$1,000 each from Districts 6, 2, and 5; \$5,000 from District 3; \$750 each from Districts 1 and 4; and \$500 each from Districts 7, 9, 10, 12, 13, 15, 21, 25 and 26; through the Office of Management and Budget, to University of Louisville Research Foundation, Inc. for costs associated with the "Future of Our Community" forum series.


SECTION II: The Council has determined the funds requested in this Ordinance will be expended for a public purpose.
