#### Hello Councilwoman Butler,

I hope you are doing well. Today I had the opportunity to talk with Susan Hughes about the possibility of your office sponsoring a historical highway marker for the Louisville Landmark, Roscoe Goose House, located in your district. Myself and another volunteer are willing to research, write and submit the application to the Kentucky Historical Society if this is something you are willing to consider. The cost of the marker is \$2,500.

One of the really neat things about adding a highway marker to your district is combining it with the two you already have in close proximity (Churchill Downs and the Wheelman's Bench) along with several additional markers in Councilman Johnson's District and Councilwoman Welch's District, will give us the number of historical highway markers necessary to be eligible to apply for the Explore KY History Smart Phone App sponsored by the Kentucky Historical Society. The app takes the stories behind a group of historical markers and adds pictures and talking points to turn it into a tour. The focus of the phone app would be our South Louisville historical assets.

I am one of the folks that worked on the historical highway marker application for the Iroquois Amphitheater several years ago when you sponsored it along with some of the other South End Council Members. Based on the rich history of Roscoe Goose's career and his contributions to the horse racing industry, I am pretty confident that we can put together a successful application.
