PRESIDENT YATES: MR. CLERK, ARE THERE ANY ADDRESSES TO THE COUNCIL?

MR. CLERK: YES, SIR, THERE ARE.

PRESIDENT YATES: LET ME REMIND THOSE ADDRESSING THE COUNCIL TO

PLEASE REFRAIN FROM USING ANY PROFANITY OR MAKING DEROGATORY STATEMENTS TO

COUNCIL MEMBERS.

BRING THE FIRST SPEAKER FORWARD.

MR. CLERK: PATRICIA RAMEY.

PATRICIA RAMEY: MY NAME IS TRISH RAMEY.

I LIVE IN COUNCIL MEMBER MULVIHILL'S DISTRICT.

I AM A MEMBER OF CLOUT AND THE COCHAIR OF THE CLOUT AFFORDABLE HOUSING COMMITTEE, WHICH HAS BEEN WORKING FOR THE CREATION OF AND DEDICATED FUNDING OF THE LOUISVILLE HOUSING TRUST FUND FOR 13 YEARS.

THE AFFORDABLE HOUSING TRUST FUND WAS CREATED BY METRO COUNCIL WITH THE ORDINANCE CALLING FOR FUNDING OF 10 MILLION DOLLARS A YEAR.

IN THE YEARS SINCE THEN, IT HAS NEVER BEEN FUNDED AT THAT LEVEL UNTIL NOW.

AFTER THE HARD WORK OF CLOUT LEADERS, TRUST FUND COMMITTEE

MEMBERS, AND YOU, METRO COUNCIL, WE HAVE FINALLY REACHED THAT BENCHMARK.

THE \$9.6 MILLION IS AN IMPORTANT STEP FOR LOUISVILLE.

IT WILL TRANSFORM HUNDREDS OF LIVES.

IT WILL NOT ONLY IMPROVE PEOPLE'S LIVING CONDITIONS, BUT PEOPLE'S FINANCIAL STABILITY, PHYSICAL HEALTH, AND JOB PERFORMANCE.

EQUALLY IMPORTANT, THE HOME FACILITY WILL ENHANCE CHILDREN'S SCHOOL PERFORMANCE, HEALTHY LIFESTYLE, AND EMOTIONAL WELL-BEING.

BECAUSE OF THE \$9.6 MILLION GOING INTO THE TRUST FUND, LOUISVILLE WILL BE A STRONGER CITY.

BUT WE FOE THAT THIS IS JUST THE START.

THERE ARE STILL 65,000 WHO NEED THIS SAME STABILITY.

WE ALL NEED TO REMEMBER OUR WORK FOR AFFORDABLE HOUSING IS A MARATHON, NOT A SPRINT.

WE NEED TO MAINTAIN THE \$10 MILLION COMMITMENT EVERY YEAR.

THIS TRUST FUND IS SO IMPORTANT FOR SO MANY PEOPLE AND THAT IS WHY WE NEED FULL FUNDING EVERY YEAR THROUGH A DEDICATED FUNDING SOURCE.

WE LOOK FORWARD TO WORKING WITH YOU IN THE MONTHS TO COME.

MR. CLERK: CONNOR ALLEN.

PRESIDENT YATES: I JUST WANTED TO GIVE AN OPPORTUNITY.

CONNOR ALLEN: I AM CONNOR ALLEN.

- I HAVE LIVED IN LOUISVILLE MY ENTIRE LIFE.
- I GRADUATED FROM THE UNIVERSITY OF LOUISVILLE.
- I LIVE IN COUNCIL MEMBER COAN'S DISTRICT.
- I WANTED TO BE HERE TWO WEEKS AGO TO SPEAK IN OPPOSITION OF THE SOCCER STADIUM BUT YOU HAD QUITE THE PACKED AGENDA SO I DECIDED I WOULD SIGN UP TODAY.

ON MONDAY LOUISVILLE CITY SD IS ABOUT TO PLAY FOR THE CHAMPIONSHIP, AND I REALLY DO HOPE THEY WIN.

SO I'M NOT SPEAKING HERE AGAINST THE TEAM.

BUT I AM AGAINST THE BOND THAT THE CITY PROVIDED TO FUND THE STADIUM AND HOW IT FITS INTO THE OVERALL ECONOMIC DEVELOPMENT PICTURE.

SO I WORK WITH SURVIVORS OF DOMESTIC VIOLENCE, AND ONE OF THE BIGGEST IMPEDIMENTS IS SPECIFICALLY A LACK OF HOUSING OPPORTUNITIES, ESPECIALLY FOR PEOPLE WHO ARE LIVING IN POVERTY.

SO I HAVE ONE CLIENT.

I WAS GOING TO GO INTO SOME OF THE ABUSE, BUT LET'S JUST SAY THAT IT IS HORRIFIC.

AND SHE WAS IN A VERY SERIOUS CONCERN -- I WAS VERY CONCERNED.

ALL THE HOMELESS SHELTERS ARE ALWAYS FULL.

IT IS DIFFICULT TO FIND HOUSING.

THE SHORTEST LIST FOR ANY INCOME-BASED HOUSING IN THE CITY IS SIX MONTHS, AND THAT IS ON THE BORDER.

AND ANOTHER SECTION 8 WAITING LIST IS THREE YEARS LONG.

SO WHAT DOES THIS HAVE TO DO WITH THE SOCCER STADIUM?

I'M NOT AGAINST THE STADIUM PER SE.

I'M AGAINST THE FACT THAT THE CITY HAS GIVEN MORE MONEY IN ONE YEAR TO THE SOCCER STADIUM THAN IT HAS EVER PUT INTO AFFORDABLE HOUSING, AT LEAST IN THE LAST TEN YEARS.

I KNOW THAT WE HAVE GIVEN ABOUT \$25 MILLION IN THE LAST TWO YEARS, AND I THINK THAT SHOULD BE APPLAUDED.

HOWEVER, THERE WAS A STUDY IN 2008 WHERE THE COUNCIL FOUND THAT THE CITY WOULD NEED \$10 MILLION A YEAR TO KEEP UP WITH THE AMOUNT OF AFFORDABLE HOUSING NECESSARY TO ADDRESS OUR PROBLEM WITH HOUSING INSECURITY.

AND WE HAVE GIVEN \$25 MILLION OF THE \$90 MILLION THAT SHOULD HAVE BEEN GIVEN OVER THAT TIME.

IF YOU LOOK AT THE OMNI HOTEL, WE GAVE THEM \$140 MILLION.

WE GAVE A COUPLE LUXURY APARTMENT COMPLEXES \$5 MILLION TIFS.

BUT WE HAVEN'T PUT AS MUCH MONEY INTO AFFORDABLE HOUSING AS I THINK THAT WE SHOULD.

AND I UNDERSTAND THAT THE ARGUMENT IS GIVING THESE TIFS WILL

GENERATE MORE ECONOMIC REVENUE, BUT I ALSO THINK THAT IF YOU FUND

AFFORDABLE HOUSING APART FROM A HUMANITARIAN STANDPOINT, THAT ALSO

GENERATES REVENUE, BECAUSE YOU ARE PUTTING PEOPLE IN A POSITION WHERE THEY

HAVE MORE ECONOMIC MOBILITY.

SO I THINK BUILDING AFFORDABLE HOUSING AND PUTTING MORE FUNDS INTO THAT IS ACTUALLY COMPASSIONATE, AND I THINK THAT IS THE POLICY THAT THE CITY SHOULD BE LOOKING AT, AS WELL AS FUNDING OTHER CRISIS MANAGEMENT PROGRAMS.

THANK YOU.

MR. CLERK: JAISON GARDNER.

JAISON GARDNER: GOOD EVENING.

I'M HERE TO DISCUSS THE VOTE TO NOT REMOVE THE ACCUSED FROM METRO COUNCIL.

THANKS TO THE JOURNALISM SHOW I WAS ABLE TO GET THE PLAY BY PLAY AND HAVE FEEDBACK FOR YOU.

-- -- LOVE TO SEE THE ACCUSED STAY ON THE COUNCIL BECAUSE IT HAS NEVER BEEN A PROBLEM FOR YOU.

YOU ALSO SAID IT WAS VERY HARD TO VOTE FOR BECAUSE YOU HAVE BEEN IN THIS SITUATION.

I AM TRULY PERPLEXED AND DISAPPOINTED THAT YOU HAVE

MORE -- -- WITH THE WHITE MALE SEXUAL PREDATOR THAN YOU DO WITH YOUR BLACK

WOMAN COLLEAGUE WHO WAS THE VICTIM OF A SEXUAL ASSAULT.

IT IS STOCKHOLM SYNDROME AT ITS MOST SIMPLE LEVEL.

SHAME ON YOU FOR YOUR VOTES.

OUR ENTIRE COMMUNITY IS IN DISGUST AT THE THREE OF YOU ALL.

IF YOUR COWARDICE HAS DONE NOTHING -- -- YOUNG ADULTS WHO ARE MOBILIZING AND STRATEGIZING TO RUN FOR COUNCIL SEATS.

WE HAVE THOUSANDS OF BLACK FOLKS WHO ARE SIMILARLY MOTIVATED TO TAKE PLACE.

MR. PRESIDENT, YOU EXPECT US TO IGNORE THE CONTRADICTION AND IRONY OF YOUR OWN -- AGAINST THE CITY FOR PEOPLE WHO ARE VICTIMIZED WHILE YOU FAIL TO PURSUE -- -- YOU EXPRESS CONCERN ABOUT THE HIGH FINANCIAL COST TO THE CITY -- -- WHILE YOU ARE SUING THE CITY FOR MONEY.

YOU SAID DURING THE MEETING THAT THE ACCUSED WOULD ABSOLUTELY BE REMOVED -- WELL IT APPEARED HE BROKE THE TERMS DAYS LATER AND YET HE HAS ABSOLUTELY NOT BEEN REMOVED.

IT FURTHER HIGHLIGHTS THAT MANY OF YOU ALL LACK THE ABILITY TO KNOW WHAT IS GOING ON AROUND YOU.

I AM MOST DISAPPOINTED IN YOU BECAUSE YOU SAID YOU WERE A STAND-UP GUY -- -- TO KEEP A SEXUAL PREDATOR ON THE METRO COUNCIL.

I AM DISAPPOINTED IN YOU BECAUSE YOU HAVE PROVEN TO BE PRECISELY THE KIND OF POLITICIAN I THOUGHT YOU WERE DURING THE CAMPAIGN.

ALL THE PANDERING TO BLACK PEOPLE, TALKING ABOUT HOW MUCH BLACK LIVES MATTER, BUT THROUGH YOUR VOTES TO KEEP THE ACCUSED YOU HAVE DONE

WHAT MOST NEOLIBERAL WHITE WOMEN DO -- -- VOTE AGAINST THE INTEREST OF BLACK PEOPLE.

SHAME ON YOU.

I'M SURE THAT MANY OF YOU VOTED TO -- UNFORTUNATELY HISTORY WILL LOOK AT YOU ALL WITH THE SAME DISGUST AS TRAITORS AND RACISTS AND HOMOPHOBES BECAUSE YOU HAVE PROVEN THROUGH YOUR VOTES TO BE ANTIWOMEN.

AT THE VERY LEAST YOU OWE COUNCILWOMAN GREEN AND OTHER VICTIMS

AN APOLOGY AND YOU OWE YOURSELVES -- -- THANK YOU, COUNCILMAN JAMES FOR

YOUR VOTE TO DO THE RIGHT THING.

MR. CLERK: NICOLE HARDIN.

NICOLE HARDIN: HI.

I'M NICOLE HARDIN TO SPEAK AROUND VICTIMS OF SEXUAL ASSAULT, AND
IN PARTICULAR AROUND THE COUNCIL AGREEMENT LAST WEEK.

AS OF THE CENSUS, THE POPULATION IN LOUISVILLE IS LOOSELY ABOUT 600,000 PEOPLE, 308,000 OF THOSE ARE WOMEN AND ONE OUT OF EVERY SIX WOMEN IN AMERICA ARE A VICTIM OF SEXUAL ASSAULT.

THIS IS AROUND 51,000 WOMEN IN LOUISVILLE METRO, AND I AM INCLUDED IN THAT NUMBER.

YOU MAY HAVE NOTICED SEVERAL OF US GATHERED OUTSIDE BEFORE THIS MEETING TODAY, AND I HOPE TO TALK TO YOU ABOUT YOUR ETHICS AND STANDARDS AROUND THE HANDLING OF THESE ASSAULTS AND THE PURVEYORS OF THESE ASSAULTS, PARTICULARLY THOSE THAT ARE ELECTED.

WE TALK A LOT IN LOUISVILLE ABOUT BEING A COMPASSIONATE CITY,
BUT LITERALLY COMPASSION MEANS TO SUFFER WITH.

COMPASSION AND INJUSTICE ARE ALIKE BECAUSE THEY BOTH COME AS A COST.

IT IS A COMPASSION IF YOU AREN'T SUFFERING.

YOU SACRIFICE AND TAKE ON SOME OF THE HEAVY LIFTING OF THE BURDEN AND IN THIS CASE THE BURDEN OF BEING ASSAULTED IN YOUR PLACE OF EMPLOYMENT.

LAST WEEK WAS A SHAME BECAUSE YOU FAILED TO SUFFER WITH YOUR COLLEAGUES.

MANY VICTIMS, MEN, WOMEN, AND CHILDREN ALIKE LEARN FROM WHAT THEY SEE.

THEY LEARN THAT THEY SHOULDN'T TELL ANYONE WHEN THEY ARE ABUSED.

THEY LEARN FROM WATCHING US THAT OUR CULTURE TOLERATES THE ABUSE AND FAVORS THE ABUSE.

IT IS A SHAME TO SEE THAT ECHOED IN OUR ELECTED GOVERNMENT.

AS I WATCH ALL OF THIS ON THE NEWS LAST WEEK I FELT IT BUBBLE UP IN ME AGAIN, TEACHING VICTIMS NOT TO SPEAK UP BECAUSE IT ISN'T WORTH THE RISK, THAT THERE IS NO RESOLVE AND THAT THERE IS STILL ROOM FOR POLITICS OR FAVORITISM OR NUANCE WHEN IT COMES TO THE TOPIC OF ABUSE.

WE STILL HAVEN'T PAID FOR TOLERANCE FOR INTOLERABLE ACTS UNDER THE RIGHT CIRCUMSTANCE.

THAT IS WHY WE ARE HERE TO TELL YOU TO THAT WE EXPECT MORE, WE EXPECT WHATEVER IT TAKES TO STAND ALONGSIDE AND SUFFER WITH THE ACCUSED.

AND IF IT TAKES ME A UNANIMOUS VOTE, WE HAVE SEEN THIS COUNCIL MOVE BY UNANIMOUS VOTE BEFORE.

WE EXPECT MORE.

LAST WEEK YOU SAID A LOT WITHOUT SAYING A WORD, BUT WE HEARD YOU.

I THANK THE SIX MEMBERS OF THE COUNCIL WHO DECIDED TO SUFFER ALONG WITH US AND TO THE REST.

THE VICTIMS WILL NOT BE SILENCED.

WHERE WE MAY -- -- THE STRENGTH OF COUNCILWOMAN GREEN TO SPEAK WITH WORDS ABOUT HER OWN ASSAULT.

WE SPEAK AT ELECTION TIME.

WE WON'T TOLERATE IT.

WE CANNOT AFFORD TO CONTINUE TO PERPETUATE A CULTURE OF VICTIM SILENCING OR ANOTHER GENERATION WHO HAVE NO INTENTION TO DO THAT, AND WE ARE BETTER THAN THIS.

MR. CLERK: KATELAIN HULA.

KATELAIN HULA: GOOD EVENING.

MY NAME IS KATE HULA, A SOCIAL WORK STUDENT.

I AM ALSO AN INTERN HERE AT JEFFERSON COUNTY HELPING WITH COORDINATION AND PLANNING OF THE UPCOMING SEX TRAFFICKING AND INTERSECTIONAL EXPLOITATION CONFERENCE TAKING PLACE.

THIS EVENT IS DESIGNED TO SPREAD AWARENESS, EDUCATE ATTEN-DEES
AS WELL AS ADVOCATE FOR THOSE INDIVIDUALS WHO HAVE EXPERIENCED HUMAN
TRAFFICKING.

I UNDERSTAND THAT MANY OF YOU HAVE GIVEN AID TO THE NEIGHBORHOOD DEVELOPMENT FUNDING.

THERE IS STILL A LITTLE MORE.

THIS ISSUE IS IMPORTANT TO ADDRESS NO MATTER WHAT AGE YOU ARE, YOUR GENDER, WHERE YOU COME FROM.

I FEEL IT IS MY RESPONSIBILITY TO MAKE OTHERS AWARE OF WHAT HUMAN TRAFFICKING IS, WHY IT EXISTS, AND WHAT WE CAN DO TO PREVENT OR ELIMINATE IT.

I WANTED TO RESEARCH THE SIGNIFICANCE OF THIS ISSUE AND HOW IT CAN AFFECT THE COMMUNITY.

THE MISSION WAS TO HIGHLIGHT THE SEVERITY OF PREVALENCE OF HUMAN TRAFFICKING IN THE CITY OF LOUISVILLE SINCE 2014.

I GATHERED MY FINDINGS AND CREATED AN ORGANIZED BROCHURE AS WELL.

IN THIS BROCHURE YOU'LL FIND INFORMATION THAT CONTAINS POWERFUL HEADLINES AND QUOTES WITH ADDRESS THE REALITY AND FREQUENCY OF INCIDENCES THAT OCCUR WITHIN THE CITY.

THERE ARE A NUMBER OF VARIABLES THAT MAKE INDIVIDUALS VULNERABLE TO HUMAN TRAFFICKING.

OUT OF 132 HOMELESS YOUTH SURVEYED IN LOUISVILLE, 41% REPORTED THEY HAVE BEEN A VICTIM OF SEX TRAFFICKING AT LEAST ONE.

HUMAN TRAFFICKING OCCURS MOSTLY THROUGHOUT INTERNET ON THE WEBSITE KNOWN AS BACKSTAGE.COM.

HUNDREDS OF SEX ADS CAN BE FOUND ON ANY GIVEN DAY BUT WHEN THE CITY OF LOUISVILLE HOSTS POPULAR EVENTS SUCH AS KENTUCKY DERBY OR THUNDER OVER LOUISVILLE, THOUSANDS CAN BE FOUND.

WITH EVENTS EVERY YEAR AND MAJOR HIGHWAYS, IT IS A DESTINATION FOR TOURISTS AND ALSO PREDATORS.

IN 2016 A MAN WAS CHARGED WITH TRANSPORTING A 14-YEAR-OLD GIRL FROM KALAMAZOO, MICHIGAN, TO LOUISVILLE IN ORDER TO PROSTITUTE HER.

THIS PAST SEPTEMBER A 17-YEAR-OLD WAS TRAFFICKED WITHIN A MILE RADIUS OF FIVE SCHOOLS IN THE CITY OF LOUISVILLE, A SIX-MINUTE WALK FROM THE PUBLIC SCHOOL.

THE MAN WHO COMMITTED THIS ACT LIVED WITHIN THE SAME NEIGHBORHOOD AS CHILDREN AND FAMILIES.

SADLY HE IS NOT THE ONLY MAN WHO COMMITS THE CRIME, AND THERE ARE MORE OUT THERE, AND IT IS SOMEONE'S RESPONSIBILITY TO STOP THEM.

SO WHOSE RESPONSIBILITY SHOULD THIS BE?

MINE OR YOURS?

OTHER COMMUNITY MEMBERS?

POLICYMAKERS?

ANYONE WHO CAN DO SOMETHING ABOUT THIS ISSUE SHOULD BE DOING SOMETHING.

I HOPE THIS TOPIC RESONATES WITH YOU AND YOU HAVE MADE THE DECISION TO ADVOCATE WITH ME.

ONE WAY THAT YOU CAN HELP NOW IS SUPPORT THE UPCOMING HUMAN TRAFFICKING CONFERENCE ON DECEMBER 6TH.

MYSELF AND MANY OTHERS ARE DEVOTING THEIR TIME AND ENERGY TO MAKE THIS SUCCESSFUL FOR EVERYONE WHO ATTENDS.

I WANT TO THANK THOSE OF YOU WHO HAVE BEEN ABLE TO HELP SO FAR AND I ASK IF YOU WOULD PLEASE HELP.

MR. CLERK: ROBIN FREDERICK.

ROBIN FREDERICK: HEY, EVERYONE.

MY NAME IS ROBIN FREDERICK.

I AM THE MANAGER OF A LOCAL GRASSROOTS RADIO.

SO WHAT AM I HERE FOR?

I'M HERE TO DISCUSS HUMAN RIGHTS AND INTERSECTIONALITY AND EXPLOITATION, WHICH IS A ONE-DAY CONFERENCE.

FIRST I WANTED TO THANK EVERYONE WHO HAS DONATED AND I ENCOURAGE THOSE WHO HAVEN'T TO DONATE.

WE HAVE ALMOST REACHED OUR GOAL.

SO LET'S BREAK SOME THINGS DOWN A LITTLE BIT.

136 PEOPLE AN HOUR.

THIS IS JUST REPORTED CASES.

THE U.S. DEPARTMENT OF HEALTH AND HUMAN SERVICES SAYS THAT EVERY MINUTE SOMEONE WILL BE BOUGHT, SOLD, OR FORCED INTO SLAVERY.

SO THE NEXT THREE MINUTES THAT I SPEAK WITH YOU, THREE PEOPLE WILL BECOME A VICTIM OF HUMAN TRAFFICKING.

IT IS HARD TO THINK ABOUT HUMAN TRAFFICKING OCCURRING RIGHT HERE IN LOUISVILLE.

BUT IT DOES.

AND KENTUCKY ISN'T EXEMPT FROM THE PROBLEM, EVEN THOUGH IT DOESN'T SEEM LIKE IT IS HAPPENING HERE.

THIS IN FACT IS A GROWING SECRET.

HALF OF KENTUCKY'S CASES ARE OF SEX TRAFFICKING, THE OTHER HALF IS LABOR.

VICTIMS ARE FORCED TO WORK IN RESTAURANTS, ON FARMS, HOMES, AND HOTELS.

AND LOUISVILLE IS KNOWN AS ONE OF THE HUBS FOR TRAFFICKING BECAUSE OF THE INTERSTATES THAT ARE CROSSING OVER.

A RECENT STUDY ALSO FOUND THAT 70% OF THESE VICTIMS REPORTED THAT TECHNOLOGY WAS USED FOR THE PURPOSE OF RECRUITING.

SMART PHONES BEING THE TOP 35%.

OTHER AVENUES CAN INCLUDE BACKSTAGE.COM, FACEBOOK, SNAPCHAT AND TWITTER.

THE TOTAL VALUE OF HUMAN TRAFFICKING IS \$32 BILLION, U.S. DOLLARS, A YEAR.

AND I HOPE EACH AND EVERY ONE OF YOU GOT TO EXPERIENCE THAT.

THAT IS REALLY WHAT IT IS ALL ABOUT.

WE ARE HOPING THAT THAT DESIRE TO SERVE WILL BE CONTAGIOUS, BECAUSE WE REALLY NEED THE NEXT GENERATION OF PUBLIC SERVICE.

I WOULD LIKE TO THANK DR. SHAREE WALLACE FROM THE UNIVERSITY OF LOUISVILLE FOR HELPING US THROUGH THIS PROCESS.

AND I WOULD LIKE TO THANK EACH AND EVERY OFFICE WHO WELCOMED INTERNS INTO THEIR OFFICE.

THANK YOU.

PRESIDENT YATES: WELL SAID, COUNCILMAN.

THANK YOU.

SO THE REQUEST IS \$2,000 FROM DISTRICT 20.

AND I GUESS THE REQUEST -- WILL YOU INTRODUCE YOURS.

>> YES, MR. PRESIDENT.

THAT IS WHAT I WAS GOING TO SAY, WE HAVE ABOUT FOUR OTHER PEOPLE IN THE QUEUE.

DISTRICT 26 WILL GIVE \$500 AND REDUCE FOR DISTRICT THREE.

IT IS A VERY WORTHY PROGRAM.

PRESIDENT YATES: THANK YOU, COUNCILMAN.

COUNCILWOMAN FOWLER.

COUNCIL MEMBER FOWLER: THANK YOU, MR. PRESIDENT.

I THOUGHT THAT I HAD ALREADY PUT IN ON THIS, BUT MAYBE NOT.

COUNCILMAN PARKER.

\$250 FROM DISTRICT 18.

THANK YOU, COUNCILWOMAN.

COUNCILMAN REED.

COUNCIL MEMBER REED: \$500 FROM DISTRICT 16.

PRESIDENT YATES: \$500 FROM DISTRICT 16.

MR. CLERK, I LOST COUNT.

WHAT IS OUR TOTAL?

MR. CLERK: NEW TOTAL IS \$16,400, WHICH ALSO LEAVES DISTRICT THREE WITH NOTHING -- AFTER REDUCING YOUR AMOUNT.

PRESIDENT YATES: YOU CAN STEP UP.
