THE REGULAR LOUISVILLE METRO COUNCIL

MEETING OF NOVEMBER 30, 2017, WILL PLEASE COME TO ORDER.

PLEASE RISE FOR THE PLEDGE OF ALLEGIANCE TO THE FLAG.

I PLEDGE ALLEGIANCE TO THE FLAG OF THE UNITED STATES OF AMERICA AND TO THE REPUBLIC FOR WHICH IT STANDS, ONE NATION UNDER GOD, INDIVISIBLE, WITH LIBERTY AND JUSTICE FOR ALL.

PRESIDENT YATES: THANK YOU.

MR. CLERK, A ROLL CALL,

PLEASE.

[ROLL CALL].

MR. CLERK: MR. PRESIDENT, WE HAVE 22 IN A ATTENDANCE AND A QUORUM.

PRESIDENT YATES: THANK YOU.

WILL YOU HAVE THE RECORD REFLECT COUNCILMEMBER DENTON AND GREEN HAVE EXCUSED ABSENCES.

MR. CLERK: WILL DO.

CLAIRE MULHALL: HI, EVERYONE, GOOD EVENING, MY NAME IS CLAIRE MULHALL, I'M A STUDENT.

MY CLASS SPECIFICALLY FOCUSING ON SOCIAL JUSTICE DECIDED TO FOCUS ON STUDENT EXCHANGE PROGRAM IN LOUISVILLE.

WE KIND OF SAW A NEED WHEN WE WENT OUT SERVING PLACES IN THE V.O.A. AND TALKING TO COMMUNITY MEMBERS ABOUT THEIR FEELING FOR ANOTHER ONE IN A DIFFERENT PART OF LOUISVILLE.

SO THROUGHOUT THIS SEMESTER WE TRY TO FOCUS ON LOOKING AT THE POSSIBILITIES OF WHAT CITIZENS OF SOUTHWEST LOUISVILLE, LIKE MYSELF, I'M A PART OF CINDI FOWLER'S DISTRICT.

WE HAD A SURPRISING RESPONSE.

JUST TO ADDRESS SOME OF THE BENEFITS OF THE EXCHANGE PROGRAM IN LOUISVILLE, WE AREN'T TRYING TO PROMOTE DRUG USE, WE ARE TRYING TO SEGUE PEOPLE INTO RECOVERY.

AND WHEN WE ASKED CITIZENS AROUND OUR COMMUNITY IF THEY ARE IN THIS POSITION, THEIR SONS, DAUGHTERS, SISTERS, THEY KNOW THEY HAVE THIS PROBLEM BUT THEY ARE WONDERING, I DON'T CARE THEY ARE USING, I CARE THEY GET HELP.

AS LONG AS THERE IS SOMETHING TO HELP THEM, AID, I DON'T CARE BECAUSE I WANT THEM TO BE HEALTHY.

SO I WOULD LIKE YOU ALL TO CONSIDER THESE ASPECTS WHEN VOTING ON EXPANDING THE EXCHANGE PROGRAM, IT'S NEAR AND DEAR TO THE GIRLS AT MERCY ACADEMY AND WE URGE YOU TO VOTE ON EXPANDING IT.

THANK YOU.

MR. CLERK: KENNETH HARRINGTON?

KEN HARRINGTON?

PRESIDENT YATES: MR. HARRINGTON, BEFORE YOU BEGIN, I KNOW THERE'S BEEN A LETTER SENT FROM THE COUNTY ATTORNEY'S OFFICE OR CLERK'S OFFICE, BECAUSE OF THE TOPIC IN WHICH WE ARE DISCUSSING, YOU CANNOT ADDRESS THE RECORD DIRECTLY.

IT'S THE PROCESS IN GENERAL, PLEASE GO AHEAD.

KEN HARRINGTON: THANK YOU FOR ALLOWING ME TO SPEAK.

MY NAME IS KEN HARRINGTON AND MY WIFE KATHY AND I LIVE AT 2218 ROSEHILL PLACE.

I'M HERE TO REPRESENT MYSELF AND MY SMALL COMMUNITY ASSOCIATION.

FIRST, I WOULD LIKE TO COMMEND THE LANDMARKS COMMISSION AND THE WONDERFULLY DEDICATED WORK THEY DO FOR THE COMMUNITY.

WHILE I'VE ALWAYS LOVED HISTORY AND CONSIDER MYSELF A HISTORIAN, I RECOGNIZE IT WOULD TAKE A LOT OF STUDY TO SUPPORT MY FAMILY, SO I APPRECIATE ALL THE WORK THE COMMISSION DOES.

I FIRMLY BELIEVE IT'S IMPORTANT WE PRESERVE LEGITIMATE LANDMARKS AND TEACH OUR YOUTH THE HISTORY OF OUR GREAT NATION, STATE AND COMMUNITY.

I ALSO FIND IT TROUBLING THAT ADULTS ARE UNINFORMED OR JUST DON'T CARE.

RESERVING LANDMARKS IN HISTORY IS A VITAL ROLE AND MISSION TODAY AS UNFORTUNATELY, HISTORY IN OUR FORMAL EDUCATION SYSTEM HAS BEEN DEEMPHASIZED.

TO RECEIVE A HISTORIC PLATE ON YOUR HOUSE IN CHARLESTON, WE BELIEVE IT'S TRULY AN ACHIEVEMENT.

WHILE WE HAVE ONLY A FEW PLACES IN KENTUCKY, WE DON'T NEED TO SUBSTITUTE OR TRY TO USE INFERIOR COPIES.

IT WOULD SIMPLY BE ABSURD AND RIDICULOUS.

REVIEWING THE LANDMARKS COMMISSION, AND IN A RECENT HEARING, I WOULD SUGGEST A COUPLE OF CONSIDERATIONS.

THE LANDMARKS COMMISSION SHOULD NEVER BE USED AS A STRATEGIC LEGAL TOOL TO HARASS AND INTIMIDATE ANY CITIZEN BY A GROUP OF INDIVIDUALS THAT MAY HAVE OTHER MOTIVES.

THIS ACTION DEMEANS THE REPUTATION OF THE LANDMARKS COMMISSION.

AND AS A LANDMARK DEEMED HISTORIC SHOULD BE A REWARD, NOT A CURSE, PUNISHMENT OR OVERREACHING TOOL TO BE ABUSED.

TO ADDRESS THIS ISSUE, I WOULD SUGGEST THE ONLY PROPERTY OWNERS SEEK OR BUY HISTORIC PROPERTY OR RESIDENT CERTIFICATION TO BE ENDORSED BY THE COMMUNITY AND LOCAL NEIGHBORS.

FOR PROPERTIES REQUESTED NAMED HISTORIC, THERE SHOULD ALSO BE AN INSPECTION OF THE STRUCTURE TO DETERMINE IF IT'S SALVAGEABLE OR FEASIBLE TO BE PRESERVED.

ADDITIONALLY, IT SHOULD NEVER BE THE RESPONSIBILITY OF THE COMMUNITY OR THE GOVERNMENT TO DO THAT.

HOWEVER, THE PROPERTY OWNER SHOULD BE HELD TO THE HIGHEST STANDARDS IN MAINTAINING THE HISTORIC STRUCTURE, IF IT'S IN FACT QUALIFIED TO BE SO.

AND AN IMPACT STUDY BE CONDUCTED THOSE WHO LIVE NEXT DOOR TO THOSE NAMED PROPERTIES AND SEE HOW IT AFFECTS THEIR NEIGHBORHOOD AND POINT OF VIEW.

ONE MORE POINT.

PRESIDENT YATES: YOU MAY FINISH YOUR POINT.

KEN HARRINGTON: FURTHERMORE, I WOULD CERTAINLY NOT ALLOW OUT-OF-STATE RESIDENTS TO ABUSE THE COMMUNITY SINCE THIS IS NOT THEIR PRIMARY RESIDENCE AND THEY DON'T PAY STATE TAXES.

I WOULD ASK THE COMMISSION TO PLEASE NOT BE DISTRACTED BY THOSE WHO HAVE NO REAL INTEREST IN HISTORY BUT WANT TO USE THE INFLUENCE OF THE COMMISSION FOR THEIR AGENDA.

THANK YOU FOR ALLOWING ME TO SPEAK.

MR. CLERK: NICK PARSONS.

NICK PARSONS: FIRST OF ALL, THANK YOU FOR ALLOWING ME TO SPEAK TO YOU TONIGHT.

I WORK WITH ONE OF THE SEVERAL ORGANIZATIONS IN THIS CITY THAT SERVES THE HOMELESS COMMUNITY.

BUT I'M NOT SPEAKING ON BEHALF OF THE ORGANIZATION I WORK WITH, I'M SPEAKING ON BEHALF OF MYSELF.

CURRENTLY IN THE CITY THERE ARE 365 BEDS AVAILABLE FOR OUR HOMELESS POPULATION.

AND THE LAST HOMELESS COUNT PUT US AT 356, IF THAT WAS ACCURATE THERE WOULD STILL BE ROOM IN THE SHELTERS FOR PEOPLE WHO NEED THEM.

BUT IF YOU WERE TO CALL ANY OF THE SHELTERS RIGHT NOW, AT THIS MOMENT, ALL BEDS ARE FULL.

THE CITY HAS MADE IT'S INTENTIONS CLEAR WITH THE 21-DAY NOTICE IT WAS GIVEN AND THOSE OF US WHO WORK IN OUTREACH APPRECIATE THE CITY ATTEMPTING TO GIVE NOTICE TO THOSE FOLKS WE SERVE, SO WE CAN FIGURE OUT SOMETHING TO DO WITH THEM.

I GUESS I CAN ONLY ASSUME THAT PART OF THE LOGIC, ESPECIALLY THIS TIME OF YEAR WITH THE COLD WEATHER COMING, IF THE HOMELESS COMMUNITY WHO ATTEND THE CAMPS ARE PUSHED OUT, THAT THESE FOLKS WILL GO TO THE SHELTERS OR FIND OTHER RESOURCES.

THAT IS NOT WHAT HAPPENS AT ALL.

AND IT'S IMPORTANT THAT YOU REALIZE WITH THE PROCEDURE THAT YOU ARE ENACTING WITH THINGS YOU PUT IN PLACE TO PUSH THE HOMELESS AWAY FROM THE PLACES THEY CALL HOME THAT YOU ARE NOT PUSHING THEM TOWARDS RESOURCES, YOU ARE PUSHING THEM OUT OF DOWNTOWN AND FURTHER AWAY FROM RESOURCES.

IF YOU KNOW ANYTHING ABOUT THE HOMELESS COMMUNITY, YOU WOULD KNOW THAT ALL MAJOR RESOURCES, I'M SURE YOU DO KNOW, THAT ALL MAJOR RESOURCES ARE CENTERED DOWNTOWN.

AND PUSHING THEM OUT WILL PUSH THEM FURTHER AWAY.

THEY WILL NOT GO TO THE SHELTERS, BECAUSE ONE, THERE IS NO ROOM.

IT WOULD BE NICE TO THINK THERE WERE ONLY 156 HOMELESS PEOPLE IN THE CITY OF LOUISVILLE TONIGHT.

BUT I CAN TELL YOU, ON A WEEKLY BASIS, I SERVE ABOUT 200 PEOPLE. AND THOSE ARE NOT THE PEOPLE WHO ARE IN THE SHELTERS.

THOSE ARE PEOPLE NOT IN THE SHELTER SYSTEM.

SO I WOULD LIKE TO URGE THIS BODY TO PLEASE CONSIDER HOW IT IS TREATING IT'S HOMELESS CONSTITUENTS.

BECAUSE THEY ARE YOUR CONSTITUENTS, WHETHER YOU WANT THEM OR NOT, OR THINK THEY DESERVE YOUR ATTENTION OR NOT, THEY ARE RESIDENTS OF THE CITY, THEY ARE HUMAN BEINGS AND THEY DESERVE CONSIDERATION.

IT'S HARD TO GO AND SERVE THEM WHEN THEY KNOW IN A COUPLE WEEKS THAT WE'RE NOT GOING TO BE ABLE TO FIND THEM.

> IT WILL MAKE IT HARDER FOR US, BECAUSE WE WILL NOT BE ABLE TO. THANK YOU.

MR. CLERK: THANK YOU.

BETTY BAYE: MY NAME IS BETTY BAYE, AND I'M HERE WITH DR. ARCHER, UNIVERSITY OF LOUISVILLE, VICE PROVOST, AND DWANE ARCHER, MEMBER OF THE PLANNING COMMITTEE FOR THE 2018 NATIONAL BLACK FAMILY CONFERENCE.

I AM HERE TO ENCOURAGE ALL OF YOU TO SUPPORT OUR APPLICATION FOR GRANTS TO HELP UNDER WRITE THE CONFERENCE, FEBRUARY 23RD AND 24TH AT THE LOUISVILLE COMMUNITY CENTER IN WEST LOUISVILLE.

COUNCILMAN JAMES HAS THE PAPERWORK.

IT HAPPENED UNDER DR. JOSEPH MCMILLEN.

EVERYBODY CAN AGREE AN EMPOWERED BLACK FAMILY -- IT SEEKS TO COUNTER UNFLATTERING STEREOTYPES OF BLACK FAMILIES AND TO GIVE THOSE FAMILIES INFORMATION AND THE TOOLS THEY NEED, NOT JUST TO SURVIVE BUT TO THRIVE IN THESE CHALLENGING, SOCIAL AND ECONOMIC TIMES.

THE BLACK FAMILY CONFERENCE IS A PLATFORM FOR COLLABORATION BETWEEN UNIVERSITY OF LOUISVILLE, THE COMMUNITY AND ACADEMICS.

> THIS CAN GO RIGHT NEXT TO YOUR CUP WITH ALL OF OUR SIGNATURES. AND WE ALSO HAVE CERTIFICATES FOR THE PLAYERS AND OWNERS. I WILL GIVE IT TO YOU, TIM, SO YOU CAN GIVE IT TO WHOMEVER.

COUNCIL MEMBER BRYANT HAMILTON: COLLEAGUES, I DON'T KNOW WHETHER OUR SPECIAL GUEST TONIGHT SHELDON SHAFER WAS PART OF THAT GREAT PRESS LOUISVILLE CITY THAT LEAD THEM ON THEIR WAY TO THE CHAMPIONSHIP.

BUT HE HAS BEEN PART OF A LOT OF GREAT STORIES IN THIS COMMUNITY.

IT'S A REAL PLEASURE TONIGHT TO BE ABLE TO RECOGNIZE A LONG SERVING JOURNALIST IN OUR COMMUNITY, MR. SHELDON SHAFER, ON HIS RETIREMENT FROM THE COURIER JOURNAL AFTER 44 YEARS.

I FIRST MET SHELDON BACK IN THE BOARD OF ALDERMEN DAYS WHEN THERE WERE TWO CHERI'S WORKING HERE.

THE OTHER CHERI WAS LITTLE CHERI, IN SPEAKING WITH A FORMER COLLEAGUE OF HIS, BETTY BAYE, WHO HAPPENS TO BE HERE TONIGHT, I ASKED HER TO SHARE A SHELDON SHAFER STORY.

SHE SAID YEAH WE WERE SEATMATES FOR A NUMBER OF YEARS.

WE SIT THERE, SMOKE UP THE NEWSROOM, BACK IN THE DAY, BEFORE EVERYTHING WENT SMOKE-FREE.

I GUESS IT WAS ALSO IN THE DAYS WHEN TYPEWRITERS WERE GOING OUT IN THE NEWSROOM AND COMPUTERS WERE COMING IN, BECAUSE THEY ACTUALLY HAD TO SHARE A COMPUTER ON A SWIVEL.

> THEY WOULD BOTH BE THERE WORKING ON THEIR STORIES ON A DEADLINE. YOU CAN SEE HOW TIMES HAVE CHANGED.

YOU HAVE SEEN A LOT.

I THINK I SPEAK FOR MOST, IF NOT ALL OF MY COLLEAGUES, DESPITE THE NATURAL TENSION THAT EXISTS BETWEEN POLITICIANS AND JOURNALISTS, THERE'S NEVER BEEN A FEELING THAT SHELDON SHAFER WAS A GOTCHA TYPE OF JOURNALIST.

HE DID HIS HOMEWORK.

HE WAS PATIENT, THOROUGH, WOULD ENCOURAGE YOU TO GO "OFF THE RECORD" FOR BACKGROUND PURPOSES, BECAUSE HE ALWAYS WANTED TO DO A GOOD STORY AND HE CARED SO MUCH ABOUT THIS COMMUNITY AND HE NEVER VIOLATED THAT TRUST.

I DON'T KNOW WHO WAS MORE EXCITED ABOUT THE PROPOSED WATERFRONT PHASE 4 PROJECT, ME OR SHELDON.

I THINK HE WAS EXCITED ABOUT THE POSSIBILITY OF THAT FERRIS WHEEL IN THE INITIAL DESIGN THAT DIDN'T MAKE IT TO THE FINAL CUT.

HE HAS BEEN A LONG-TIME SUPPORTER OF ALL THINGS LOUISVILLE.

SO WE WANTED TO PRESENT THIS PROCLAMATION TO YOU, WHICH I WILL READ.

LOUISVILLE METRO COUNCIL, ALL THESE LETTERS SHALL COME GREETINGS, HERE BY RECOGNIZES AND CELEBRATES SHELDON SCOTT SHAFER, HONORED AND WELL RESPECTED JOURNALIST.

WHEREAS INTRODUCED TO A NEWS REPORTER, AN INDIANA NATIVE, WHO AFTER STUDYING JOURNALISM AT INDIANA UNIVERSITY AND STARTED AS A COPY EDITOR BEFORE BECOMING A BELOVED REPORTER AND INSTITUTIONED HIMSELF AT THE C.J. IN 1973.

YOU ALSO WENT TO BUTLER, DIDN'T YOU? BUTLER HIGH SCHOOL?

IT WAS ANOTHER BUTLER.

BUTLER IN INDIANA, OKAY.

WHEREAS SHELDON FAITHFULLY COVERED LOCAL GOVERNMENT AND CITY HALL FROM THE BOARD OF ALDERMANS TO THE METRO COUNCIL, INCLUDING A TOTAL OF SIX MAYORS AND VARIOUS STORIES INCLUDING THE DEVELOPMENT OF WATERFRONT

PARK WHERE A SWING AND PLAQUE WERE DEDICATED IN HIS HONOR IN 2014 BY THREE FORMER MAYORS.

THE CREATION OF GOVERNMENT, ECONOMIC DEVELOPMENT, PUBLIC INTEREST AND A WIDE RANGE OF ISSUES.

WHEREAS IN THE SPAN OF A CAREER OF 44 YEARS AT THE COURIER, IT HAS BEEN ESTIMATED THAT SHELDON, A PROLIFIC JOURNALIST HAS WRITTEN MORE THAN 25,000 STORIES.

AND WHEREAS DURING THAT TIME, HIS GOAL AS A REPORTER HAS BEEN A SIMPLE ONE OF INFORMING PEOPLE ABOUT WHAT'S GOING ON IN LOUISVILLE.

NOW THEREFORE BE IT RESOLVED THE LOUISVILLE METRO COUNCIL HERE BY CONFERS AND PAYS TRIBUTE TO HIM BY WAY OF THIS PROCLAMATION WITH ALL RIGHTS, PRIVILEGES AND RESPONSIBILITIES THERE UNTO APPERTAINING IN TESTIMONY WHERE OF, WE HAVE CAUSED THESE LETTERS TO BE MADE AND THE SEAL OF METRO GOVERNMENT TO BE HERE UNTO AFFIXED, DONE IN LOUISVILLE METRO CITY HALL, WITHIN THE COMMONWEALTH OF KENTUCKY THIS 30TH DAY OF NOVEMBER.

I ALWAYS APPRECIATED IT WHEN THEY CALLED FOR THE QUESTION.

THE THING SAYS I HAVE WRITTEN 25,000 ARTICLES.

I HAVEN'T KEPT TRACK BUT THAT'S A PRETTY GOOD ESTIMATE.

HOLLENBECK, SLOAN, DAVE ARMSTRONG, REBECCA JACKSON, BILL STANCE BURY, JERRY ABRAHAMSON, JERRY FISHER, I HAVE PROBABLY WRITTEN THOSE NAMES THOUSANDS OF TIMES AND PROBABLY COVERED COUPLE THOUSAND PRESS CONFERENCES AND MEETINGS.

I THINK THE CITY IS IN GOOD HANDS WITH YOU SITTING HERE AND I WANT TO URGE YOU TO KEEP ON AND CARRYING THE CROSS AND DO THE PUBLIC GOOD.

THANK YOU VERY MUCH, IT'S BEEN AN INTERESTING CAREER.

THANK YOU.

PRESIDENT YATES: COUNCILMAN LEET, WOULD YOU LIKE A POINT OF PERSONAL PRIVILEGE?

COUNCIL MEMBER LEET: YES, MR. PRESIDENT, THAT WOULD BE WONDERFUL, THANK YOU.

ON THE LAST DAY OF NOVEMBER, I WANT TO TALK TO YOU ALL FOR A MOMENT ABOUT PART OF THE REASON OF THE COLOR PURPLE.

I REALIZE WE MAY HAVE PURPLE BEFORE US THIS EVENING BECAUSE OF OUR WONDERFUL LOUISVILLE CITY FOOTBALL CLUB TEAM AND THEIR CHAMPIONSHIP.

BUT IT'S ALSO A NATIONAL EPILEPSY AWARENESS MONTH.

I THINK ONE OF THE PRIVILEGES WE HAVE AS CITY COUNCIL MEMBERS IS PEOPLE REACH OUT TO US AND BRING AWARENESS TO US ABOUT A VARIETY OF DIFFERENT ISSUES.

I THANK MR. KEVIN DOYLE K. WHO REACHED OUT TO BRING AWARENESS TO ME ABOUT EPILEPSY.

AND WITH THIS AWARENESS HE MADE ME AWARE THAT 1 IN 26 AMERICANS ARE AFFECTED BY EPILEPSY, WHICH IS A HARD WORD TO SAY.

BUT IT IS A CHRONIC DISORDER.

AND IT'S A HALLMARK WHICH RECURRENT, UNPROVOKED SEIZURES.

I'VE KNOWN CHILDREN WHO HAVE HAD IT.

TEENAGERS WHO HAVE SUFFERED FROM IT.

AND ADULTS WHO CARRIED ON INTO THEIR ADULTHOOD AND LIFE TIME.

IT'S A SPECTRUM CONDITION WITH A WIDE RANGE OF SEIZURE TYPES AND CONTROL VARYING FROM PERSON TO PERSON.

JUST YESTERDAY I WAS TOLD OF AN INCIDENT SOMEONE WAS IN A RESTAURANT SITTING ON A BARSTOOL AT A COUNTER EATING LUNCH AND LITERALLY SUFFERED A SEIZURE.

AND BECAUSE OF AWARENESS AND BECAUSE OF THEIR UNDERSTANDING AND OUICK RESPONSE THEY WERE ABLE TO PROVIDE THE MEDICAL ATTENTION.

THEY DIDN'T JUDGE.

THEY SIMPLY WERE AWARE OF SOMETHING WASN'T QUITE RIGHT.

THIS PERSON WITH A FROZEN FACE AND THEY RESPONDED.

SO I JUST WANTED TO TAKE A MOMENT TO BRING THAT AWARENESS TO YOU ALL AND THOSE WHO MIGHT BE LISTENING TO OUR MEETING THIS EVENING.

> AND PLEASE BE AWARE OF THIS, AND LEARN A LITTLE MORE ABOUT IT. PLEASE RESPOND.

CALL 9-1-1.

AND LOOK AT OTHER WAYS.

WE DON'T KNOW WHAT CAUSES EPILEPSY YET BUT THERE'S RESEARCH IT'S STILL RECURRING AND APPROPRIATE METHODS TO TRY TO TREAT IT AND DEAL WITH IT.

JUST TO HAVE AWARENESS AND COMPASSION AND UNDERSTANDING FOR THIS.

THANK YOU.

THIS WAS DISCUSSED AT COMMITTEE.

IS THERE ANY DISCUSSION ON THIS? AS WE DISCUSSED, THIS WOULD IMMEDIATELY SUSPEND THE ADMINISTRATIVE, I THINK IT'S THE POSITION HELD PREVIOUSLY, SUSPEND THAT POSITION EFFECTIVE IMMEDIATELY.

> IS THERE ANY DISCUSSION? HEARING NONE. ALL THOSE IN FAVOR RESPOND BY SAYING AYE. THE AYE'S HAVE IT. THE RESOLUTION IS ADOPTED. MR. CLERK, A READING OF ITEM 17.

MR. CLERK: A RESOLUTION OVERTURNING THE DECISION OF THE LANDMARKS COMMISSION DESIGNATING THE PROPERTY LOCATED AT 609 BLANKENBAKER LANE IN LOUISVILLE METRO AS A LOCAL LANDMARK (CASE NO. 17DESGNATION1000).

> PRESIDENT YATES: MAY I HAVE A MOTION AND SECOND FOR APPROVAL. PROPERLY MOVED AND SECONDED.

IT'S BEFORE US FOR DISCUSSION.

COUNCILMEMBER FLOOD?

COUNCIL MEMBER FLOOD: MR. PRESIDENT, IF YOU WOULD, SINCE THIS IS SCOTT REED'S RESOLUTION I WOULD LIKE TO DEFER TO HIM.

> PRESIDENT YATES: THANK YOU, COUNCILWOMAN. COUNCILMAN REED WOULD YOU LIKE THE FLOOR? COUNCIL MEMBER REED: YES, SIR. PRESIDENT YATES: THE FLOOR IS YOURS. COUNCIL MEMBER REED: THANK YOU, MR. PRESIDENT. A BRIEF STATEMENT TO READ.

THE LANDMARKS ORDINANCE IS A CREATION OF THE METRO COUNCIL.

SINCE STARTING THE REVIEW PROCESS I HAVE HEARD NEAR UNANIMOUS SUPPORT CHANGING THE ORDINANCE.

FOR THOSE OF YOU NOT ABLE TO ATTEND THE HEARING A NUMBER OF THOSE PERSONS WHO SPOKE WERE STILL BEMOANING THE METRO COUNCIL'S DECISION OF THE TREE -- CASE.

> THE POWER TO DECIDE WHAT IS AND NOT HISTORIC IS IN OUR HANDS. THE SUBJECTIVE NATURE OF THE CRITERIA ARE OURS TO INTERPRET.

I'M GLAD WE HAD THIS HEARING A FEW WEEKS AGO, IT DID BRING CLARITY TO A NUMBER OF MATTERS.

AT THAT HEARING WE LEARNED THERE IS NO PROOF THAT 609 BLANKENBAKER IS A STRATTON HAMMON HOME.

NONE IN WHICH STRATTON HAMMON LIVED ARE DESIGNATED HISTORIC, NONE.

WE LEARNED THE MAIN PETITIONER IN THE CASE OWNS A STRATTON HAMMON HOME BUT HASN'T SOUGHT HISTORIC DESIGNATION.

WE LEARNED THE TESTIMONY RECEIVED ABOUT MR. WINTER'S WILLINGNESS TO VOLUNTEER HIS HOME TO RESTORE THE HOME AND VIEWING OF THE HOME WERE NOT ACCURATE.

WE LEARNED THAT THE PETITIONER OR LEGAL REPRESENTATIVE OFFERED ON MULTIPLE OCCASIONS TO WITHDRAW THE PETITION DESIGNATING THE HOME HISTORIC IF THE PROPERTY OWNER WOULD REDUCE THE HOME, OR NUMBER OF HOMES TO BE BUILT.

WE LEARNED THAT THE HOME WAS DESIGNATED FOR DEMOLITION APPROXIMATELY A YEAR AGO AND NO EFFORT WAS MADE TO SAVE THE HOME.

EFFORTS ONLY STARTED IN THE LAST ONE OR TWO YEARS AGO, NOT A DECADE AGO.

WE LEARNED SOME SIGNATORIES, INCLUDING POTENTIALLY [INAUDIBLE] WERE NOT RESIDENTS OF JEFFERSON COUNTY.

WE LEARNED THERE HAVE BEEN ZERO SUCCESSFUL APPEALS DUE TO ECONOMIC HARDSHIP GRANTED IN THE PAST DECADE.

AND THE TESTIMONY OF NEIGHBORS DESCRIBE WHY OUTLINED IN CHAPTER 32.250 SECTION C, NUMBERS 3, 6 AND 7 AND 9.

THESE STATE THE PURPOSE OF DESIGNATION IS TO "STABILIZE AND IMPROVE PROPERTY VALUES".

STRENGTHEN THE ECONOMY OF THE METRO GOVERNMENT.

AS WELL AS TO PROTECT AND ENHANCE METRO GOVERNMENT'S ATTRACTION TO RESIDENTS, TOURISTS AND VISITORS AND SERVE AS A SUPPORT TO BUSINESS AND INDUSTRY.

DESIGNATION WOULD ONLY ACHIEVE THE OPPOSITE.

THIS ORDINANCE IS MEANT TO SAVE AND PROTECT ACTUAL LANDMARKS NOT BECOME PART OF A WEBONIZED EFFORT FOR SOMETHING A NEIGHBOR DOESN'T LIKE.

WE HAVE BEEN TALKING ABOUT REDUCING VACANT HOMES, NOT SANCTIONING THEM.

THAT'S WHY I OFFERED THIS RESOLUTION AND WHY I'M ASKING FOR YOUR SUPPORT TONIGHT.

FINALLY I WOULD LIKE TO THANK THE MEMBERS OF THE METRO COUNCIL FOR THEIR TIME ON THIS MATTER, ESPECIALLY COUNCILWOMAN MADONNA FLOOD WHO DID A FANTASTIC JOB AT THE PUBLIC HEARING AND CHAIRED THE COMMITTEE HEARING AND MY COLLEAGUES ON THE PLANNING AND ZONING COMMITTEE AND THOSE WHO VISITED THE HOME LAST MONTH.

THANK YOU, AND I ASK FOR YOUR SUPPORT.

PRESIDENT YATES: THANK YOU, COUNCILMAN.

IS THERE ANY FURTHER DISCUSSION? COUNCILWOMAN FOWLER?

COUNCIL MEMBER FOWLER: THANK YOU.

MR. PRESIDENT.

I JUST WANT TO EXPLAIN MY VOTE.

AT YOUR DESK YOU WILL SEE PICTURES I TOOK A COUPLE MONTHS AGO WHEN I VISITED THE HOME.

AND AS EVERYBODY KNOWS THE FIRE DESTROYED THE HOUSE IN 1952, I BELIEVE IT WAS AND LEFT NOTHING BUT THE STONE SHELL.

IT WAS BUILT IN THE 1950'S STYLE AND NOT BACK TO THE ORIGINAL WAY IT WAS BUILT IN THE EARLY PART OF THE CENTURY.

I ENCOUNTERED WARPED FLOORING ON THE MAIN FLOOR AND IN THE BASEMENT AREAS OF THE FLOOR JOISTS THAT HAD FAILED OVERHEAD.

THERE WERE LARGE CRACKS IN THE WALLS.

THROUGHOUT THE STRUCTURE, LARGE CRACKS AROUND SEVERAL DOOR JAMBS AND WINDOWS AND DAYLIGHT I COULD SEE AROUND THE CHIMNEY AND THE ROOF LINE.

THE COST ESTIMATE TO REPAIR THAT HOME TO MAKE IT RIGHT UNDER TWO ESTIMATES WAS OVER \$1 MILLION.

I JUST FEEL LIKE WE SHOULD TAKE INTO CONSIDERATION THE STRUCTURAL INTEGRITY OF THE HOME AND FINAL COST TO THE OWNERS.

AND LET THE COMMISSION, THE COMMISSION HAS A PLAN TO FINANCIALLY BACK OR FUND RAISE IN SUPPORT OF THE OWNERS TO RENOVATE THE HOUSE, AND I FEEL IT'S MUCH TOO HEAVY A BURDEN TO BE PLACED ON THEM.

AND I JUST WANTED TO EXPLAIN MY VOTE.

BECAUSE I FELT THIS WAS JUST NOT REALLY HISTORIC.

THE WALLS OF THE OUTSIDE OF THE FACADE OF THE HOUSE ARE THE ONLY THING I SAW.

THE TOUCH POINTS WERE SO BADLY IN NEED OF REPAIR THAT WOULD BE A MAJOR UNDERTAKING AS WELL.

SO THANK YOU.

PRESIDENT YATES: THANK YOU, COUNCILWOMAN.

I WILL TURN TO THE ASSISTANT COUNTY ATTORNEY, HE KIND OF MOTIONED.

I THINK MAYBE AN ADMONISHMENT NEEDED OR CLARIFICATION.

PAUL WHITTY: THANK YOU, MR. PRESIDENT.

PAUL WHITTY, CITY ATTORNEY.

WITH ALL DUE RESPECT TO COUNCILMAN FOWLER, THESE PHOTOGRAPHS WERE NOT PART OF THE RECORD THAT WAS MADE BEFORE THE LANDMARKS COMMISSION, NOR WERE THEY INTRODUCED IN THE HEARING BEFORE THE PLANNING AND ZONING COMMITTEE.

THEREFORE, I WILL ASK YOU TO IGNORE THOSE PHOTOGRAPHS, PLEASE.

PRESIDENT YATES: THERE HAD BEEN PHOTOGRAPHS THAT HAD BEEN PASSED OUT OR OTHERWISE MENTIONED, PLEASE DO NOT CONSIDER THOSE PHOTOGRAPHS OR PAY ATTENTION AND MOVE FORWARD WITH THIS BODY.

NOW I KNOW, EVERYBODY HAS HAD A CHANCE TO VIEW THE STRUCTURE AND SEE IT WITH THEIR OWN EYES BUT THOSE PHOTOGRAPHS SHOULD NOT BE CONSIDERED IN CASTING YOUR VOTE.

COUNCILMAN COAN.

COUNCIL MEMBER COAN: THANK YOU -- I'M HEARING COUNCILMAN REED AND FOWLER SAYING THEY DON'T LIKE THE LANDMARKS ORDINANCE.

I DON'T LIKE IT EITHER.

BUT YOU ALL CREATED IT.

THE LAW IS THE LAW.

AND OUR JOB AT THE LANDMARKS COMMISSION IS TO APPLY THE LAW, INCLUDING THE CRITERIA THAT DETERMINES WHETHER OR NOT LOCAL LANDMARKS, CERTAIN BUILDINGS AND STRUCTURES ARE DESIGNATED AS SUCH.

AS A MEMBER OF THE LANDMARKS COMMISSION, WE GAVE A FULL AND COMPLETE DUE PROCESS TO THIS BUILDING, AS ALL RECEIVE.

WE CAREFULLY DELIBERATED.

WE VOTED.

THERE'S AMPLE EVIDENCE ON THE RECORD TO SUPPORT OUR DECISION.

OUR DECISION IS NOT ERRONEOUS, NO ARBITRARY OR CAPRICIOUS.

I DON'T THINK THERE'S ANY LEGAL STANDARD WHATSOEVER FOR COUNCIL TO REVERSE IT.

BUT THAT BEING SAID, THE LANDMARKS COMMISSION STANDARDS SHOULD BE CHANGED GOING FORWARD AND WE COULD DO THAT HERE.

BUT IT'S NOT SOMETHING WE CAN CHANGE ON A CASE-BY-CASE REVIEW BASIS, INCLUDING THE SUBJECT PROPERTY TONIGHT.

I WILL LEAVE IT AT THAT FOR THE TIME BEING.

THANK YOU VERY MUCH.

PRESIDENT YATES: THANK YOU, COUNCILMAN COAN.

HE MENTIONED THERE MAY BE SOME OTHER PROCEDURE THAT NEEDS TO TAKE PLACE BESIDES ADMONISHMENT OF THE PICTURES.

AND SECOND JUST FOR CLARIFICATION, THE STANDARD REVIEW OF THIS

>> IT'S ARBITRARY AND CAPRICIOUS, BUT TO REINFORCE WHAT I SAID, THOSE PHOTOGRAPHS SHOULD BE DISREGARDED.

UNFORTUNATELY THEY WERE NOT MADE PART OF THE RECORD PROPERLY.

PRESIDENT YATES: OTHER THAN DISREGARDING THOSE AND NOT

CONSIDERING THEM, IS THERE ANYTHING ELSE WE NEED TO DO AS THIS BODY?

>> NO, SIR.

PRESIDENT YATES: THANK YOU.

COUNCILWOMAN FLOOD?

COUNCIL MEMBER FLOOD: THANK YOU, MR. PRESIDENT.

WHILE PHILOSOPHICALLY I HAVE A HUGE ISSUE WITH ANY ONE CITIZEN, OR GROUP OF CITIZENS BEING ABLE TO GO OUT AND LANDMARK SOMEONE ELSE'S

PROPERTY JUST BECAUSE THEY DON'T LIKE WHAT'S GOING TO HAPPEN ON THAT HILL, WE FIND OURSELVES THROWN IN THE MIDDLE OF THIS.

BECAUSE THIS IS THE ORDINANCE WE PASSED, THAT WE ALL HAD A CHANCE TO MAKE MAJOR CHANGES.

AND THE ONLY MAJOR CHANGE WE MADE ON A LANDMARK ORDINANCE IS IT GETS APPEALED TO US.

WHAT NEEDS TO HAPPEN, A LOT OF US HAVE SAID THIS TIME AND TIME AGAIN FOR THE LAST 14 YEARS, LANDMARKS, MARKING THINGS LANDMARK SHOULD BE DONE PROACTIVELY, NOT REACTIVELY WHEN SOMETHING IS COMING UP.

I AGREE WITH A LOT OF THINGS MY COLLEAGUE MR. REED SAID.

BUT, I FEEL AN OBLIGATION THAT I AM NOT GOING TO STAND HERE TODAY AND SAY THAT LANDMARKS, THE COMMISSION, MADE AN ERROR IN THEIR RULING.

BECAUSE THEY APPLIED THE NINE CRITERIA AND THEY FOUND SEVEN OUT OF THE NINE APPLIED.

AND THOSE ARE THE THINGS THAT WE SET FORTH IN THAT ORDINANCE.

SO MY VOTE TONIGHT WILL BE TO BACK THE LANDMARK SIMPLY BECAUSE THAT'S THE WAY THE ORDINANCE IS WRITTEN.

WE DO NEED TO CHANGE THAT.

COUNCILMAN COAN, I AGREE WITH YOU.

WE NEED TO REVISIT THAT AND WRITE IT A LOT BETTER THAN WHAT IT'S WRITTEN NOW.

BECAUSE THINGS WILL KEEP COMING BACK IN FRONT OF US, AND WE WILL BE THE DECISION MAKERS OR ARBITRATORS BETWEEN THE PROPERTY OWNER AND SOME OTHER GROUP.

AND THAT, I DON'T THINK IS WHAT WE INTENDED TO DO FOR EVERYTHING THAT COMES DOWN THE PIKE TO COME OVER HERE.

BUT THANK YOU, MR. PRESIDENT.

PRESIDENT YATES: ON THAT, I THINK I STILL HAVE MY ORIGINAL DRAFT BEFORE IT GOT HACKED THE FIRST TIME.

COUNCILWOMAN WOOLRIDGE?

COUNCIL MEMBER WOOLRIDGE: THANK YOU, MR. PRESIDENT.

I WOULD LIKE TO WEIGH IN AS FAR AS FINDING OUT HOW MANY ON THE LANDMARK COMMISSION.

FIRST OF ALL, HOW MANY ARE ON THE LANDMARK COMMISSION AND HOW MANY VOTED FOR THIS TO BE A HISTORICAL LANDMARK.

PRESIDENT YATES: COUNCILMAN COAN, WOULD YOU LIKE TO ANSWER THAT? COUNCIL MEMBER COAN: I SHOULD PROBABLY KNOW THE ANSWER, THE VOTE WAS 7-1, I BELIEVE.

NOT EVERYONE WAS PRESENT, SO MAYBE DEBRA OR PAUL COULD TELL US IF THERE'S TEN MEMBERS.

I'M NOT SURE EXACTLY.

>> THERE ARE 13 TOTAL MEMBERS.

>> AND DID WE GET THE NUMBER THAT VOTED?

>> COUNCILMEMBER WOOLRIDGE, 13 MEMBERS, 8 VOTED.

7 IN FAVOR OF LOCAL LANDMARK STATUS, ONE OPPOSED.

I WAS ONE OF THE SEVEN FOR-VOTES.

>> WELL, F.Y.I. I WILL BE VOTING THE WAY THE LANDMARK COMMISSION

VOTED.

THANK YOU.

PRESIDENT YATES: THANK YOU, COUNCILWOMAN,.

COUNCILWOMAN FOWLER.

COUNCIL MEMBER FOWLER: THANK YOU, MR. PRESIDENT.

TO COUNCILMAN COAN'S COMMENT, I NEVER SAID I DIDN'T LIKE THE LANDMARKS COMMISSION.

I JUST WANT TO SAY I TOOK THE PICTURES BECAUSE NO ONE FROM THE LANDMARKS COMMISSION [INAUDIBLE] AND I FOUND IT VERY IMPORTANT THAT PEOPLE SHOULD SEE.

AND I HOPE THAT PEOPLE ARE ABLE TO GO TO THAT BUILDING AND SEE THE STRUCTURAL DAMAGE THAT IS THERE.

SO JUST TO BE CLEAR, THAT'S ALL I WANTED TO SAY, THANK YOU.

PRESIDENT YATES: THANK YOU, COUNCILWOMAN.

COUNCILMAN HOLLANDER?

COUNCIL MEMBER HOLLANDER: THANK YOU, MR. PRESIDENT.

I WILL BE BRIEF.

I JUST WANT TO POINT OUT ANOTHER WAY THIS WHOLE PROCESS IS BROKEN.

THE LANDMARKS COMMISSION, AT THIS STAGE OF THE PROCEEDINGS LOOKS AT THE NINE CRITERIA AND SAYS WHICH OF THESE DOES IT MEET.

THEY DO NOT LOOK AT ECONOMIC HARDSHIP.

THEY DO NOT RECEIVE ANY EVIDENCE ABOUT HOW MUCH IT WOULD COST TO REPAIR THE PROPERTY, THAT IS IRRELEVANT TO THEIR DECISION.

AND THEY HAVE, IN FACT, FOLLOWED THE LAW.

WHAT HAPPENS WHEN IT COMES HERE IS THAT WE THEN BEGIN TO TALK ABOUT, WELL IT WOULD COST A LOT TO REPAIR IT AND GET INTO THE WHOLE ECONOMIC HARDSHIP ISSUE.

THAT'S NOT BEFORE US.

I'M NOT SAYING IT SHOULDN'T BE.

I'M JUST SAYING THE SYSTEM IS BROKEN.

WE ARE REVIEWING A COMMISSION'S DECISION, WHEN THEY DIDN'T EVEN LOOK AT THAT DECISION BECAUSE THEY WEREN'T SUPPOSED TO.

WE NEED TO FIX THIS, THIS IS TWICE WE HAVE GOTTEN INTO THE SAME ISSUE.

I'M NOT ARGUING THE MERITS OF EITHER ONE.

BUT IT'S THE SAME SITUATION WHERE WE ARE REVIEWING THE

COMMISSION AND MAKING A DECISION ON SOMETHING THAT WASN'T BEFORE THEM AND THEY DIDN'T LOOK AT.

THANK YOU.

PRESIDENT YATES: THANK YOU, COUNCILMAN.

AND JUST HISTORY OF THE DISCUSSION, ONE OF THE ARGUMENTS WE HAD OVER AND OVER AGAIN, WHILE THE BUILDING COULD MEET THE QUALIFICATIONS, THERE SHOULD BE OVERSIGHT, BECAUSE METRO COUNCIL BALANCES EVERYTHING, AND SOMETIMES THE COST OF PRESERVING MAY EVEN BE AN IMPEDEMENT -- WOULD BE PROHIBITIVE.

THIS WAS AN ORDINANCE WITH A LOT OF DEBATE.

I THINK WE HAVE A CONSENSUS WE NEED TO PUT TOGETHER A WORK GROUP.

BECAUSE I KNOW THE COMMISSION SPENDS A LOT OF TIME AND THEY DON'T GET PAID AND IT'S A LOT OF VOLUNTEER WORK.

> SO WE WANT TO MAKE SURE THAT THEY ARE NOT COMPLETELY OVERLOOKED. I THINK WE SHOULD BE IN AGREEMENT WITH THIS BODY ON THAT NOTE. COUNCILMEMBER COAN?

COUNCIL MEMBER COAN: THANK YOU, MR. PRESIDENT.

COUNCILMEMBER, I AM SORRY.

NUMBER TWO, I AM PART OF THE SUBCOMMITTEE OF THE LANDMARKS COMMISSION THAT IS WORKING TO PROPOSE REVISIONS TO THE ORDINANCE.

I THINK IT'S IMPORTANT.

I HAVE SEVERAL IDEAS ABOUT IT.

I EVEN HAVE A SEPARATE ORDINANCE CURRENTLY BEING TABLED IN THE ZONING AND PLANNING COMMITTEE THAT WILL ADDRESS IT IN SOME RESPECTS ONCE I FILE AN AMENDMENT BY SUBSTITUTION, BUT I AGREE WHOLEHEARTEDLY AND I WILL BE SURE TO REACH OUT TO ANYONE WHO WANTS TO WORK ON THAT POLICY ITEM.

THE OTHER IS ABOUT OUR CONSIDERATION OF ECONOMICS.

I THINK IT MIGHT BE WORTH 30 SECONDS FOR PAUL TO EXPLAIN THAT THERE IS A PROCESS BEYOND THE LANDMARKING, BEYOND THIS COUNCIL'S CONSIDERATION OF WHATEVER HAPPENS TONIGHT.

LET'S SAY THAT THE LOCAL LANDMARK STAYS THE SAME AFTER TONIGHT.

THE APPLICANT STILL HAS AN OPPORTUNITY TO APPLY FOR THAT ECONOMIC HARDSHIP EXEMPTION THAT WOULD ALLOW WHATEVER CHANGES THEY DESIRE.

COULD YOU EXPLAIN FOR MAYBE 30 SECONDS HOW THAT WORKS SO FOLKS CAN UNDERSTAND THAT?

>> WELL, YES, SIR I WILL DO MY BEST.

I WASN'T AT THE HEARINGS AND I DON'T REPRESENT THE LANDMARKS COMMISSION, BUT, THERE IS A HARDSHIP EX -- EXCEPTION FOR THE BASIS OF AN APPEAL WHICH MUST BE TAKEN WITHIN A CERTAIN AMOUNT OF TIME.

AND I BELIEVE THEY HAVE TO MAKE A SHOWING THAT THE DESIGNATION OF THE LANDMARK WOULD NOT ENABLE THEM TO HAVE ANY ECONOMIC RETURN ON THE PROPERTY.

THAT'S ADMITTEDLY A DIFFICULT THRESHOLD TO REACH.

BUT THAT'S THE PROCESS.

AND NOT PART OF THE INITIAL CONSIDERATION, AS YOU POINT OUT, BEFORE THE LANDMARKS COMMISSION.

PRESIDENT YATES: THANK YOU.

COUNCILMAN KRAMER?

COUNCIL MEMBER KRAMER: THANK YOU, MR. PRESIDENT.

WHILE I THINK IT'S TRUE THAT SEVERAL OF US ON THIS BODY MIGHT AGREE THE LANDMARKS ORDINANCE NEEDS WORK, THE PROBLEM BEFORE US TONIGHT ISN'T RATHER THE LANDMARKS ORDINANCE NEEDS WORK.

THE REALITY IS THERE'S A HOMEOWNER WHO IS FACED WITH AN OUTSIDE GROUP OF FOLKS.

SOME OF WHOM MAY EVEN BE FROM OUT-OF-STATE WHO ARE DECLARING THEIR PROPERTY A HISTORIC PROPERTY AND HAVE MADE IT CLEAR IN THE RECORD THAT THE REASON THEY WANT TO BE DECLARED HISTORIC IS BECAUSE THE DEVELOPER WANTS TO PUT MORE HOMES ON THAT LOT THAN THEY WANT AND EVEN WENT AS FAR TO SAY THIS IS ABOUT REDUCING THE SIZE OF THE DEVELOPMENT.

SO TO MAKE THE ARGUMENT THAT THERE WAS NOTHING IN THE RECORD, OR THAT WE ARE GOING AGAINST THIS WELL-THOUGHT-OUT PROCESS, MAYBE IN THE FUTURE WE NEED TO FIX THAT, OR NOT MAYBE, I WOULD AGREE WITH MY COLLEAGUE, WE NEED TO FIX THE ORDINANCE.

BUT FIXING THE ORDINANCE IN THE FUTURE DOES NO GOOD FOR THE OWNERS OF THIS PARTICULAR PROPERTY.

IF WHAT WE ARE TALKING ABOUT IS AN INJUSTICE TO THE OWNER OF THE PROPERTY, I DON'T FEEL VERY GOOD THAT TOMORROW I CAN SAY TO THEM, O GOSH, WE HAVE AN ORDINANCE THAT'S TERRIBLE AND WE WISH WE WOULD HAVE FIXED IT

SOONER, BUT YOU KNOW, IT'S WHAT WE HAD, BUT YOUR HOUSE IS HISTORIC AND YOU CAN'T DEVELOP.

IF YOU ARE IN FAVOR OF CHANGING THE ORDINANCE, I AGREE, BUT PLEASE DON'T LET YOUR VOTE BE BASED ON THE FACT THAT OUR ORDINANCE IS BROKEN AND SAY BECAUSE OF THAT THIS PROPERTY OWNER IS STUCK WITH THAT RESULT.

IT'S NOT THE HOMEOWNERS FAULT.

THIS BODY, WE GAVE OURSELVES THE OPPORTUNITY TO HEAR THESE THINGS.

WE CHANGED THE LAW.

MAYBE WE DIDN'T PERFECT IT.

MAYBE OUR NEWER COLLEAGUES ON THE COUNCIL WOULD HAVE DONE A BETTER JOB MAKING THE CORRECTIONS THAN WE DID.

BUT WE UNDERSTOOD THINGS WERE HAPPENING WITH THIS LANDMARKS COMMISSION THAT WERE OVER THE TOP.

SO WHAT WE DID IS SAID KEEP DOING WHAT YOU DO, BUT JUST KNOW, WE PUT A CHECK ON YOU.

AND YOU ARE RIGHT, THIS IS THE SECOND TIME -- THERE'S BEEN OTHER LANDMARK CASES WE DIDN'T FEEL THE NEED TO CHECK.

THIS IS THE SECOND TIME WE ARE LOOKING AT IT, AND SAYING WHY ARE YOU DECLARING THIS HISTORIC.

I THINK COUNCILMEMBER REED HAS MADE SEVERAL GOOD POINTS.

HIS ARGUMENT IS SOUND AND I WOULD ENCOURAGE MY COLLEAGUES TO VOTE YES TONIGHT.

PRESIDENT YATES: THANK YOU.

COUNCILMEMBER MULVIHILL?

COUNCIL MEMBER MULVIHILL: YES, JUST TO FOLLOW-UP ON A COUPLE QUESTIONS.

I ASKED A QUESTION ABOUT THE PROCESS WHEN I WAS IN THE HEARING.

EVEN IF TONIGHT IT'S LANDMARK, THERE'S A PROCESS DEALING WITH ECONOMIC HARDSHIP.

THAT MAY NOT BE THE BEST WAY TO DO IT BUT THERE'S ANOTHER PROCESS.

SO TO SAY THERE'S NO REMEDY, IT'S NOT ENTIRELY TRUE BECAUSE THERE IS A REMEDY, THE ORDINANCE PROVIDES FOR.

THAT BEING SAID, THERE'S BEEN A LOT OF TALK ABOUT THE BEST WAY TO DO THIS.

I MEAN, CURRENTLY THE LANDMARKS COMMISSION HAS NINE CRITERIA AND THE COUNCIL HAS NONE.

SO I THINK YOU REALLY DO WANT TO PROBABLY MATCH THOSE UP.

OTHERWISE, YOU KNOW, I'M NOT SURE THE LANDMARKS COMMISSION IS THAT IMPORTANT IF THEIR DECISIONS CAN BE OVERTURNED JUST BASED ON ANY CRITERIA.

I THINK THEY SHOULD MATCHUP.

THANK YOU.

PRESIDENT YATES: THANK YOU, COUNCILMAN.

COUNCILWOMAN FLOOD?

COUNCIL MEMBER FLOOD: I JUST HAVE A COUPLE QUICK QUESTIONS FOR THE COUNTY ATTORNEY.

PAUL, OR SARAH, EITHER ONE.

THIS IS NOT THE LAST OF THIS.

IS THERE AN APPEAL PROCESS ALSO TO THE CIRCUIT COURT?

>> YES, THERE'S AN APPEAL FROM THE DECISION OF THIS BODY.

>> WITHIN 30 DAYS, LIKE ZONING ISSUES, OR IS IT LONGER?

>> I THINK THAT'S CORRECT.

BUT I WOULD ALSO LIKE TO ADDRESS THE HARDSHIP EXCEPTION, BECAUSE I DIDN'T STATE IT SO I WANT TO CLARIFY.

THE BURDEN UPON SOMEONE APPEALING THE COMMISSION'S DECISION, TO GRANT AN ECONOMIC HARDSHIP AND THIS IS WITH RESPECT TO A NON-INCOME PRODUCING PROPERTY, WHICH THIS IS BEFORE YOU.

THAT RESPECT TO AN APPLICATION INVOLVING A NON-INCOME PRODUCING STRUCTURE OR PROPERTY, THE PROPERTY OR STRUCTURE CANNOT BE PUT TO ANY REASONABLE BENEFICIAL USE, ACCORDING TO THE GUIDELINES ADOPTED BY THE COMMISSION FOR ECONOMIC HARDSHIP WITHOUT APPROVAL OF THE APPLICATION.

PRESIDENT YATES: THANK YOU.

IN THAT APPEAL, THE STANDARD, THE ONLY WAY TO OVERTURN ON AN APPEAL WOULD BE THIS BODY WAS ARBITRARY AND CAPRICIOUS IN OUR DECISION MAKING.

COUNCILMEMBER KRAMER? OR COUNCILMEMBER FLOOD WANTED THE FLOOR BACK.

COUNCIL MEMBER FLOOD: THE OTHER QUESTION, YOU MAY NOT KNOW THIS OFF THE TOP OF YOUR HEAD, I REMEMBER THIS FROM PREVIOUS CONVERSATIONS.

> ARE THERE TAX CREDITS? >> I BELIEVE THERE ARE. HISTORIC TAX CREDITS. PRESIDENT YATES: IT'S NOT OUR LOCAL LANDMARK. >> THAT'S A SEPARATE APPLICATION. >> I UNDERSTAND THAT.

I LOOKED AT A PIECE OF PROPERTY THAT WAS 175 YEARS OLD THAT WE HAD THOUGHT ABOUT, WE PASSED BECAUSE STRUCTURAL BUT WE WERE TOLD THERE WERE FUNDS AVAILABLE TO HELP, IF WE WANTED TO LANDMARK THE PROPERTY.

PRESIDENT YATES: THANK YOU, COUNCILWOMAN.

COUNCILMAN KRAMER?

COUNCIL MEMBER KRAMER: COUNCILMEMBER REED MAY SAY WHAT I'M GOING TO SAY BUT SINCE I HAVE THE FLOOR.

IT'S IN THE RECORD THAT NO ONE HAS EVER SUCCESSFULLY WON ON THE HARDSHIP.

I HAD HEARD EARLIER TONIGHT IN THE PAST DECADE.

SO I WILL USE, IN THE PAST DECADE, INSTEAD OF NEVER.

BUT IN THE PAST DECADE, THAT'S TEN YEARS, NO ONE HAS EVER SUCCESSFULLY WON THE HARDSHIP CHALLENGE.

SO SOME OF MY COLLEAGUES ARE SAYING, WELL, YOU KNOW, MAYBE WE SHOULD GO AHEAD AND PASS THIS THROUGH AND LET THEM GO THE HARDSHIP ROUTE BECAUSE IF YOU ARE RIGHT ABOUT THAT THEY WILL GET IT THERE.

BUT THIS MIGHT BE THE ONE THAT TURNS IT AROUND.

THANK YOU, \$1,000 FROM DISTRICT 15.

COUNCILMEMBER ACKERSON, DISTRICT 26.

I AM SUPPORTIVE OF THE PROJECT, THIS WAS SUPPORTED BY THE NEIGHBORHOOD ASSOCIATIONS AND MANY RESIDENTS, EVERYBODY SUPPORTIVE OF THIS BUT I DID ADD, AND I THINK IT'S AT THE END OF SECTION 1.

IT SHOULD READ AS FOLLOWS ANY CHANGE FROM THE USE OF SPECIAL PERMITTED USES SET FORTH IN SECTION 2.4.2 OF THE LAND DEVELOPMENT CODE ON THE SUBJECT PROPERTY SHALL REQUIRE REVIEW AND APPROVAL BY THE METRO COUNCIL.

THAT LIST CONTAINS MANY THINGS CONTAINED IN A COMMERCIAL RESIDENTIAL AREA.

I THINK THE FOLKS THAT RESIDENTS THAT LIVE AROUND THERE WOULD EXPECT THIS WOULD BE AND CONTINUE TO BE SOME SORT OF COMMERCIAL TYPE ESTABLISHMENT SUCH AS, COFFEE SHOP, LAUNDRY MAT OR PHOTOGRAPHY STUDIO.

THAT WAS JUST PUT IN THERE IN CASE IT WAS CHANGED TO ANYTHING OTHER THAN THOSE LAUNDRY LIST OF SPECIAL PERMITTED USES.

THANK YOU.

PRESIDENT YATES: I'M SURE COUNCILMEMBER BLACKWELL WILL BACK YOU UP ON THAT ONE.

ADVOCATE NOW BAIT AND SWITCH.

IS THERE ANY DISCUSSION? HEARING NONE, THIS REQUIRES A ROLL CALL VOTE.

WITHOUT OBJECTION THE VOTING IS CLOSING.

MR. CLERK: 23 YES-VOTES AND TWO NOT VOTING.

PRESIDENT YATES: THE AMENDED ORDINANCE PASSES.

MR. CLERK, A READING OF ITEM 37.

MR. CLERK: AN ORDINANCE CREATING A NEW SUBCHAPTER OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT CODE OF ORDINANCES RELATING TO THE PROTECTION OF PUBLIC TREES, TREE CANOPY AND ENVIRONMENTAL INFRASTRUCTURE (AMENDED BY SUBSTITUTION) READ IN FULL.

PRESIDENT YATES: MOTION AND SECOND FOR APPROVAL.

COUNCILMEMBER FOWLER?

COUNCIL MEMBER FOWLER: THANK YOU.

THIS CAME OUT OF COMMITTEE, I'M GLAD WE GOT A GOOD ORDINANCE ON OUR BOOKS TO PROTECT OUR PUBLIC TREES AND RIGHT OF WAYS AND HOPEFULLY WE WILL GO ONE STEP FURTHER TO PROTECT TREES.

I THINK COUNCILMEMBER HOLLANDER MAY WANT TO SPEAK ON THIS.

COUNCIL MEMBER HOLLANDER: THANK YOU, CHAIRWOMAN FOWLER AND MR. PRESIDENT.

SO WE DON'T FORGET, I WOULD LIKE TO OFFER A COMMITTEE, OR RATHER A FLOOR AMENDMENT, THIS IS IN YOUR SYSTEM, PROPOSED TREE CANOPY FOR AMENDMENT BY SUBSTITUTION, 113017 THAT I'VE MADE AVAILABLE TO EVERYONE.

PRESIDENT YATES: PROPERLY MOVED.

DO WE HAVE A SECOND? PROPERLY MOVED AND SECONDED.

ANY DISCUSSION ON THE AMENDMENT? COUNCILMEMBER HOLLANDER, THE FLOOR IS STILL YOURS.

COUNCIL MEMBER HOLLANDER: PERHAPS WE WANT TO ADOPT THAT SO WE COULD HAVE THAT ON THE FLOOR AND I WILL TALK ABOUT IT.

PRESIDENT YATES: ALL THOSE IN FAVOR RESPOND BY SAYING AYE.

THE AYE'S HAVE IT.

>> THANK YOU, PRESIDENT YATES.

WE HAVE BEEN DISCUSSING, AS YOU KNOW, A TREE CANOPY AMENDMENT ORDINANCE FOR A YEAR NOW.

WHICH SEEMS LIKE A VERY LONG TIME.

BUT I WILL SAY IT'S BEEN DISCUSSED FOR DECADES.

WE ARE ONE OF THE FEW CITIES THAT DOESN'T HAVE A PUBLIC TREE ORDINANCE.

WE DO HAVE PUBLIC TREE RULES AND WE ARE CLARIFYING THEM IN THIS PROPOSAL.

IN WAYS I THINK ADD COMMON SENSE.

FOR EXAMPLE, THE ORDINANCE ON THE BOOKS SAYS TREES IN THE PUBLIC RIGHTS OF WAY CANNOT BE TRIMMED WITHOUT A PERMIT.

WHICH SIMPLY DOESN'T MAKE MUCH SENSE.

SO WE ARE NOW SAYING THAT TREES CAN BE SUBJECT TO ROUTINE PRUNING WITHOUT A PERMIT.

WE ARE JOINING OTHER CITIES IN KENTUCKY.

WE HAVE HAD MANY, MANY MEETINGS SINCE COUNCILWOMAN HAMILTON AND I INTRODUCED THIS BACK IN DECEMBER.

WE KNEW WE WANTED TO HAVE A LONG DISCUSSION.

WE HAD MEETINGS IN VARIOUS METRO COUNCIL DISTRICTS.

WE HAVE HAD MANY SUGGESTIONS AND MADE MANY, MANY CHANGES, INCLUDING AT THE COMMITTEE MEETING AND ALSO LATE LAST EVENING AT THE SUGGESTION OF COUNCILMEMBER DENTON AND I APPRECIATE ALL OF THOSE COMMENTS.

I WILL JUST POINT OUT A COUPLE DISCUSSED AT THE COMMITTEE MEETING.

THERE'S POTENTIAL FEES.

THAT COULD BE IMPOSED BY THE DIVISION OF FORESTRY, COUNCILMEMBER STUCKEL AND DENTON WANTED THOSE TO COME BACK FOR APPROVAL AND THAT'S BEEN ADDED TO THE DRAFT BEFORE YOU NOW, THE SUBSTITUTE.

I THINK WHAT WE HAVE HERE IS AN ORDINANCE THAT WILL HELP FOCUS ATTENTION ON THE ISSUE OF OUR DECLINING TREE CANOPY WHICH IS A HEALTH ISSUE FOR OUR COMMUNITY.

IT WILL PROTECT THE TREES WE HAVE AND PREVENT FURTHER LOSSES.

TREES REALLY ARE IMPORTANT TO OUR HEALTH AND QUALITY OF LIFE, HAVING SAID THAT, WE WILL TAKE SHELDON SHAFER'S ADVICE AND SHUT UP AND ASK FOR YOUR VOTE.

PRESIDENT YATES: THANK YOU.

COUNCILWOMAN BRYANT HAMILTON?

COUNCIL MEMBER BRYANT HAMILTON: THANK YOU, MR. PRESIDENT.

I WANT TO THANK COUNCILMAN HOLLANDER FOR HIS DILIGENCE AND SUPPORT ON THIS ENDEAVOR OVER THE PAST YEAR.

MY COMMUNITY WAS CONCERNED ALSO ABOUT THE LOSS OF THE TREE CANOPY.

BUT THERE WAS CONCERN ABOUT THE COST OF HAVING TO REPLACE TREES.

THIS FILLS THE TREES IN THE PUBLIC RIGHT AWAY AND I THINK BY ESTABLISHING THIS ESCROW FUND WILL HELP RESIDENTS WHO DON'T HAVE THE MEANS TO TAKE TREES DOWN AND TO REPLACE THEM.

> I'M ASKING FOR YOUR SUPPORT AS WELL. PRESIDENT YATES: THANK YOU. COUNCILMEMBER WOOLRIDGE?

COUNICL MEMBER WOOLRIDGE: THANK YOU, MR. PRESIDENT.

FIRST OF ALL I WON'T BE VOTING IN THE AFFIRMATIVE ON THIS PARTICULAR TREE CANOPY.

AND MY REASONS BEING, ON THE PUBLIC RIGHT OF WAY, WE CONTINUE TO PUSH SIDEWALKS UP AT THE TREE ROOTS AND IT'S COSTING A FORTUNE.

THE OTHER PART, I DON'T QUITE UNDERSTAND ABOUT THE TRIMMING OF THE TREES AND WHO IS RESPONSIBLE FOR THIS.

AND IF CONSTITUENTS ARE RESPONSIBLE FOR THIS TREE TRIMMING ON THE RIGHT OF WAY AND MAINTENANCE, THAT IS A PROBLEM THAT I CERTAINLY SEE WITH THIS PARTICULAR ORDINANCE, SO I WILL NOT BE VOTING IN THE AFFIRMATIVE ON THIS ORDINANCE.

AND I DO APPRECIATE EVERYBODY'S HARD WORK ON IT, BUT I WON'T BE VOTING IN FAVOR.

THANK YOU.

PRESIDENT YATES: THANK YOU, COUNCILWOMAN.

I WANT TO MAKE SURE THERE'S A CLARIFICATION, IN THE EVENT A TREE IS REMOVED FROM THE RIGHT OF WAY, THAT IT CAN BE REPLACED ON THE OWNER'S PROPERTY SO IT DOESN'T HAVE TO BE BACK IN THE RIGHT OF WAY.

IS THAT CORRECT?

>> THAT'S CORRECT.

PRESIDENT YATES: COUNCILMEMBER COAN.

COUNCIL MEMBE COAN: I WANT TO THANK COUNCILMEMBER HOLLANDER AND BRYANT HAMILTON AND THE MANY CITIZENS WHO SPENT A LOT OF TIME AND EFFORT GETTING US TO THE POINT WHERE WE HAVE THIS ORDINANCE BEFORE US.

I THINK THAT MANY PEOPLE IN OUR COMMUNITY, AND ON THIS COUNCIL HAVE LEARNED AND HEARD OVER AND OVER AGAIN THAT TREES ARE SORT OF THE ULTIMATE NATURAL INFRASTRUCTURE IN A RECURRING POLICY ISSUE.

WE SPEND A LOT OF TIME IN THIS COUNCIL TALKING ABOUT AIR POLLUTION IN CERTAIN PARTS OF TOWN AND I ALWAYS THINK ABOUT TREES WORKING TO CONTRIBUTE SOAK UP SOME OF THAT NASTY STUFF WHEN TECHNOLOGY CAN'T DO THAT AT THE CURRENT MOMENT.

WE ARE GETTING READY TO TALK ABOUT A BIG STORM WATER MANAGEMENT PROBLEM AND I THINK HOW TREES COULD HELP ABSORB AND DEAL WITH SOME OF THAT.

I DON'T NEED ANY CONVINCING THAT TREES ARE GOOD.

I'M HAPPY TO HEAR A LOT OF OUR COLLEAGUES TALK ABOUT THIS BEING AN IMPORTANT FIRST STEP BUT NOT THE LAST STEP.

I SUPPORT THIS WHOLEHEARTEDLY.

IF THE SPONSORS WOULD ALLOW ME TO, I WOULD LOVE TO CO-SPONSOR IT.

GIVE MY SUPPORT, PEOPLE I REPRESENT FOR EVERYBODY ELSE IN THE COMMUNITY.

PRESIDENT YATES: WITHOUT OBJECTION.
>> THANK YOU.
PRESIDENT YATES: COUNCILMEMBER DENTON?
COUNCIL MEMBER DENTON: THANK YOU, MR. PRESIDENT.

I WAS A NO-VOTE.

AND CHERI SAID I HAVE A HARD TIME UNDERSTANDING SOMETIMES WHERE YOU ARE.

I AM A PERSON, I LIKE FREEDOM, UNTIL THIS COMES UP I DIDN'T KNOW WE HAD A PROBLEM WITH A CANOPY.

WHEN I WAS A KID THEY PUT SEWERS IN OUR FRONT YARD, IT WAS CALLED SOMETHING SEWER COMPANY, LOUISVILLE SEWER.

THEY CAME AND CLEAR GUTTED THE WHOLE STREET EVERYTHING IN THE RIGHT OF WAY, AND IT LOOKED LIKE A WAR ZONE.

ONE OF THE TREES IN THE MIDDLE OF THE STREET A COTTONWOOD IT MUST HAVE BEEN 3-4 FOOT IN DIAMETER, IT SHADED EVERYTHING AND IT LOOKED TERRIBLE.

AFTER THEY GOT DONE, THEY DIDN'T PUT SOD, MY DAD STRAIGHTENED UP.

WE WENT TO MITCHELL HILL ROAD AND DUG UP A COUPLE WALNUT TREES AND PLANTED THEM.

MY DAD SAID, WE MARKED THE TREE, HE SAID YOU HAVE TO WORRY ABOUT THE [INAUDIBLE] MAKE SURE YOU PUT IT IN THE SAME POSITION SO THE LINE STAYS THE SAME.

I LEARNED A LOT OF THINGS.

MY DAD SAID THE ROOTS GO DOWN AND THEY DON'T BUST UP THE SIDEWALK AND IT'S NOT SUCH A DENSE TREE, SUNLIGHT GOES THROUGH AND GRASS GROWS AROUND THE TRUNK.

AFTER THAT ALL THE NEIGHBORS SAID, GUNNER, THAT'S MY DAD'S NAME, CAN YOU GET ANY MORE TREES.

WE WENT TO MITCHELL HILL AND WE DUG, I DON'T KNOW HOW MUCH I DID, WE DUG UP A WHOLE BUNCH OF TREES, POPLARS.

BUT WE PLANTED A BUNCH OF WALNUT TREES, THAT'S ABOUT 60 YEARS AGO.

WE PLANTED A BUNCH.

KNOWING TODAY, MY DAD PROBABLY WOULDN'T PLANT ANYTHING.

I PROBABLY PLANT MORE TREES, I HAVE PROBABLY CUT DOWN MORE TREES THAN ANYBODY HERE, I PLANT THEM ALL THE TIME.

M.S.D. CAME TO MY FRONT YARD, MY PROPERTY AND CUT OVER 200 TREES.

100 WERE SIX INCHES OR BIGGER.

24 OVER TWO FOOT IN DIAMETER.

YOU ARE TALKING ABOUT DEVASTATION, YOU LOOK AT MY PROPERTY.

THEY DECIDED, PROBABLY DID THE BEST THEY COULD.

BUT ANYWAY, THEY NEVER ASKED TO PLANT ANY MORE TREES.

I'M THE ONE PLANTING THE TREES.

THOUGH 30 SOME YEARS AGO I PLANTED WALNUT TREES ON MY DRIVEWAY. ME AND MY WIFE, MY DECEASED WIFE.

AND WHEN THEY CAME THROUGH, AS SON AS THEY CUT ABOUT 12 OUT, WHICH BOTHERED ME, IT DIDN'T MEAN ANYTHING TO THEM, THEY WERE JUST TREES.

MY WIFE AND I PLANTED THOSE TREES.

I GOT ONE ON THE CORNER OF MY DRIVEWAY, IT'S A WALNUT TREE, TELL YOU HOW STUPID I AM, I PLANTED UNDER THE ELECTRICAL LINE, AND I THINK EIGHT YEARS, THEY CUT IT OUT.

AND EVERYBODY KNOWS WHEN YOU TOP A TREE IT'S JUST A MATTER OF TIME IT'S DYING.

WHEN M.S.D. CAME, THEY DEBARKED IT ON PART OF IT. THEY SAID, YOU WANT US TO CUT IT DOWN? I SAID NO. I'LL TAKE CARE OF IT. THEY SAID OKAY, IT MIGHT DIE. I SAID I WILL TAKE CARE OF IT. WELL, IT'S NOT DEAD YET.

BUT I DON'T KNOW THIS WEEKEND, I'M NOT REALLY GOING DOWNTOWN TO ASK PERMISSION TO CUT THAT TREE DOWN, AND I DON'T LIKE TO BE AGAINST THE LAW.

BUT THAT KIND OF BOTHERS ME.

SEE, IN MY DISTRICT WE DON'T HAVE ANY TROUBLE WITH, I DON'T THINK, WITH TREES.

BECAUSE IF WE DID, I WOULD SAY WE NEED TO PLANT SOME TREES, LET'S GO.

THAT'S ONE OF THE THINGS IN THIS ORDINANCE, HEY, THERE'S A NEED, LET'S DO IT.

AND GET PEOPLE OUT.

THERE'S PEOPLE ON OUR STREET ON HOME VIEW DRIVE THAT KNOW HOW TO PLANT A TREE, I DIDN'T KNOW WHAT OLD MAPLE WAS.

WE PLANTED PROBABLY 15 TREES IN THAT YARD.

BUT TO BE PUNISHED OR THINK SOMEBODY WILL GO AFTER YOU.

I KNOW EVERYBODY IS THINKING GOVERNMENT WOULD NEVER DO THAT, THEY WOULD NEVER GO AFTER ANYBODY.

I PROMISE YOU, THERE IS SOME PEOPLE WHO WILL GO AFTER YOU.

SINCE I'VE BEEN ON COUNCIL I'VE HAD AN AGENCY GO AFTER ME, BUT THEY WON'T GO AFTER ME AS A COUNCILMAN, THEY ARE NICE, BUT AS AN

INDIVIDUAL CITIZEN, I THINK THEIR METHODS OF DEALING WITH US IS A LITTLE BIT WRONG.

WE GOT TO HAVE GOVERNMENT.

AND HOW MUCH, AND HOW MUCH CONTROL.

I WOULD REALLY LIKE TO, IF THERE'S A PROBLEM, I WISH WE COULD DEAL WITH IT.

THAT'S WHY I APPRECIATE, BILL, YOU WORKING HARD.

I LOVE WATCHING PEOPLE WORK HARD.

WITH THE CAUSE AND TRY TO DO THINGS BETTER.

IT'S POSITIVE.

I JUST DON'T AGREE.

THAT'S WHY I'M VOTING NO.

PRESIDENT YATES: THANK YOU.

COUNCILMEMBER [INAUDIBLE].

>> THANK YOU, MR. PRESIDENT.

I REALIZE WE HAVE BEEN WORKING ON THIS ORDINANCE ALMOST A YEAR AND WE READ MANY DRAFTS AND I KNOW IT'S BEEN WATERED DOWN TO MAKE IT MORE AMENABLE TO GET VOTES PASSED.

HOWEVER, I GUESS, I WILL JUST NAME A FEW OF MY CONCERNS IS ONE, I DON'T THINK IT WILL BE ENFORCEABLE.

AND TWO, I THINK IT WILL STILL BE CONFUSING FOR THE PUBLIC.

AND I UNDERSTAND THIS GOAL OF THIS ORDINANCE IS TO SAVE TREES.

BUT MY CONCERN IS THAT I'M AFRAID IT WILL DISCOURAGE THE PUBLIC FROM PLANTING TREES.

THERE'S FUNDS IN THIS ORDINANCE AND THEY STILL GO UP TO \$10,000, WHICH I FEEL LIKE IS PRETTY PUNITIVE. I DON'T LIKE THE FINES.

I THINK IT WILL DISCOURAGE THE PUBLIC.

WHILE WE MAY BE SAVING TREES, WE MAY BE DISCOURAGING THE PLANTING OF TREES.

I GUESS THOSE ARE MY CONCERNS. SO I WILL BE A NO-VOTE AS WELL. THANK YOU.

PRESIDENT YATES: COUNCILMEMBER PEDEN?

COUNCIL MEMBER PEDEN: THANK YOU.

I HAVE SOME ISSUES.

I WOULD LIKE TO MAKE AN AMENDMENT IN THE VEIN, I APPRECIATE THE PERMITTING PROCESS HAS BECOME FREE.

THE ONE LINE I DIDN'T SEE AND I'M TAKING THIS FROM OUR TIME WITH THE AIRBNB ORDINANCE TO GIVE THE DIVISION OF FORESTRY A 6-MONTH WINDOW TO CREATE AN ONLINE PROCESS FOR PERMITTING APPLICATIONS, JUST LIKE WE HAVE DONE WITH AIRBNB.

WHICH MEANS, THEORETICALLY, IF YOU WANT TO OBEY THE LAW AND GET YOUR PERMIT FOR FREE, YOU REALLY DON'T HAVE TO LEAVE THE HOUSE. ALSO I THINK IT'S A WAY OF KICKING LOUISVILLE KICKING AND SCREAMING.

DIVISION OF FORESTRY, GETS A WINDOW FOR AN ONLINE PROCESS FOR APPLYING FOR TREE PERMITS.

>> SECOND.

PRESIDENT YATES: THAT IS A MOTION, IS THERE ANY DISCUSSION ON COUNCILMEMBER PEDEN'S MOTION? ALL IN FAVOR RESPOND BY SAYING AYE.

>> AYE.

PRESIDENT YATES: SORRY, THERE IS DISCUSSION ON THAT MOTION.

>> I DO NOT THINK YOU NEED TO COME DOWNTOWN.

YOU CURRENTLY NEED A PERMIT.

>> I UNDERSTAND.

>> BUT I DON'T THINK YOU HAVE TO COME DOWNTOWN NOW.

I THINK YOU CAN CALL THE OFFICE, TELL THEM THERE'S A TREE.

I DON'T KNOW, IF WE CAN NOTE SOMEONE NODDING, BUT THE FORESTRY IS NODDING.

IF YOU GIVE AN ADDRESS AND SAY I THINK THIS TREE IS DECLINING, YOU HAVE TO COME OUT AND LOOK AT THE TREE AND THEN THEY WILL WRITE A LETTER SAYING YES, YOUR TREE WILL DIE WITHIN A YEAR, SO YOU CAN TAKE IT DOWN.

TO THE EXTENT THIS IS DESIGNED TO KEEP PEOPLE FROM COMING DOWNTOWN, I DON'T THINK THAT'S NECESSARY.

BUT YOU KNOW, IF WE FIND A SPOT WE CAN PUT THIS, I HAVE NO PROBLEM IN COMING UP WITH SOME KIND OF ONLINE FORUM.

PRESIDENT YATES: COUNCILMEMBER PEDEN, DO YOU HAVE A RESPONSE TO THAT?

COUNCIL MEMBER PEDEN: I WOULD REALLY, WHETHER IT'S THIS ORDINANCE OR A LOT OF OUR OTHER PROCESSES, I TRULY BELIEVE WE NEED TO GET TO WHERE, I MEAN, MILLENNIALS DON'T KNOW HOW TO NOT USE THEIR PHONE. PRESIDENT YATES: HOPEFULLY I.T. INCREASES TO INCORPORATE THAT.

COUNCILMEMBER JAMES?

COUNCIL MEMBER JAMES: THANK YOU, MR. PRESIDENT.

I WANT TO SAY TO THE SPONSORS, I'M HAPPY FOR THE WORK YOU ALL HAVE DONE ON THIS, IT'S GOOD FOR OUR COMMUNITY.

I WOULD BE HUMBLED IF YOU ALLOW ME TO BE ONE OF THE SPONSORS.

>> NO.

NO, I'M JUST KIDDING.

PRESIDENT YATES: WITHOUT OBJECTION, COUNCILMEMBER PARKER?

COUNCIL MEMBER PARKER: I FORGOT TO ADD A COMMENT I WANTED TO MAKE AS WELL.

OVER THE DISCUSSION OF THIS ORDINANCE, IF YOU GUYS REMEMBER, I THINK WITH THE PASSAGE OF THIS ORDINANCE, AND I WANT TO MAKE THIS STATEMENT AS WELL, I LOVE THE IDEA OF AN ADVISE -- ADVISORY COMMITTEE.

I DON'T LIKE THE REGULATIONS AND THE FINES IN THIS ORDINANCE.

BUT IF THE REMEMBER THE ARBORIST CAME TO US AND SAID, I CAN'T REMEMBER THE EXACT NUMBER BUT WE WILL NEED SIX MORE POSITIONS OF ARBORISTS.

AND THE SALARY IS GOING TO BE AROUND \$50,000.

SO JUST KEEP THAT IN MIND, THAT MIGHT COME BACK TO US WITH THIS ORDINANCE, AS FAR AS ADDING MORE POSITIONS WITH BENEFITS AND PENSIONS AND SO THAT'S ALWAYS SOMETHING FOR US TO THINK ABOUT AS FAR AS OUR BUDGET PROCESS AS WELL.

THANK YOU.

PRESIDENT YATES: I WANT TO REMIND YOU, WE HAVE A MOTION BEFORE US.

UNLESS HE IS WITHDRAWING, I BELIEVE IT'S STILL ON THE FLOOR. COUNCILMEMBER BARBARA SEXTON SMITH.

COUNCIL MEMBER SEXTON SMITH: THANK YOU, I WAS JUST GOING TO EXPLAIN MY VOTE, OR DO YOU WANT ME TO WAIT?

PRESIDENT YATES: ON COUNCILMEMBER PEDEN'S AMENDMENT.

>> NO, I WILL WAIT.

>> POINT OF ORDER, DIDN'T WE ALREADY VOTE ON THAT AMENDMENT.

PRESIDENT YATES: NO, WE BEGAN TO, THERE WAS AN OBJECTION AND

THEN WE BEGAN DISCUSSION.

COUNCILMEMBER PEDEN IS NEXT IN THE QUEUE, AND THEN COUNCILMEMBER HOLLANDER.

COUNCIL MEMBER PEDEN: IF YOU WANT TO PROCEED WITH THE VOTE ON THE ONLINE THING.

I ACTUALLY WAS GOING TO TALK ON SOMETHING ELSE AS WELL.

>> WE ARE TRYING TO JUST DRAFT SOME LANGUAGE TO ADDRESS THAT

ISSUE.

>> THE LANGUAGE WASN'T, I WASN'T LANGUAGE SPECIFIC.

I SUPPORT THE PRINCIPLE OF CREATING AN ONLINE APPLICATION.

AND CAN GO IN THERE ANY WHERE YOU WANT IT.

>> OKAY.

PRESIDENT YATES: COUNCILMEMBER HOLLANDER, TO GIVE YOU TIME DO YOU WANT ME TO GO TO COUNCILWOMAN BARBARA SEXTON SMITH? I CAN TALK TO.

COUNCILMEMBER PEDEN.

COUNCIL MEMBER PEDEN: YOU ARE GOING TO VAMP FOR A WHILE UNTIL THEY GET THAT DONE.

THIS IS NOT A SECRET TO THE MAIN WORKER ON THIS BILL, COUNCILMAN HOLLANDER.

I WASN'T A FAN. STILL NOT A BIG FAN, A LITTLE BIT OF REASONS FOR STEWART -- A LOT OF THE REASONS COUNCILMEMBER BENTON MENTIONED IN A LOT FEWER WORDS.

PROPERTY RIGHTS ISSUES ETC. BUT I THINK THE SINGLE BIGGEST THING THAT BUGS ME AND THE LAST TIME I TALKED WITH COUNCILMEMBER HOLLANDER ABOUT THIS IS THE GRAND OPENING OF THE SOUTHEAST LIBRARY.

WE SPENT THE FIRST 20 MINUTES TALKING ABOUT HOW WONDERFULLY THAT NEW LIBRARY WAS BUILT AND DESIGNED AND THE TREES THAT WERE ON THE LOT WERE MAINTAINED AND THE PARKING LOT AND THE SIDEWALKS WERE ALL BUILT AROUND IT.

AND THEN I WALK COUNCILMEMBER HOLLANDER OVER TO THIS GIANT PICTURE WINDOW THAT OVER LOOKED A SKINNED FIELD WHERE THEY BUTCHERED AN ENTIRE FOREST AND LEFT IT THERE, BECAUSE AT SOME POINT THEY WERE GOING TO DEVELOP SOMETHING AND THEY CLEAR CUT PROBABLY 200 TREES ON 100 ACRES AND THEY STILL HAVEN'T BUILT ANYTHING.

SO I GUESS DEEP DOWN INSIDE, ALTHOUGH I WILL VOTE YES, BECAUSE EVERYBODY WORKED HARD TO COMPROMISE ON THAT BETWEEN COUNCILWOMAN DENTON AND HOLLANDER, IF THOSE TWO CAN AGREE, YOU KNOW, THAT DESERVES SOME RESPECT.

BUT I STILL HAVE A GIANT, SOMETHING STUCK IN MY CRAW WHEN I'M MAKING OLD LADIES HAVE TO PAY TO HAVE TREES REMOVED AND TREES REPLACED AND I'M LETTING OUT OF TOWN COMPANIES COME AND CLEAR CUT HUNDREDS OF ACRES AT A TIME AND THEN ALLOWING THEM TO PUT IN ABOUT FOUR INCHES PINE TREES THAT MAY OR MAY NOT LIVE BECAUSE WE REALLY DON'T MAKE THEM TAKE CARE OF IT.

TO ME THAT'S WRONG, OR AT LEAST HYPOCRITICAL.

THE OTHER PIECE OF THIS, I DIDN'T KNOW IT WAS COMING UNTIL I SAW IT IN THE PAPER BECAUSE I THOUGHT WE WERE JUST BATTING IT IN COMMITTEE.

UTILITIES WE HAVE GIVEN THEM A LOT OF WALKS.

THE ONE THING I WISH WE WEREN'T GIVING THEM A WALK ON IS AESTHETICKS.

ANYONE WHO SPENT 15 MINUTES ON THIS COUNCIL HAS RECEIVED A CALL FROM A CONSTITUENT TELLING YOU L.G. AND E. BUTCHERED A TREE IN MY FRONT YARD.

WE ARE TALKING ABOUT RIGHT OF WAY TREES TO ADD SOMETHING IN THERE TO SAY IF YOU CUT 9/10 OF A TREE OUT OF THE WIRES, TAKE THE TREE.

OR AT LEAST MAKE IT LOOK LIKE IT'S STILL A TREE.

THOSE KIND OF THINGS.

WE AREN'T TAKING ADVANTAGE OF THAT AT ALL WITH THIS.

SO AGAIN, I'M A YES-VOTE BECAUSE, BUT I STILL THINK, EVEN INDIVIDUALLY WITH THIS IT'S FAR FROM BEFORE PERFECT.

SO THANK YOU.

PRESIDENT YATES: THANK YOU, COUNCILMEMBER PEDEN, I THINK IT'S BEEN ECHOED SEVERAL PEOPLE THINK THERE COULD POTENTIALLY BE ADDITIONAL WORK IN THE FUTURE.

COUNCILMEMBER HOLLANDER?

COUNCIL MEMBER HOLLANDER: THANK YOU, MR. PRESIDENT, I WILL RESPOND BRIEFLY TO COUNCILMEMBER PEDEN, I COULDN'T AGREE MORE.

I THINK THE LAND DEVELOPMENT CODE NEEDS WORK.

AND I THINK THAT'S A BIPARTISAN VIEW ON THIS COUNCIL.

AND I HOPE WE MOVE FORWARD WITH THAT.

WE HAVE TALKED ABOUT, THAT WAS SORT OF PUT OFF WHILE WE LOOKED AT THE URBAN TREE CANOPY ASSESSMENT AND THAT WAS DONE IN 2015, THEN IT WAS PUT OFF BECAUSE WE HAVE A NEW COMPREHENSIVE PLAN AND I THINK IT'S TIME TO MOVE ON WITH THAT.

AND I THINK THERE'S A REAL CONSENSUS AMONG A LOT OF PEOPLE ON BOTH SIDES OF THE AISLE THAT'S SOMETHING WE OUGHT TO BE LOOKING AT.

AND I HOPE, IF WE CAN MOVE FORWARD TONIGHT, I HOPE TO WORK ON THAT VERY SOON.

I WILL SAY, IF THIS COULD MAYBE BE A FRIENDLY AMENDMENT AS TO WHERE TO PUT THIS.

IT'S BEEN SUGGESTED WE MAKE IN SECTION 12, A NEW -- ACTUALLY A NEW SECTION, ROMAN NUMERAL III, ABOVE ROMAN NUMERAL IV THAT WOULD READ WITHIN SIX MONTHS OF THE PASSAGE OF THIS ORDINANCE THE DIVISION SHALL CAUSE PERMIT APPLICATIONS TO BE MADE OBTAINABLE ONLINE.

>> PERFECT, WORKS FOR ME.

>> CALL THE QUESTION?

>> SECOND.

PRESIDENT YATES: ALL IN FAVOR RESPOND BY SAYING AYE? THAT'S A FRIENDLY AMENDMENT TO COUNCILMEMBER PEDEN'S ORIGINAL AMENDMENT THAT HAD JUST BEEN PASSED AND WE ARE BACK FOR DISCUSSION ON THE ENTIRE ORDINANCE.

COUNCILMEMBER BARBARA SEXTON SMITH?

COUNCIL MEMBER SEXTON SMITH: YES, THERE PRESIDENT, I WILL VOTE YES AND I WANT TO EXPLAIN MY VOTE.

FOR ME, THIS IS A HEALTH ISSUE AND I BELIEVE COUNCILMEMBER BENSON MENTIONED EARLIER HE WASN'T FULLY UP TO SPEED ON ALL THE INFORMATION.

I HAVE ONE FACT I WOULD LIKE TO SHARE, THERE WAS A REPORT RECENTLY THAT SAID WE LOSE 54,000 TREES A YEAR IN JEFFERSON COUNTY, THAT'S ALMOST UNIMAGINABLE.

SO FOR ME WHEN YOU TAKE THAT MANY TREES OUT OF THE ENVIRONMENT THAT DOES PRODUCE A SERIOUS HEALTH THREAT.

THIS ORDINANCE, I VALUE AND APPRECIATE THE AMOUNT OF WORK AND THOUGHT THAT'S GONE INTO THIS.

THIS ISN'T GOING TO SOLVE ALL OF OUR PROBLEMS AND CHALLENGES BUT IT'S A GREAT STEP IN THE RIGHT DIRECTION.

AND I TOO, WILL ALSO WANT TO WORK ON AND FULLY SUPPORT LOOKING AT THE LAND DEVELOPMENT, BECAUSE I THINK THAT IS A VERY SERIOUS ISSUE THAT WE HAVE AS WELL.

ONE LAST THING, MR. PRESIDENT, I DIDN'T HAVE MY WORD COUNTER ON BUT WHEN COUNCILMEMBER PEDEN MENTIONED HE WOULD MAKE A COMMENT AND USE FEWER WORDS THAN COUNCILMEMBER DENTON, IT'S A TOSS-UP.

SO THANK YOU, MR. PRESIDENT AND I WOULD LIKE TO BE ADDED AS A SPONSOR IF COUNCILMEMBER CHERI BRYANT HAMILTON AND COUNCILMAN BILL HOLLANDER WILL ACCEPT ME AS A SPONSOR.

>> GLADLY.

PRESIDENT YATES: WITHOUT OBJECTION, ADDED AS A SPONSOR.

COUNCILMEMBER BENSON.

COUNCIL MEMBER BENSON: SORRY, I DON'T KNOW ABOUT SAYING QUICK, BUT WHEN THEY TALK ABOUT 54,000 TREES, I THINK, WHEN I TAUGHT SCHOOL IT WAS EASIER TO GET PEOPLE TO DO SOMETHING WHEN I SAID WOULD YOU HELP ME.

AND TO ME, YOU DAVID, OR THE MAYOR, A COUPLE WEEKS BEFORE ARBOR DAY SAY, WE ARE MAKING A PUSH.

YOU DON'T HAVE TO HAVE A PERMIT.

WE WILL PLANT TREES.

WE WILL GIVE YOU THE TREES.

BUT IF YOU CAN'T PLANT THEM, WE ARE GOING TO HELP YOU OUT.

AND YOU START WORKING ON GOING ON THE CANOPY.

COUNCILMEMBER PEDEN IS TALKING ABOUT SOMEONE CLEAR-CUTTING A FOREST.

MY DAD CAME FROM IOWA AND HE PULLED A LOT OF TREES OUT, ROOTS, BECAUSE THEY FARMED.

AND YOU KNOW, THEY CUT ALL THE TREES DOWN SO THEY CAN FARM, IF YOU GO TO IOWA AND LOOK AROUND, THERE'S NOT A LOT OF TREES, BECAUSE THEY FARM.

WHEN SOMEBODY CUTS DOWN TREES, IF YOU KNOW WHY THEY ARE CUTTING THE TREES DOWN, OR ARE THEY GROWING HAPHAZARD, ARE THEY REALLY WORTH ANYTHING? I REALLY HAVE A LOT OF PROBLEMS, TO ME, A LITTLE BIT, THAT A PERSON OWNS SOME PROPERTY, SOMEHOW OR ANOTHER, THEY HAVE SOME RIGHTS.

I MEAN THE CONSTITUTION SAYS A LOT OF THINGS ABOUT WE PROPERTY OWNERS.

WHAT RIGHT NOW, WE ARE WORKING IN THE FLOYD FORK AREA AND WE WERE LOOKING FOR SOME VOLUNTEERS TO BE ON A COMMITTEE.

WE GOT MORE PEOPLE THAN WE COULD EVER HOPE.

WE HAD A MEETING AT THE FOUNDATION HAD 120 PEOPLE COME OUT.

WE ARE WORKING ON HOW TO HELP OUT.

AND HELP PEOPLE UNDERSTAND THEIR PROPERTY AND HOW WE COULD MAKE SURE THAT WE KEEP THE FLOYD FORK AREA NICE AND RULE BUT WE STILL HAVE TO DEVELOP SOME STUFF.

SO WE ARE WORKING AS A TEAM.

AND SOMETIMES I THINK WHEN WE SAY, WELL, YOU DO THIS, SOME PEOPLE NEED TO BE REGULATED BECAUSE THEY JUST AREN'T GOING TO DO THE RIGHT THING.

THEY AREN'T WITH ME.

MOST PEOPLE I KNOW, THEY WILL TRY TO DO THE RIGHT THING. I MEAN, SO I JUST, HAVE A LOT OF PROBLEMS WITH REGULATIONS. TELL ME WHEN TO GO TO BED, WHEN TO GET UP AND WHAT TO EAT.

A COUPLE YEARS AGO WE TRIED TO TELL PEOPLE WE CAN'T EAT TRANSFATS, WE WILL GO IN EVERYBODY'S HOUSE AND SEE WHAT THEY ARE EATING? NO, I THINK IT'S BETTER TO TEACH THEM.

YEARS AGO, SOUTHERN HIGH SCHOOL THE PRINCIPAL MADE AN ANNOUNCEMENT OVER THE LOUD SPEAKER SAY NO STUDENT OPEN ANY WINDOWS, ONLY THE TEACHER.

> I TURNED TO MY COLLEAGUE AND I SAID I THOUGHT THIS WAS A SCHOOL. SOMEHOW OR ANOTHER WOULDN'T IT BE GOOD IF THE TEACHER SAID,

STUDENTS, LET ME SHOW YOU HOW TO OPEN THE WINDOW.

THAT WOULD BE BETTER.

BUT NO, NO, WE ALWAYS HAVE TO REGULATE, WE ARE GOING TO GET YOU. I JUST HAVE A LOT OF TROUBLE WITH REGULATIONS, SORRY.

PRESIDENT YATES: COUNCILMEMBER FOWLER?

COUNCIL MEMBER FOWLER: THANK YOU, MR. PRESIDENT, STEWART, I THINK THAT WAS TO KEEP THEM FROM JUMPING OUT OF THE WINDOW.

IT MIGHT HAVE BEEN, I DON'T KNOW.

I JUST WANT TO ECHO WHAT COUNCILMAN PEDEN SAID ABOUT THE CLEAR CUTTING.

I HATE TO SEE THAT THEY WILL CLEAR CUT AND THEY DON'T EVEN HAVE A DEVELOPMENT PLAN, THERE'S NO IDEA WHAT THEY WILL DO BUT THEY WILL JUST, YOU KNOW, CUT DOWN 50 TREES.

AND IF WE ARE LOSING 54,000 TREES A YEAR, I PROMISE YOU, MOST OF THAT IS COMING FROM THE CLEAR CUTTING BECAUSE I DON'T THINK WE LOSE THAT MANY PERCENTAGE WISE FROM DISEASE OR JUST DYING TREES.

I WOULD LIKE TO BE A SPONSOR, IF I'M NOT ALREADY.

I APPRECIATE THE WORK THAT YOU HAVE DONE ON THIS, COUNCILMAN HOLLANDER AND COUNCILWOMAN BRYANT HAMILTON, THANK YOU.

PRESIDENT YATES: THANK YOU, COUNCILWOMAN.

WITHOUT OBJECTION, COUNCILMEMBER FOWLER WILL ALSO BE ADDED AS SPONSOR.

COUNCILMEMBER BRENT ACKERSON?

COUNCIL MEMBER ACKERSON: THANK YOU, MR. PRESIDENT.

I WILL BE A YES-VOTE, I TOO APPRECIATE THE WORK THAT'S GONE INTO THIS BUT I DON'T THINK THE COUNCIL SHOULD GO INTO THE COMMUNITY AND BE TOO PROUD OF THIS AT THE MOMENT.

WE RECOGNIZED TODAY, WE TALKED ABOUT THE CLEARING OF TREES AND I HEARD THE NUMBER 54,000.

ULTIMATELY IS THIS ORDINANCE GOING TO DO ANYTHING TO THAT? NO, IT'S A DROP IN THE BUCKET.

THAT'S STILL 49,000 THIS YEAR, NEXT YEAR, 49,000 THEN BECOMES 88,000 TREES LOST, OR IS THAT 98,000 TREES LOST.

THE YEAR AFTER THAT, SO UNTIL WE ARE ABLE TO REALLY, NOW THAT WE RECOGNIZE REALLY TAKE THE TIME AND SIT DOWN, THIS TOOK A YEAR.

THE NEXT ONE WILL BE EVEN HARDER.

SO THE PROCESS, IF THIS COMMUNITY WANTS TO BE PROUD OF THIS BODY ABOUT MAKING AN IMPACT, WE HAVE TO START TOMORROW.

BECAUSE IT WILL TAKE THAT LONG TO TRULY MAKE AN IMPACT ON THIS LEAKING SHIP.

I'M A YES-VOTE AND I APPRECIATE THE TIME THAT WENT INTO IT TONIGHT.

I HOPE WE WILL BE PEOPLE OF OUR WORD AND DO SOMETHING FOR THIS COMMUNITY OTHERWISE AND MAKE A REAL IMPACT ON THAT 54,000 TREES WE ARE LOSING.

THANK YOU, MR. PRESIDENT.

PRESIDENT YATES: THANK YOU, COUNCILMAN.

SEEING NO FURTHER DISCUSSION, PLEASE OPEN THE VOTING.

WITHOUT OBJECTION THE VOTING IS CLOSING AND THE VOTING IS

CLOSED.

PRESIDENT YATES: AND THE AMENDED ORDINANCE PASSES.
