THE TRUST FUND WAS ABLE TO ASSIST IN THE CREATION OF 326 UNITS OF HOUSING FOR METRO RESIDENTS.

FOLLOWING THAT SUCCESS, OUR STAFF AND ADVOCATES ATTENDED COUNCIL MEETINGS EMPHASIZING THE NEED WE HAVE IN THIS COMMUNITY.

WE CAN TELL THAT YOU WERE LISTENING.

THANKS TO YOU, METRO COUNCIL AND MAYOR FISCHER \$14.5 MILLION WAS ALLOCATED TO AFFORDABLE HOUSING FOR FISCAL YEAR 2018.

OF THAT, \$9.5 MILLION WAS GOING TO THE LOUISVILLE HOUSING TRUST FUND.

WE'RE HARD AT WORK MAKING SURE THOSE DOLLARS WILL BE SPENT PRUDENTLY AND EFFECTIVELY.

DURING THIS SUMMER GUIDELINES WERE ESTABLISHED FOR DEVELOPMENT PROJECTS INCLUDING A REVOLVING LOAN FUND TO HAVE THE MONEY RECYCLED BACK INTO THE COMMUNITY AND ADOPT A BLOCK POOL TO REVITALIZE VACANT HOUSES.

WE BEGAN TO ACCEPT APPLICATIONS IN OCTOBER.

BY NOVEMBER 10th, WE RECEIVED 22 FULL APPLICATIONS WITH REQUESTS TOTALING MORE THAN \$16 MILLION TO DATE WE COMMITTED 17.5 MILLION IN NEW PROJECTS AND ASSISTING IN THE CREATION OR PRESERVATION OF NEARLY 1,000 UNITS OF HOUSING.

WITH THAT LEVERAGING \$122 MILLION IN THE COMMUNITY FOR HOUSING DEVELOPMENT.

WE'RE ECSTATIC ABOUT THIS DEVELOPMENT.

THERE IS SO MUCH MORE THAT NEEDS TO BE DONE.

AS YOU'LL HEAR FROM CATHY, THE NEED CONTINUES TO GROW.

WE'RE ALL FACING FINANCIAL CHALLENGES.

EVERYONE DESERVES A SAFE, DECENT, FORDABLE PLACE TO LIVE.

THEY DESERVE TO BE ABLE TO MAKE THEIR OWN CHOICES ABOUT WHERE THEY LIVE.

AGAIN, PLEASE CONTINUE TO FUNNELED THE TRUST FUND FOR 2019 AND THE CITIZENS OF LOUISVILLE WILL THANK YOU FOR IT.

I AM HERE TO ASK YOU FOR HOUSING IN THE NEXT BUDGET.

MHC STANDS FOR THE PROPOSITION THAT ALL CHILDREN SHOULD LIVE IN SAFE AND STABLE HOUSING.

THAT SENIORS AND THOSE WITH A DISABILITY THAT PUT THEM ON FIXED INCOMES SHOULD HAVE STABLE, USABLE HOUSING.

THAT IF YOU WORK FULL-TIME, YOU SHOULD BE ABLE TO HAVE STABILITY AND DECENT, NOT LUXURIOUS, BUT DECENT HOUSING.

THAT EVERYONE SHOULD BE ABLE TO HAVE HOUSING CHOICES IN ALL PARTS OF JEFFERSON COUNTY.

MHC HAS PRODUCED STATE OF METROPOLITAN HOUSING REPORTS.

AND EACH ONE CONTAINS DATA TO SHOW THERE WAS NOT ENOUGH AFFORDABLE HOUSING FOR UP TO 40% OF OUR WORKERS AND THOSE ON FIXED INCOMES.

THE 2017 REPORT WHICH WAS DELIVERED TO YOU, FOCUSES RENTERS AND WHAT JUMPED OUT IS OUT OF THE 50 LARGEST METRO AREAS, LOUISVILLE HAS THE 7TH HIGHEST EVICTION RATE.

WE HAVE INCREASED RENTER HOUSING BY 10% SINCE 2010, SO THAT'S A 5.3 PERCENT EVICTION RATE.

HOW ELSE ARE WE TREATING OUR RESIDENTS IN BEING ABLE TO AFFORD HOUSING? 65% OF RENTER AND HOMEOWNER HOUSEHOLDS WITH INCOMES UNDER \$35,000 ARE COST-BURDENED BY THEIR SHELTER.

SINCE 38% OF OUR WORKFORCE EARNS A WAGE THAT IS LESS THAN \$15.25 AN HOUR, WE'RE NOT SUPPORTING OUR WORKERS, MUCH LESS THOSE ON FIXED INCOME.

WE'RE NOT TREATING OUR CHILDREN AS IF THEY ARE OUR FUTURE.

HEALTH STUDIES LINK HOUSING STABILITY WITH INCREASED WELLNESS DAYS AND BETTER HEALTH OUTCOMES.

LACK OF AFFORDABLE HOUSING JEOPARDIZES OUR WORKFORCE IN THE FUTURE.

WE HAVE WORK TO DO.

THE FULL FUNDING OF THE AFFORDABLE HOUSING TRUST FUND IS IN IMPERATIVE AND INVESTMENT IN OUR FUTURE.

YOUR WORK HAS BEEN GREAT ON ASKING FOR AFFORDABLE HOUSING CONTRIBUTION TO A NARCOTIC-RATE HOUSING DEVELOPER ASKING FOR A BOON OF SOME KIND FROM THE CITY.

BUT IT NEEDS TO BE CODIFIED WITH THE PREDICTABLE CONTINUUM FOR CONTRIBUTING TO THE AFFORDABLE HOUSING TRUST FUND AS AN OPTION.

THE TRUST FUND HAS PROVED THE CAPACITY, DEVELOPER CAPACITY AND KNOW THERE IS A FINANCIAL PAYBACK FROM BETTER HOUSING.

TOGETHER WE CAN MAKE OUR COMMUNITY MORE FAIR AND HEALTHY.

PLEASE FUND AT FORDABLE HOUSING TRUST FUND.

AND BY SHOW OF HANDS REAL QUICK, HOW MANY COUNCILMEMBERS ACTUALLY CONSIDER THE NEEDS OF THE CITIZENS? OKAY.

WITH THAT BEING SAID, FIRST, I WOULD LIKE TO START OFF, I'M A CONCERNED CITIZEN OF LOUISVILLE.

I WOULD LIKE TO DEFINE THE WORD "COMPASSION" IT'S SYMPATHETIC PITY AND CONCERN FOR THE SUFFERING AND MISFORTUNE.

WE LOUISVILLIANS GO BY THE SLOGAN OF THE "COMPASSIONATE CITY"

AFTER THE CLEARING OF THE HOMELESS CAMPS SHOWS A LACK OF COMPASSION.

WE APPROVED OVER \$30 MILLION FOR A MINOR SOCCER LEAGUE, TRACK FACILITY IN WEST LOUISVILLE, [INAUDIBLE] OMNI ON THIRD AND WE ARE CONSISTENTLY BUILDING HOTELS AND GENTRIFICATION.

BUT THIS IS ABOUT THE DOLLAR.

IF IT DOESN'T MAKE DOLLARS, IT DOESN'T MAKE SENSE.

DISPLACING THE HOMELESS DOESN'T MAKE SENSE BECAUSE THEY DON'T HAVE ANY MONEY.

AT LEAST WITH GENTRIFICATION, PEOPLE WILL BE UPROOTED AND ALLOWED TO RELOCATE, OR PAID TO MOVE.

WHY CAN'T WE FIND ADEQUATE HOUSING AND AFFORDABLE PLACEMENT FOR THE HOMELESS? I'M FOR THE PEOPLE.

NEVER FOR CORPORATIONS DOWNTOWN LOUISVILLE IS EMERGING WITH NEW BUSINESSES UP AND DOWN THE DISTRICT.

TO HAVE HOMELESS CAMPS UNTIL THIS AREA IS AN EYESORE AND DETERRENT TO ATTRACT BUSINESSES DOWNTOWN.

A BUSINESS DECISION WAS MADE BY THE MAYOR QUOTED AS SAYING HE'S A BUSINESS MAN.

IF YOU CAN'T BRING REVENUE TO THE CITY, YOU HAVE TO GO.

STREET EVICTION.

THAT'S WHAT IT IS.

LET'S NOT BE FOOLED BY THE WORD "COMPASSION." REALLY, IT'S GENEROSITY.

THE DIFFERENCE BETWEEN COMPASSION AND GENEROSITY, IS COMPASSION IS DEEP AWARENESS OF THE SUFFERING OF ANOTHER COUPLED BY THE WISH TO RELIEVE IT WHILE GENEROSITY IS UNACCOUNTABLE OF THE TRAITS BEING WILLING TO DONATE MONEY AT TIMES.

THROWING OUT MONEY INSTEAD OF CREATING TANGIBLE SOLUTIONS.

DEMOCRATS COLLECTIVELY HAVE SUCCESSFULLY MANUFACTURED AN IMAGE
OF PROTECTORS OF THE POOR AND PROTECTORS OF THE DOWNTRODDEN.

OUR COUNCIL -- WE NEED YOUR HELP, BUDDY.

>> THERE ARE THREE NATIONAL SECURITY EMERGENCIES BEING IGNORED BY OUR GOVERNMENT.

FIRST, THREE ECONOMIC POLICIES HAVE ACCELERATED DEBT WE'RE FACING, NOTE GOVERNMENT SPENDING.

TRANSFERS WEALTH TO THE RICH.

I SPOKE ON THESE POLICIES ON JULY 27TH WHEN THE DEBT WAS OVER \$19 TRILLION.

AGAIN, THESE POLICIES ARE ARTIFICIALLY LOW RATES.

WE SEE THE CAP STALL FROM THE FEDERAL RESERVE AND WITHOUT THE [INAUDIBLE] DEPOSITORS ARE NOT OPENING SAVINGS ACCOUNTS AT U.S. BANKS.

TODAY WE'RE IN THE YELLOW ZONE WITH \$20 TRILLION IN DEBT.

WE'LL SOON BE ENTERING THE RED ZONE AT \$21 TRILLION WHEN MANY BOND HOLDERS WILL STOP BUYING U.S. TREASURIES THAT THREATEN THE U.S. BUDGET.

THIS IS WHY REPUBLICAN DONORS ARE DEMANDING REFORM SO THAT ANY EXTRA REVENUE MUST BE APPLIED TO THE DEBT TO PREVENT IT.

IF WE ENTER THE RED ZONE, THESE DAMAGING POLICIES CANNOT SUSTAIN THIS UNLAWFUL TRANSFER OF WEALTH.

FENTANYL IS 100 TIMES MORE POWERFUL THAN MORPHINE.

AM I MISSING SOMETHING HERE. THIS LETHAL CANNOT BE INTENDED FOR PUSHING DRUGS BUT ONLY MEANT TO KILL PEOPLE.

CHINA IS CONSPIRING WITH MEXICO TO COMMIT MURDER IN THE U.S.

THIS LEGAL CLARIFICATION IS I GOD BY OUR AND THE FBI BECAUSE WE MUST MOVE TO TERMINATE ALL NONESSENTIAL TRADE WITH CHINA AND MEXICO.

UNDER THESE CONDITIONS, PRESIDENT TRUMP IS REQUIRED TO SUSPEND SUCH TRADE UNTIL THIS JUNK IS COMPLETELY OFF OUR STREETS.

SHE SERVES ON THE LOUISVILLE DEMOCRATIC COMMITTEE.

HER VOLUNTEER EXPERIENCE ALSO INCLUDES BIG BROTHERS AND BIG SISTERS.

AS A LICENSED SOCIAL WORKER, SHE HAS SPENT HER CAREER WORKING WITH FAMILIES TO IMPROVE CHILD SAFETY AND WELL-BEING, LOCALLY AND STATEWIDE.

HER PROFESSIONAL TRAINING INCLUDES TEAM DECISION MAKING, UNDOING RACISM, AND PUBLIC CHILD WELFARE CERTIFICATION.

IN ORDER TO DISPEL THE RUMORS AND UNTRUTH ALSO NICOLE BEING HAND-PICKED BY THE PARTY, I WANT TO SET THE RECORD STRAIGHT.

NICOLE SPOKE WITH ME FOUR YEARS AGO ABOUT RUNNING FOR THE DISTRICT 21 SEAT.

I DIDN'T KNOW HER WELL AT THAT TIME.

I TOLD HER NO DEMOCRAT ON THIS COUNCIL COULD HELP HER AT THAT TIME ACCORDING TO THE RULES.

BECAUSE THE INCUMBENT COUNCILMEMBER WAS RUNNING IN 2014. SHE DID NOT RUN.

I AM A PERSON TRUE TO MY WORD, AN LOYAL TO THOSE THAT I GIVE MY COMMITMENT.

YOU KNOW THAT ABOUT ME.

FOR THAT REASON, I AM PROUD TO NOMINATE THE MOST QUALIFIED CANDIDATE FOR THIS DISTRICT 21 COUNCIL SEAT WHICH IS NICOLE GEORGE.

I HOPE MY COLLEAGUES HERE TONIGHT WILL CHOOSE WIDELY TO PREVENT FURTHER TURMOIL IN DISTRICT 21.

MR. CLERK: AN ORDINANCE AMENDING LMCO CHAPTERS 32.840 AND 32.850 WITH RESPECT TO COMPENSATION FOR PLANNING COMMISSION AND BOARD OF ZONING ADJUSTMENT MEMBERS (AS AMENDED). READ IN FULL.

I WAS APPROACHED BY THE COUNTY ATTORNEY'S OFFICE AND BY PLANNING AND DESIGN TO MAKE A CLANG IN THE COMPENSATION FOR OUR PLANNING/ZONING COMMISSIONERS.

THEIR PAY HAS NOT BEEN CHANGED SINCE THE LATE '70S EARLY '80S.

THEY DO A LOT OF NIGHT MEETINGS LIKE THE ONE WE JUST HAD IN COUNCILWOMAN ANGELA LEET'S DISTRICT.

THAT WAS A NIGHT MEETING.

THEY HAD A LOT OF TIMES DOING THAT.

AND THE DIRECTOR THOUGHT IT WAS TIME.

IF WE KEEP QUALIFIED PEOPLE AND ATTRACT QUALIFIED PEOPLE TO THIS BOARD BECAUSE IT IS ONE OF THE HARDEST BOARDS, ESPECIALLY WITH HOMEWORK.

67 C CHANGED ON JUNE 29TH OF THIS YEAR AND WENT INTO EFFECT JULY 1ST.

SO WE ARE ABOUT FOUR, ALMOST FIVE MONTHS BEHIND.

WE ARE TRYING TO PLAY CATCH-UP.

THE CHANGES IN THE LAW DICTATE THAT DOW LAY OUT A PROCESS.

SO THE WAY THE NEW LAW WORKS, ONCE THE MAYOR'S TIME HAS EXPIRED ON AN APPOINTMENT WE WILL HAVE 30 DAYS TO MAKE AN APPOINTMENT HERE AT THE COUNCIL LEVEL.

BE THAT AS IT MAY, WE HAVE TO PUT A PROCESS IN PLACE.

WE DON'T HAVE TO LIKE IT BUT UNTIL THE GENERAL ASSEMBLY SAYS OTHERWISE, THIS IS THE LAW.

THE OTHER CHANGES, AMONG THE OTHER CHANGES THAT WERE MADE IN 67

C WERE GIVING THE GOVERNMENT OVERSIGHT AND AUDIT COMMITTEE SUBPOENA

AUTHORITY AND AN ABILITY TO SWEAR WITNESSES.

AND SO THE COMMITTEE IS ACTUALLY ESTABLISHED BY STATE LAW.

THOSE POWERS ARE ESTABLISHED BY STATE LAW.

BUT THE PROCEDURE UNDER WHICH WE WOULD EXERCISE THEM, WE HAVE TO ESTABLISH.

WHAT WE ARE TRYING TO DO HERE, AS COUNCILWOMAN GREEN SAID, 67 C CHANGES HAS BEEN IN EFFECT FOR SOME TIME.

THE PROCEDURE IS A LITTLE UNUSUAL TO DO THIS AMENDMENT ON THE FLOOR BUT WE ARE TRYING TO GET IN THIS PLACE THIS YEAR PRIOR TO OUR NEXT MEETING.

WE THANK COUNCIL MEMBERS GREEN AND PARKER FOR THE FRIENDLY AMENDMENT BY SUBSTITUTION.

SO I WOULD MOVE THAT, PLEASE.

PRESIDENT YATES: THE MOTION TO MOVE THE AMENDMENT BY SUBSTITUTION.

PROPERLY MOVED AND SECONDED BY.

ALL THOSE IN FAVOR RESPOND BY SAYING AYE.

AND I APOLOGIZE.

IT LOOKS LIKE -- IS THIS ON THE AMENDMENT BY SUBSTITUTION? COUNCILWOMAN DENTON, ON THE AMENDMENT BY SUBSTITUTION.

ON THE COPY THAT YOU HANDED OUT AT COMMITTEE OF THE WHOLE AND THEN AT THE BOTTOM OF THE FIRST PAGE ONLINE, THE VERY LAST LINE OF THAT

FIRST PAGE UNDER 4A.02 IT SAYS COUNCIL TO COMPLY WITH ITS DUTIES, AND IT IS JUST TECHNICAL, THE WORD IN IS IN THERE TWICE.

ASK IT WOULD JUST NEED -- ONE WOULD NEED TO BE DELETED IS WHAT IT APPEARS TO BE.

PRESIDENT YATES: MR. CLERK CAN DO THAT ON A TECHNICAL.

>> JUST WANTED TO MAKE SURE.

THAT IS ALL I WANTED.

>> THANK YOU, WELL POINTED OUT.

PRESIDENT YATES: TWO OTHER PEOPLE ARE ON THE QUEUE.

IS THAT ON THE FLOOR AMENDMENT?

>> I HAVE A OUESTION.

THE NO MORE THAN THREE TERMS, DOES STATE LAW REQUIRE THAT OR IS

THAT SOMETHING THAT WE ARE ADDING?

>> SOMETHING THAT WE ARE ADDING AT THE LOCAL LEVEL.

WHATEVER THE STATE LAW SAYS PREEMPTS THAT.

THE TERMS THAT WERE TALKED ABOUT IS ACTUALLY ITEM 49, THE ORDINANCE.

SO THAT IS NOT REALLY THE AMENDMENT HERE.

BUT WE ARE DISCUSSING SORT OF BOTH ITEMS.

ONE OF THE THINGS I DID WANT TO HIGHLIGHT AND ONE OF THE CHANGES
IS BECAUSE THIS NEW PROCESS WILL BE IMPLEMENTED.

THE CLERK HAS GRACIOUSLY AGREED AND HIS STAFF TO STAFF IT AND KIND OF KEEP TRACK OF ALL THESE THINGS.

SO WE DID PUT IN A 90-DAY EXTENDED PERIOD OF THIS PASSES TO GIVE THEM TIME TO IMPLEMENT THIS.

PRESIDENT YATES: THE AMENDMENT BY SUBSTITUTION HAS PASSED AND WE ARE IN DISCUSSION ABOUT THE ITEM.

COUNCILWOMAN PARKER.

>> I HAVE ALREADY SPOKEN.

PRESIDENT YATES: COUNCILWOMAN FLOOD.

>> NEVER MIND.

PRESIDENT YATES: COUNCILMAN MULVIHILL.

>> I WOULD LIKE TO ECHO THE CONCERNS ON THE FIRE DISTRICTS.

NOT ALL THE POSITIONS BUT THERE ARE FOUR SPECIFIC ONES, TWO OF THEM BEING PROPERTY OWNERS IN THE DISTRICT.

THAT GREATLY LIMITS YOUR TALENT POOL, AS IN YOU CAN DRAW FROM ALL OVER THE COUNTY LIKE WE CAN WITH MANY DISTRICTS.

AND THE OTHER TWO THAT ARE HARDER ARE THE FIREFIGHTER REPS.

THEY ARE VOTED ON SPECIFICALLY BY EACH MEMBER OF THE FIRE DISTRICT. IF WE ARE TRULY LIMITING THOSE FOLKS TO THREE TERMS, WHICH AGAIN, TERM LIMITS, WE GET IT.

BUT IN THIS CASE YOU MAY BE TAKING AWAY THE VOTE OF THE PEOPLE WHO ARE ACTUALLY ON THE FIRE DEPARTMENT THEMSELVES AND THEY ARE LIMITED TO AN EVEN SMALLER POOL OF PEOPLE.

SO AGAIN I'M NOT PROPOSING AN AMENDMENT BUT I'M JUST SAYING,

AGAIN, WHAT COUNCILWOMAN FLOOD BROUGHT UP EARLIER IS A REAL ISSUE FOR THAT

SPECIFIC GROUP OF BOARDS.

PRESIDENT YATES: WOULD THE PRIMARY SPONSOR ENTERTAIN AN EXCEPTION?

>> THAT IS WHAT I WAS GOING TO SAY.

IF SOMEONE WANTED TO MAKE SOME SORT OF EXCEPTION, I WOULD BE WILLING TO EXPLAIN THAT AND WOULD NOT HAVE ANY OBJECTION TO THE SUBURBAN FIREFIGHTER BOARDS BECAUSE I KNOW THOSE ARE SPECIFIC CARVED-OUT BOARDS.

>> WOULD YOU ACCEPT AN AMENDMENT EXCLUDING SUBURBAN FIRE DEPARTMENTS? FROM THE TERM LIMITS?

JUST FROM THE TERM LIMITS.

>> I WOULD BE MOST COMFORTABLE IF WE ARE TALKING ABOUT THE CATEGORIES OF THAT COUNCILMAN PEDEN MENTIONED, IS WHAT I WOULD BE MOST COMFORTABLE WITH.

PRESIDENT YATES: IF COUNCILMAN PEDEN WOULD SAY THAT IN THE FORM OF A MOTION.

>> I'LL MAKE A MOTION TO EXEMPT THE TWO PROPERTY OWNER POSITIONS AND THE TWO FIREFIGHTER POSITIONS FOR EACH SUBURBAN FIRE DISTRICT.

>> DO WE HAVE A SECOND?

>> SECOND.

PRESIDENT YATES: ALL THOSE IN FAVOR RESPOND BY SAYING AYE.
THOSE OPPOSED?

THE AYES HAVE IT.

COUNCILWOMAN FLOOD.

>> THE OTHER POSITIONS ARE ELECTED BY ELECTIONS, ACCORDING TO THE CHAPTER, 75.

THE OTHER POSITIONS, THEY ACTUALLY HOLD ELECTIONS THE LAST SATURDAY IN JUNE FOR FIREFIGHTER REP AND PROPERTY OWNERS ALSO.

THANK YOU VERY MUCH.

PRESIDENT YATES: WHILE THAT MY BE PREEMPTED, WE DO NEED TO GO STATE THE AMENDMENT.

WE WOULD BE PREEMPTED LEGALLY.

DO WE NEED TO PUT THAT IN THE RECORD, WE WOULD BE EXEMPTING THOSE ELECTIONS THEMSELVES?

>> PRESIDENT YATES, SARAH MARTIN WITH THE COUNTY ATTORNEY'S OFFICE.

THIS DISCUSSION IS BETTER SUITED FOR THE ORDINANCE WHICH YOU ARE AMENDING WHICH IS THE NEXT ITEM ON THE AGENDA.

PRESIDENT YATES: THANK YOU.

>> BUT WE CAN SAY FOR THE ORDINANCE, WE HAVE TWO PIECES OF LEGISLATION HERE.

AND I AGREE.

THANK YOU.

PRESIDENT YATES: SO THIS HAS BEEN DIVIDED BETWEEN ITEM 48 AND 49.

SO RIGHT NOW OUR AMENDMENT BY SUBSTITUTION HAS BEEN BEFORE US THAT WAS PROPOSED BY COUNCILMAN HOLLANDER.

SO THE AMENDED, IT WOULD BE A FRIENDLY WITHDRAWAL.

>> FOR PROCEDURAL PURPOSES I WITHDRAW MY MOTION.

PRESIDENT YATES: SO WITHDRAWN.

SO WE ARE BACK AGAIN TO THE ORIGINAL AMENDMENT BY SUBSTITUTION THAT WAS PASSED.

ANY DISCUSSION ON THAT, ITEM 49.

>> 48.

PRESIDENT YATES: 48.

ALL RIGHT.

HEARING NONE, THIS IS A RESOLUTION ALLOWING A VOICE VOTE.

ALL THOSE IN FAVOR RESPOND BY SAYING AYE.

OPPOSED?

THE AYES HAVE IT.

THE AMENDED RESOLUTION IS ADOPTED.

NOW WE ARE AT 49.

MR. CLERK, A READING OF THIS ITEM, PLEASE.

MR. CLERK: AN ORDINANCE AMENDING LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT CODE OF ORDINANCES CHAPTER 32 RELATING TO POLICIES ON APPOINTMENTS TO BOARDS AND COMMISSIONS (AS AMENDED).

READ IN FULL.

PRESIDENT YATES: MOTION AND SECOND FOR APPROVAL?

>> SO MOVED.

>> SECOND.

PRESIDENT YATES: PROPERLY MOVED AND SECONDED.

THE AMENDED ORDINANCE IS BEFORE US.

FOR DISCUSSION, COUNCILMAN MULVIHILL.

>> WE HAVE DISCUSSED THIS ITEM PRETTY THOROUGHLY.

ONE OF THE OTHER HIGHLIGHTS OF IT NOW, JUST BRIEFLY TOUCH ON THIS, THERE IS AN ELECTRONIC DATABASE THAT WILL NOW BE SHARED WITH THE METRO COUNCIL, AND THE ADMINISTRATION IS REQUIRED TO KEEP IT UP TO DATE SO THAT IF THERE IS A LAPSE IN EMPLOYMENT THE COUNCIL CAN ACT WITHIN THEIR 30-DAY PERIOD.

THAT BEING SAID, I WOULD TURN IT OVER TO COUNCILMAN PEDEN FOR HIS AMENDMENT.

AND I WOULD SUGGEST THAT GO ON ITEM TWO, SECTION ONE, ITEM TWO.

PRESIDENT YATES: ITEM TWO SECTION ONE.

AND THE DIFFERENCE IS THIS IS THE ORDINANCE BEFORE US NOW.
COUNCILMAN PEDEN.

>> THANK YOU.

I WOULD LIKE TO MAKE A MOTION TO AMEND ITEM TWO SECTION ONE TO EXEMPT THE TWO PROPERTY OWNER POSITIONS AND THE TWO FIREFIGHTER POSITIONS ON THE SUBURBAN FIRE DISTRICTS FROM THE TERM LIMITS.

PRESIDENT YATES: AND, COUNCILMAN, JUST FOR CLARIFICATION WOULD
YOU ALSO WANT TO STATE IN THERE AND ALL THOSE ELECTIONS THAT ARE OTHERWISE
HELD --

>> I AM OPEN TO ANYTHING THAT MAKES IT VERY LEGAL.

PRESIDENT YATES: THE ELECTIONS -- COUNCILWOMAN FLOOD, YOU HAD AN ADDITIONAL AMENDMENT.

>> NO, I WAS JUST SAYING THE OTHER POSITIONS ARE ELECTED, THE OTHER FIREFIGHTERS AND THE OTHER PROPERTY OWNERS ARE ELECTED BY ELECTION THE LAST SATURDAY IN JUNE.

PRESIDENT YATES: SO WE ARE PREEMPTED ANYWAY.

>> YES, WE ARE PREEMPTED.

WE DON'T REALLY NEED IT.

THAT IS WHY I WAS EXPLAINING THERE ARE ONLY FOUR POSITIONS ON THE BOARD THAT ARE APPOINTED.

PRESIDENT YATES: WE JUST WANT TO MAKE IT CLEAR THAT WE ARE NOT REQUIRING TERM LIMITS ON POSITIONS ELECTED BY THE PEOPLE.

SARAH MARTIN, I KNOW THERE ARE TECHNICAL DIFFICULTIES HERE.

JUST TO CLARIFY FOR THE RECORD, WE JUST WANT TO MAKE SURE THAT WE ARE NOT TRYING TO DO SOMETHING WE ARE LEGALLY PREEMPTED FROM DOING.

>> SARAH MARTIN WITH THE COUNTY ATTORNEY'S OFFICE.

IF THERE IS A STATUTE GOVERNING THE OFFICE THAT STATUTE WOULD GOVERN AND THE ORDINANCE WOULDN'T APPLY.

SO I'M NOT SURE IF THIS CONCERNS ANY KIND OF -- ANY CREATED BY ORDINANCE.

IS THAT WHAT YOU ARE REFERRING TO?

JUST TRYING TO UNDERSTAND THE AMENDMENT SO I CAN CONSIDER IT.

>> WHAT COUNCILWOMAN FLOOD BROUGHT UP EARLIER WAS THAT THE TERM LIMITS MAY APPLY TO SUBURBAN FIRE DISTRICT BOARDS, WHICH THEN MADE ME REALIZE THAT THE PROPERTY OWNER REPS, WHICH ARE ELECTED BY OTHER PROPERTY OWNERS AND THE FIREFIGHTER REPS WHO ARE IN SOME CASES A VERY LIMITED NUMBER OF FIREFIGHTERS ELECT TWO MEMBERS TO THE BOARD, YOU MAY NOT HAVE ANYONE ELSE WHO WANTS TO BE ON THE BOARD.

SO AN EXEMPTION FOR THOSE FOUR ELECTED POSITIONS SEEM TO BE IN ORDER.

>> YES, SIR, I UNDERSTAND THAT.

BUT THE QUESTION WAS IS IT A STATUTORY POSITION.

OTHERWISE, IT DOESN'T GOVERN.

>> I'M GOING TO ASSUME IT IS SET OUT BY CHAPTER 75 WHICH GOVERNS FIRE DISTRICTS.

>> KRS?

>> KRS CHAPTER 75.

>> THOSE POSITIONS AREN'T GOVERNED BY THIS ORDINANCE.

SO THAT AMENDMENT IS UNNECESSARY.

PRESIDENT YATES: GO AHEAD.

>> THE ONLY THING THAT MAKES ME -- WE HAVE SET RULES FOR OTHER BOARD POSITIONS, SPECIFICALLY THE THREE MAYORAL APPOINTMENTS, FOR INSTANCE, WHEN WE FIRST TOOK OFFICE IN 2003.

THAT WAS ON THE LIST OF BOARD APPOINTMENTS THAT WOULD COME BACK
THROUGH THE METRO COUNCIL VERSUS THE ONES THAT -- WHEN THE CLERK READS OFF
THESE ARE REQUIRED FOR COUNCIL APPROVAL, THESE ARE NOT, WE SET THOSE RULES
IN PLACE.

SO I'M ASSUMING IF WE HAVE THE LEGALITY TO MAKE THOSE RULES, WE HAVE THE LEGALITY THESE RULES MAY APPLY.

AND THAT WAS MY ONLY CONCERN.

>> YOU WOULD HAVE TO CLANG THE LANGUAGE IN THE ORDINANCE BECAUSE IT EXCLUDES STATUTORY BOARDS, THE BOARDS THAT ARE GOVERNED BY STATUTE.

>> THAT SEEMS TO TAKE CARE OF IT ANYWAY THEN.

>> THAT IS WHAT I WAS TRYING TO SAY.

>> OKAY.

PRESIDENT YATES: THANK YOU FOR THE CLARIFICATION.

THE EXPLANATION IS THAT IS ALREADY IN THERE.

SO WE HAVE THE ORIGINAL AMENDMENT BY COUNCILMAN PEDEN.

COUNCILWOMAN PARKER HAS CLICKED IN FOR DISCUSSION.

COUNCILWOMAN PARKER.

>> FOR CLARIFICATION, DID COUNCILMAN PEDEN JUST WITHDRAW HIS AMENDMENT?

PRESIDENT YATES: HIS ORIGINAL AMENDMENT IN THE RESOLUTION AND NOW THERE IS AN AMENDMENT AS IT APPLIES TO THE ORDINANCE.

>> FOR CLARIFICATION, WHAT IS THAT AMENDMENT?

PRESIDENT YATES: COUNCILMAN PEDEN, WOULD YOU LIKE TO READ THAT AMENDMENT AGAIN?

>> IT WOULD BE AN EXEMPTION FOR THE TWO PROPERTY OWNER-ELECTED BOARD MEMBERS AND THE TWO FIREFIGHTER-ELECTED MEMBERS OF EACH SUBURBAN FIRE DISTRICT.

>> YOU WITHDREW THAT, CORRECT?

>> I JUST WANTED TO MAKE IT CLEAR THIS IS ONLY ABOUT MAYORAL APPOINTMENTS.

EVERYTHING ELSE IS OUTSIDE OF THE STATUTE.

PRESIDENT YATES: SO WE HAD A MOTION.

WE HAVEN'T HAD A SECOND BUT IT LOOKS LIKE THAT MOTION WILL BE WITHDRAWN.

>> I'M OKAY WITH WITHDRAWING THAT MOTION.

AGAIN, I WAS JUST -- WHEN COUNCILWOMAN FLOOD FIRST BROUGHT UP
THE FIRE DISTRICTS AND COUNCILWOMAN GREEN SAID THERE ARE NO EXCEPTIONS, I
WAS UNAWARE OF THE CREATED STATUTE LINE THAT PRETTY MUCH TAKES CARE OF
EVERYTHING.

PRESIDENT YATES: I APPRECIATE THE DISCUSSION.

WE GOT THAT INFORMATION OUT.

IS THERE ANY OTHER DISCUSSION?

SEEING NONE, THIS IS AN ORDINANCE REQUIRING A ROLL CALL VOTE.
WITHOUT OBJECTION THE VOTING IS CLOSING.

THE VOTING IS CLOSED.

MR. CLERK: 21 YES VOTES, ONE PRESENT VOTE AND FOUR NOT VOTING.

THE ONE PRESENT VOTE IS COUNCIL MEMBER LANSHIMA.

PRESIDENT YATES: THE AMENDED ORDINANCE PASSES.

MR. CLERK, A READING OF ITEM 50.

MR. CLERK: AN ORDINANCE ESTABLISHING A DEVELOPMENT AREA PURSUANT TO PROVISIONS OF KRS 65.7041- 65.7083 TO BE KNOWN AS THE ELEVENTH AND JEFFERSON DEVELOPMENT AREA, DESIGNATING THE METRO DEVELOPMENT AUTHORITY, INC. PRESIDENT YATES: MAY I HAVE A MOTION AND SECOND FOR APPROVAL.

>> SO MOVED.

>> SECOND.

PRESIDENT YATES: PROPERLY MOVED AND SECONDED.

THE ORDINANCE IS BEFORE US.

COUNCIL MEMBER HAMILTON

>> THANK YOU, MR. PRESIDENT.

THIS CAME OUT OF THE LABOR AND ECONOMIC COMMITTEE ON A UNANIMOUS VOTE.

THE 11TH AND JEFFERSON REDEVELOPMENT PROJECT, OTHERWISE KNOWN AS THE HENRY GREEN APARTMENTS.

WHEN YOU GET OFF NINTH STREET GOING WEST TOWARDS THE FIRE DEPARTMENT HEADQUARTERS.

THIS IS THE TIF, ANOTHER TIF WEST LOUISVILLE, WHICH WE ARE HAPPY ABOUT.

THIS REDEVELOPMENT BY ALLIED ARJENTA WILL ALLOW TO HAVE UNITS TO BE REDEVELOPED BRINGING ABOUT \$45,000 PER UNIT UPDATE THEM TO SOLAR, NEW APPLIANCES.

ALL IN ALL IT WOULD BE ABOUT A \$17.5 MILLION INVESTMENT IN THIS PROPERTY, AND WE ARE EXCITED ABOUT IT BECAUSE THE TIF WILL PLAY IN NICELY WITH THE RUSSELL REDEVELOPMENT OF BEECHER TERRACE, WHICH WILL BE TAKING PLACE RIGHT ACROSS THE STREET.

THIS IS IN DISTRICT FOUR.

AND COUNCILWOMAN BARBARA SEXTON SMITH I'M SURE WOULD LIKE TO SPEAK ON IT.

AND IF YOU COULD GET COUNCILMAN ACKERSON BACK IN THE ROOM, HE WANTED TO -- I WOULD LIKE HIM TO HAVE AN OPPORTUNITY TO SPEAK TO IT.

THANKS.

PRESIDENT YATES: COUNCILWOMAN SEXTON SMITH, WOULD YOU LIKE THE FLOOR ON THIS?

>> YES, MR. PRESIDENT.

THANK YOU VERY MUCH AS WE WELCOME COUNCILMAN ACKERSON BACK INTO THE CHAMBERS FOR THIS MOST HISTORICAL NUMBER 50 ITEM ON OUR AGENDA THIS EVENING.

PRESIDENT YATES: I'M NOT SURE WE GAVE HIM TIME TO WASH HIS HANDS.

>> COLLEAGUES, WE ARE VERY EXCITED ABOUT THIS PARTICULAR TAX

INCREMENT FINANCING ORDINANCE BECAUSE THIS WILL BE THE FIFTH TIF THAT THIS

BODY HAS APPROVED THIS YEAR.

SO THAT MEANS EACH OF THESE TIFS HAVE BEEN ALONG THE SAME FORMULA.

80% OF THE INCREMENTAL TAXES GO TO THE DEVELOPER.

WE HOLD 20% OF THOSE TAXES WITH METRO LOUISVILLE.

SO IN THE YEAR 2038 WHEN THESE FIVE TIFS TURN OVER TO METRO, I WOULD LIKE A POINT IN THE RECORD TO NOTE I WILL BE 81 YEARS OF AGE AND THERE WILL BE PLENTY OF REVENUE COMING INTO METRO BUDGET BECAUSE OF YOUR VISION TO DO THIS.

THIS IS AN EXCITING PROJECT, AS COUNCILWOMAN HAMILTON STATED.

ANOTHER VERY GOOD POINT.

IT IS 100% AFFORDABLE HOUSING.

AS A MATTER OF FACT, AS DEFINED BY HUD, ALL OF THE UNITS, ALL 125, ARE EITHER EXTREMELY LOW OR VERY LOW GUIDELINES ACCORDING TO HUD.

THERE WILL BE ENERGY EFFICIENCY UPDATES MADE.

IT IS OUR SECOND TIF WEST OF NINTH STREET.

THERE WILL BE INTERNAL AND EXTERNAL IMPROVEMENTS MADE TO EACH OF THE UNITS.

THEY WILL BE INCLUDING A LITERACY AND WORKFORCE TRAINING COMPONENT ON SITE.

AND I KNOW THAT THE RESIDENTS ARE VERY EXCITED ABOUT THIS.

FINANCIAL UPTICK FOR THE METRO LOUISVILLE IS THE FACT THAT A CHURCH OWNS THE PROPERTY RIGHT NOW.

THAT PROPERTY IS GOING TO BE TRANSFERRED TO A FOR-PROFIT ORGANIZATION, TO THE DEVELOPER.

WHICH MEANS THE PROPERTY TAXES OF \$62,000 A YEAR WE WILL START IN THE YEAR 2019.

WHEN YOU REACH YEAR 2038, THOSE PROPERTY TAXES ARE GOING -- THAT WILL ACHIEVE \$1.2 MILLION OVER THE 20-YEAR PERIOD.

ANOTHER COMPONENT, WE ARE CAPPING THE TAX INCREMENT FINANCING THAT GOES TO THE DEVELOPER AT \$1,268,228.

IT IS A QUESTION WE ALWAYS GET TYPICALLY WITH THESE.

SO WE SO MUCH ASK FOR YOUR VOTE ON THIS THIS EVENING.

IT WILL BE A VOTE AND A WIN FOR ALL OF US IN JEFFERSON COUNTY.

THANK YOU, MR. PRESIDENT.

PRESIDENT YATES: AS ALWAYS, COUNCILWOMAN.

COUNCILMAN BRENT ACKERSON.

>> THIS IS A TIF WE ALL SHOULD BE PROUD OF BECAUSE IT ABSOLUTELY FITS WITHIN THE MEANING OF THE TIF LAWS THE WAY THEY WERE WRITTEN.

COUNCILWOMAN CHAIR BRYANT HAMILTON, I WANT YOU TO KNOW.

OF ALL THE TIFS THAT I HAVE OPPOSED BECAUSE OF THE LACK OF AFFORDABLE HOUSING, THIS ONE, WE ARE NOT TALKING 80% OF AMI OR ANYTHING ELSE.

WE ARE TALKING TRULY AFFECTING PEOPLE OF LOW AND EXTREMELY LOW INCOMES.

SO WHAT BETTER INVESTMENT OF CITY TAX DOLLARS?

SO I'M EXCITED ABOUT THIS ONE AND I WANTED TO SPEAK OUT IN FAVOR AND HOPEFULLY THIS WILL BE A MODEL OF TIFS TO COME.

VERY MUCH IN SUPPORT.

THANK YOU.

PRESIDENT YATES: THANK YOU, COUNCILMAN.

IS THERE ANY FURTHER DISCUSSION?

HEARING NONE, THIS IS AN ORDINANCE REQUIRING A ROLL CALL VOTE.

WITHOUT OBJECTION, THE VOTING IS CLOSING.

THE VOTING IS CLOSED.

MR. CLERK: 21 YES VOTES AND FIVE NOT VOTING.

PRESIDENT YATES: THE ORDINANCE PASSES.

MR. CLERK, A READING OF ITEM 51.

MR. >> MOTION TO APPROVE.

>> SECOND.

PRESIDENT YATES: PROPERLY MOVED AND SECONDED.

THE RESOLUTION IS BEFORE US.

COUNCILWOMAN BUTLER.

>> THANK YOU VERY MUCH.

THIS WAS IN THE BUDGET COMMITTEE AND IT FAILED IN THE BUDGET COMMITTEE, WHICH IS WHY IT IS ON OLD BUSINESS.

BUT I WANT TO GIVE A LITTLE HISTORY TO THIS.

AS YOU REMEMBER LAST YEAR IN THE BUDGET THERE WAS MONEY IN THERE FROM THE ADMINISTRATION TO MOVE HEADQUARTERS OUT AND VACATE THE BUILDING BUT THERE WAS NO PLAN FOR THE BUILDING OR ANY OTHER BUILDINGS THAT WE HAVE THAT NEED HELP AS WELL.

AND SO COUNCILMAN KRAMER AND I SPOKE ABOUT THIS.

WE SPOKE WITH OUR CAUCUSES ABOUT THIS.

AND WE PUT THE FOLLOWING LANGUAGE IN THE BUDGET.

UNDER THE OFFICE OF FACILITIES AND FLEET MANAGEMENT, SPACE
UTILIZATION STUDY OF \$100,000, METRO COUNCIL DIRECTS THE OFFICE OF
FACILITIES FLEET MANAGEMENT TO INCLUDE BUT NOT LIMITED TO THE FUTURE USE
OF POLICE HEADQUARTERS IN THE PHYSICAL COURT BUILDING AND DESIGN OF NEW
SPACE.

THE ADDITIONAL COST OF THE STUDY IF ANY WILL BE PAID FROM THE FACILITIES BUDGET.

WE DID NOT ASK FOR A COMPLETION DATE ON THIS PARTICULAR STUDY.

AND WITH THAT IN MIND, IN NOVEMBER I E-MAILED KATHY DUNCAN, DIRECTOR OF FACILITIES AND ASKED STROPHES.

AND SHE SAID THEY WOULD HAVE SOMETHING THIRD QUARTER FROM THE CONSULTANT.

WE HEARD FROM MARY ELLEN WITH. AND MS. DUNCAN AT THE LAST COMMITTEE MEETING TALKING ABOUT THE RFP THEY ARE SENDING OUT, THE ADMINISTRATION SENT OUT PRESS RELEASES TALKING ABOUT IT.

AND THEY ARE LOOKING AT A WELL THOUGHT-OUT THING.

SEVERAL DIFFERENT OPTIONS THERE.

WE HAD A ROBUST DISCUSSION NOT JUST SHOULD IT BE LMPD AND THE PHYSICAL COURT BUILDING BUT SHOULD IT INCLUDE A MASTER CAPACITY PLAN FOR THE JAIL BECAUSE WE ARE GOING TO LOSE BEDS WHEN WE TAKE DOWN THE OLD HEADQUARTERS IF THAT IS SOMETHING THAT SHOULD COME DOWN.

SO IF THIS IS SOMETHING TO BE INCLUDED.

AND I THINK THE ADMINISTRATION AGREED TO THAT.

THEY ARE REWORDING SOME OF THE RFP.

THEY TELL US THE RFP WILL BE RELEASED IN JANUARY.

IT WILL HAVE TO BE ON THE STREET FOR PURCHASING REQUIREMENTS FOR AT LEAST 50 DAY AND IS THEY WILL COME BACK AND REVIEW IT AND HOPEFULLY THEY WILL NEGOTIATE WITH WHOEVER IS SELECTED TO GET THE BEST PRICE THAT WE CAN POSSIBLY GET.

PRESIDENT YATES: TABLED TO JANUARY 11TH.

DISCUSSION ON THAT?

FIRST PERSON IN THE QUEUE IS COUNCILWOMAN LEET.

I FEEL LIKE THAT WE DID HAVE AN HOUR -- WE NEARLY DEBATED IT FOR AN HOUR IN THE BUDGET COMMITTEE.

I HAVE HANDED OUT A COPY OF THE AMENDMENT WHICH IS VERY MINOR.

THE WHEREAS THAT IS REQUESTED AS AN AMENDMENT ACTUALLY COPIES

LANGUAGE DIRECTLY FROM MAYOR FISCHER'S PRESS RELEASE IN REGARDS TO HIS

LANGUAGE FOR THE REVIEW OF LOUISVILLE METRO'S CURRENT AND FUTURE FACILITY

NEEDS.

AND THEN ADDITIONALLY PROVIDES A DATE-CERTAIN AND STRIKES ANY DATES HOLDING ANY VOTE.

AND THE DATE-CERTAIN SELECTED OF APRIL 15TH, 2018, MATCHES

LANGUAGE PROVIDED IN ANOTHER E-MAIL I JUST HANDED OUT FROM DOUG HAMILTON

INDICATING THAT MARCH 31ST WAS A DATE THAT COULD BE ACCOMPLISHED TO

IDENTIFY THIS.

SO I WANTED TO READ THOSE ITEMS INTO THE RECORD.

FIRST FROM THE FRATERNAL ORDER OF POLICE.

I WAS AT THE BUDGET COMMITTEE MEETING.

I STAYED FOR THE WHOLE MEETING.

AND I ALSO HAVE LOOKED AT WHAT IS IN THE CAPITAL BUDGET.

SO WHAT WE HAVE DONE HERE, WHAT WE ARE ATTEMPTING TO DO HERE IS PUT A DATE WHEN WE HAVE NEVER PUT A DATE.

THIS IS A COMMITMENT THAT I BELIEVE THIS COUNCIL NEEDS TO MAKE.

WE ARE MAKING A COMMITMENT.

YOU HAVE TO APPLAUD COUNCILMAN ACKERSON FOR THE DISCUSSION FOR YEARS ABOUT THE DEPLETION OF OUR ROADS IN THIS COMMUNITY.

WE HEARD IT YEAR AFTER YEAR AFTER YEAR.

WE FINALLY AS A COUNCIL GOT BEHIND IT, AND LOOK WHAT HAS HAPPENED.

WE HAVE COMMITTED TO PAVING ROADS IN THIS COMMUNITY.

I BELIEVE IT IS TIME THAT WE GET BEHIND OUR COMMITMENT TO METRO POLICE AND THE FACILITY THAT THEY OPERATE OUT OF, AND, MR. PRESIDENT, WITH THAT I CALL THE OUESTION.

THANK YOU.

PRESIDENT YATES: CALLED THE QUESTION.

IS THERE A SECOND?

>> OBJECTION.

PRESIDENT YATES: THERE IS AN OBJECTION TO CALLING THE QUESTION.

WE HAVE ONE OTHER PERSON IN THE OUEUE.

DO YOU WANT TO MOVE FORWARD?

IT HAS BEEN SECONDED BY.

ALL THOSE IN FAVOR RESPOND BY SAYING AYE.

THOSE OPPOSED?

DO WE WANT A ROLL CALL VOTE?

>> ROLL CALL, PLEASE.

PRESIDENT YATES: MR. CLERK, PLEASE OPEN THE VOTING.

THIS IS ON CALLING THE QUESTION.

-- --

PRESIDENT YATES: THE MOTION FAILS.

COUNCILWOMAN PARKER.

>> YES.

I WOULD JUST LIKE TO MAKE A POINT ABOUT THE ARGUMENT THAT WAS JUST SUBMITTED THAT THERE WAS NO CONVERSATION AT BUDGET.

AND THESE WERE NOT DISCUSSED.

WE WOULD NEVER DO ANYTHING OR HAVE ANY KIND OF PROGRESS ON THIS COUNCIL IF WE WENT BACK AND WE SAID THINGS WEREN'T DISCUSSED.

THAT IS WHERE YOU MOVE FORWARD.

YOU THINK ABOUT WHAT WASN'T DONE, WHAT YOUR PRIORITIES ARE, AND WHERE YOU NEED TO GO.

AND THEN YOU MOVE FORWARD WITH FUTURE ORDINANCES OR RESOLUTIONS FOR WHAT NEEDS TO BE DONE.

SO I JUST WANTED TO BRING THAT POINT UP, THAT I DON'T THINK THAT THAT WAS AN ADEQUATE ARGUMENT THAT FITS THE NEEDS OF THE RESOLUTION.

THANK YOU.

PRESIDENT YATES: COUNCILMAN COAN.

>> THANK YOU, MR. PRESIDENT.

MAYBE IT IS A QUESTION FOR MY COLLEAGUE COUNCILWOMAN BUTLER.

DID WE HAVE THE REASONABLE EXPECTATION THAT THIS STUDY WOULD BE FINAL IN TIME THAT WE WOULD HAVE THE INFORMATION OR WHATEVER OTHER LENGTH OF TIME WE NEED PROCESS-WISE TO BE ABLE TO PLAN FOR CAPITAL PROJECTS IN THE FISCAL 2019 BUDGET?

I GUESS MY QUESTION IS, DO WE ALL EXPECT TO HAVE THE INFORMATION WE NEED IN THE RUNWAY OF TIME TO BE ABLE TO PLAN FOR THIS KIND OF CAPITAL INVESTMENT IN THE 2019 BUDGET?

PRESIDENT YATES: THAT WAS ACTUALLY SENT OVER THERE TOO.

COUNCILWOMAN BUTLER.

>> I DO NOT THINK SO.

I THINK A STUDY LIKE THIS IS PROBABLY GOING TO TAKE THREE TO SIX MONTHS BECAUSE NOT ONLY ARE THEY GOING TO DO A STUDY TO SEE ABOUT THE VIABILITY OF THE BUILDINGS AND WHAT WE ARE GOING TO DO WITH THEM.

THEY ARE ALSO GOING TO HAVE TO DO A COST ANALYSIS TO FIGURE OUT
HOW MUCH IT IS GOING TO COST US AND IF IT WILL BE A PUBLIC/PRIVATE
PARTNERSHIP.

THAT IS ALL STUFF WE TALKED ABOUT.

WE WANTED THIS FINISHED THIS FISCAL YEAR T STUDY SO WE KNOW WHAT TO DO AS WE MOVE FORWARD TO PLAN AHEAD.

OUR WHOLE PURPOSE WAS LET'S JUST NOT PUT THEM OVER HERE FOR A WHILE AND VACATE THE BUILDING AND DO NOTHING WITH IT.

THAT IS JUST NOT A GOOD WAY TO TREAT OUR FACILITIES.

WE DON'T WANT TO HAVE GOVERNMENT BOARDED UP FACILITIES.

>> OBVIOUSLY THE REASON I ASK IS I THINK THAT EVERYBODY IN THE COUNCIL WANTS TO PUT THE POLICE IN THE FACILITIES THEY NEED AS SOON AS PRACTICABLE.

WE CREATE PLANS ALL THE TIME FOR CAPITAL PROJECTS THAT TAKE PLACE TO REVIEW, NOT THAT WE GET BACK LATER FOR THE BUDGET.

SO I ASSUMED THAT WE WILL DO WHAT IS NECESSARY IN ORDER TO HOUSE OUR POLICE DEPARTMENT NEXT FISCAL YEAR TOWARDS A FINAL SOLUTION AS SOON AS POSSIBLE.

BUT I WOULDN'T WANT TO PUT IN AN ARBITRARY DUE DATE ON THE STUDY IF IT IS NOT GOING TO ENABLE US TO EXECUTE IT ANYWAY.

THAT IS MY COMMENT.

PRESIDENT YATES: THANK YOU.

AND NEXT IN THE OUEUE I HAVE COUNCILWOMAN HAMILTON.

I KNOW THAT COUNCILMAN KRAMER IS WANTING TO ANSWER COUNCIL MEMBER COAN'S QUESTION.

IF YOUR REMARKS HAVE TO DO WITH COUNCIL MEMBER COAN'S QUESTION, I WILL LET YOU DO THAT.

COUNCILWOMAN HAMILTON.

>> WE ARE TALKING ABOUT APRIL 15TH.

WE ARE TALKING ABOUT NEXT YEAR, WHEN WE WILL BE LOOKING AT PENSION COSTS.

AND I'M WONDERING IF WE ARE EVEN GOING TO HAVE MONEY FOR CAPITAL PROJECTS IN NEXT YEAR'S BUDGET.

I KNOW THIS IS A PRIORITY AND I KNOW THIS IS SOMETHING WE HAVE TALKED ABOUT.

AND I DON'T KNOW HOW SOON WE ARE GOING TO KNOW WHAT THOSE FORECASTS ARE.

BUT I THINK THE SOONER WE KNOW, THE BETTER.

AND I THINK WE HAVE MOVED UP OUR BUDGET PROCESS A MONTH EARLIER THAN WE USUALLY DO.

SO I THINK IT WOULD BE PRUDENT ON THE PART OF THE ADMINISTRATION TO GET THIS DONE AS QUICKLY AS POSSIBLE.

IF IT IS NOT APRIL 15TH MAYBE IT IS MAY 1ST.

BUT I THINK WE NEED TO HAVE THAT INFORMATION.

PRESIDENT YATES: THANK YOU, COUNCILWOMAN.

COUNCILMAN KRAMER.

>> THANK YOU, MR. PRESIDENT.

AND I APPRECIATE YOUR COMING TO ME.

I DID WANT TO RESPOND DIRECTLY TO COUNCILMAN COAN'S QUESTION.

AND I HATE TO TAKE A POSITION AGAINST THE CHAIR OF THE BUDGET COMMITTEE WHILE I'M THE VICE CHAIR.

BUT I BELIEVE THAT THERE WERE A NUMBER OF US, AND I WILL SPEAK FOR MYSELF, I WILL SPEAK FOR MYSELF AS WELL AS THE OTHERS THAT I WAS IN COMMUNICATION WITH IN JUNE.

YES, THE ANSWER TO YOUR QUESTION IS YES.

THERE IS A REASONABLE EXPECTATION THAT WE WOULD HAVE THIS STUDY DONE IN TIME FOR US TO BE ABLE TO USE THAT INFORMATION FOR THIS COMING YEAR'S BUDGET.

THE PLAN WAS NEVER, THE INTENT FROM OUR PERSPECTIVE, MINE AND THOSE FOLKS WHO I WAS WORKING WITH, WAS NEVER TO WAIT UNTIL THE FOLLOWING BUDGET CYCLE.

OUR INTENT ALL ALONG WAS THAT WE WOULD HAVE THIS STUDY DONE IN TIME FOR WHEN THE MAYOR PRESENTS HIS BUDGET THIS YEAR IN THE COMING MAY, THAT HE WOULD INCLUDE IN THIS COMING BUDGET ANNOUNCEMENT A PLAN TO DEAL WITH THE PROBLEM THAT WE HAD BECAUSE IN LAST YEAR'S BUDGET IF YOU RECALL THERE WAS MONEY TO LEASE PROPERTY TO MOVE THE POLICE OUT OF HEADQUARTERS.

WE UNDERSTOOD THAT WAS A SERIOUS PROBLEM.

WE UNDERSTOOD THAT THIS NEEDED TO BE TAKEN CARE OF AND IT NEEDED TO BE TAKEN CARE OF IN A RESPONSIBLE WAY.

THAT IS WHY WE PUT THE LANGUAGE IN THAT SAID COME BACK AND TELL US HOW TO DO THIS IN A REASONABLE WAY.

THE EXPECTATION IS WE WOULD ABSOLUTELY HAVE NIT TIME FOR THE BUDGET.

SO WHEN WE LOOK AT A DATE THAT IS APRIL 15TH AND FOLKS ARE SAYING PUT IT OFF, PUT IT OFF, PUT IT OFF, ANYTHING LATER THAN APRIL 15TH MAKES DISCUSSION IN THIS YEAR'S BUDGET SOMEWHAT DIFFICULT.

I ALMOST SAY MOOT BUT IT WOULDN'T BE MOOT BECAUSE WE DID GET A SOCCER STADIUM AND WE HAVE DONE THOSE KINDS OF THINGS.

WHEN YOU ARE LOOKING AT AN \$800 MILLION BUDGET AND YOU KNOW YOU HAVE AN UPCOMING EXPENSE IT SEEMS REASONABLE YOU WOULD AT LEAST TRY TO FIGURE OUT WHAT THE EXPENSE IS BEFORE YOU SPEND \$800 MILLION.

I DON'T THINK IT IS UNREASONABLE TO ASK FOR APRIL 15TH.

THE FACT THE MAYOR WAITED UNTIL DECEMBER TO LET THE RFP, THAT IS -- I JUST BELIEVE THAT IN JUNE OUR INTENT WAS TO HAVE THIS BEFORE THE BUDGET CYCLE.

PRESIDENT YATES: COUNCILMAN BENSON.

>> THANK YOU, MR. PRESIDENT.

YOU KNOW, I NEVER -- I HAVE.

I'LL TAKE THAT BACK.

BUT MOST OF THE TIME I HAVE NEVER BUILT ANYTHING WITHOUT A DRAWING.

SO TO HAVE A DRAWING, SOMEBODY HAS TO MAKE AN IDEA WE ARE GOING TO DO SOMETHING.

AND I THOUGHT SIX MONTHS AGO WE TALKED ABOUT DOING SOMETHING WITH THE POLICEMEN.

AND AS I COMES OUT, WE ARE NOT SURE WHAT WE WANT TO DO WITH THEM.

MAYBE THEY CAN WORK OUT OF THEIR CARS OR SOMETHING.

I DON'T KNOW.

BUT YOU KNOW, THIS WEEK THE WATER COMPANY HAD A LITTLE BIT OF A PROBLEM.

THEY HAD A MAIN BUST AND THEY GOT TOGETHER AND SAID YOU KNOW
WHAT, IN THE NEXT BOARD MEETING WE WILL TALK THIS OVER AND SEE IF WE OUGHT
TO MAYBE FIX THIS MAIN.

BUT THERE IS A LOT OF PEOPLE DOWN IN THE AREA THAT SAID WAIT A MINUTE, WAIT A MINUTE, WE WANT YOU TO FIX IT NOW.

WELL, THERE ARE PROBABLY A LOT OF POLICEMEN WHO SAY, YOU KNOW WHAT, THIS BUILDING IS NOT REALLY THAT HEALTHY.

AND CAN YOU ALL COME UP WITH A PLAN?

AND EVEN THE ADMINISTRATION, US WORKING TOGETHER TO SAY, HEY, THIS IS IMPORTANT.

INSTEAD OF SAYING WE WILL DO IT THIS WAY.

AND SOMEBODY SAYS, WAIT A MINUTE, WE DON'T UNDERSTAND.

OKAY, WE WILL STUDY NIT ANOTHER SIX MONTHS OR YEAR AND THEN COME TOGETHER AND SAY MAYBE NOT.

MAYBE IN TWO OR THREE OR FOUR YEARS FROM NOW THEY WILL SAY HEY WE OUGHT TO FIX THE POLICE DEPARTMENT.

MAYBE ALL WILL BE DEAD BY THEN.

WE ARE OKAY, BUT PUTTING THINGS ON.

SOMEWHERE ALONG THE LINES SOMEBODY HAS TO LEAD.

MAYBE WE DON'T NEED TO FIX THE SEWERS.

SOME PEOPLE ARE THINKING WE DO.

NO, JUST LET IT GO.

SOMETIMES WHEN THEY JUST FALL IN WE WILL FIX THEM AS THEY GO.

AND THEN THAT WOULD BE HOW WE WORK, BACKWARDS.

THANK YOU.

PRESIDENT YATES: COUNCILMAN HOLLANDER.

>> THANK YOU, MR. PRESIDENT.

LET ME REITERATE WHAT COUNCILMAN KRAMER SAID.

FIRST OF ALL LET ME POINT OUT IT MAY HAVE BEEN THE INTENTION BUT

THERE WAS NO LANGUAGE IN THE BUDGET -- I HAVE IT RIGHT IN FRONT OF

ME -- NO LANGUAGE THAT HAS A DATE.

I DON'T KNOW WHY WE DIDN'T PUT IN A DATE IF WE WANTED TO DATE.

THAT IS WHAT I WOULD DO.

THAT WAS NOT DONE.

THE ADMINISTRATION PROPOSED A SOLUTION TO THE LMPD HEADQUARTERS LAST JUNE.

THEY WERE GOING TO MOVE LMPD OUT OF THE CURRENT LOCATION LAST YEAR AND ASKED US TO DO THAT THROUGH LEASING AND WE DECIDED NOT TO DO THAT.

SO I THINK IT IS IMPORTANT TO SAY I THINK EVERYBODY WANTS LMPD TO BE IN A DIFFERENT SPACE AND THAT INCLUDES THE ADMINISTRATION.

I WAS ALSO GLAD TO HEAR AT THE COUNCIL BUDGET MEETING LAST WEEK AFTER WE, A NUMBER OF PEOPLE CATEGORICALLY REJECTED LEASING THAT WE NOW SAY WELL MAYBE LEASING IS OKAY.

E3 SEEMED TO BE OKAY.

THAT IS WHAT WE ARE DOING IN FRANKFORT.

I'M GLAD LEASING APPEARS TO BE ON THE TABLE IN A P3 PROCESS.

THAT IS WHAT WAS PROPOSED BY THE ADMINISTRATION LAST YEAR.

I HOPE WE MOVE TO SOMETHING LIKE THAT.

I CERTAINLY THINK WE OUGHT TO CONSIDER IT MOVING FORWARD.

AND THAT IS WHAT THE SPATE UTILIZATION STUDY WILL DO.

THANK YOU.

PRESIDENT YATES: THANK YOU, COUNCILMAN.

COUNCILWOMAN LEET.

>> I JUST WANTED TO REITERATE THAT TO SAY WE HAVE NEVER PUT A DATE ON ANYTHING IN THE BUDGET, WE HAVE PUT DEADLINES ON THINGS WE HAVE FUNDED IN THE BUDGET AND STUDIES AND REPORTS BACK.

WE HAVE DONE IT QUITE FREQUENTLY.

I DISAGREE WITH THE CHARACTERIZATION THAT WE HAVE NEVER PUT A DATE ON THINGS IN THE BUDGET BECAUSE WE HAVE DONE REPORTS BACK.

WITHIN THAT CONTEXT.

I'LL JUST SIMPLY DISAGREE.

PRESIDENT YATES: COUNCILMAN HOLLANDER.

>> MR. PRESIDENT, LET ME RESPOND.

I DIDN'T SAY WE NEVER PUT A DATE IN THE BUDGET.

WHEN WE WANT SOMETHING BACK BY A DATE CERTAIN WE DO PUT NIT THE BUDGET.

I AGREE WITH COUNCILWOMAN LEET ON THAT POINT.

BUT THIS LANGUAGE WHICH I AM READING HAS NO DATE.

WE KNOW HOW TO PUT A DATE IN THE BUDGET WHEN WE WANT TO.

WE DO IT FREQUENTLY.

IN THIS CASE WE DID NOT DO THAT.

THANK YOU.

PRESIDENT YATES: COUNCILWOMAN LEET.

>> YES.

AND I WOULD JUST COUNTER BACK THAT I BELIEVE THAT WAS AN OMISSION.

IT WAS NOT INTENTIONAL.

I BELIEVE THE IDEA WAS THAT WE WOULD HAVE A SOLUTION AND THAT THERE WOULD NOT -- BECAUSE THERE WAS AN URGENCY IDENTIFIED.

IN FACT, IN THE LANGUAGE DONE IN THE BUDGET PROPOSAL FROM THE MAYOR, THERE WAS AN URGENCY TO ADDRESS THIS.

AND I THINK THERE WAS SOMEWHAT OF AN UNDERSTANDING OR AN ASSUMPTION THAT IT WOULD BE DONE IN A PRIORITIZED MANNER AND THAT IT WOULD BE ONE OF THE VERY FIRST THINGS THAT WOULD BE ACCOMPLISHED EARLY ON IN THE FOLLOWING FISCAL YEAR.

SO I THINK THIS SIMPLY REITERATES THE NEED AND THE IMPORTANCE AND THE PRIORITIZATION TO GET IT DONE.

THANK YOU.

PRESIDENT YATES: COUNCILMAN JAMES.

>> THANK YOU, MR. PRESIDENT.

I WOULD JUST LIKE TO REFLY THAT MY BELIEF OF THE LEGISLATIVE INTENT WAS THAT WE WERE ASKING FOR THIS REPORT TO BE DONE IN THE BUDGET

AND THAT IT WOULD ALLOW US TO HAVE DISCUSSIONS DURING BUDGET DISCUSSIONS ABOUT HOW WE WERE GOING TO DEAL WITH THE PROBLEM.

PRESIDENT YATES: THANK YOU, COUNCILMAN JAMES.

COUNCILMAN REED.

>> THANK YOU, MR. PRESIDENT.

I JUST WANTED TO STATE THAT IT SHOULD HAVE BEEN IN THE BUDGET.

WE SHOULD HAVE HAD DATES.

ONE OF THE THINGS THAT WE LEARN IN BUSINESS IF YOU DON'T HAVE

DATES THINGS GET PUSHED AND PUSHED AND YOU ARE TALKING ABOUT IT

FIVE YEARS FROM NOW.

SO I THINK THIS IS OUR OPPORTUNITY TO FIX IT.

THANK YOU.

PRESIDENT YATES: I WILL ABSTAIN BECAUSE THE CONVERSATION DID MOVE TO THIS WAY, INFRASTRUCTURE.

>> I AM BRINGING BACK THE IDEA THAT COUNCIL MEMBER SEXTON SMITH HAD OFFERED UP EARLIER.

MY ONLY QUESTION IS IS THERE A DATE CERTAIN IN THE BUDGET

PROCESS THAT MAY BE LATER THAN APRIL 15TH BY WHICH THE BUDGET COMPLETE AND

THE FULL COUNCIL CAN GET THE BEST REPORT WE CAN POSSIBLY GET IN ORDER TO

CONSIDER IT FOR THE BUDGET?

IF SO, UNLESS THERE IS AN -- MAYBE COUNCILWOMAN LEET HAS APRIL 15TH FOR A SPECIFIC REASON, IF THAT IS THE DATE.

BUT IF THERE IS NO SPECIFIC REASON FOR THAT BEING THE DATE MAYBE THERE IS SOME OTHER DATE THAT MAKES MORE SENSE.

PRESIDENT YATES: COUNCILWOMAN LEET.

>> I'LL ADDRESS THAT.

I THINK I SELECTED THAT DATE WITH SOME INTENTIONALITY BASED ON THE FACT THAT MARCH 31ST WAS THE DATE THEY SAID THEY COULD FINISH THE STUDY AND NOT NECESSARILY THAT IT WOULD BE WRITTEN INTO THE BUDGET BOOK THAT WE RECEIVED, BUT THAT WE AT LEAST WOULD HAVE THE DATE AND HAVE AN OPPORTUNITY TO GET A PRESENTATION SPECIFICALLY ON THAT SO THAT IT DOESN'T GET CONFUSED WITHIN THE ENTIRE BUDGET PROPOSAL PROCESS.

AND IF THERE ARE REFINEMENTS THEY COULD BE ADDRESSED AT THAT TIME.

PRESIDENT YATES: COUNCILWOMAN HAMILTON.

>> I WAS NOT IN FAVOR OF THE RESOLUTION WHEN IT HAD THE LANGUAGE
ABOUT THE INTENTION TO POSTPONE THE VOTE ON DEBT OBLIGATIONS AND OTHER
THINGS LIKE THAT.

BUT SINCE THAT HAS BEEN STRICKEN I THINK THE INTENTION TO GET THE REPORT, TO GET IT IN A TIMELY MANNER IS SOMETHING THAT I CAN SUPPORT.

PRESIDENT YATES: THANK YOU.

COUNCILMAN ACKERSON.

>> THANK YOU, MR. PRESIDENT.

I RECALL DURING THE BUDGET PROCESS TALKING ABOUT INFRASTRUCTURE AND THE POLICE HEADQUARTERS.

I WAS ONE OF THE PEOPLE WHO FELT VERY STRONGLY ABOUT THE FACT OF RUSHING TO LEASE MIGHT HAVE FREED UP A FEW DOLLARS BUT IN MY OPINION I THINK IT WAS NOT A WISE DECISION FOR THE LONG HAUL.

IF THEY ARE LISTENING, WE MADE ATE PRIORITY SIX MONTHS AGO.

OUR VOICES TONIGHT ARE SAYING IT IS A PRIORITY AGAIN.

YOU CAN LISTEN TO US OR NOT LISTEN TO US.

AND WITH I WOULD CALL THE QUESTION AND LET'S MOVE ON.

PRESIDENT YATES: SECOND?

ALL THOSE IN FAVOR RESPOND BY SAYING AYE.

THOSE OPPOSED?

THE AYES HAVE IT.

THE QUESTION HAS BEEN CALLED.

AND THIS IS, MR. CLERK, ON THE AMENDMENT, CORRECT?

DISTRICT SEVEN'S AMENDMENT.

CAN WE HAVE A ROLL CALL VOTE, PLEASE.

THIS IS THE AMENDMENT BY SUBSTITUTION THAT WAS PROPOSED BY DISTRICT SEVEN.

WITHOUT OBJECTION, THE VOTING IS CLOSING.

THE VOTING IS CLOSED.

MR. CLERK: THERE ARE 18 YES VOTES, TWO NO VOTES, ONE ABSTENTION, AND FIVE NOT VOTING.

TWO NO VOTES ARE COUNCIL MEMBERS HOLLANDER AND BUTLER.

PRESIDENT YATES: THE RESOLUTION IS ADOPTED WITH ONE ABSTENTION.

MR. CLERK: THE AMENDMENT.

PRESIDENT YATES: THE AMENDMENT IS ADOPTED WITH ONE ABSTENTION.

THANK YOU.

ON THE ORDINANCE, THE RESOLUTION AS A WHOLE.

IS THERE ANY DISCUSSION?

SEEING NONE, THIS RESOLUTION ALLOWS A VOICE VOTE, UNLESS THERE IS AN OBJECTION.

ROLL CALL VOTE.

WOULD THE CLERK PLEASE OPEN THE VOTING?

WITHOUT OBJECTION, THE VOTING IS CLOSING.

THE VOTING IS CLOSED.

MR. CLERK: THERE ARE 18 YES VOTES, TWO NO VOTES, ONE ABSTENTION, AND FIVE NOT VOTING.

THIS WAS IN THE BUDGET COMMITTEE AND PASSED UNANIMOUSLY.

IT IS NOW ON OLD BUSINESS TO ALLOW ABSTENTION.

PRESIDENT YATES: FOR THE REASONS STATED BEFORE, OUT OF AN ABUNDANCE OF CAUTION, IF ANYONE THINKS BY ANY STRETCH OF THE IMAGINATION THAT I HAVE A CONFLICT, I WILL BE ABSTAINING.

COUNCIL MEMBER HAMILTON.

BACK TO COUNCILWOMAN BUTLER AND HAMILTON.

>> THIS IS THE YEAR-END BUDGET FOR THE FISCAL YEAR THAT ENDED JUNE 30TH, 2017.

AND WHAT THIS DOES, AFTER WE HAVE AN AUDIT BY AN OUTSIDE AUDITOR
AND WE BALANCE ALL THE BOOKS AND WE HAVE THAT CLEAN AUDIT IT COMES TO US
TO APPROVE. WHAT WE DID HERE IS WE MADE EVERYONE WHOLE IN THIS SO THAT WE
HAD A BALANCED BUDGET.

AND COUNCILWOMAN HAMILTON AND COUNCILMAN JAMES BOTH HAVE SOME OUESTIONS.

THE ADMINISTRATION ADDRESSED THIS BUT I KNOW YOU WOULD LIKE TO ASK.

PRESIDENT YATES: THANK YOU FOR EXPLAINING THAT FOR THE RECORD.

COUNCILWOMAN HAMILTON.

>> I DID ASK THIS ITEM TO BE ON OLD BUSINESS ORIGINALLY BUT I
DID GET MY OUESTION ANSWERED.

I DID WANT TO DEAL WITH THE \$1.2 MILLION LAST YEAR THAT CAME FORWARD TO BUDGET AND ASKED FOR \$1.5 MILLION IN ADDITIONAL FOR VIOLENCE REDUCTION INITIATIVES.

AS YOU RECALL LAST NOVEMBER THERE WAS A REORGANIZATION OF THE POLICE DEPARTMENT AND WE NEEDED ADDITIONAL OFFICERS.

THERE WAS ADDITIONAL MONEY PUT IN FOR THE DRUG TASK FORCE, OTHERS THAT WERE TALKED ABOUT.

AND SOME OTHER INITIATIVES WE PUT IN.

WE ASKED FOR THEM TO COME BACK AND TALK ABOUT, WHICH WE DID.

THE EXPECTED EXPENDITURES BY JUNE 30TH, AND TO INDICATE THE SUCCESS OR FAILURE OF THE \$1.5 MILLION.

SINCE THAT TIME, BECAUSE THE OVERTIME WAS SUPPOSED TO BE SPENT IN THE FIRST, SECOND AND FOURTH DIVISION, WHAT WE WERE SPECIFICALLY TOLD IN THE NEIGHBORHOODS.

SINCE THAT TIME, THE YEAR-END APPROPRIATION, IT WENT ALMOST \$5 MILLION OVERBUDGET.

AND I DON'T THINK THAT IS A GOOD PRACTICE FOR US TO KEEP EXPENDING FUNDS WITHOUT KNOWING WHAT IS GOING ON.

NOT TO BE COMING AND LETTING US KNOW AND CHECKING IN.

IF WE LOOK AT THE NUMBERS THAT WE WERE SUPPOSED TO HAVE RESULTS REGARDING THE REDUCTION OF VIOLENT CRIMES AND THOSE CONDITIONS.

WE HAVE 108 HOMICIDE FOR THIS CALENDAR YEAR.

93 OF THOSE HAVE BEEN IN THE FIRST, SECOND, AND FOURTH -- I CAN LOOK AT THE NUMBERS SINCE REORGANIZATION.

AND TO DATE LAST NOVEMBER -- SO I'M NOT THINKING THAT WE ARE JUST THROWING MONEY AT THE PROBLEM AND IT HAS BEEN ENOUGH.

AND WE HAVE SEEN THROUGH THE NEWS MEDIA THERE HAVE BEEN SEVERAL PEOPLE WHO HAVE ABUSED THE OVERTIME PRIVILEGES.

I KNOW WHEN WE HAVE PUBLIC WORKS AND THEY SPEND MONEY, BECAUSE THEY HAVE TO FOR OVERTIME BECAUSE WE DON'T KNOW WHAT IS GOING TO HAPPEN WITH SNOWSTORMS OR ANYTHING.

THEY GO WITH THE BUDGET.

BUT THIS KIND WENT UNCHECKED AND I DON'T BELIEVE WE CAN GO

ANOTHER YEAR NOR WITH THE EXPENSES WE WILL HAVE NEXT YEAR WITH PENSION AND

OTHER COSTS.

IT WILL BE A LEAN YEAR.

AND SO I JUST WANTED TO SEND A MESSAGE TO LMPD THAT THEY CAN'T JUST DO THIS.

AND THEY HAVE TO COME BACK AND REPORT.

AND I WOULD LIKE, AND I DID GET A BREAK DOWN OF ALL EIGHT DIVISIONS, HOW OVERTIME WAS SPENT.

- I JUST GOT THAT THIS AFTERNOON.
- I HAVE NOT HAD A CHANCE TO LOOK AT IT.

BUT I THINK THERE WERE OTHER STRATEGIES THAT COULD BE ADDRESSED AND I THINK WE HAVE TO RELY ON THOSE AS WELL.

PRESIDENT YATES: THANK YOU, COUNCILWOMAN.

COUNCILMAN JAMES.
