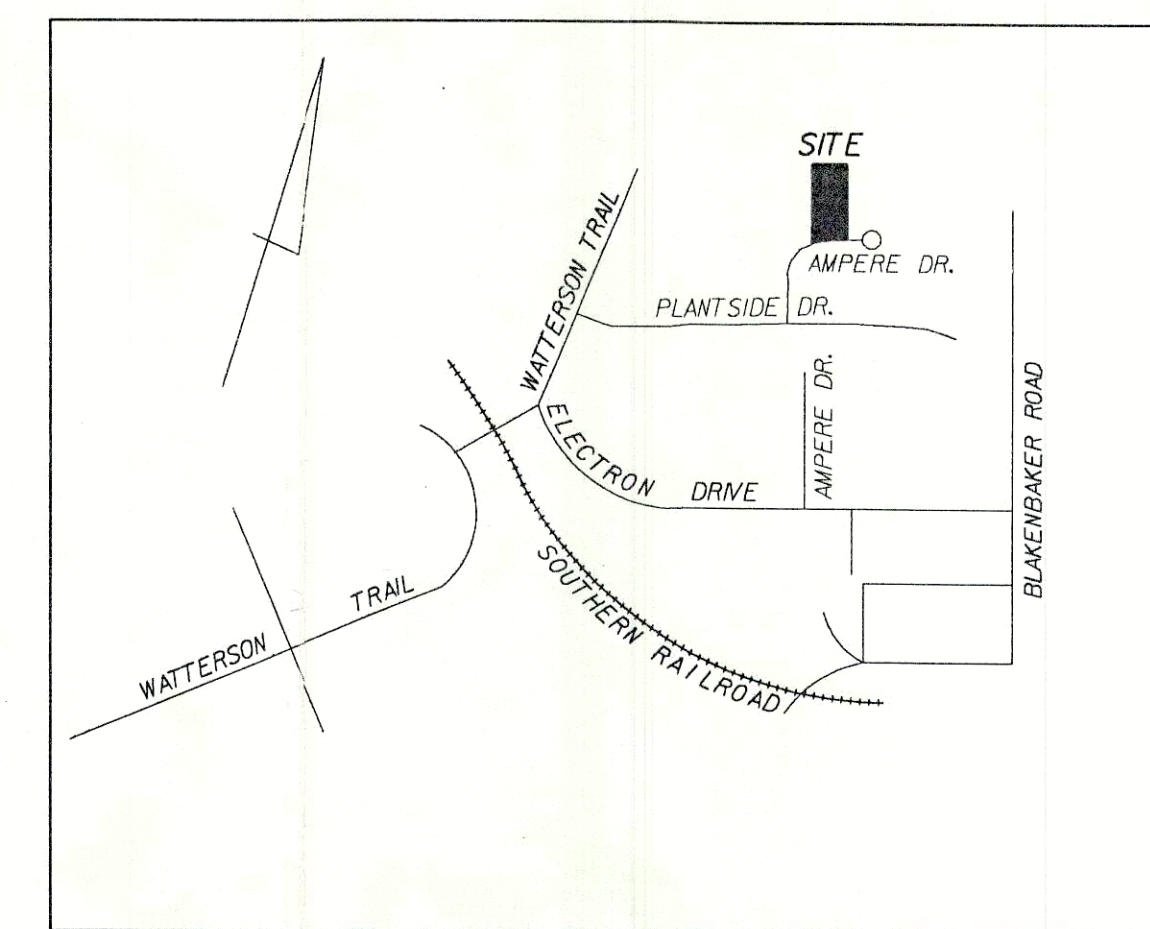
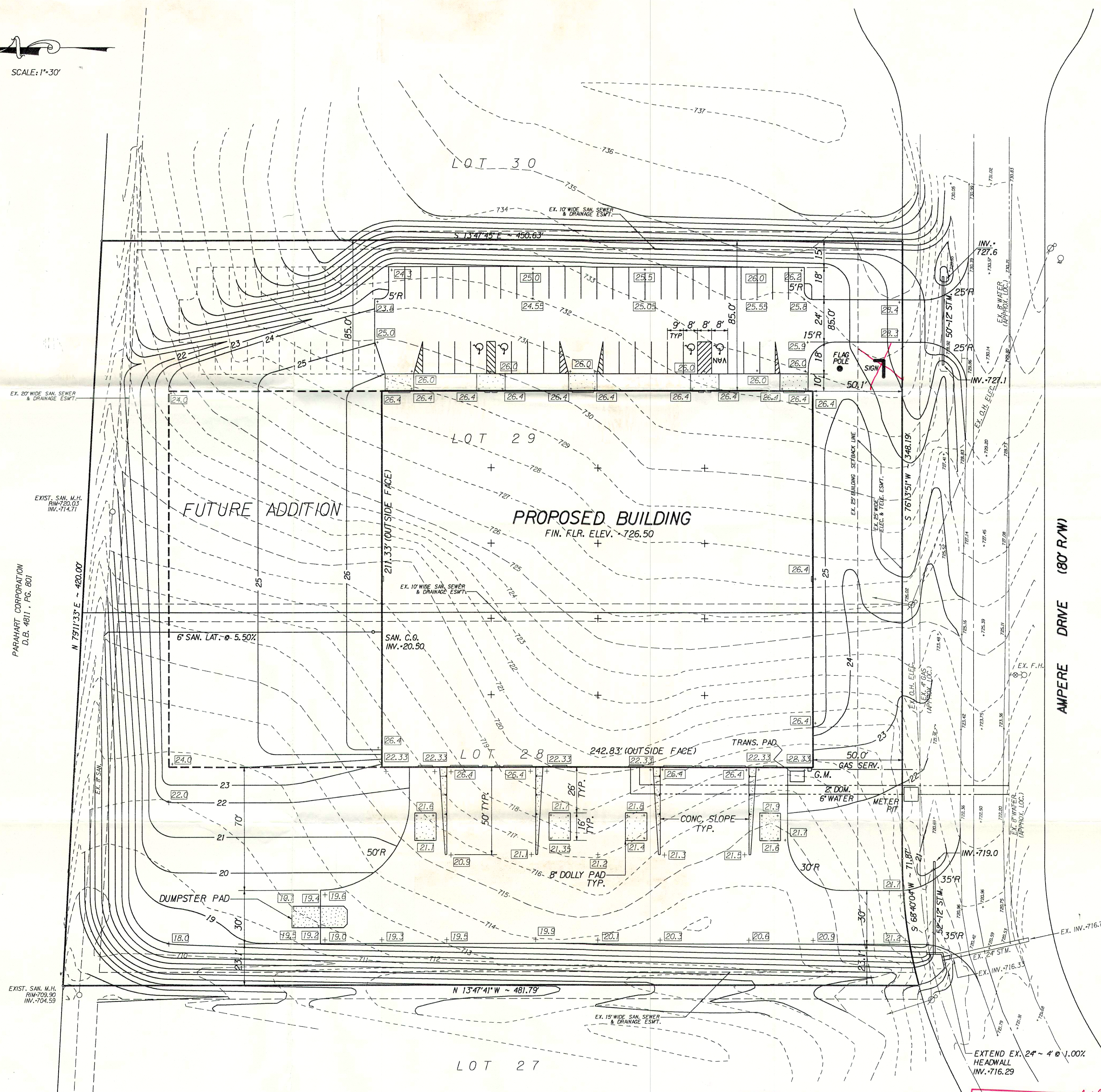
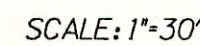


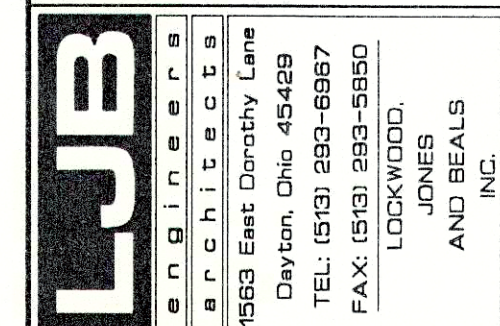


LOCATION MAP
