Neighbor Tom Hall came to the meeting in order to express his dislike of vacation rentals and his concerns with having one on his street.

Mr. Hall voiced concerns that the renters are anonymous and not invested in the neighborhood. We assured Mr. Hall that we also care about our home and neighborhood and that we will carefully select our renters through Airbnb based on the reviews of other hosts. In addition we will charge a security deposit insuring that the guests have a financial investment in maintaining the beauty of our property and neighborhood.

Mr. Hall voiced concerns that there will be "frat parties" at the residence, noise issues, and large groups of rowdy individuals staying in the home. We responded that our maximum occupancy is 8 people, that is the most guests we will have at any given time. Our listing rules will include a NO PARTIES rule, a NO ILLEGAL ACTIVITY WHATSOEVER rule, and an agreement that if the police are called and the complaint is valid, the guests must leave the property immediately and will receive no refund. Our guests will have to digitally "agree" to these terms before they book with us.

We gave Mr. Hall our business cards with our personal numbers, and asked that he give us a call if he had any further questions or issues he would like to discuss.
