One staff member or Commissioner of the Louisville Metro Planning Commission (one year initial term). 3. One architect or landscape architect (one year initial term). 4. One member of the Mayor's Committee on Public Amenities (two year initial term). 5. One representative of the Board of the Downtown Development Corporation (two year initial term). 6. One resident of the NuLu Review Overlay District (two year initial term). 7. One representative of the Phoenix Hill Neighborhood Association (three year initial term). 8. One Representative of the Butchertown Neighborhood Association (three year initial term). 9. One representative of the NuLu Business Association (three year initial term).
