AND I HOPE AND PRAY IT SHOWS YOU HOW URGENT THIS BILL NEEDS TO BE PASSED, LEGALIZED MEDICAL CANNABIS.

I KNOW YOU HAVE HEARD ABOUT HOW THE ECONOMY WOULD BENEFIT, PATIENTS WITH CHRONIC ILLNESSES AND DISEASES.

ALL OF US COULD BENEFIT FROM THIS.

YOU HAVE HEARD ABOUT THE OVERDOSES.

AND LET'S NOT KID OURSELVES.

THERE HAVE BEEN MANY AND THE NUMBERS ARE STILL GROWING.

ALSO THE AMOUNT OF HOMELESSNESS.

OUR JAILS ARE OVERCROWDED WITH PATIENTS WHO ARE LOCKED UP FOR POSSESSION OF A PLANT.

IT IS INSANE.

WE CAN ALSO COMPARE THE STATS BETWEEN ALCOHOL AND OTHER DANGEROUS DRUGS.

AND JUST FYI, THIS IS STAGGERING TO ME, EVERY 19 MINUTES SOMEONE DIES FROM A PRESCRIPTION OVERDOSE.

THAT IS STAGGERING TO ME.

SO IF YOU ARE AGAINST THIS, OR IF YOU ARE ON THE FENCE ABOUT IT,

MAY I PLEASE SUGGEST YOU GO VISIT -- OR GO TO THE RECOVERY CENTER AT THE

VA OR KOSAIR AND WITNESS A CHILD THAT HAS SEIZURES.

SEE THESE PEOPLE OR THEIR FAMILY OR SEE THEIR PAINS.

ASK THEM HOW WOULD THEY FEEL ABOUT LEGALIZING CANNABIS.

I BELIEVE WE ALL HAVE THE CHOICE TO MEDICATE OURSELVES AS WE SEE FIT.

THIS IS A HUMAN RIGHTS ISSUE, PERIOD.

NOT ONLY HAVE I WITNESSED MANY FAMILIES AND FRIENDS SUFFER, EVEN PASS AWAY FROM DISEASE, CHRONIC ILLNESSES, DEPRESSION, THE LIST GOES ON, I TOO SUFFER.

I BATTLE WITH FIBROMYALGIA, DEPRESSION, ANXIETY AND OTHER ARTHRITIC CONDITIONS.

IT TOOK A LOT TO GET HERE TONIGHT. BUT THIS MEANT THE WORLD TO ME AND THAT IS WHY I'M HERE.

I WANT YOU TO HEAR ME.

I WANT TO TELL YOU ABOUT MY PRECIOUS MOTHER WHO NEVER SMOKED, NEVER DRANK, NEVER DID DRUGS.

THE ONLY ADDICTION SHE EVER HAD WAS LOVE FOR EVERYONE.

SHE GOT BREAST CANCER IN 2013 AND BEAT IT WITHOUT PAIN MEDS.

SHE WAS THE STRONGEST WOMAN I EVER KNEW.

SADLY THE CANCER CAME BACK WITH A VENGEANCE ON MOTHER'S DAY IN 2016 I WAS WITH HER AND WE GOT THE NEWS THAT IT HAD METASTASIZED TO HER BRAIN AND HER LUNGS.

AND THEN A COUPLE MONTHS LATER SHE BROKE A FEMUR BONE AND IT SPREAD TO HER BONES WHICH LED TO HER DEATH.

IT WAS LESS THAN SIX MONTHS FROM THE DIAGNOSIS.

SHE WOULD HAVE BEEN 65 THE FOLLOWING MONTH.

I HAVE NEVER SEEN MY MOTHER SUFFER SO MUCH IN MY LIFE.

REFUSED PAIN MEDS AGAIN EXCEPT TYLENOL AND ALEVE.

THEN SHE TOOK THE PAIN MEDS.

AND OF COURSE, THEY CAUSE SIDE EFFECTS, LOSS OF APPETITE, WHICH WEAKENED HER SYSTEM MORE AND EVENTUALLY LED TO HER DEATH.

BUT I KNOW THAT CANNABIS COULD HAVE HELPED HER EVEN IF IT WAS HER TIME TO PASS, WOULD HAVE HELPED HER WITH HER APPETITE, PAIN.

TO ME THAT IS QUALITY OF LIFE.

ON A REAL QUICK NOTE I JUST WANT TO MENTION THAT OUR VETS ARE GETTING SHUT OUT OF FRANKFORT.

WE ARE GETTING SHUT OUT BY SENATOR ALBERT ROBINSON.

HE HAS CANCELED THE LAST THREE MEETINGS IN OCTOBER.

IF ANY OF YOU KIND OF ANY KIND OF LEEWAY WITH THIS MAN TO LET OUR VETERANS SPEAK TO ME, THEY REALLY NEED THIS PASSED.

THEY WANT MEDICAL CANNABIS ALL THE WAY AROUND THE BOARD.

TO BE ABLE TO GROW IT AND USE IT.

I THANK YOU GUYS SO MUCH FOR YOUR TIME AND YOUR CONSIDERATION AND EVERY BIT OF THIS.

>> GOOD EVENING.

MY NAME IS MIKE K. AND I'M A MEMBER OF ST. JOHN PAUL THE SECOND THE CHURCH, A 24-YEAR MEMBER OF CLOUT LOCATED IN COUNCIL MEMBER ACKERSON'S 26TH DISTRICT AND I LIVE IN COUNCIL MEMBER COAN'S DISTRICT EIGHT IN THE UPPER HIGHLAND NEIGHBORHOOD.

WE ALL KNOW THAT THIS PAST YEAR WE SECURED THE NEARLY \$10 MILLION FUNDING MARK IN THE AFFORDABLE HOUSING TRUST FUND AFTER EIGHT YEARS OF VERY LIMITED FUNDING.

IT WAS BECAUSE OF THIS COUNCIL'S REPRESENTATIVE, YOUR BOLD LEADERSHIP, THAT WE FOR THE FIRST TIME HIT THIS BENCHMARK.

THAT LEADERSHIP WAS CARRIED OUT FURTHER BY THE LOUISVILLE

AFFORDABLE HOUSING TRUST FUND IN FUNDING A VARIETY OF INCREDIBLE PROJECTS

THAT WILL TRANSFORM THIS COMMUNITY.

WE HAVE SEEN LEADERSHIP FROM DEVELOPERS STEPPING UP WITH CREATIVE AND TRANSFORMATIVE PROJECTS.

A PERFECT EXAMPLE WAS EXHIBITED THIS PAST DECEMBER WHEN NEW DIRECTIONS HOUSING CORPORATION PARTNERED WITH RIVER CITY HOUSING TO PURCHASE AND FIX UP A NUMBER OF HOMES IN THE SHELBY PARK NEIGHBORHOOD THAT HAD BEEN LEFT VACANT AND ABANDONED FOR YEARS.

28% OF THE FUNDING FOR THAT PROJECT WILL COME FROM THE LOUISVILLE AFFORDABLE HOUSING TRUST FUND UNDER THE EXECUTIVE LEADERSHIP OF DIRECTOR CHRISTIE MCGRAVY.

THE INVESTMENT IN OUR SHELBY PARK NEIGHBORHOOD WILL LEAD TO EVENTUALLY IMPROVEMENTS IN THESE PROPERTY VALUES AND THOSE OF NEIGHBORING RESIDENCES, IMPROVED NEIGHBORHOOD SAFETY, AND IN THE PROCESS THE CITY WILL COLLECT THOUSANDS OF DOLLARS IN UNPAID FEES AND BACK TAXES.

PROJECTS LIKE THIS THAT CAN ONLY BE UNIQUELY AND FLEXIBLY FUNDED THROUGH THE LOUISVILLE AFFORDABLE HOUSING TRUST FUND NOT ONLY PROVIDE SAFE, DECENT, AFFORDABLE PLACES FOR FAMILIES IN OUR COMMUNITY TO LIVE, BUT THEY HELP IMPROVE AND BUILD UP OUR NEIGHBORHOODS.

WE NEED THIS KIND OF DEVELOPMENT.

SAFE, DECENT, AND AFFORDABLE AND FAIR HOUSING IN ALL PARTS OF THE LOUISVILLE METRO.

THIS DEVELOPMENT, THIS INVESTMENT, AND YOUR LEADERSHIP MUST CONTINUE AND GROW.

IT TOOK BOLD LEADERSHIP TO GET US TO THE FIRST YEAR OF FULL FUNDING AND IN THESE UNCERTAIN BUDGET TIMES IT WILL TAKE EVEN BOLDER LEADERSHIP TO KEEP IT THERE.

BUT THAT IS WHAT WE ARE ASKING FOR.

TO AGAIN FULLY FUND AND AGAIN KEEP THE \$10 MILLION BUDGET
ALLOCATION INVESTMENT IN THE 2019 FISCAL YEAR BUDGET, AND TO TAKE STEPS TO
FUNDING AND FINDING AND IMPLEMENTING A DEDICATED FUNDING SOURCE.

KEEP INVESTING IN OUR COMMUNITY.

>> LOVE I BELIEVE IS REALIZED THROUGH OUR CHOICE AND ACTIONS.

LOVE REQUIRES US TO SEE BEYOND OURSELF AND IS SEE THE NEEDS AND SUFFERING OF OTHERS.

IT REQUIRES US TO RECOGNIZE THE POWER WE HAVE TO AMELIORATE THE SUFFERING OF OTHERS AND TO CHOOSE TO ACT IN WAYS TO PROMOTE THEIR WELL-BEING.

I BELIEVE THAT YOU, THE METRO COUNCIL, OFTEN HAVE WRESTLED WITH DIFFICULT DECISIONS ON WHAT CAN DO THE MOST GOOD TO THE MOST AMOUNT OF PEOPLE.

I BELIEVE THAT ONE ACTION YOU HAVE TAKEN IS TO FUND MORE FULLY
THE AFFORDABLE HOUSING TRUST FUND THIS PAST YEAR.

LOVE, HOWEVER, REQUIRES MORE THAN GOOD INTENTIONS.

IT REQUIRES US TO BE OBSERVANT ABOUT THE EXTENT OF OUR ACTIONS SO WE KNOW HOW BEST TO PROCEED TO PROMOTE THE WELFARE OF OTHERS.

MY NAME IS TOM P. AND I'M A HOUSING COUNSELOR.

I'M HERE TO TELL YOU ABOUT SOME OF THE WAYS BY WHICH YOUR LOVING INTENTIONS WERE REALIZED THIS PAST YEAR.

MY POSITION IS PARTIALLY FUNDED BY A GRANT RECEIVED FROM THE AFFORDABLE HOUSING TRUST FUND.

AS SUCH I HAVE THE DISTINCT PRIVILEGE OF TRYING TO BE AN INSTRUMENT OF YOUR LOVING INTENTION THROUGH MY OCCUPATION.

THE FUNDS YOU PROVIDED LAST YEAR ENABLED ME TO HAVE OVER 3,400 CONVERSATIONS WITH AT LEAST 533 SEPARATE MEN ABOUT HOW TO MOVE OUT OF THE OVERWHELMING SENSE OF LOSS, GRIEF, SUFFERING, AND DESPAIR THAT COMES FROM NOT HAVING A PLACE TO CALL HOME.

TO BEGIN TO LIVE INTO HOPE AND TAKE ACTIONS FOR FINDING A NEW HOME FOR THEMSELVES AND SOMETIMES FOR FAMILIES.

YOU ENABLED ME TO MAKE 395 REFERRALS FOR THESE MEN TO GET CONNECTED WITH HOUSING RESOURCES.

YOU ENABLED ME TO HELP THESE MEN PUT IN 247 SEPARATE HOUSING APPLICATIONS.

YOU ENABLED 211 MEN TO REALIZE THE JOY, STABILITY, AND WELL-BEING THAT COMES FROM HAVING A PLACE TO CALL HOME.

YES, AND IT IS YOUR CHOICE TO INCREASE THE FUNDING FOR THE AFFORDABLE HOUSING TRUST FUND LAST YEAR.

LOVE WAS COMPLETELY REALIZED BY ENABLING AT LEAST 211 HOMELESS MEN TO MOVE INTO A NEW HOME FROM WHICH THEY COULD BEGIN TO REBUILD THEIR LIVES AND DREAM A NEW DREAM.

I WANTED YOU TO KNOW WHAT A PROFOUNDLY BENEFICIAL EFFECT YOUR CHOICE HAS FOR JOHNNY, BRIAN, RICHARD, KURT, AND AT LEAST 200 OTHER MEMBERS.

I WISH YOU COULD KNOW HOW PROFOUNDLY BENEFICIAL YOUR HELP HAS BEEN.

THANK YOU FOR CHOOSING TO PRACTICE LOVE IN THIS PLACE.

THANK YOU FOR HAVING AFFECTED THE LIVES OF THESE MEN.

I INVITE YOU TO CHOOSE AND CONTINUE TO PRACTICE LOVING KINDNESS BY DEDICATING ONGOING RENEWABLE FUNDING FOR THE AFFORDABLE HOUSING TRUST FUND.

AFFORDABLE HOUSING IS THE SOLUTION TO HOMELESSNESS.

BUT IT WILL ONLY BE REALIZED IF DEVELOPERS CAN DEPEND ON THIS FUNDING.

I KNOW THROUGH THE EXPERIENCES I HAVE HAD IN MY PRIVILEGED POSITION THAT PROVIDING SUCH FUNDING WILL MAKE A GREAT DIFFERENCE YEAR

AFTER YEAR FOR PEOPLE LIKE BOB, WILLY, LAQUAN, AND DANIEL AND THE MANY
OTHERS WHO STILL NEED OUR HELP FINDING A HOME WHO STILL NEED TO KNOW THEY
ARE WORTHY RECIPIENTS OF YOUR LOVE.

MY NAME IS GINA DAVIS.

I'M A RESIDENT IN LOUISVILLE.

I AM ALSO HERE TODAY TO ENCOURAGE YOUR SUPPORT OF -- I'M A STAY

AT HOME MOM OF TWO KIDS -- I AM STANDING HERE ADVOCATING FOR -- AND ONE OF

THE THINGS IN MY LIFE THAT HAS CHANGED IS LAST FEBRUARY I WAS DIAGNOSED

WITH BREAST CANCER.

I AM ONE OF THE LUCKY ONES IN THAT THEY CAUGHT IT EARLY.

ONE OF THE RESULTS IS I HAVE A CONDITION NOW THAT IS CALLED NEUROPLASTICITY, CHRONIC NERVE PAIN.

I AM GIVEN MEDICATION TO HELP WITH THIS TO MANAGE THE PAIN.

I CURRENTLY HAVE A LIST OF MEDICATIONS THAT I'M PRESCRIBED, OXYCODONE, MUSCLE RELAXERS, ALSO CLONAZEPAM BECAUSE I TRY TO KEEP IT TOGETHER.

AND ALSO --

THERE WAS ONE PARTICULARLY BAD DAY -- I FORGOT I ALSO TAKE PILLS FOR NAUSEA.

THERE WAS ONE PARTICULARLY BAD DAY WHERE I COULD NOT MANAGE.

-- -- I THINK THE MISCONCEPTION WITH MARIJUANA IS THAT PEOPLE ARE TRYING TO -- THAT THEY ARE JUST TRYING TO GET HIGH.

I'M TELLING YOU PEOPLE LIKE ME CAN GET HIGH ALL THEY WANT -- WE HAVE CANCER.

AND IT IS REALLY THE OPPOSITE.

- I AM TERRIFIED OF THIS.
- I AM TERRIFIED OF BECOMING ADDICTED.
- I COULD NOT TOLERATE OPIOIDS.

AND I HAVE A NINE-YEAR-OLD AND A FOUR-YEAR-OLD.

SO WHAT I WANT AS AN OPTION FOR PAIN RELIEF THAT WILL NOT LEAVE ME INCAPACITATED FOR WORK.

I WANT TO CONSOLIDATE MY MEDICATIONS SO I'M NOT TAKING A HANDFUL OF PILLS A DAY.

BECAUSE RIGHT NOW I REALLY ONLY HAVE THREE OPTIONS.

I CAN TAKE THE PRESCRIBED MEDICINE, AND MY DAY IS EFFECTIVELY OVER.

I CAN TOUGH IT OUT, PRETTY MUCH MOST DAYS, BECAUSE I CAN'T TAKE
THE DAY-TO-DAY STUFFMENT OR I CAN PLAN ON MOVING, WHICH IS SOMETHING THAT
MY FAMILY HAS LEGITIMATELY THOUGHT ABOUT DOING, WHICH KIND OF BREAKS OUR
HEARTS BECAUSE BOTH OF OUR FAMILIES ARE FROM HERE, WE HAVE RAISED KIDS
HERE.

WE DON'T WANT TO MOVE.

AND WE WANT TO BE TAKEN CARE OF OUR HOME, NEIGHBORHOODS, CHURCHES, SCHOOLS.

AND I THINK THE MEDICAL COMMUNITY IS BEHIND THIS.

THE SCIENCE BACKS IT UP.

AND I THINK LOUISVILLE WILL SUPPORT IT.

AND I HOPE YOU SUPPORT IT AS WELL.

I REALLY APPRECIATE YOU TAKING THE TIME AND I THANK YOU FOR LETTING ME SPEAK ON THIS MATTER.

THANK YOU.

SO WITH US THIS EVENING, SANKARA AND IAN.

IF YOU COULD JOIN US, PLEASE.

TO LOUISVILLE METRO COUNCIL, TO WHOM ALL THESE LETTERS SHALL COME, GREETINGS.

KNOW YE THAT THE LOUISVILLE METRO COUNCIL HEREBY HONORS THE OPERA.

WHEREAS, OH FREEDOM, THE TOUR -- BY CELEBRATING AFRICAN-AMERICANS FROM PRESLAVERY TO MODERN TIMES.

OH, FREEDOM, TAKES ALL AUDIENCES THROUGH THE CULTURE OF AFRICAN-AMERICANS.

AND WHEREAS THE JOURNEY BEGINS IN AFRICA AND FOLLOWS THE CHRONOLOGICAL PATH THROUGH THE MIDDLE PASSAGE FROM SLAVERY TO THE CIVIL RIGHTS AND FINALLY TO THE ELECTION OF THE FIRST AFRICAN-AMERICAN PRESIDENT OF THE UNITED STATES.

AUDIENCE WILL LEARN HOW THE DRUM SONG OF WEST AFRICA BECAME THE CALL AND RESPONSE SONGS OF SLAVERY AND HOW CODES WERE HIDDEN IN THE SONG TO HELP THE SLAVES TO FREEDOM.

AND WHEREAS THE JOURNEY CONTINUES THROUGH NEW YORK AND THE HARLEM RENAISSANCE AS WELL AS THE WORLD OF OPERA WITH GERSHWIN'S LIFE AND DEATH.

RECOGNIZES THE LIFE OF THE GREAT AFRICAN-AMERICAN OPERA STAR MARION ANDERSON AND HER ROLE IN THE CIVIL RIGHTS MOVEMENT AND HONORS DR. MARTIN LUTHER KING AND THE JOURNEY THROUGH MODERN DAY.

DONE THIS DAY IN LOUISVILLE, KENTUCKY.

THE 22ND DAY OF FEBRUARY, YOUR COUNCILWOMAN, BARBARA SEXTON SMITH.

SINCE IT IS CUSTOMARY TO MAKE A SPEECH, IAN HAS GRACIOUSLY GIVEN UP HIS TIME SO A YOUNG MAN WHO IS FROM WEST AFRICA AND NOW LIVES IN FRANKFORT AND IS BECOMING A WORLD RENOWNED OPERA STAR IN HIS OWN RIGHT, SANKARA HAROUNA WILL PERFORM ONE OF THE CALL AND RESPONSES FROM OH, FREEDOM.

SANKARA, THE STAGE IS YOURS.

AND ESPECIALLY HOW THIS TURNED OUT GOING FROM DIXIE HIGHWAY --

I SEE FOR THINGS LIKE THIS -- I THINK THERE WERE -- THANK YOU.

>> PRESIDENT JAMES: THANK YOU.

COUNCILWOMAN FLOOD.

- >> MY MOM AND DAD WOULD SAY WHEN THE STREET LIGHTS COME ON AND THEN YOU ARE SUPPOSED TO COME HOME.
- >> MR. PRESIDENT, MY INTENT WAS SIMPLY TO ESTABLISH WHETHER OR NOT WE OPERATE -- IF THESE ARE DONE BEFORE IN ANOTHER DISTRICT.
  - >> PRESIDENT JAMES: TOTALLY UNDERSTAND. COUNCILMAN YATES.
- >> I'M SORRY. I DIDN'T ATTEND THE MEETING. I WAS AT THE HOSPITAL WITH MY MOTHER. THAT IS WHY I'M HAVING TO LOOK AT THE BINDING ELEMENTS.
- >> PRESIDENT JAMES: COUNCILMAN YATES, WHILE SHE IS DOING THAT,
  COULD YOU PLEASE PROVIDE US WITH SOME INFORMATION ABOUT THE PROJECT?
- >> THE KENTUCKY FORD TRUCK PLANT ON CHAMBERLAIN LANE IS IN COUNCILMAN STUCKEL'S LANE. THEY PRODUCE THE FINEST LARGE TRUCKS IN THE WORLD. THIS IS KNOWN AS THE LARGEST REGION OF FORD MOTOR COMPANY HERE IN LOUISVILLE, KENTUCKY, WHICH IS ACCOMPANIED BY THE FERN VALLEY ROAD TRUCK PLANT AS WELL. - >> YOU'LL JUST HAVE TO GO THROUGH THE RECORD. I WOULD HAVE TO GO THROUGH THE WHOLE RECORD SINCE I WASN'T AT THE COMMITTEE MEETING.
  - >> ALL RIGHT. COUNCILWOMAN FLOOD, THANK YOU VERY MUCH.
- >> PRESIDENT JAMES: THANK YOU. ANY FURTHER DISCUSSION? I ALL RIGHT. HEARING NONE, THIS IS AN ORDINANCE REQUIRING A ROLL CALL VOTE. WILL THE CLERK PLEASE OPEN THE VOTING? WITHOUT OBJECTION, THE VOTING IS CLOSING. AND THE VOTING IS CLOSED.

- >> PRESIDENT JAMES: MAY I HAVE A MOTION AND SECOND, PLEASE?
- >> SO MOVED.
- >> SECOND.
- >> PRESIDENT JAMES: THE AMENDED RESOLUTION IS BEFORE US. IS THERE ANY DISCUSSION? COUNCILMAN ACKERSON.
- >> THANK YOU, MR. PRESIDENT. THIS CAME OUT OF OUR

  COMMITTEE -- WHAT WE ARE TALKING ABOUT HERE -- COMING TO FRUITION. AND AS

  SUCH I WOULD YIELD THE FLOOR TO THE COUNCILWOMAN FROM DISTRICT THREE.
  - >> PRESIDENT JAMES: COUNCILWOMAN WOOLRIDGE.
- >> THANK YOU, MR. PRESIDENT. THANK YOU, COUNCILMAN ACKERSON. I
  HAVE SPOKE ABOUT PEOPLE ELECTING ON THEIR OWN AND NOT 25 OF US APPOINTING
  SOMEONE TO A SEAT. THE AMENDMENT, I MAY HAVE TO WITHDRAW. AND I THINK I AM
  GOING TO WITHDRAW MY SPONSORSHIP TO THIS. IT HAS BEEN AMENDED TO INCLUDE
  THE MAYOR. THAT WAS NOT PART OF MY INTENTION. MY INTENTION WAS THAT THIS
  BODY HERE, 26 OF US, AND WHEN ONE IS GONE, I DON'T THINK 25 OF US SHOULD
  CHOOSE OR SELECT A COUNCILPERSON TO SERVE PEOPLE. I THINK IT SHOULD BE
  PART OF A SPECIAL ELECTION. AND I HAVE, I HAVE JUMPED UP AND DOWN ABOUT

- >> MR. CLERK: SO NOTED.
- >> PRESIDENT JAMES: COUNCILMAN ACKERSON.
- >> THANK YOU, MR. PRESIDENT. YES, THIS STARTED OFF AS AN ORDINANCE OR A RESOLUTION THAT WAS GOING TO RECOMMEND THE VOTE OF THE PEOPLE WITHIN THE DISTRICT TO ELECT THEIR COUNCILPERSON VERSUS THIS BODY SELECTING FOR ANOTHER DISTRICT. IT WAS AMENDED TO INCLUDE THE MAYOR.

- >> THANK YOU, MR. PRESIDENT. I WOULD LIKE TO ENCOURAGE US TO TAKE THE STEPS TO REMOVE THE MAYOR. I THINK THOSE ARE TWO VERY, VERY

DIFFERENT THINGS, NOT JUST BECAUSE OF -- BECAUSE AT LEAST IN MY MIND THE REASON THAT REPLACING A COUNCIL PERSON WITH A SPECIAL ELECTION IS SO IMPORTANT IS I THINK BOTH EFFICIENT, BECAUSE IT IS ONLY -- NOT THAT YOU DON'T HAVE SOMEONE FROM THE DISTRICT, YOU HAVE NO ONE. - >> I WOULD LIKE TO, YES.
- >> SECOND.
- >> PRESIDENT JAMES: DO WE HAVE A SECOND?
- >> SECOND.
- >> PRESIDENT JAMES: DISCUSSION ON THE AMENDED ORDINANCE.
- >> MR. PRESIDENT JUST SO WE ARE CLEAR, THE MOTION IS TO TAKE IT BACK TO THE ORIGINAL STATE PRIOR TO WHAT WAS AMENDED IN COMMITTEE, CORRECT?
- >> PRESIDENT JAMES: CORRECT. ANY DISCUSSION ON THE AMENDMENT?
  COUNCILWOMAN GREEN.
- >> I'M IN FAVOR OF THE PEOPLE HAVING THE OPPORTUNITY -- IF WE SAY THAT -- WILL BE ABLE TO VOTE -- I THINK IT IS VERY ELITIST OF US TO SAY, HEY, TRUST US, WE HAVE IT UNDER CONTROL FOR Y'ALL. THIS BODY HAS THE OPPORTUNITY -- I THINK THAT THE WHOLE VOTING PROCESS -- THE SAME RATIONALE FOR CITY COUNCIL INDIVIDUALS AS IT WOULD BE FOR THE CITYWIDE ELECTION. THANK YOU.
- >> PRESIDENT JAMES: THANK YOU. MORE DISCUSSION UNDER THE AMENDMENT. COUNCILMAN REED.

>> THANK YOU, MR. PRESIDENT. I ALSO AGREE WITH WHAT COUNCILWOMAN GREEN JUST BECAUSE. I BELIEVE THAT I WOULD REFER THIS TO TO THE GENERAL PUBLIC TO MAKE THE DECISION RATHER THAN IN THIS BODY. I GIVE THEM A LITTLE BIT MORE CREDIT TO MAKE AN INFORMED DECISION. BUT I WOULD ALSO LIKE TO ASK, IT WAS SAID EARLIER IF WE GO BACK TO THE WAY IT WAS, WHAT IS IT THAT WE WOULD BE GOING BACK TO?

- >> PRESIDENT JAMES: COUNCILMAN ACKERSON.
- >> IF YOU CLICK ON THE DOCUMENTS ON YOUR SYSTEM, YOU'LL SEE THE ORIGINAL VERSION.
  - >> PRESIDENT JAMES: COUNCILMAN BLACKWELL.
  - >> -- --

>> SARAH MARTIN WITH THE COUNTY ATTORNEY'S OFFICE. THE CURRENT PROCESS FOR REPLACING THE SEAT OF THE MAYOR IF IT BECOMES VACANT -- LET ME SEE WHAT THAT IS. IT IS SUBSECTION 6. IF THE OFFICE OF THE MAYOR BECOMES VACANT BY REASON OF DEATH, RESIGNATION OR REMOVAL, THE DEPUTY MAYOR SHALL BECOME THE TEMPORARY MAYOR INHERITING ALL POWERS AND DUTIES OF THE MAYOR. THE DEPUTY MAYOR SHALL SERVE AS TEMPORARY MAYOR BY NO MORE THAN 30 DAYS. -- -- WHO MEETS THE QUALIFICATIONS FOR MAYOR PURSUANT TO SUBSECTION THREE TO SERVE AS MAYOR. COUNCIL MAY SELECT A TEMPORARY MAYOR. IF THE LEGISLATIVE COUNCIL FAILS TO ELECT A PERSON TO FILL THE VACANCY WITHIN 30 DAYS AFTER THE VACANCY OCCURS, THE GOVERNOR SHALL FILL THE VACANCY IN THE OFFICE BY A QUALIFIED PERSON WITH THE CONSOLIDATED LOCAL GOVERNMENT FOR QUALIFICATIONS FOR MAYOR.

EVEN FOR A SHORT PERIOD OF TIME. FOR AN AMOUNT OF MONEY THAT

TRULY I CAN SEE WHERE COUNCILMEMBER GREEN WOULD SUGGEST IT SEEMS ELITIST

ALMOST TO WORRY ABOUT THESE THINGS WE WILL TAKE CARE OF IT FOR YOU.

WE WANT YOU TO VOTE BUT LET US TAKE CARE OF THIS ONE.

>> COUNCILMEMBER BLACKWELL -- I THINK THE \$39,000 MY COLLEAGUE ELUDED TO WAS THE COST OF THE SPECIAL ELECTION IF WE HELD IT IN ONE DISTRICT.

IF WE DO IT TIMES 26 THAT PUTS THE NUMBER AT OVER \$1 MILLION, I THINK, IF MY MATH IS CORRECT.

WE ARE ADVOCATING, THAT'S A DIFFERENT ANIMAL AS WELL.

>> THANK YOU, COUNCILWOMAN FLOOD?

>> I WOULD JUST OFFER MY TWO CENTS, THE FACT THAT OUR JOBS ARE VERY DIFFERENT FROM WHAT THE MAYOR DOES.

THE MAYOR ACTUALLY IS A PERSON RESPONSIBLE FOR DAY-TO-DAY OPERATIONS OTHER THAN HIS DIRECTORS.

HE IS THE ONE ON CONTRACT FOR THE CITY, HE SIGNS, EVEN UNION CONTRACTS, THINGS COULD COME TO A SCREECHING HALT IF WE DIDN'T DO SOMETHING AND ACT AND I THINK IT'S NOT UNFAIR TO ASK US TO TAKE THAT BURDEN FOR A SHORT WHILE.

IT COULD BE THREE MONTHS, IT COULD BE NINE MONTHS, IT CERTAINLY WON'T BE OVER A YEAR BECAUSE THERE'S ALWAYS A PRIMARY AND GENERAL EXCEPT THAT ONE YEAR AND YOU MAY WAIT ONE YEAR AND FIVE MONTHS BUT IT'S STILL NOT LIKE ONE OF US BEING MISSING BUT I DON'T KNOW WHO THE MAYOR CAN GET TO SIGN HIS SIGNATURE, THANK YOU.

>> I WAS GOING TO POINT OUT THERE WAS EVERY FOUR YEARS,
FOLLOWING THE PRESIDENTIAL ELECTION, THERE ARE NO ELECTIONS THAT YEAR.

IT'S NOT ABOUT PICKING SOMEBODY WHO HOLDS TEMPORARILY, EVERY FOUR YEARS THERE'S THE POTENTIAL THAT IF SOMETHING HAPPENED WHETHER IT'S

AUGUST FIRST IF THERE'S A REPLACEMENT, THEY WOULD HOLD THAT FOR A YEAR PLUS.

I'M JUST PUTTING IT ON THE TABLE BECAUSE IT'S NOT ALWAYS A QUICK PRIMARY, NEXT GENERAL, EVERY FOUR YEARS THERE'S THE MATHEMATICAL POTENTIAL THAT IF A VACANCY WERE TO OCCUR AFTER AUGUST 1ST IN A PRESIDENTIAL ELECTION YEAR THAT PERSON WOULD BE SELECTED BY THIS BODY VERSUS THE GENERAL PUBLIC AND FOUR MONTHS.

THANK YOU MR. PRESIDENT.

- >> PRESIDENT JAMES: THANK YOU.
- >> THANK YOU, MR. PRESIDENT.

I JUST WANT TO POINT OUT WHAT WE ARE DOING IS WE ARE DEBATING A RESOLUTION THAT'S NON-BINDING.

WHEN WE SPEAK AS ONE BODY WE SEND A MESSAGE BUT RIGHT NOW IT'S OBVIOUS WE AREN'T SPEAKING AS ONE BODY.

WHAT WE ARE DOING WITH THE STATE SHOULD BE DOING.

WE HAVE A LOT OF WORK AT METRO GOVERNMENT, THERE'S A LOT OF THINGS WE COULD TAKE CARE OF.

A LOT OF THINGS WE ARE JUDICIALLY PREEMPTED FROM TOUCHING.

RIGHT NOW WE ARE WASTING TAX PAYER TIME, IT WILL BE -- WE CAN DRIVE UP THERE BIPARTISAN IN GROUPS, RIGHT NOW WE ARE IN CHAMBERS AND DEBATING A NON-BINDING RESOLUTION.

I SAY THAT IF WE CAN FIX IT, GREAT WE WILL TELL THEM TO FIX IT

BUT RIGHT NOW THERE WAS ONE SPONSOR LEFT, COUNCIL ACTION WILL WITHDRAW?

>> THAT'S COMING.

>> I WOULD HOPE WE WOULDN'T WASTE TIME DOING IT, I WORRY MY
CONSTITUENTS LOOKING AT HOME WHEN THEY SEE US DEBATING AND ARGUING THEY
WILL BELIEVE WE HAVE THE POWER TO CHANGE IT, I THINK IT'S DISINGENUOUS.

- >> WHAT WAS THE RATIONALE FOR INCLUDING THE MAYOR?
- >> THE RATIONALE AT THE TIME, I BELIEVE WAS ESSENTIALLY COUNCILWOMAN GREEN SUMMED UP BEST.

IF WE ARE GOING TO TRY TO EMPOWER VOTERS WE OUGHT TO MAKE THE SUGGESTION ACROSS-THE-BOARD.

IT DID COME OUT OF COMMITTEE UNANIMOUS ON THAT ISSUE, HOWEVER I SEE WHAT COUNCILMEMBER YATES IS SAYING.

IF IS NOT UNANIMOUS IT DOESN'T REALLY SEND A MESSAGE.

HE SENDS A STRONG ARGUMENT TO FALL BACK WHAT WE CAN ALL AGREE UPON.

>> ONE THING, I DON'T THINK WE ARE WASTING TIME IN HERE.

A LOT OF TIMES BUT IT SHOULDN'T BE AN EXCUSE TO NOT TALK ABOUT POTENTIALLY IMPORTANT ISSUES BECAUSE THEY ARE RESOLUTIONS.

I THINK IT'S AN OVERLY BROAD ISSUE.

WE CAN SET TIME LIMITS, BUT I DON'T REALLY WANT TO START, THAT'S THE REASON WE DON'T TALK ABOUT CERTAIN THINGS.

WE DON'T HAVE THE LUXURY OF TALKING ABOUT THINGS ON THE RECORD IN HERE, WE DON'T GET TO DO THAT OTHER TIMES AND THAT'S HOW WE DISCUSS THINGS AMONGST OURSELVES.

I JUST WANTED TO EXPLAIN MYSELF.

MY REASON FOR SUPPORTING COUNCILMEMBER BLACKWELL'S SUGGESTION

THAT WE DON'T INCLUDE THE MAYOR AND I'LL BE HAPPY TO MOVE ON WITH THIS IS

THE NATURE OF A RESIGNATION WITH A MAYOR IS INHERENTLY POLITICAL TURBULENT TIME AND I'M VERY CONCERNED ABOUT THE EXTREME COMPETITIVE ADVANTAGES THAT SOMEBODY HAS IF THEY ARE EXCEPTIONALLY WEALTHY OR WELL CONNECTED COUPLED WITH SOME KIND OF STRATEGIC WAY OF DOING THIS AND IT'S NOT JUST A FUTURE MAYOR THAT HAS A HEART ATTACK.

>> I WILL TRY TO BE BRIEF.

TALKING ABOUT ELITENESS AND ELITISM, IF WE WERE ABLE TO GET THIS PASSED, THE ONLY STATUTORY MUNICIPAL OR COUNTY TO HAVE THE AUTHORITY TO SPECIAL ELECT, NOT EVEN THE SPECIAL ASSEMBLY, IT'S IN THE KENTUCKY CONSTITUTION.

I THINK WHEN WE SPEAK WITH ONE VOICE LIKE COUNCILMEMBER YATES

SAID WE NEED TO ALL BE ON THE SAME PAGE BECAUSE I DOUBT IT WILL HAVE ANY

CHANCE WITH DIVISION BUT UNANIMOUSLY WE WOULD AGAIN BE ONE OF 120 COUNTIES

OR 400 CITIES WOULD HAVE ANYTHING REMOTELY LIKE THIS.

THE 82 CITIES THAT SIT WITHIN OUR BORDERS DON'T HAVE ANYTHING LIKE IT SO I THINK WE NEED TO BE MINDFUL BEFORE ASKING THEM TO PASS AND CONSIDER OUR UNIQUENESS, THANK YOU.

>> COUNCILWOMAN WOOLRIDGE?

- >> THANK YOU, MR. PRESIDENT.
- I WOULD JUST LIKE TO SAY, WHEN I FIRST THOUGHT ABOUT THIS, WHEN WE HAVE TO APPOINT SOMEONE TO THIS METRO COUNCIL, IT DIVIDES THIS COUNCIL.
- I WANT THIS PERSON, SOMEBODY WANTS THE OTHER PERSON, IT'S A DIVISION, IT JUST TAKES US A WHILE TO COME BACK TOGETHER.
  - SO THAT'S WHY I SIT IN CAUCUS, IT SHOULD BE SPECIAL ELECTION.
- I STILL THINK IT SHOULD BE A SPECIAL ELECTION BUT ONLY FOR THAT COUNCILMEMBER, NOT FOR THE MAYOR AND JUST HAD A SPECIAL ELECTION I'M THINKING SHEPHERDS VILLE OR A COUPLE DAYS OR SO AGO.
  - I THINK THAT'S HOW THE PROCESS SHOULD WORK.
- AND THE ONLY REASON I WANTED TO BE A PRIMARY SPONSOR OF THIS RESOLUTION WHICH IS NOT A LAW, AND I UNDERSTAND THAT BECAUSE THERE WAS A HOUSE BILL ENTERED, I THINK HOUSE BILL 93.

  - >> ROLL CALL, MR. CLERK, PLEASE.
  - >> THIS IS FOR CALLING THE QUESTION.
