SECTION I: The sum of \$16,050\frac{16,800\\$20,000}{16,800\\$20,000} is hereby appropriated from Neighborhood Development Funds in the following manner: \$3,000 from District 4; \$2,000 from District 24; \$1,000 each from Districts 9, 10, 11, 12, 14, 15, and 16, and 17; \$750 each from Districts 1 and 6; \$500 each from Districts 2, 3, 7, 8, 13, \frac{14, 17, 21}{22}, \frac{22}{22}, \frac{24}{22}, \frac{25}{22}, \f

SECTION II: The Council has determined the funds requested in this Ordinance will be expended for a public purpose.

SECTION III: This grant is subject to the Council's Policies and Procedures as adopted and effective at the date of passage of this Ordinance.

SECTION IV: This Ordinance shall take effect upon its passage and approval.
