AN ORDINANCE APPROPRIATING <u>\$24,000</u> <u>\$26,000</u> FROM NEIGHBORHOOD DEVELOPMENT FUNDS IN THE FOLLOWING MANNER: \$2,000 EACH FROM DISTRICTS 6, 1, 2, 4, 5, 10, 12, 14, <u>AND</u> 17, <u>AND</u> 23; \$1,500 FROM DISTRICT 20; \$1,000 EACH FROM DISTRICTS 7 AND 9; AND \$500 EACH FROM DISTRICTS 8, 13, 15, 21, AND 25; THROUGH THE OFFICE OF MANAGEMENT AND BUDGET, TO KENTUCKY SHAKESPEARE FESTIVAL, INC. FOR COSTS ASSOCIATED WITH PERFORMANCES OF SHAKESPEARE IN THE PARKS. (<u>AS AMENDED</u>)

BE IT ORDAINED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT (THE COUNCIL) AS FOLLOWS:

SECTION I: The sum of \$24,000 \$26,000 is hereby appropriated from

Neighborhood Development Funds in the following manner: \$2,000 each from

Districts 6, 1, 2, 4, 5, 10, 12, 14, and 17, and 23; \$1,500 from District 20; \$1,000

each from Districts 7 and 9; and \$500 each from Districts 8, 13, 15, 21, and 25;

through the Office of Management and Budget, to Kentucky Shakespeare Festival,

Inc. for costs associated with performances of Shakespeare in the Parks.

SECTION II: The Council has determined the funds requested in this Ordinance will be expended for a public purpose.

SECTION III: This grant is subject to the Council's Policies and Procedures as adopted and effective at the date of passage of this Ordinance.

SECTION IV: This Ordinance shall take effect upon its passage and approval.
