Good morning,

I have attached the landscape design and price estimate for the traffic island at 3400 Garland, and wanted to explain what we had in mind.

The pricing of \$750.00 per tree includes a contractor planting 4 new trees and Brightside providing the waterbag, watering and all care needed for those trees for the first three years. If you wanted to gather a few volunteers to plant the trees, the price would drop to \$500.00 per tree. I am sure we could find some volunteers to plant them if you decide to go that route.

The larger bed area along the sidewalk is planted with daffodil bulbs and a perennial groundcover. I am including a picture. It is very hardy once established, and will come back every year. The daffodil is the same bright golden yellow variety we are using as our Brightside "Signature Plant".

Those bulbs would need to be planted this coming fall.

The smaller bed area to the right is planted with a tough evergreen groundcover juniper. I have tried to provide a very low maintenance design that should naturalize and provide very little care once we get it established.


