I am requesting a Conditional Use Permit (CUP) to allow me to operate short-term rentals (e.g. AirBNB) at $1474 \, S \, 1^{st} \, St.$

I previously rented this unit to long term renters but have started doing short term rentals this year. I have had an average of three to four guests over this time. It ranges from one guest to a maximum of eight, typically from one to three days. The building is a duplex and currently has long term renters in the lower unit. When that renter leaves, I intend to convert that unit to short term rentals as well.

The impact of parking on 1st St is one area that may be a concern. The number of cars will vary much more than it did when long term renters were in the unit. However, though sometimes more vehicles will be parking, often there will be fewer, and overall I would anticipate the average to be about the same. In addition, I do have two off street parking spaces that currently are not being used

I live at $1478 \, \mathrm{S} \, 1^{\mathrm{st}} \, \mathrm{St.}$, next door to the building in question so I am always keeping a close eye on the guests. I am your neighbor and value having a fun and harmonious neighborhood as much as anyone.

As part of the CUP process, I will be hosting a meeting on Saturday, March 3rd at the Burger Boy at Brook and Burnett called Smokey's Bean, at 10:30 am. At this meeting, I'll explain my proposal and answer any questions you might have.
