

### QUORUM

A majority of the total membership of the Continission shall constitute a quorum ter the transaction of business. The affirmative vote of a majority of the members present shall be required for any action taken by the Commission.

#### **HOW APPOINTED**

Mayor appoints 10 with approval of the Council

### QUALIFICATION OF MEMBERS

Mayoral appointees must include 1 architect, 1 architect or landscape architect, 1 historian or architectural historian qualified in the filed of historic preservation, 1 registered professional archaeologist, 1 licensed real estate broker or MAI designated real estate appraiser. 1 attorney, 1 member of Mouo Area Chamber of Communes who has recognized experience in business. All must have a known interest in Local Landmarks and District Preservation.

### SUBCOMMITTEES

ARCHITECTURAL REVIEW COMMITTEE—each District has this Committee consisting of 6 members — The Director of IPL or designee, 2 Commission members appointed by Commission, 3 appointed by Commission with Council approval. No fewer than 2 members of each Committee shall be owner-residents or tanants within the District, 1 must be a real estate professional and 1 the owner of income producing property within the District. Members serve at pleasure of Commission, Quorum is 4 members.

ECONOMIC REVIEW PARIEL - established upon request for an economic hardship exemption. Composed of 3 persons with expertise in rest estate and development who are knowledgeable in real estate economics in general, 1 suitabled by Commission, 1 person selected by applicant and 1 person from recognitic review panel pool. Economic review panel consists of no less than 3 or more than 12 peoples appointed by Mayor and approved by Council
