## Edgehill Rd Description of events and timeline from May 13, 2018

- 3:23 Gant received a text from Jim, the neighbor who shared a driveway with 2122 Edgehill Rd, claiming there was a party in process next door and all parking spaces on the road were taken (presumably from "guests" at the "party")
- 3:33 Call received from neighbor that claimed to be immediately behind 2122 Edgehill Rd. She stated there might be a game of beer pong in progress. And while that is ok, she wanted us to be aware in the event a party developed later.
- 4:30 I drove past the house and sat out front to gauge the noise level. Nothing at all could be heard from the street. There was also a minimum of four parking spaces nearby.
- 5:11 Second call received from neighbor to the rear of 2122. She said she has decided to call and file a noise complaint if they did not stop the back yard party. She noted base coming from a speaker and screaming. I mentioned that I drove by less than 30 minutes prior and didn't hear anything at all. She didn't have an additional statement.
- 5:18 Guest was contacted. Everyone went inside. Neighbor confirmed all was well.
- 7:30 Gant received a text from Jim, the shared driveway neighbor, that a guest vehicle was blocking the driveway. We immediately contacted the guest, but the vehicle had already been removed. The guest stated the car was there for a few minutes for loading, which is well within our 15-minute loading/unloading policy.

The neighbor stated they were there longer, but he was returning to the house, which would indicate he sat in the street for longer than 15 minutes. We are installing a security camera for the driveway to monitor.
