Due to the emergency repairs required to be completed in the 84" Ohio River Interceptor in Main Street between 4th and 7th Streets, beginning on or after June 11, 2018, MSD shall have rights to utilize the property to establish a temporary pumping system along the north side of the property. Work will include clearing trees and shrubs as needed. The fence will be removed during installation of the piping, but will be replaced in kind when the emergency repairs have been completed and the piping removed from property. The construction period is anticipated to be 6 months.

NOW THEREFORE, in consideration of the benefits accruing to said property through improved sanitary sewer and/or storm drainage service, the parties of the first part hereby consent and agree that MSD, its agents, employees and assigns may enter and come upon the above described property for the purpose of performing the work described above and further expressly agree that the parties of the first part will assert no claim whatsoever, of any kind or type, against MSD, its agents, employees or assigns by reason of the performing of said work, but by these presents shall be forever barred except that MSD shall be liable for any damage to persons or property which results from its acts or omissions during the course of the project as it is performed on party of the first part's property and which occurs during such performance.
