#### **Request**

The Office of Vacant & Public Property Administration is seeking approval to sell the properties listed on the attached "Exhibit A" through the Real Estate Disposition Program known as "Adjacent Side Yards".

#### **Overview**

The Louisville and Jefferson County Landbank Authority, Inc. (the "Authority") owns over 400 vacant lots; many of which have been in the Authority's inventory for over a decade. Although a small portion of the total number of vacant properties collectively, these undeveloped sites pose a hindrance to strengthening neighborhoods. Even though they are non-tax revenue assets, Louisville Metro spends over \$500,000 annually to maintain these properties.

The Adjacent Side Yard Disposition Program was created to allow for the sale of city-own, vacant land to adjacent property owners. This program was adopted by the Authority on September 11, 2017 via Resolution 27, Series 2017. This resolution set a maximum square footage of 4,000 and a minimum asking price of \$1.00 for each vacant lot sold under this real estate disposition program.

#### **Program Description**

*Adjacent Side Yards*: This program allows the Applicant to purchase any unimproved land that is up to 4,000 square feet and adjacent to the property currently owned by the applicant.

Note: Applicants are required to submit proof of ownership of the adjacent property to participate.

### Staff Conclusions / Proposed Conditions of Approval

Staff recommends approval of the sale of properties listed on the attached "Exhibit A" through the Authority's Real Estate Disposition Program known as "**Adjacent Side Yards**". The following conditions are also recommended:

### Adjacent Side Yards:

- 1. The Applicants shall maintain the property in a manner consistent with the Codes and Ordinances of the Louisville/Jefferson County Metro Government.
- 2. The Applicants shall only utilize the subject property as a side yard.
- 3. The Applicants agree to pay the property taxes associated with the subject property in accordance with the guidelines established by the Louisville/Jefferson County Metro Government.
