**APPROPRIATING** AN ORDINANCE <del>\$7,425</del> \$9.050 FROM NEIGHBORHOOD DEVELOPMENT FUNDS IN THE FOLLOWING MANNER: \$2,000 FROM DISTRICT 9; \$1,200 FROM DISTRICT 8; \$850 FROM DISTRICT 10; \$725 FROM DISTRICT 4; \$575 FROM DISTRICT 7; \$350 EACH FROM DISTRICTS 2, 5, 6, 12, 13, 14, 15, 17, 25, AND 21; \$200 **FROM** DISTRICT 1; THROUGH THE OFFICE BUDGET, TO MANAGEMENT AND LOUISVILLE INDEPENDENT **BUSINESS** ALLIANCE, INC. **FOR PROGRAMMING** ASSOCIATED WITH THE TENTH (10<sup>TH</sup>) ANNUAL BUY LOCAL FAIR (AS AMENDED).

BE IT ORDAINED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT (THE COUNCIL) AS FOLLOWS:

**SECTION I:** The sum of \$7,425 \$9,050 is hereby appropriated from Neighborhood Development Funds in the following manner: \$2,000 from District 9; \$1,200 from District 8; \$850 from District 10; \$725 from District 4; \$575 from District 7; \$350 each from Districts 2, 5, 6, 12, 13, 14, 15, 17, 25, and 21; and \$200 from District 1; through the Office of Management and Budget, to Louisville Independent Business Alliance, Inc. for programming expenses associated with the Tenth (10<sup>th</sup>) Annual Buy Local Fair to be held at the Louisville Water Tower Park.

**SECTION II:** The Council has determined the funds requested in this Ordinance will be expended for a public purpose.

**SECTION III:** This grant is subject to the Council's Policies and Procedures as adopted and effective at the date of passage of this Ordinance.

**SECTION IV:** This Ordinance shall take effect upon its passage and approval.
