## BE IT ORDAINED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT (THE COUNCIL) AS FOLLOWS:

**SECTION I:** The sum of \$7,425<u>\$9,050</u>\$10,050 is hereby appropriated from

Neighborhood Development Funds in the following manner: \$2,000 from District 9;

\$1,200 from District 8; \$850 from District 10; \$725 from District 4; <u>\$575 from District 7;</u>

\$500 each from Districts 3 and 24: \$350 each from Districts 2, 5, 6, 12, 13, 14, 15, 17,

25, and 21; and \$200 from District 1; through the Office of Management and Budget, to

Louisville Independent Business Alliance, Inc. for programming expenses associated with

the Tenth (10<sup>th</sup>) Annual Buy Local Fair to be held at the Louisville Water Tower Park.

**SECTION II:** The Council has determined the funds requested in this Ordinance will be expended for a public purpose.

**SECTION III:** This grant is subject to the Council's Policies and Procedures as adopted and effective at the date of passage of this Ordinance.
