



Old 18th Street Closure Description

Tracts 1 & 2

Being a certain portion of right of way of Old 18th Street situated in the County of Jefferson, Commonwealth of Kentucky, and more particularly described as follows:

Commencing in the East line of Old Dixie Highway at the corner of the tract conveyed to Valley Station Church of God, as recorded in Deed Book 4766 Page 49, in the Office of the Clerk of Jefferson County, Kentucky; thence with the east line of Old Dixie Highway North 32°11'30" East, a distance of 215.01 feet; thence North 37°15'00" East a distance of 100.00 feet to the **True Point of Beginning**; thence along the northeastern line of Old Dixie Highway **North 29°06'32" East**, a distance of **163.95 feet** to the northern line of 18th Street; thence along the north line of 18th Street **North 62°24'10" East**, a distance of **525.94 feet** to a point in the West line of the tract conveyed to Gerald and Blanche Lawrence as recorded in Deed Book 5173 Page 440, in the Office of the Clerk of Jefferson County, Kentucky; thence crossing 18th Street **South 57°40'42" East**, a distance of **69.34 feet** to a point in the West line of East Orell Road; thence leaving East Orell Road **South 62°24'10" West**, a distance of **500.00 feet**; thence **South 53°46'36" West**, a distance of **200.00 feet** to the Point of Beginning. Containing 0.86 ACRES, more or less.

Tract 3

Being a certain portion of right of way of Old 18th Street situated in the County of Jefferson, Commonwealth of Kentucky, and more particularly described as follows:

Beginning in the East line of Old Dixie Highway at the corner of the tract conveyed to Valley Station Church of God, as recorded in Deed Book 4766 Page 49, in the Office of the Clerk of Jefferson County, Kentucky; thence with the east line of Old Dixie Highway North 32°11'30" East, a distance of 215.01 feet; thence North 37°15'00" East a distance of 100.00 feet; thence North 29°06'32" East, a distance of 163.95 feet to the northern line of 18th Street; thence with the northern line North 62°23'52" East a distance of 525.94 feet to the Southern line of a tract conveyed to Gerald Lawrence and Blanche Lawrence, as recorded in Deed Book 5173 Page 440, in the Office of the Clerk of Jefferson County, Kentucky being the True Point of Beginning; thence North 62°23'52" East, a distance of 59.41 feet to a point in the West line of East Orell Road, said point being the southwest corner of the tract conveyed to Gerald Lawrence and Blanche Lawrence as recorded in Deed Book 5173 Page 440, in the Office of the Clerk of Jefferson County, Kentucky; thence South 05°15'42" East, a distance of 64.87 feet; thence North 57°40'42" West, a distance of 69.34 feet; to the Point of Beginning. Containing 0.04 ACRES, more or less.
