- Conditional Use Permit: to allow outdoor alcohol sales in the C-1 zoning district

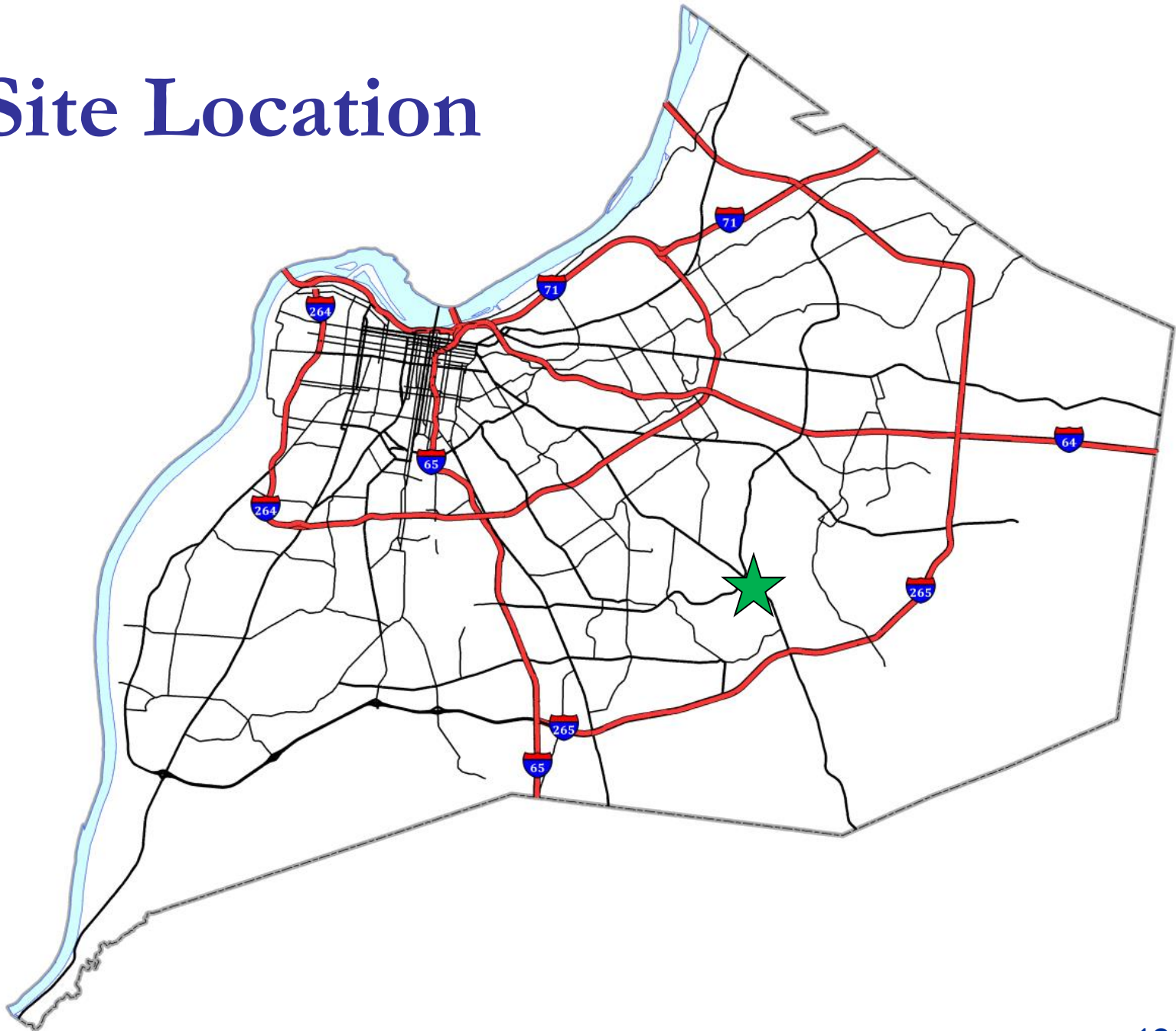
# Case Summary / Background

- The applicant proposes to sell and serve alcohol in an outdoor setting on the property.

# Site Location



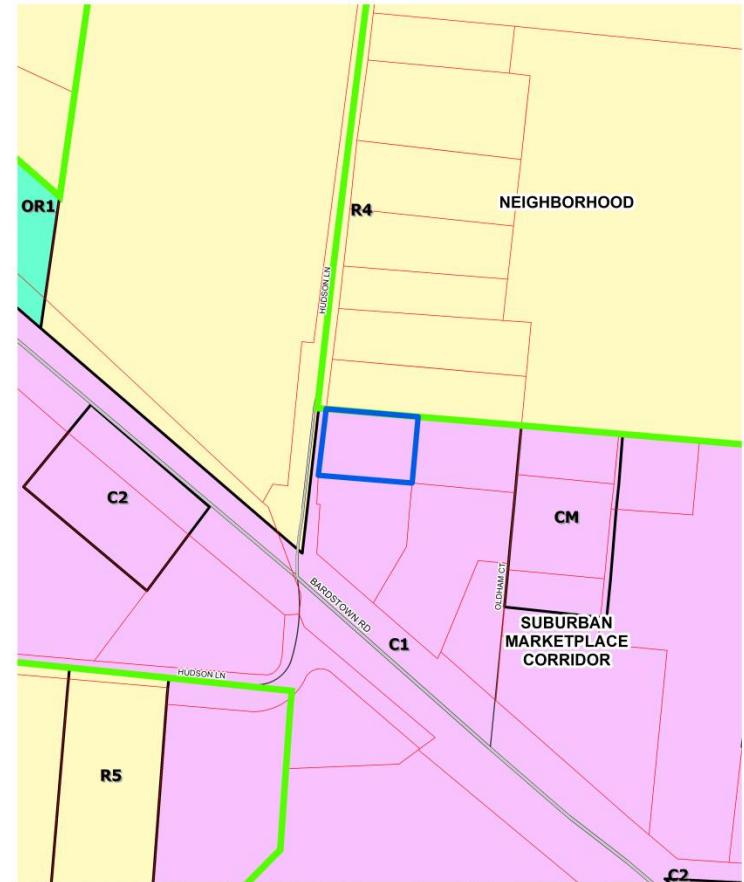

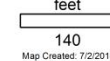
