ORDINANCE APPROPRIATING \$<del>6.250</del> \$12,750 NEIGHBORHOOD DEVELOPMENT FUNDS, IN THE FOLLOWING MANNER: \$1000 EACH FROM DISTRICTS 4, 2, 9, 12, 15, 20, AND 22; \$500 EACH FROM DISTRICTS 1, 3, 5, 7, 10, 14, 16, 17, 23, 24, AND 25; \$250 FROM DISTRICT 13; THROUGH THE OFFICE OF THE MANAGEMENT AND BUDGET, TO WATERFRONT DEVELOPMENT CORPORATION FOR COSTS ASSOCIATED WITH THE LOUISVILLE WATERFRONT 4TH OF JULY (AS AMENDED).

BE IT ORDAINED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT (THE COUNCIL) AS FOLLOWS:

SECTION I: The sum of \$6,250 \$12,750 is hereby appropriated from Neighborhood Development Funds, in the following manner: \$1000 each from Districts 4, 2, 9, 12, 15, 20, and 22; \$500 each from Districts 1, 3, 5, 7, 10, 14, 16, 17, 23, 24, and 25; \$250 from District 13; through the Office of Management and Budget, to the Waterfront Development Corporation for costs associated with the Louisville Waterfront 4<sup>th</sup> of July.

**SECTION II:** The Council has determined the funds requested in this Ordinance will be expended for a public purpose.

**SECTION III:** This grant is subject to the Council's Policies and Procedures as adopted and effective at the date of passage of this Ordinance.

SECTION IV: This Ordinance shall take effect upon its passage and approval.
