ORDINANCE NO. , SERIES 2018

AN ORDINANCE APPROPRIATING \$8,000 \$2,500 \$2,000 FROM NEIGHBORHOOD DEVELOPMENT FUNDS, IN THE FOLLOWING MANNER: \$1,000 EACH FROM DISTRICTS 2, 3, AND 21; \$500 EACH FROM DISTRICTS 4, 5, 6, 7, 9, 10, 16, 17 AND 2221; THROUGH THE OFFICE OF MANAGEMENT AND BUDGET, TO BRIDGE KIDS INTERNATIONAL, INC. FOR "OUR PLACE AT BEN WASHER PARK" FOR PHASE I OF A BUILDING RENOVATION AND IMPROVEMENT PROJECT TO INCLUDE STRUCTURAL ENGINEERING TO DETERMINE THE POSSIBILITY OF ADDING A BASEMENT STORAGE AREA FOR THE BUILDING (AS AMENDED).

BE IT ORDAINED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT (THE COUNCIL) AS FOLLOWS:

SECTION I: The sum of \$8,000 \$2,500 \$2,000 is hereby appropriated from the Neighborhood Development Funds in the following manner: \$1,000 each from Districts 2, 3, and 21; \$500 each from Districts 4, 5, 6, 7, 9, 10, 16, 17, and 2224; through the Office of Management and Budget, to Bridge Kids International, Inc. for "Our Place at Ben Washer Park" for Phase I of a building renovation and improvement project to include structural engineering to determine the possibility of adding a basement storage area for the building.

SECTION II: The Council has determined the funds requested in this Ordinance will be expended for a public purpose.

SECTION III: This grant is subject to the Council's Policies and Procedures as adopted and effective at the date of passage of this Ordinance.

SECTION IV: This Ordinance shall take effect upon its passage and approval.
