Since we're having such a hard time catching each other, I'll get it all in writing here:

- I was not aware until reviewing your neighborhood meeting invitation that your units is a condo. I understood it to be one unit of a duplex. The regulation clearly states that a condo may be used for short-term rental ONLY if it's the primary resident of the host.
- If this condo is your primary residence, you must supply minutes of a meeting of the condo association showing a vote permitting use of the units for short-term rental.

I apologize for not catching this earlier in the process! If you are able to continue with the hearing, notification to your neighbors via our postcards must be postmarked no later than Friday. That's why I mentioned the time-sensitivity. Please keep trying to call, or you can just reply to this message.
