MR. CLERK, ANY ADDRESSES TO COUNCIL?

>> PRESIDENT JAMES: LET ME REMIND THOSE ADDRESSING THE COUNCIL TO REFRAIN FROM USING PROFANITY OR MAKING DEROGATORY STATEMENTS TO THE COUNCIL.

MR. CLERK, CALL THE FIRST ONE FORWARD.

>> MR. CLERK: BECKY SWANSBURG.

TOM RECTOR?

>> CANNABIS PROHIBITION IS THE BIGGEST MISTAKE OUR GOVERNMENT HAS EVER MADE.

WE WASTED A TRILLION DOLLARS, ARRESTED 25 MILLION CITIZENS AND PERFORMED NEARLY A BILLION DRUG TESTS IN THE LAST 30 YEARS.

GOVERNMENT HAS PUNISHED ITS CITIZENS IN SO MANY WAYS, DENYING ACCESS TO COLLEGE, TAKING CHILDREN AWAY FROM THEIR PARENTS, DENYING SECOND AMENDMENT RIGHT AND FORCING PEOPLE INTO REHAB WHO DON'T NEED IT.

DESPITE ALL THIS EFFORT BY THE GOVERNMENT AT ALL LEVELS, CANNABIS IS ON THE VERGE OF BEING RELEGALIZED NATIONWIDE AND AROUND THE WORLD.

IT'S A MASSIVE MISTAKE AND WE ARE HERE TONIGHT BECAUSE WE NEED YOUR HELP TO CORRECT IT.

WE APPRECIATE YOU PASSING THE MEDICAL CANNABIS  
RESOLUTION WE BROUGHT TO YOU IN THE SPRING BUT IT DOESN'T GO  
NEARLY FAR ENOUGH.

THAT'S WHY THE CONCERNED CITIZENS HERE WITH ME TONIGHT  
ARE SUBMITTING THIS.

IT DIRECTS THE LOUISVILLE POLICE DEPARTMENT FROM  
MAKING ARRESTS UNLESS OTHER CRIMES ARE INVOLVED.

A REVIEW PROCESS.

THAT THE ORDINANCE HAS BEEN ENACTED AND REQUIRES A  
LETTER TO BE SENT TO THE PRESIDENT OF THE UNITED STATES.

SAYING LOUISVILLE IS NO LONGER ARRESTING ANYONE, THE  
PROHIBITION FAILED AND THEY AREN'T GOING TO CREATE ANY MORE  
RECORD THAT'S WILL EVENTUALLY BE EXPUNGED.

AND THE LETTER RECOMMENDS STATE, FEDERAL AND  
INTERNATIONAL LAW BE CHANGED TO REFLECT THE LAW OF THE PEOPLE.

LEGAL CANNABIS ACCESS REDUCES OPIOID MISUSE.

I WILL FOREVER BE GRATEFUL FOR THAT.

YOU SEE HE WATCHED THAT ELECTION IN INTENSIVE CARE, ANGRY AT ALL OF US BECAUSE WE WOULDN'T BRING HIM HERE.

I RETELL THIS STORY BECAUSE IT'S IMPORTANT.

IT'S IMPORTANT TO REMEMBER THE JOURNEY WE ARE ON TOGETHER.

JIM DIED AT THE AGE OF 63 YEARS OLD AT A TIME HE HAD JUST FOUND HIS STRIDE.

HE LOVED COMING HERE, WORKING HERE, MAKING A DIFFERENCE IN OUR COMMUNITY.

THIS BRINGS ME TO TONIGHT.

WE CAN MAKE A DIFFERENCE TONIGHT.

I'M ASKING FOR YOUR SUPPORT.

I AM NOW THE BOARD CHAIR FOR THE KENTUCKY INDIANA LYMPHOMA SOCIETY SOMETHING I THOUGHT WAS A ONE YEAR COMMITMENT IS NOW FOUR YEARS.

I'M HERE TO INVITE YOU TO SUPPORT US AND JOIN US FOR A WONDERFUL FAMILY EVENT OCTOBER 6th, 2018.

RECENTLY THE F.D.A. APPROVED A NEW FORM OF TREATMENT  
FOR CHILDREN WITH LEUKEMIA AND THERE'S BEEN OVER 18 NEW  
TREATMENTS APPROVED THIS YEAR BY THE F.D.A. FOR BLOOD CANCER.

IS THERE ANY DISCUSSION? COUNCILMEMBER ACKERSON?

>> THANK YOU, MR. PRESIDENT.

THIS IS A RESOLUTION THAT CAME OUT OF THE GOVERNMENT ACCOUNTABILITY COMMITTEE.

CAME OUT WITH TREMENDOUS SUPPORT.

IT WAS AMENDED IN COMMITTEE ADDING IN LANGUAGE THAT ESSENTIALLY THIS RESOLUTION IS ONE THAT IS TRYING TO CURTAIL SPENDING IN LIGHT OF SEVEN MEMBERS OF THIS COUNCIL FOR LEAVING MIDWAY THROUGH THE YEAR.

IT WAS AMENDED TO ADD IN LANGUAGE FOR THE IF-COME.

I REMEMBER WHEN I CAME TO WORK HERE SOME 22 YEARS AGO AND THE ALDERMAN SPENT ALL THE MONEY BECAUSE THE APPROPRIATIONS COMMITTEE AT THE TIME LET HIM SPEND IT, I THINK WE HAD \$1.17 WHEN WE STARTED OUT AND WE HAD TO BORROW A LEGAL PAD TO USE.

COUNCILWOMAN PARKER.

>> THANK YOU.

I HAVE A CLARIFICATION QUESTION.

I HEARD REFERENCE THERE WERE SEVEN COUNCIL PEOPLE  
LEAVING AT THE END OF THIS YEAR, AT LEAST ON THE FIRST DOCUMENT.

I DON'T SEE, THE WAY IT READS, SAYS IF A  
COUNCILMEMBER'S TERM ENDS BEFORE THE END OF THE FISCAL YEAR.

THIS IS JUST IF A COUNCILMEMBER LEAVES BEFORE THEIR  
TERM IS UP, IS THAT CORRECT? OR IS THIS FOR ANYONE NOT RUNNING  
FOR RE-ELECTION?

>> PRESIDENT JAMES: COUNCILMEMBER HOLLANDER?

>> THANK YOU, MR. PRESIDENT.

THIS IS REALLY FOR ANYONE WHOSE TERM EXPIRES.

EVERYBODY'S TERM EXPIRES EVERY FOUR YEARS.

DURING THAT YEAR YOU NEED TO LEAVE HALF OF THE FUNDING  
FOR THAT YEAR IN THE N.D.F. AND THE CALL CENTER.

>> OKAY.

>> I THINK THE REFERENCE IS THIS YEAR WE HAVE A LARGER  
NUMBER LEAVING.

IF EVERYONE'S WENT TO ZERO THAT WOULD CAUSE A PROBLEM  
FOR OUR COUNCIL ADMINISTRATIVE ACCOUNT BUT THIS WOULD APPLY TO  
EVERYBODY WHOSE TERM IS EXPIRING THAT YEAR.

>> OKAY, I JUST WANTED THAT CLARIFICATION BECAUSE I  
WASN'T SURE THE WAY IT READ VERSUS THE COMMENT THAT WAS JUST  
MADE.

I WAS THINKING IT WAS JUST, OKAY.

THAT'S FINE.

>> PRESIDENT JAMES: THANK YOU, COUNCILWOMAN HAMILTON.

>> MY ONLY COMMENT IS IN MAY SEVEN COLLEAGUES ARE LEAVING BUT THERE'S ALWAYS A NOVEMBER GENERAL ELECTION AND SOME PEOPLE IN HERE HAVE OPPONENTS SO THERE MAY BE MORE LEAVING.

AND SO KNOWING IN MAY THAT YOU GOT TO LEAVE \$37,500, AS OPPOSED TO NOVEMBER, MAKES A DIFFERENCE.

IN 15 YEARS HAS ONLY BEEN ABUSED BY A FEW PEOPLE.

I THINK IT WAS REFERRED TO AS THE SORE LOSERS RESOLUTION OR WHATEVER.

I DON'T THINK COUNCILMEMBERS SHOULD BE POLICED TO THE POINT HOW YOU SPEND YOUR FUNDS.

TONIGHT THERE WERE SEVERAL APPROPRIATIONS THAT I WOULD HAVE NORMALLY LIKED TO HAVE ADDED ON BUT I DID NOT BECAUSE I'VE GOT TO WATCH THOSE DOLLARS NOW, WHERE IT'S \$250 HERE, OR \$500 OR \$1,000.

>> PRESIDENT JAMES: THANK YOU, COUNCILWOMAN.

COUNCILWOMAN DENTON.

>> WELL, I AM LEAVING AT THE END OF THE YEAR AND MY INTENT WAS TO LEAVE AT LEAST THAT MUCH FOR MY SUCCESSOR.

I LIKE THE INTENT BUT I DON'T THINK IT'S NECESSARILY DEFINED THAT IT'S IN AN ELECTION YEAR WHEN YOU PLAN TO NOT BE, JUST MAKE IT ANY ELECTION YEAR WHETHER YOU ARE PLANNING TO LEAVE OR NOT.

BECAUSE YOU COULD LOSE YOUR ELECTION IN NOVEMBER AND MAYBE WHAT YOU DO IS YOU TALK ABOUT THIS IS ONLY AN ELECTION YEAR RATHER THAN EVERY YEAR.

BECAUSE WHAT IF YOU LEFT IN THE SECOND YEAR OF YOUR TERM IN APRIL BECAUSE YOU ARE SICK AND YOU DIDN'T INTEND TO HAVE CANCER OR WHATEVER AND THEN YOU LEAVE.

THIS LEAVES IT UP TO THE COMMITTEE TO MAKE THAT DETERMINATION.

WHILE I WOULDN'T THINK THE BODY AS ITS CONSTITUTED NOW THAT THEY WOULDN'T AGREE TO LET THAT GO, WHAT IF THERE WAS SOME MISCHIEF AFOOT AND SOMEBODY WANTED TO BE MISCHIEVOUS AND CAUSE SOMEBODY SOME GRIEF BECAUSE THEY DIDN'T LIKE THEM.

MAYBE THERE'S SOMEBODY WHO AGGRIEVED A LOT OF MEMBERS.

>> I HAVE TEXTED ALL THE SPONSORS EARLIER.

I SAID I DON'T THINK THIS IS GOING TO AFFECT ME BECAUSE I KNOW WHAT MY INTENT IS BETWEEN NOW AND DECEMBER 31ST, SO GOING FORWARD IT DOESN'T AFFECT ME BUT GOING FORWARD I WANT TO BRING IT TO THE BODY'S ATTENTION IF THAT'S SOMETHING THEY MIGHT BE CONCERNED ABOUT BECAUSE IT'S NOT GOING TO AFFECT ME.

>> PRESIDENT JAMES: MR. WOODY, WE COULDN'T HEAR WHEN YOU SPOKE EARLIER.

>> I WOULD JUST ASK THE SPONSOR ADDRESS THAT ISSUE.

>> PRESIDENT JAMES: OKAY.

THANK YOU.

COUNCILMEMBER HOLLANDER?

>> COUNCILMEMBER KRAMER WANTS TO SPEAK TO THIS TOO, I'M NOT SURE I UNDERSTAND THE POINT BUT AS I READ IT AND WHAT WAS INTENDED, IF A COUNCILMEMBER'S TERM ENDS BEFORE THE COMPLETION OF THE FISCAL YEAR, THAT WOULD NOT BE THE SITUATION WHERE SOMEONE WOULD RESIGN AND LEAVE, THEIR TERM CONTINUES ON.

I WOULD INTERPRET THIS THAT ANY TIME, THAT MEANS THE ODD-NUMBERED SEATS ARE UP FOR ELECTION IN EVEN-NUMBERED YEARS

WHEN YOUR TERM IS UP THAT YEAR YOU NEED TO ARRANGE TO HAVE AT THE END OF THE YEAR HALF OF YOUR N.D.F. AND CALL CENTER AVAILABLE TO THE NEXT PERSON.

THAT WOULDN'T APPLY THE OTHER THREE YEARS OF YOUR TERM BUT THAT'S THE YEAR YOUR TERM LEAVES.

WE DID LOOK AT THE SITUATION WHERE SOMEONE MIGHT LEAVE BECAUSE OF ILLNESS OR RESIGNATION OR SOME OTHER REASON AND FRANKLY IT GETS EXTREMELY COMPLICATED THAT CAN'T BE PLANNED.

YOU DON'T KNOW WHEN THAT'S GOING TO HAPPEN SO WE DIDN'T DEAL WITH THAT.

SO IF SOMEONE LEAVES IN THE MIDDLE OF THEIR TERM, IN MY VIEW, AT LEAST, THIS RESOLUTION WOULD NOT AFFECT THEM.

WE ARE NOT TRYING TO DEAL WITH THAT.

YOUR TERM ENDS ONE TIME EVERY FOUR YEARS.

I HOPE THAT'S RESPONSIVE.

>> AND I UNDERSTAND WHAT YOU ARE SAYING.

I'M JUST LOOKING AT THIS FROM SOMEONE COMING IN READING IT AND NOT HAVING THE KNOWLEDGE OF INTENT.

THERE'S NO DEFINITION OF TERMS.

BECAUSE THE END OF YOUR TERM SOME COULD TAKE IT TO MEAN WHENEVER YOU LEAVE YOUR TERM IS UP, EVEN THOUGH THERE'S TIME LEFT.

I'M JUST BRINGING IT UP FOR CONSIDERATION.

LIKE I SAID, IT DOESN'T AFFECT ME.

I'M GOING TO VOTE FOR IT, BECAUSE OBVIOUSLY, I THINK THIS THE INTENT IS GOOD BUT I'M JUST BRINGING THIS UP FOR THOSE WHO ARE GOING TO STAY TO CONSIDER.

IF YOU WANT TO DO SOMETHING WITH IT, FINE, IF NOT, IT'S NO SKIN OFF MY NOSE.

>> PRESIDENT JAMES: COUNCILMEMBER KRAMER?

>> COUNCILMEMBER HOLLANDER EXPLAINED IT WELL.

THE ONLY THING I WOULD ADD, AND IF WE NEED TO DEFINE TERM MORE CLEARLY, I AGREE, THE TERM IS THE TERM YOU WERE ELECTED FOR.

THE TERM I'M CURRENTLY SERVING ENDS JANUARY 1ST, 2019 AND HALF OF THE FISCAL YEAR WILL STILL BE LEFT.

THAT'S THE END OF MY TERM.

THE ONLY THING I MIGHT CHANGE A LITTLE BIT IS THAT'S THE END OF MY TERM REGARDLESS.

IF I FINISH EARLY I WOULDN'T BE FINISHING MY TERM, IF THERE'S SIX MONTHS IN THE YEAR LEFT IT WOULD BE APPROPRIATE FOR ME TO LEAVE SOME FUNDS THERE FOR THE INCOMING CANDIDATE.

THE REALITY IS THOUGH, THAT'S WHERE AGAIN I WOULD REAFFIRM WHAT COUNCILMEMBER HOLLANDER SAID, IF SOMEONE GETS SICK AND RESIGNS EARLY THEY MAY HAVE SPENT IT ALL AND THEY GOT SICK AND DIDN'T ANTICIPATE THAT AND IF SOMEONE WERE TO BE PARTICULARLY NEFARIOUS AND KNEW IN JUNE THEY WOULD RESIGN AND THEY SPENT IT ALL BY APRIL OR WHATEVER, AND THEY DIDN'T ANNOUNCE

RESOLUTION OVERTURNING THE DECISION OF THE LANDMARKS COMMISSION, 3700 DUTCHMAN'S LANE IN LOUISVILLE METRO AS A LOCAL LANDMARK AMENDMENT BY SUBSTITUTION.

THE LEGISLATIVE COUNCIL OF THE LOUISVILLE JEFFERSON COUNTY METRO GOVERNMENT WILL BE KNOWN AS THE COUNCIL, HAS CONSIDERED THE EVIDENCE PRESENTED, WILL BE KNOWN AS THE COMMITTEE, MARCH 2018, THE RECORD REVIEWED AT THE PUBLIC MEETING HELD BY THE COUNCIL ON JULY 17TH, 2018.

THE COMMISSION FOUND THEY MET FOUR, 32260 E1, A, B, E AND F AND ALSO FOUND THE PETITION DIDN'T MEET FIVE OF THE NINE CRITERIA OF THE LOCAL CODE OF ORDINANCES, 32, 260, E1, C. D, G H AND I.

WHEREAS THIS DESIGNATION PETITION WAS APPROVED OVER THE OBJECTION OF THE PROPERTY OWNER IN AN INTERNAL DISPUTE WITH THE CONGREGATION AND WHEREAS PURSUANT TO LOUISVILLE METRO CODE OF ORDINANCES 32260 G, THE COUNCIL DISAGREES WITH THE DECISION OF THE COMMISSION DATED MARCH 22ND, 2018, DESIGNATING 3700 DUTCHMAN'S LANE AS A LOCAL LANDMARK AND MAKES THE FOLLOWING FINDINGS OF FACT.

ONE, LIKE ALL RELIGIOUS CONGREGATIONS IS HIGHLY VALUED IN OUR COMMUNITY AND CERTAINLY IS A PART OF THE COMMUNITY'S COLLECTIVE HERITAGE.

HOWEVER, AS THE COMMISSION ITSELF FOUND WITH RESPECT TO LOUISVILLE METRO CODE OF ORDINANCES, 32260E1-A THESE PARTICULAR PROPERTY STRUCTURES DO NOT APPEAR TO BE INDIVIDUALLY DISTINCTIVE FOR THE DEVELOPMENT OF THE CITY COMMONWEALTH OF THE UNITED STATES.

2, AS THE COMMISSION FOUND 32260E1-B DUE TO CHANGES IN THE SURROUNDING CONTEXT OVER TIME THE ASSOCIATION WITH SETTINGS FEELING AND ASSOCIATION HAVE DIMINISHED.

MID CENTURY ARCHITECTURE IS UBIQUITOUS IN THIS COMMUNITY.

THE FRONT YARD SETBACK OF THE STRUCTURES WHILE ARGUABLY A DESIGN FEATURE OF THE MID CENTURY MODERN STYLE DOESN'T WARRANT A DESIGNATION.

SUCH SETBACKS ARE COMMON IN SUBURBAN DEVELOPMENT.

3, WITH RESPECT TO LOUISVILLE METRO CODE OF ORDINANCES 32260E-1-E THE COMMISSION FOUND THAT ONLY ONE OF THE TWO STRUCTURES DISPLAYS DISTINGUISHING CHARACTERISTICS OF THE MID CENTURY MODERN ARCHITECTURAL STYLE.

THIS IS NOT ADEQUATE TO JUSTIFY DESIGNATION OF BOTH STRUCTURES AND THE SITE.

IT'S BEEN LOST WITH THE DEVELOPMENT OF A LARGE APARTMENT BUILDING TO THE SOUTH SHALOM TOWERS AND JEWISH COMMUNITY CENTER TO THE WEST.

FOUR, DESPITE BEING ACKNOWLEDGED AS A WELL-KNOWN ARCHITECTURAL FIRM, PARTICULARLY FOR ITS USE OF THE BOZART STYLE, THE FINDINGS WITH RESPECT TO THE CODE OF ORDINANCES 32260E-1-F STATES THERE'S BEEN NO EVALUATION OF JOSEPH AND JOSEPH'S INFLUENCE ON MID CENTURY MODERN DESIGN IN LOUISVILLE, THE COMMONWEALTH OR THE NATION.

FIVE, THE COUNCIL AGREES WITH AND ACCEPTS THE FINDINGS OF THE COMMISSION THAT THE PROPERTY STRUCTURES DO NOT MEET GUIDELINES 32260E-1, C, D, G, H AND I AND THEREFORE THE COUNCIL FINDS THAT ON BALANCE THE PROPERTY STRUCTURES DID NOT SATISFY THE CRITERIA FOR LOCAL LANDMARK DESIGNATION.

NOW THEREFORE BE IT RESOLVED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE METRO COUNTY GOVERNMENT AS FOLLOWS SECTION 1, MARCH 22ND, 2018 DECISION OF THE COMMISSION DESIGNATING THE PROPERTY AT 3700 DUTCHMAN'S LANE IN LOUISVILLE METRO AS A LOCAL LANDMARK IS OVERTURNED AND SET ASIDE.

>> WHOEVER, I GOT IT, OVER HERE I DO HAVE AN  
AMENDMENT.

IT'S REALLY A MATTER OF MAKING SURE IF THERE'S ANY CHANGES THAT WOULD HAPPEN WOULD COME BEFORE US, SIGNIFICANT CHANGES.

THIS DOES COMPLY WITH THE HIGH VIEW NEIGHBORHOOD PLAN THAT CAME WITH RECOMMENDATION 8-0 IN COUNCILMAN PEDEN'S DISTRICT, HE MAY WISH TO ADDRESS.

>> PRESIDENT JAMES: COUNCILMEMBER PEDEN?

>> THANK YOU.

THIS WAS WIDELY ACCEPTED AT THE PRE-APPLICATION MEETING.

NO ONE SPOKE IN OPPOSITION.

I BELIEVE THEY WERE HAND PICKED BY THE PEOPLE SELLING THE PROPERTY BECAUSE THEY WERE GOING TO MAINTAIN THEIR CHURCH.

THIS IS SURPLUS CHURCH PROPERTY.

THEY WERE PLEASED.

SO I WOULD URGE YOUR SUPPORT, THANK YOU.

>> PRESIDENT JAMES: THANK YOU.

IS THERE ANY FURTHER DISCUSSION? HEARING NONE.

THIS IS AN ORDINANCE REQUIRING A ROLL CALL VOTE.

VOTING IS CLOSING AND VOTING IS CLOSED.

>> MR. CLERK: 24 YES VOTES AND 2 NOT VOTING.

>> PRESIDENT JAMES: THANK YOU, THE ORDINANCE PASSES.

MR. CLERK A READING OF ITEM 56.

>> MR. CLERK: AN ORDINANCE DENYING THE CHANGE IN ZONING FROM R-4 RESIDENTIAL SINGLE FAMILY TO C-2 COMMERCIAL ON PROPERTY LOCATED AT 7500 BARDSTOWN ROAD CONTAINING 6.475 ACRES AND BEING IN LOUISVILLE METRO (CASE NO. 17ZONE1060)(AS AMENDED).

>> PRESIDENT JAMES: MOTION AND SECOND.

THE ORDINANCE IS BEFORE US.

COUNCILMEMBER FLOOD?

>> THIS IS THE FIRST FOR METRO COUNCIL WE HAD A TIED VOTE FROM THE PLANNING COMMISSION OF 3-3.

THERE WAS THREE FOR AND THREE AGAINST, THEY TRIED FOR APPROVAL IT WAS STILL 3-3, THEY TRIED FOR DENIAL AND IT WAS 3-3.

IT COMES BACK TO US.

THEY ASKED FOR AN ADDITIONAL 30 DAYS TO RECONSIDER BUT ACCORDING TO STATE LAW ONLY THOSE SIX PRESENT AT THE BEGINNING OF THE PUBLIC HEARING WERE ALLOWED TO REVOTE.

SO WE ARE BACK AT THE 3-3.

WHAT THEY ARE WANTING TO BUILD IS 9, 920 SQUARE FOOT MINI HOUSES.

THERE WERE 13 POINTS PRESENTED BY JOEL DOCK, HE IS A STAFF MEMBER FOR THE PLANNING COMMISSION AND WHY IT DID NOT MEET THE COMPREHENSIVE PLAN.

THE STAFF MET IT DIDN'T MEET THE COMPREHENSIVE PLAN AND RETAIL PLAN BECAUSE IT CALLS FOR A NEIGHBORHOOD PLAN, CALLED FOR A TOWN CENTER WITH MIXED USE.

AND THE MIXED USE IS NOT CONSIDERED 100,000 SQUARE FOOT MINI WAREHOUSE WHEN THEY WERE TALKING ABOUT USE THEY ARE TALKING ABOUT COMMERCIAL RESTAURANT, RETAIL.

THIS IS IN COUNCILMAN ENGEL'S DISTRICT.

WE LOOKED TO HIM FOR GUIDANCE, HE DID WRITE THE 13 POINTS ON THE STAFF FOR HIS REASONS FOR DENIAL AND I WILL TURN THE FLOOR OVER TO COUNCILMEMBER ENGEL.

>> PRESIDENT JAMES: THANK YOU.

COUNCILMEMBER ENGEL?

>> THANK YOU, MR. PRESIDENT.

COLLEAGUES A STORMY CLOUD MOVED INTO THE ATLANTA AIRPORT ABOUT 3:00 TODAY JUST AS I BOARDED MY DELTA FLIGHT BACK TO LOUISVILLE AND IT DELAYED MY ARRIVAL BY 30 MINUTES.

THUS MISSING THE 5:15 MEETING WHERE I REALLY FULLY INTENDED TO DISCUSS THIS WITH YOU, SO I APOLOGIZE FOR NOT ATTENDING THE 5:15 BECAUSE I REALLY WANTED TO BE THERE.

SO I THOUGHT I WOULD GO BACK TO SOME OF MY COMMENTS IN COMMITTEE AS I BEGIN TO DISCUSS THIS.

WE ARE FACED WITH THE PROVERBIAL FORK IN THE ROAD.

JUST A REVIEW FOR THE LISTENING PUBLIC, MR. PRESIDENT, I ASK FOR INDULGENCE BECAUSE THIS IS VERY SERIOUS.

IN JUNE THE PLANNING COMMISSION VOTED WHICH INVOLVED CHANGING THE ZONING FOR PROPERTY AT 7500 BARDSTOWN ROAD FROM R-4 RESIDENTIAL SINGLE FAMILY TO C-2 COMMERCIAL AND JUST SO EVERYBODY KNOWS GEOGRAPHICALLY WHERE THAT IS, IF YOU ARE COMING FROM MY COLLEAGUE COUNCILMAN PEDEN'S DISTRICT HIGH VIEW ON THE GENE SCHNEIDER HIGHWAY AND YOU EXIT AS IF YOU ARE HEADED TO BARDSTOWN KENTUCKY, IT'S JUST ABOUT THE VERY FIRST PROPERTY ON YOUR RIGHT-HAND SIDE BY BARTLEY DRIVE.

SO THIS VOTE WAS UNPRECEDENTED IN A 3-3 TIE WITH TWO ABSENT AND ONE ABSTENTION.

THIS RESULTED AGAIN, AS YOU HAVE HEARD FROM THE CHAIR WITH NO, IT CAME BACK A SECOND TIME WITH NO CHANGE IN THE VOTE.

WORKING WITH ASSISTANT COUNTY ATTORNEY AND JOEL DOCK THESE KEY FINDINGS OF FACT THAT I'M BASING MY DECISION ON AND I ASK FOR YOU TOO AS WELL THE COMPREHENSIVE PLAN AS WELL AS RETAIL STUDY AND SOUTHEAST REGIONAL PLAN CALL FOR A NEIGHBORHOOD CENTER.

THE PROPOSED DEVELOPMENT IS PRIMARILY BEING DEVELOPED FOR A SOLITARY USER THAT DOES NOT PROVIDE NEIGHBORHOOD GOODS AND SERVICES.

THE SCALE OF THIS PRIMARY USER IS NOT APPROPRIATE AS THE SITE IS DOMINATED BY STRUCTURAL FOOTPRINT THAT DOESN'T ENGAGE THE PUBLIC.

NUMBER TWO, THE PROPOSAL IS LOCATED WITHIN THE NEIGHBORHOOD FORM DISTRICT.

HOWEVER THE SOUTHEAST REGIONAL CENTER PLAN CALLS FOR THE CREATION OF SITE-SPECIFIC RECOMMENDATIONS CALL FOR A TOWN CENTER-LIKE SUPER COMMUNITY CENTER DEVELOPMENT INCLUDING MIX OF SHOPS, RESTAURANTS, OFFICES AND SERVICES AS WELL AS RESIDENTIAL SERVICES WITH AN ANCHOR TENANT.

NUMBER THREE THE SITE IS DOMINATED BY STRUCTURE OR FOOTPRINT AS I INDICATED AND OCCUPIES VIABLE LAND AS RECOMMENDED BY SMALL AREA STUDIES.

THE PROPOSAL CALLS FOR TWO USERS WITH ONE DOMINATING THE MAJORITY, MANY WAREHOUSE FACILITIES DON'T PRODUCE FUNCTIONAL INTERACTION WITH MULTIMODAL USERS OR CREATE A SENSE OF PLACE.

THE PROPOSAL DOES NOT CREATE A CENTER AS RECOMMENDED BY THE SMALL AREA STUDIES ADOPTED FOR THE AREA AND SINGLE STORY DESIGN SPRAWLS THE DEVELOPMENT SITE WITH NO AMENITIES.

NUMBER SIX THE PROPOSAL PROVIDES A PRIVATE ROADWAY TO FACILITATE REAR DEVELOPMENT AWAY FROM BARDSTOWN ROAD.

THE IDEAL CONDITION WOULD BE TO HAVE THE PROPOSED USE AT THE REAR OF THE DEVELOPMENT AND MIXED USE ALONG FRONTAGE WITH ANCHOR TENANT AS SUGGESTED BY THE RETAIL MARKET STUDY.

NUMBER 7 IT DOESN'T ENCOURAGE MULTIMODAL ACCESS AND ACCESS BY VEHICLE IS LIMITED DUE TO A FUTURE PROPOSED MEDIAN THAT WOULD RESTRICT ACCESS TO THE SITE FROM THE SOUTH VIA BARDSTOWN ROAD WITHOUT PASSING THE SITE FIRST TO FIND AN ALTERNATIVE ROAD.

FURTHER WING FIELD ROAD IS BEING REALIGNED SOUTH POINT COMMONS.

YOU HAVE HEARD THAT BEFORE.

AND BATES ELEMENTARY SCHOOL.

ALL OF THIS IS HAPPENING ACROSS FROM THIS DEVELOPMENT AND SINGLE INTERSECTION WILL ACCOMPANY SO ANY FUTURE DEVELOPMENT SHOULD INTEGRATE INTO THE INTERSECTION.

TRAFFIC PROBLEMS MAY RESULT AS A MEDIAN THAT WOULD RESTRICT ACCESS TO THE SITE FROM THE SOUTH VIA BARDSTOWN WITHOUT PASSING THE SITE FIRST TO AN ALTERNATIVE ROAD.

NUMBER 9 PROPOSAL DOESN'T PROVIDE OPEN SPACE TO MEET THE NEEDS OF THE COMMUNITY AS SITE-SPECIFIC GUIDELINES CALL FOR INTEGRATION OF SMART GROWTH PRINCIPLES WHICH WOULD INCLUDE PUBLIC SPACE AND WALKABLE AREAS.

NUMBER 10 PROPOSED USE IS NOT FOR RETAIL COMMERCIAL AND WE WOULD BE BETTER SUITED IN AN AREA OF EXISTING DEVELOPMENT AWAY FROM VIABLE LAND AS CALLED FOR AND ADOPTED SMALL AREA PLANS.

NUMBER 11, THE USE IS AUTO CENTRIC AND DOESN'T PROMOTE MASS TRANSIT, BICYCLE AND PEDESTRIAN USE.

THE TRANSPORTATION FACILITIES ARE NOT COMPATIBLE WITH SURROUNDING USES AS THE SITE DOESN'T APPROPRIATELY LINK TO A FUTURE SIGNALIZED THE INTERSECTION AS I MENTIONED.

NUMBER 13, THE DEVELOPMENT DOESN'T PROVIDE FOR APPROPRIATE LINKAGES BETWEEN ACTIVITY AREA AS THE SITE DOESN'T APPROPRIATELY LINK FUTURE SIGNALIZATION.

SO COLLEAGUES, THE PLANNERS HAVE LOOKED AT THIS NOT ONCE BUT TWICE.

I HAVE LOOKED AT THIS EXTENSIVELY AND INVESTED IN AREA STUDIES TO ASSIST OUR VISION FOR THIS AREA AND SO I RESPECTFULLY ASK YOU TO SUPPORT THE DENIAL THAT COMES OVER -- THAT CAME OVER TO US WITH THE UNANIMOUS VOTE FROM THE PLANNING AND ZONING COMMITTEE.

AND THEN IN CONCLUSION, AT LEAST FOR NOW.

WE HAVE A LETTER FROM OUR COUNTY ATTORNEY STATING THAT THE RECORD IS CLOSED, NO NEW EVIDENCE IS TO BE CONSIDERED.

WE JUST GOT THIS, FOLKS, THIS AFTERNOON.

SO THE PLANNING AND ZONING, I WOULD SIMPLY ASK, WE HAVE LOTS OF DISCUSSION TO FOLLOW BUT I AM, AS THE COUNCILMEMBER FOR DISTRICT 22 IN THIS PARTICULAR PROPERTY I WILL BE ASKING FOR MY COLLEAGUES SUPPORT FOR DENIAL AND WE HAVE SUFFICIENT FINDINGS AND HAVE BEEN BACKED UP BY OUR JEFFERSON COUNTY ATTORNEY FOR THAT.

THANK YOU.

>> PRESIDENT JAMES: THANK YOU, COUNCILMAN.

COUNCILMEMBER FLOOD.

>> THANK YOU, MR. PRESIDENT.

AT THE 5:15 COMMITTEE OF THE WHOLE I WAS PRESENTED A LETTER FROM CLIFF ASHBURNER WHO IS THE APPLICANT'S ATTORNEY WANTING TO WITHDRAW THEIR CONSIDERATION FOR A ZONING CHANGE.

I HAVE ALWAYS, ALWAYS, ALWAYS, FOR THE LAST -- SINCE THE INCEPTION OF MERGER AND I'VE BEEN ON THIS COMMITTEE EVERY YEAR HAVE BEEN TOLD ONCE THE PLANNING COMMISSION MAKES A DECISION AND THEY HAVE APPROVED THEIR MINUTE, ONCE IT'S IN OUR HANDS THERE'S NO LONGER THAT CHANCE TO WITHDRAW THE ZONING.

IT IS WHAT IT IS.

AND I DIDN'T JUST MAKE THAT UP.

BECAUSE I WAS READING ON THE RULES AND REGULATIONS FOR THE PLANNING COMMISSION.

BECAUSE STATE LAW GIVES THEM THE RIGHT TO MAKE RULES AND REGULATIONS.

IT SAYS, LET ME FIND IT HERE REAL QUICK.

NO APPLICATION FOR CHANGE OF ZONING SHALL BE ACCEPTED WITHIN TWO YEARS OF COMMISSION ACTION OF AN APPLICATION ON THE SAME OR SUBSTANTIALLY THE SAME TRACK OF PROPERTY UNLESS THE COMMISSION CAN FIND AND RESOLVE THE FACTS EITHER ONE, TWO OR THREE, THERE'S STEPS THEY CAN DO.

I'VE ALWAYS BEEN TOLD ONCE THE PLANNING COMMISSION HAS VOTED AND THEN WHEN THEY VOTE TO ACCEPT THEIR MINUTES AND APPROVE THEIR MINUTES, AND IT'S IN OUR HANDS, IT'S TOO LATE TO WITHDRAW.



THAT TIME HAS PASSED THAT YOU CAN REAPPLY FOR THE SAME APPLICATION.

WE ARE IN THIS PREDICAMENT.

ALSO YOU MAY SAY SOME PEOPLE ARE SAYING THE PLANNING COMMISSION IS 3-0 THEY DIDN'T MAKE A DECISION.

YES, THEY MADE A DECISION.

WE ARE MERELY THE TIE-BREAKERS AT IS THIS POINT.

IT WILL TAKE 14 VOTES EITHER WAY TO APPROVE OR DENY THE ZONING CHANGE ACCORDING TO COUNTY ATTORNEY STATE LAW OF RIGHTS, RIGHT, MR. WHITTIE?

>> ACTUALLY I DON'T THINK IT'S AS CLEAR AS YOU MIGHT THINK.

CHAPTER SAYS [OFF MIC] FOR PURPOSES THAT FINAL ACTION SHALL BE DEEMED TO HAVE OCCURRED ON THE CALENDAR DATE WHEN THE VOTE IS TAKEN TO APPROVE OR DISAPPROVE THE MATTER PENDING BEFORE THE BODY.

AND AS YOU KNOW, THEY DIDN'T APPROVE OR DISAPPROVE BUT SENT IT WITHOUT A RECOMMENDATION.

A COUPLE OF OTHER POINTS.

AND I AM NOT ON EITHER SIDE, I'M TRYING TO KEEP US ON THE LEGAL STRAIGHT AND NARROW.

THE RESPONSE TO THE PLANNING COMMISSION POLICY IS ONCE A PLAN HAS BEEN VOTED ON YOU CAN'T BRING IT BACK FOR TWO YEARS UNLESS THERE'S BEEN SUBSTANTIAL CHANGES OF A PHYSICAL, SOCIOECONOMIC NATURE.

SO THAT DOESN'T STATE YOU CAN'T WITHDRAW YOUR APPLICATION.

IN FACT, THIS CAME UP TODAY IN MY OFFICE AT 4:15.

I DID A QUICK SEARCH.

I COULDN'T FIND A POLICY STATUTE OR RULE THAT ADDRESSES WITHDRAWAL OF AN APPLICATION.

I CAN TELL YOU THE APPLICANT IS CLAIMING IT'S THEIR PROPERTY AND THEY CAN WITHDRAW THE APPLICATION AT ANY TIME.

I DON'T NECESSARILY SUPPORT THE WITHDRAWAL OR NOT BUT I THINK IT'S UNCLEAR AS TO RIGHT NOW WHAT THEIR RIGHTS ARE IN TERMS OF WITHDRAWING THEIR APPLICATION.

THIS DOESN'T HAVE TO BE VOTED ON UNTIL OCTOBER 5TH OLD IT UNTIL WE CAN GET SOME DUAL RESEARCH AND GUIDANCE AS TO WHETHER OR NOT THEY CAN WITHDRAW THEIR APPLICATION AT THIS STAGE.

BUT IT'S UP TO THIS BODY TO DECIDE WHETHER TO TAKE MY ADVICE OR NOT AND CERTAINLY YOU COULD PROCEED AS CHAIRMAN OF OUR PLANNING AND ZONING COMMITTEE HAS REQUESTED.

>> PRESIDENT JAMES: THANK YOU.

COUNCILMEMBER FLOOD?

>> THANK YOU.

I JUST NOTE TOO WE HAD CLIFF HALL WHO CAME AND THEY WERE GOING TO TRY TO WITHDRAW THEIR APPLICATION ALSO AND WE WERE TOLD, AND I'M PRETTY SURE I HAVE IT IN WRITING THEY COULDN'T WITHDRAW BECAUSE THE PLANNING COMMISSION ACTIONS WERE FINAL.

AND EVEN THOUGH SOMEONE WITHDRAWS SOMETHING, WHEN MERGER FIRST HAPPENED IN THE FIRST PLANNING AND ZONING COMMITTEE SAT WE FOUND OURSELVES WHERE THERE WERE SEVERAL CASES THAT HAD RUN THE 90-DAY TIME LIMIT.

BUT STILL THE COMMITTEE FELT, AND IT WENT ALL THE WAY THROUGH THE METRO COUNCIL THAT WE DID OUR DUE DILIGENCE EVEN THOUGH THE TIME EXPIRED TO REVIEW THAT RECORD AND COME UP WITH A DECISION.

IT MAY NOT HAVE CHANGED ANYTHING BUT WE STILL TOOK ACTION BECAUSE WE DIDN'T HAVEN'T TO BE SEEN AS JUST BEING A LAME DUCK AND NOT TAKING ACTION JUST BECAUSE THE TIME LIMIT RAN OUT ON US.

I THINK THERE'S PRECEDENT, THERE'S AN ORDINANCE EVEN THOUGH IT'S WITHDRAWN WE STILL HAVE A CHANCE TO VOTE ON IT BUT THAT IS ENTIRELY UP TO THIS BODY AND I WILL LEAVE IT TO THIS BODY TO MAKE A DECISION I JUST FIND IT ODD WE ARE A WEEK OR TEN DAYS FROM THE PLANNING COMMITTEE MEETING AND IT'S BEEN ON THE RECORD WHAT IS HAPPENING AND 5:15 TODAY I GET A LETTER SHOVED IN MY FACE SAYING THEY WANT TO WITHDRAW THEIR APPLICATION.

I DON'T KNOW WHY IT DIDN'T HAPPEN EARLIER THAN 5:15 TONIGHT.

>> PRESIDENT JAMES: THANK YOU.

COUNCILMEMBER KRAMER?

>> THANK YOU, I WOULD BEGIN MY COMMENTS BY REITERATING WHAT COUNCILMEMBER ENGEL SAID I THINK IT'S OUR RULE TO TRY TO

STAY AT LEAST AN ARM'S LENGTH AWAY FROM ZONING ISSUES AND SERVE MORE AS JUDGES THAN ZONING CZARS.

DID THEY DO WHAT THEY WERE SUPPOSED TO DO.

AND IF WE FEEL THEY DIDN'T DO WHAT THEY WERE SUPPOSED TO DO THEN I THINK THERE ARE OCCASIONS WHEN WE SAY WE VOTE AGAINST IT.

NOT BECAUSE WE DON'T LIKE WHAT WAS ZONED BUT BECAUSE WE DON'T BELIEVE THE ZONING COMMISSION SUCCESSFULLY CONSIDERED EVERYTHING.

THERE WAS ANOTHER CASE WHERE THE PLANNING COMMISSION DIDN'T CONSIDER THINGS IN THE RECORD AND THEY UNDERSTOOD AND RECOGNIZED THE PLANNING COMMISSION MADE A MISTAKE AND SEVERAL OF US VOTED NO, VOTED TO DENY IT.

THE COMMISSION WAS LOCKED.

THEY REALLY DIDN'T MAKE A DECISION.

COUNCILMAN ENGEL HAS OFFERED 13 REASONS, 13 DIFFERENT FINDINGS OF FACT THEY EITHER DIDN'T CONSIDER OR THEY JUST GOT WRONG.

SO I'M IN A PLACE I GENERALLY GO WITH THE ZONING COMMISSION.

EVEN MY OWN DISTRICT, I HAVE TO TELL YOU, I VOTED PRESENT ON A ZONING ISSUE IN MY OWN DISTRICT BECAUSE I KNOW MY CONSTITUENTS DIDN'T WANT THAT DEVELOPMENT GOING IN.

BELIEVE ME, I KNEW WHAT THEIR DESIRE WAS BUT I ALSO KNEW WHEN I LOOKED AT THE FINDING OF FACT, THE ZONING COMMISSION DID EVERYTHING THEY WERE SUPPOSED TO DO.

THEY CONSIDERED ALL THE LEGISLATION, THEY DIDN'T MESS IT UP.

I DIDN'T AGREE WITH THEM.

I STILL DON'T AGREE WITH THEM BUT I DON'T THINK IT'S APPROPRIATE FOR COUNCILMEMBERS TO DECIDE IF WE DON'T LIKE SOMETHING WE WILL TALK OUR COLLEAGUES INTO VOTING AGAINST IT, I THINK WE GO DOWN A DARK HOLE WHEN WE DO THAT.

I APPRECIATE THE ZONING COMMISSION WAS NOT VERY HELPFUL GIVING US A RESULT AND APPRECIATE COUNCILMEMBER ENGEL HAS 13 FINDINGS OF FACT AND IS VERY CLEAR WHAT MAKES THE MOST SENSE HERE.

REGARDLESS IF THE PETITIONER IS ASKING FOR WITHDRAWAL, THE FINDINGS OF FACT ARE WHAT THEY ARE.

IT SEEMS TO ME WE SHOULD VOTE ON THOSE FINDINGS OF FACT.

I WOULD ASK MY COLLEAGUES BOTH VOTE AND VOTE IN SUPPORT OF UPHOLDING THE DENIAL.

>> PRESIDENT JAMES: THANK YOU.

COUNCILMEMBER PEDEN?

>> THANK YOU.

NOT NECESSARILY SPEAKING FOR OR AGAINST THE DENIAL, I WOULD MORE LIKE TO SPEAK AS TO WHY THE WITHDRAWAL AND WHY WE

SHOULD PROBABLY GO AHEAD AND VOTE AND THAT WOULD BE THE 2-YEAR WINDOW THAT STARTS EITHER WITH THE PLANNING COMMISSION RULING OR OUR RULING TONIGHT, COULD BE TOTALLY AVOIDED IF THERE WERE CHANGES.

OBVIOUSLY, THE PLANNING COMMISSION DIDN'T LIKE THE PLAN HERE, SO TO ME IN MY HEAD LOGICALLY SPEAKING THE ONLY WAY TO PULL THE WITHDRAWAL IS IF YOU PLAN TO MAKE NO CHANGES TO RESUBMIT IT LATER TO A NEW PLANNING COMMISSION OR MAYBE A NEW COUNCIL WITH SEVEN NEW MEMBERS AS WE HAVE ALREADY POINTED OUT TONIGHT.

I WANT TO VOTE ON THIS PLAN TONIGHT BECAUSE AGAIN IT DOESN'T MEET THE FERN CREEK NEIGHBORHOOD PLAN WHICH I KNOW THEY PUT A LOT OF WORK.

BECAUSE AGAIN HAD THEY BEEN WILLING TO PROBABLY MAKE SOME CHANGES EARLY ON WE WOULDN'T BE IN THIS POSITION.

IF THEY INTENDED TO MAKE CHANGES LATER ON, WE WOULDN'T BE IN THIS POSITION.

I FIND THE LETTER TO WITHDRAW TO BE SOMEWHAT DISINGENUOUS TO AVOID A DENIAL.

THEY SAY THEY DON'T WANT TO WAIT TWO YEARS BUT YOU DON'T HAVE DO IF THEY MAKE SUBSTANTIAL CHANGES AND DO THE THINGS THE PLANNING COMMISSION WANTED IN THE FIRST PLACE.

I THINK THIS WILL PUSH THEM DOWN THAT ROAD IF WE GO AHEAD AND TAKE THIS VOTE.

THANK YOU.

>> PRESIDENT JAMES: THANK YOU, COUNCILMAN.

COUNCILMEMBER ACKERSON?

>> THANK YOU, MR. PRESIDENT.

THE FACT WE WOULD RUSH THE VOTE TO TAKE THAT POTENTIAL OFF THE TABLE, TO ME, PERVERTS THE PROCESS.

AND THE REASON BEING, YES, THEY COULD COME BACK AND THEY MIGHT GO BEFORE A DIFFERENT BODY BUT THAT'S THE PROCESS.

THERE'S A FINE LINE BETWEEN WHO COULD DO THE RIGHT THING AND ALSO RECOGNIZING PROPERTY OWNER RIGHTS.

LOOKS LIKE THE COUNTY ATTORNEY MAY HAVE GOT A LETTER AT 4:15, WE GOT A LETTER AT 5:15 PRIOR TO THEM BRINGING THIS UP, BECAUSE WE DON'T KNOW THE LEGALITIES INVOLVED WITH THEM WITHDRAWING, WE DON'T KNOW THE LEGALITIES.

WE HAVE UNTIL OCTOBER 5TH.

OUT OF AN ABUNDANCE OF CAUTION TO GIVE ALL PARTIES DEFERENCE TO WHAT THEIR RIGHTS ARE IS TO TABLE THIS.

IF THE COUNTY ATTORNEY COMES BACK AND SAYS NO A WITHDRAWAL UNDER THE LAW IS NOT VALID WE COULD STILL DEAL WITH THIS BEFORE OCTOBER 5TH AND ACHIEVE THE RESULTS YOU WANT TO ACHIEVE BUT FOR THE MOMENT UNDER THESE CIRCUMSTANCES, OUT OF AN ABUNDANCE OF CAUTION I WOULD MAKE A MOTION TO TABLE THIS AND TAKE THE TIME NECESSARY TO GET IT RIGHT.

IF THERE'S NO SECOND THEN IT WILL DIE BUT I WILL MAKE A MOTION FOR THE VALIDITY OF THIS WITHDRAWAL.

I WILL ASK FOR A SECOND, IF I DON'T IT WILL DIE  
WITHOUT A SECOND.

>> SECOND.

>> PRESIDENT JAMES: WE HAVE A SECOND.

ALL THOSE IN FAVOR OF TABLING UNTIL --

>> COUNTY ATTORNEY YOU NEED A MONTH? THAT WILL PUT US  
INTO SEPTEMBER.

>> WE SHOULD BE ABLE TO RESOLVE THIS BY NEXT COUNCIL  
MEETING.

>> PERFECT.

>> MR. PRESIDENT?

>> PRESIDENT JAMES: YES, SIR?

>> IS THERE COMMENT ON THIS? WE TALKED ABOUT  
LEGALITIES.

>> NOT ON A MOTION TO TABLE.

>> PRESIDENT JAMES: THERE'S NOT A DISCUSSION ON  
TABLING.

>> I WOULD MAKE THE MOTION WE WOULD TABLE IT TO OUR  
NEXT COUNCIL MEETING.

TWO WEEKS TO GET A LEGAL OPINION.

I HAVE MY SECOND.

I WOULD ASK FOR A VOTE.

>> PRESIDENT JAMES: ALL THOSE IN FAVOR OF TABLING, SAY  
AYE.



ALL OPPOSED? MR. CLERK, WOULD YOU PLEASE OPEN THE ROLL  
CALL FOR VOTING.

>> MR. CLERK: 8 YES VOTES, 15 NO VOTES AND 3 NOT  
VOTING.

>> PRESIDENT JAMES: WE WILL CONTINUE THE DISCUSSION.  
COUNCILMEMBER BENTON?

>> THANK YOU, MR. PRESIDENT.

I WILL TRY TO BE QUICK.

I DON'T KNOW IF PEOPLE BESIDE MYSELF SAY TRAFFIC IS  
TERRIBLE.

WHAT DO YOU DO ABOUT IT? KEEP DOING THE SAME THINGS.  
KEEP MAKING IT TERRIBLE.

WHY WOULDN'T WE WANT TO MAKE TRAFFIC BETTER? SO PEOPLE  
CAN GET WHERE THEY WANT TO GO? MAYBE EVEN A POSITIVE THING FOR  
OUR COMMUNITY.

GO TO LOUISVILLE, THEY CAN GET AROUND.

NOW, JUST THE OTHER DAY, MAYBE 2 MONTHS AGO, I SAT  
DOWN HERE THERE'S A ZONING CASE FOR 370 APARTMENTS ON THIS ROAD  
CALLED TUCKER STATION.

THERE WAS SUPPOSED TO BE A TURN LANE.

WHAT HAPPENED TO A TURN LANE.

THEY SAID YOU DON'T NEED A TURN LANE.

I MADE A MISTAKE.

I SAID WHAT IDIOT DECIDED THAT, PROBABLY SHOULDN'T  
HAVE DECIDED THAT.

THERE COULD BE 750 CARS.

YOU THINK YOU HAVE A STACKING PROBLEM ON THAT ROAD? WE HAVE THE FBI CENTER THERE AND SOME OTHER THINGS THAT WILL PROBABLY BE DEVELOPED AND WE DON'T THINK ABOUT TRAFFIC? THESE PEOPLE WILL BE LIVING IN THE APARTMENT THEY WON'T LIVE THERE LONG.

I CAN'T GET OUT OR EVEN GET IN.

SO THE DEVELOPER HEARD ME TALK.

AND I VOTED AGAINST IT.

AND EVERYBODY ON THE COUNCIL VOTED FOR IT.

I SAID HOW DO YOU COUNT TRAFFIC WHEN IT IS STANDING STILL? WE AREN'T GOING TO MAKE IT WORSE.

IF SOMEBODY THINKS THEY CAN MAKE SOME MONEY ON SOME KIND OF BUSINESS, STORAGE UNITS OR WHATEVER, AS FAR AS I KNOW STORAGE UNITS AREN'T A BIG TRAFFIC FLOW.

15-20 CARS MAYBE A DAY? I'M SORRY, MR. PEDEN BUT ONE OF THE PROBLEMS WE HAVE A PROBLEM ON BARDSTOWN ROAD WHERE TRAFFIC ISN'T MOVING.

SO IF COUNCILMEMBER ENGEL IS RIGHT WE WILL BUILD A TOWN CENTER THERE.

THERE'S NOBODY THINKING ABOUT MAKING ANY MORE ROADS WE WILL JUST TAKE EXISTING ROADS AND MAYBE MAKE A BIKE PATH.

MAKE A SIDEWALK.

MAYBE EVERYBODY SITTING STILL WILL RIDE BICYCLES BECAUSE THEY AREN'T GOING TO GO ANYWHERE.

I HAVE A PROBLEM.

THE GURUS AT PLANNING AND ZONING SAY WE MAKE A  
DECISION AND YOU DON'T FOLLOW IT.

I HAVE HAD SO MANY ZONING CASES THAT WAS AGAINST OUR  
RULES, IT JUST MAKES ME SICK ALMOST.

I DON'T KNOW WHERE TO GO WITH THIS BECAUSE THERE ARE  
SO MANY THINGS THAT ARE BROKEN.

IF THEY DON'T MAKE A DECISION, THEY OUGHT TO BE FORCED  
TO MAKE A DECISION.

YOU ARE SAYING THEY HAVE MADE THE DECISION.

THANK YOU FOR LISTENING.

I'M NOT REALLY HAPPY BUT I KNOW YOU WILL MAKE A  
DECISION.

>> PRESIDENT JAMES: COUNCILMEMBER ENGEL?

>> THANK YOU.

THE PLANNERS WILL HAVE DISCUSSED THIS TWICE.

OUR COUNTY ATTORNEY HAS GIVEN US 13 FINDINGS OF FACT  
TO DENY THIS.

THAT'S WHAT I'M GOING ON AND I CALL THE QUESTION.

THANK YOU.

>> PRESIDENT JAMES: THANK YOU.

THE QUESTION HAS BEEN CALLED.

SECOND.

ALL THOSE IN FAVOR SAY AYE.

ALL OPPOSED? THE AYE'S HAVE IT.

>> MR. PRESIDENT, AS WE VOTE ON THIS, THE  
CLARIFICATION TO THE PLANNING AND ZONING CHAIR, A YES VOTE AND A  
NO VOTE, WE WANT TO MAKE SURE EVERYBODY UNDERSTANDS WHAT THEY  
ARE VOTING FOR, COULD I ASK FOR CLARIFICATION, PLEASE?

>> COUNCILMEMBER FLOOD?

>> A YES VOTE IS TO DENY THE ZONING CHANGE AND NO VOTE  
IS TO NOT DENY IT.

YES VOTE DENIES THE ZONING CHANGE.

>> PRESIDENT JAMES: THANK YOU.

IS EVERYBODY CLEAR ON THAT? MR. CLERK, PLEASE OPEN THE  
VOTING.

VOTING IS CLOSING.

AND VOTING IS CLOSED.

>> MR. CLERK: THERE ARE 21 YES VOTES, 2 NO VOTES  
BENSON AND ACKERSON.

>> PRESIDENT JAMES: THANK YOU, THE ORDINANCE PASSES.

MR. CLERK, A READING OF ITEM NUMBER 57.

>> MR. CLERK: A RESOLUTION AUTHORIZING THE MAYOR TO  
ACCEPT AN AMENDMENT FROM THE COMMONWEALTH OF KENTUCKY

>> JUST BRIEFLY, THIS INITIAL GRANT THEY FOUND DIDN'T  
\$21,420 SO THE AMENDMENT WAS TO MAKE SURE THAT WAS INCLUDED SO  
THE TOTAL PRICE TAG \$1,521,420.

>> PRESIDENT JAMES: THANK YOU.

MOTION AND SECOND.

ALL IN FAVOR? THE AYES HAVE IT.

MR. CLERK, A READING OF ITEM 58.

>> MR. CLERK: AN ORDINANCE AMENDING LMCO §  
32.730(A)(1) TO INCLUDE THE PRESIDENT OF THE FRATERNAL ORDER OF  
POLICE LODGE 77 LOUISVILLE METRO CORRECTIONS AND THE PRESIDENT  
OF RIVER CITY FRATERNAL ORDER OF POLICE LODGE 614.

>> PRESIDENT JAMES: THE ORDINANCE IS BEFORE US.

IS THERE ANY DISCUSSION? COUNCILMEMBER ACKERSON?

>> THANK YOU, MR. PRESIDENT.

>> PRESIDENT JAMES: SORRY, I TAKE THAT BACK.

COUNCILWOMAN WOOLRIDGE, THIS WAS YOUR COMMITTEE.

I'M SORRY.

>> THIS CAME OUT OF THE APPOINTMENTS COMMITTEE 2-1 AND  
ONE VOTED PRESENT.

WE HAD SPEAKERS TO COME FROM F.O.B. LODGES TO SPEAK.

WE ALSO HAD THE HONORABLE DAVID BOWLS TO COME AND  
SPEAK.

MR. PRESIDENT, HE WAS TOTALLY AGAINST THIS.

I'M LOOKING FOR A NO-VOTE BUT BEFORE I SAY THAT I DON'T WANT ANYBODY IN THE CHAMBER OR ANYONE THINKING I AM ANTI POLICE, ANTI F.O.P. OR ANTI UNION BECAUSE NONE OF THAT IS TRUE.

IF I HAD BEEN ANTI-I MAY NOT HAVE BEEN SITTING HERE TONIGHT BECAUSE I HAD A LOT OF HELP FROM PEOPLE LIKE THAT.

I AM LOOKING FOR A NO-VOTE BASED ON WHAT WE HEARD FROM HONORABLE BOWLS ALONG WITH A LETTER HE SENT.

I WON'T GO OVER THE LETTER SINCE HE SENT IT TO ALL OF US.

BASICALLY, YOU KNOW, I CAN ALSO GO ON AND SAY THAT JUDGE DAVID BOWLS, HE IS NOT ANTI-POLICE.

HE IS NOT ANTI-F.O.P. BECAUSE HE SAYS IN LAST PARAGRAPH OF HIS LETTER THAT HE WAS APPOINTED CHAIR OF THE METRO CRIMINAL JUSTICE COMMISSION BOARD BUT SAID I'M ALSO A RETIRED JEFFERSON COUNTY POLICE DEPARTMENT LIEUTENANT 37-YEAR F.O.P. MEMBER.

WE AREN'T ANTI, HE JUST DIDN'T SEE A REASON FOR THIS BECAUSE THERE WAS ANOTHER COMMITTEE FORMED AND BOTH F.O.P. PRESIDENTS SERVED ON THAT JAIL COMMITTEE.

SO THAT IS BASICALLY WHAT CAME OUT OF THE COMMITTEE.

>> PRESIDENT JAMES: THANK YOU, MADAM CHAIR.

WHAT WAS THE RECOMMENDATION OF YOUR COMMITTEE?

>> 2-1 AND ONE VOTED PRESENT BECAUSE SHE WAS USING A TOUCH SCREEN AND SHE DIDN'T REALLY QUITE KNOW HOW TO OPERATE IT AND SHE NEVER GOT MY ATTENTION TO SAY SHE HAD SOME COMMENTS.

BECAUSE BASICALLY SHE SAID I DON'T EVEN KNOW WHAT THIS IS ABOUT BUT IT WAS TOO LATE IT WAS IN THE VOTING PROCESS BUT IT CAME OUT 2-1 AND ONE VOTED PRESENT.

>> PRESIDENT JAMES: 2-1 IN FAVOR AGAINST?

>> 2-1 IN FAVOR, YES, SIR.

>> PRESIDENT JAMES: THANK YOU.

COUNCILMEMBER ACKERSON?

>> THANK YOU, MR. PRESIDENT.

WE HAVE TALKED ABOUT THIS AD NAUSEAM IN CAUCUS AND COMMITTEE OF THE WHOLE.

YES THERE'S TWO LETTERS OUT THERE, THE F.O.P. SENT THEIR LETTER.

THIS IS A COMMITTEE OF 27, THIS WOULD TAKE IT TO 29 VOTING MEMBERS.

IT'S NOT LIKE WE ARE TIPPING THE SCALES.

WHAT WE ARE DOING IS WE ARE GIVING TWO ELECTED INDIVIDUALS, ESSENTIALLY EXECUTIVES OF THE LARGEST AND THIRD LARGEST PATERNAL ORDER OF POLICE ORGANIZATIONS HERE IN KENTUCKY WHO REPRESENT HUNDREDS OF MEMBERS.

THESE AREN'T MEMBERS THAT ARE MAKING POLICY.

THESE ARE MEMBERS THAT ARE GOING TO HAVE TO EXECUTE THE POLICY.

SO THESE GENTLEMEN BRING TO THE TABLE FOR DISCUSSION, WHETHER IT BE A POSITIVE OR NEGATIVE, IN FACT, I LIKE NEGATIVE.

I LIKE POSITIVE, BUT NEGATIVE IS BETTER THAN POSITIVE.

NEGATIVE YOU GET TO UNDERSTAND THE DOWN SIDE TO WHAT YOU ARE TALKING ABOUT CHANGING POLICY-WISE.

THEY BRING THE PRACTICAL APPLICATION SIDE TO WHAT'S BEING DISCUSSED AS FAR AS POLICY CHANGES.

WE TALK ABOUT INCLUSION AND GETTING EVERYBODY TO THE TABLE.

THESE TWO GENTLEMEN BRING EVEN MORE TO THE TABLE FOR CONSIDERATION SO WE MAKE EVEN BETTER DECISIONS AND I'M ALL FOR THAT.

I KNOW THE F.O.P. HAS STOOD BEHIND ME IN THE PAST TO SAY, YOU KNOW ACKERSON WE WILL STAND BEHIND YOU TO HAVE A SEAT AT THIS TABLE FOR THIS BODY AND SHAME ON ME IF I AREN'T LISTENING TO THEM.

THEY WANT A SEAT AT THE TABLE.

THEY AREN'T ASKING FOR MORE MONEY OR DISCUSS LABOR ISSUES THEY WANT TO BRING THEIR EXPERTISE AND INPUT INTO THE DECISION MAKING TO TRY TO MAKE A BETTER JUSTICE SYSTEM FOR COMMONWEALTH OF KENTUCKY AND CITY OF LOUISVILLE.

FOR THAT I APPLAUD THAT THEY WANT TO TAKE TIME OUT OF THEIR LIVES, AWAY FROM THEIR FAMILIES, TO TRY TO MAKE A DIFFERENCE IN OUR COMMUNITY AND I HOPE YOU GIVE THEM SUPPORT TO HAVE A SEAT AT THAT TABLE.

>> PRESIDENT JAMES: THANK YOU, COUNCILMEMBER.

COUNCILWOMAN WOOLRIDGE?



>> I UNDERSTAND THERE WAS A COMMITTEE FORMED, A JAIL POLICY COMMITTEE AND BOTH F.O.P. PRESIDENTS ARE PART OF THAT COMMITTEE, IS THAT NOT TRUE? CAN ANYBODY ANSWER THAT FOR ME?

>> PRESIDENT JAMES: COUNCILMEMBER ACKERSON?

>> YES.

WE FORMED A COMMITTEE TO EXAMINE AND WE TALKED ABOUT INCLUSION AND GETTING EVERYBODY AT THE TABLE AND SO WE ACTUALLY AMENDED THAT, AT THAT TIME TO EXPAND IT FOR THE PURPOSES OF INCLUSION TO INCLUDE THE TWO GENTLEMEN WE ARE TALKING ABOUT TODAY TO BE ON THAT COMMITTEE.

NOW WHAT'S HAPPENED IS THAT COMMITTEE WILL BE MIRRORING ALMOST IDENTICAL TO THE CRIMINAL JUSTICE COMMISSION SUBCOMMITTEE BEING A JAIL POLICY COMMITTEE.

WHAT THEY DID IS THEY MERGED THOSE TWO COMMITTEES TOGETHER.

IT'S A SUBCOMMITTEE NOW UNDER THE GENERAL CRIMINAL JUSTICE COMMITTEE.

THEY ALREADY PUT THOSE GENTLEMEN ON THE COMMITTEE, IT'S A SUBCOMMITTEE.

WE ARE ASKING THEM TO HAVE A SEAT AT THE FULL COMMITTEE.

NOT THE SUBCOMMITTEE ALONE BUT THE FULL COMMITTEE.

NOW THAT COMMITTEE MAY BE OPEN TO THE PUBLIC BUT JUST AS ITS OPEN PUBLIC NOW, THIS IS OPEN TO THE PUBLIC AND THERE'S PEOPLE SITTING HERE BUT THEY DON'T GET TO SPEAK UNLESS WE GIVE

THEM THE OPPORTUNITY AND WE CAN CUT THEM OFF AT ANY TIME BUT  
HAVING A SEAT AT THE TABLE GUARANTIES THEIR INPUT IS CONSIDERED.

>> THIS SEAT AT THE TABLE, AND I KNOW I HEARD IN THE  
COMMITTEE OF THE WHOLE WE AREN'T UNION, WE ARE F.O.P. BUT IT'S  
KIND OF /F.O.P. UNION.

WHAT HAPPENS IF WE OPEN UP PANDORA'S BOX AND ALL THE  
UNION PRESIDENTS NOW CAN BECOME A PART OF THIS COMMISSION? DO  
ANYBODY WANT TO ANSWER THAT QUESTION FOR ME?

>> PRESIDENT JAMES: COUNCILMEMBER ACKERSON?

>> I WOULD LOVE TO ANSWER THAT QUESTION FOR YOU.

>> GO RIGHT AHEAD.

>> FIRST AND FOREMOST YOU HAD A PHRASE BEFORE THAT I  
HAVE LOVED LOTS OF TIMES THE SKY IS NOT FALLING CHICKEN LITTLE.

TWO INDIVIDUALS, 614 AND 77.

NOW SOMEBODY IN THE FUTURE WANTS TO MAKE AN ORDINANCE  
DOWN THE ROAD TO ADD SOMEBODY ELSE TO THIS? WE WILL DEBATE THAT  
AT THAT TIME BUT THAT'S NOT WHAT WE HAVE DONE HERE.

WE HAVE NOT OPENED THE DOOR.

WE HAVE ADDED TWO PEOPLE.

EVERY TWO YEARS OR SO WE ADD SIX NEW PEOPLE BECAUSE WE  
PUT SIX CITIZENS ON THIS COMMITTEE THAT MAY NOT HAVE ANY LAW  
ENFORCEMENT EXPERIENCE WHATSOEVER.

WE AREN'T OPENING PANDORA'S BOX.

WE WILL DO THIS ON A CASE-BY-CASE BASIS.

IF SOMEBODY CAME BACK LATER AND SAID THEY WANT TO ADD FROM THE SHERIFF'S DEPARTMENT, AND SAID WE ARE INTERESTED IN BRINGING SOME EXPERTISE TO THIS, SOMEONE MADE AN ORDINANCE IT WILL BE DEBATED AT THAT TIME BUT WE AREN'T DEBATING OTHER UNIONS OR PEOPLE OR ANYTHING OTHER THAN THESE TWO PRESIDENTS OF THE LARGEST AND THIRD LARGEST PATERNAL OF POLICE ORGANIZATIONS.

THAT'S THE SOLE ISSUE BEFORE US TONIGHT, MA'AM.

I WOULD SAY NO, IT'S NOT A PANDORA'S BOX.

>> MR. PRESIDENT I WOULD JUST LIKE TO READ THIS PARAGRAPH FROM THE CHAIR, HONORABLE DAVID BOWL.

HE SAID WHILE HE HAS BEEN SUGGESTED THE PROPOSED ORDINANCE WOULD BE ADDED PERSPECTIVE OF INDIVIDUALS ON THE FRONT LINE, THE AMENDMENT IS SPECIFICALLY LIMITED TO POLICE AND CORRECTION OFFICERS AND WOULD NOT AFFORD REPRESENTATION TO THE REMAINING FRONT LINE WORK ACROSS THE ENTIRE CRIMINAL JUSTICE SYSTEM SUCH AS A STAFF OR STATE-FUNDED JUSTICE AGENCY, COURT, CORRECTION, PROBATION, PAROLE, PROSECUTOR, PUBLIC DEFENDER AND JUVENILE JUSTICE SYSTEM PERSONNEL.

>> PRESIDENT JAMES: WERE YOU FINISHED?

>> YES.

>> PRESIDENT JAMES: COUNCILMEMBER LANSHIMA?

>> THANK YOU.

JUDGE BOWLS WOULD BE MORE PERSUASIVE IF HE OFFER A SUGGESTION ON HIS THOUGHTS WITH A WAY FORWARD WITH AN OPINION BUT IT WAS NOT.

JUST SAYING WE SHOULDN'T DOESN'T MAKE SENSE TO ME.

I'M A SCHOOL TEACHER.

I-UNDERSTAND WHAT IT MEANS TO HAVE L.B.D.M. WITHOUT  
HAVING TEACHERS ON THERE, IT'S LIKE SAYING THE PRINCIPALS  
REPRESENT THE INTEREST OF THE TEACHERS.

BUT HE OR SHE DOESN'T.

THEY DON'T UNDERSTAND MY PAIN IN THE CLASSROOM THAT'S  
WHAT I WANT TO EQUATE THIS WITH.

SO THE JUDGE WAS RECOMMENDING THERE SHOULD BE A  
PROCESS TO INCLUDE THOSE INDIVIDUALS WASN'T PERSUASIVE TO ME.

I WANT TO ENCOURAGE MY COLLEAGUES TO SUPPORT THIS.

I THINK F.O.P. PRESIDENTS SHOULD BE ONLY ONES ON THIS  
I WOULD NEED SOMETHING WIDER, IT WOULD HAVE BEEN A GOOD START.

I WOULD ENCOURAGE YOU TO SUPPORT THIS.

WE NEED THOSE ON THE FRONT LINE TO HAVE A SEAT AT THE  
TABLE TO DISCUSS THEIR CONCERNS, CHALLENGES, AND MAKE  
RECOMMENDATIONS FOR A WAY FORWARD.

COUNCILMEMBER BRYANT HAMILTON.

>> THANK YOU, MR. PRESIDENT.

ONE OF THE MOST COMPELLING ARGUMENTS I HEARD IN CAUCUS  
IS THE CRIMINAL JUSTICE COMMISSION WAS THE FIRST ONE FORMED IN  
THE UNITED STATES AND SOMEBODY ASKED WELL NOBODY ELSE HAS DONE

WHAT WE ARE ASKING TO DO TO EXPAND WHO THE TWO REPRESENTATIVES ARE.

I THOUGHT ABOUT IT AND SAID WELL, IF WE ARE BREAKING GROUND WHEN WE DID THIS WHY CAN'T WE BREAK GROUND NOW.

WHEN I THINK ABOUT DIVERSITY AND PEOPLE AT THE TABLE I'M NOT ABOUT EXCLUSION, I'M ABOUT INCLUSION AND I THINK THESE VOICES WOULD BE IMPORTANT.

I THINK IT'S GREAT THEY HAVE SEATS ON THE GENERAL POLICY COMMITTEE.

AND WHEN DEALING WITH JAIL POLICY YOU DEFINITELY WANT PEOPLE ON THE FRONT LINE, THE CRIMINAL JUSTICE SYSTEM AND COMMISSION IS DEALING WITH MORE THAN JUST JAIL POLICY.

I THINK THEIR VOICES SHOULD BE ADDED TO THE 27 THAT ARE ALREADY ON THAT COMMISSION.

THANK YOU.

>> PRESIDENT JAMES: THANK YOU, COUNCILWOMAN.

COUNCILWOMAN LEET?

>> THANK YOU, MR. PRESIDENT.

AS BRYANT HAMILTON MENTIONED THEY DO GO FOR GRANTS.

I THINK ONE OF THE THINGS I RECALL DURING THE BUDGETING PROCESS THIS PAST YEAR WITH THE CRIMINAL JUSTICE COMMISSION I ASKED ABOUT A \$400,000 LEAD GRANT THEY HAD TO ADDRESS PRE-ARREST DIVERSION AND ASKED IF THEY WERE GOING TO WORK WITH CENTER STONE IN REGARDS TO THIS, AS WE KNOW METRO COUNCIL HAS FOR TWO YEARS MADE A SIGNIFICANT CONTRIBUTION TO THE

LIVING MODEL AND THEY WERE PROCEEDING HIRING A DIRECTOR AND STARTING A PROGRAM.

I FEEL IF WE HAD TWO ADDITIONAL VOICES WHO WERE AWARE AND COULD PROVIDE TESTIMONIAL AND INPUT INTO THE IDEA THESE DEPARTMENTS ARE THE BENEFICIARY OF THAT LIVING ROOM MODEL BECAUSE THEY HAVE A 2-MINUTE DROP OFF.

THEY HAVE A MORE SUCCINCT PROCESS IT MIGHT HAVE SAVED TAX PAYERS \$400,000 OR THAT MIGHT HAVE BEEN PRIORITIZED TO OTHER ISSUES.

I THINK THAT'S THE REASON FOR INCLUSION AT THE TABLE.

I WANT TO SUPPORT WE ADD THESE TWO VOICES TO THE TABLE.

THEY HAVE REQUESTED TO BE INVOLVED.

SO IT ISN'T LIKE WE ARE TRYING TO CREATE POSITIONS AND ADD PEOPLE TO THEM, BUT THESE ARE PEOPLE WHO HAVE BEEN ENTHUSIASTICALLY INVOLVED AND WOULD LIKE TO BE PART OF THAT DISCUSSION AND I THINK WE, AS A BODY, FUNCTION WITH 26 ON A REGULAR BASIS.

SO THEY ARE ALREADY OPERATING WITH 27.

I'VE BEEN ON OTHER BOARDS UPWARDS OF 70 AND IT STILL FUNCTIONS EVEN WITH THAT WIDE BREADTH OF VOICE AND I THINK THESE TWO VOICES WILL BE A WELCOME ADDED ADDITION FOR THE DISCUSSION AND THEY WILL BE FULLY COMPETENT TO ENGAGE AT THE POLICY-LEVEL OF DISCUSSION THAT OCCURRED IN THIS COMMISSION.

COUNCILWOMAN GREEN?

>> THANK YOU, MR. PRESIDENT.

I WILL BE VOTING FOR THIS ORDINANCE AND I WOULD ASK MY COLLEAGUES TO VOTE FOR THIS ORDINANCE.

I, FOR THE LIFE OF ME, CAN'T UNDERSTAND WHY PEOPLE WOULDN'T THINK THIS IS A GOOD IDEA.

WE ARE IN A CRISIS SO THE IDEA WE WOULD LEAVE OUT THE HUNDREDS OF MEN AND WOMEN WHO EVERYDAY ARE FIGHTING ALONGSIDE WITH THE REST OF US TRYING TO LOOK FOR SOLUTION, TO TRY TO LEAD THEM OUT FROM THE DISCUSSION JUST DOESN'T MAKE SENSE TO ME.

THEY DON'T HAVE A SEAT AT THE TABLE ALREADY.

MR. BOWLS AND MR. CHIEF, THEY WON'T HAVE THE SAME VOICES AS F.O.P.

I THINK THEIR VOICES ARE NEEDED SO I WOULD URGE YOU ALL TO VOTE YES.
