SINCE MY LAST SURGERY IN 2016 I HAVE LOST 90 POUNDS AND HAVE BEEN ABLE TO KEEP ANY TUMOR REGROWTH TO A MINIMUM.

MY BACKGROUND IS IN GOVERNMENT RELATIONS.

I WAS A CONTRACT LOBBYIST.

I'M FORMER CHAIRMAN OF THE LOUISVILLE SUSTAINABILITY COUNCIL'S GREEN ECONOMY TEAM.

FORMER PRESIDENT OF THE JEFFERSON COUNTY EXTENSION COUNTY AND APPOINTED TO THE DISTRICT BOARD BY MAYOR FISCHER.

FOR SIX YEARS I RAN THE LARGEST SINGLE FUNDRAISER FOR 4H AND HAVE WORKED WITH WATER STEP, AMPED AND ELEVATE RECREATION.

I AM A GRADUATE OF LEADERSHIP LOUISVILLE 2015
BINGHAMTON FELLOWS AND PART OWNER OF NATURAL FIBER COMPANY.

I'M VERY INDEBTED AND EMBEDDED IN THIS COMMUNITY.

THE NEGATIVE CONNOTATIONS AND STIGMAS SURROUNDING

CANNABIS FUEL THE FIRES THAT HAVE RUINED HUNDREDS OF THOUSANDS

WHILE I'M STRONGLY IN SUPPORT I HAVE MAJOR APPREHENSIONS AND CONCERNS.

HE HAS BEEN STABLE, IT HASN'T BEEN GROWING.

ALMOST AT THE POINT TO PUSH OUT HIS M.R.I.'S AND ONLY CHECK HIM EVERY FIVE YEARS.

IN NOVEMBER IT GREW.

AND AGAIN IN FEBRUARY IT GREW.

WE WERE TRANSFERRED TO A NEURO ONCOLOGIST.

THEY SAID LET'S DO IT ONE MORE TIME.

LET'S WAIT UNTIL JUNE.

WE WENT TO JUNE AND HE HAD AN M.R.I. AND HIS TUMOR DOUBLED AND ENHANCED WITH THE CONTRAST AND IT WAS BAD.

AND THEY SAID HE NEEDS SURGERY RIGHT AWAY.

LIKE YOU HAVE A WEEK.

SO OUR SUMMER PLANS WERE OVER.

WE DIDN'T GET TO GO TO THE BEACH.

WE DIDN'T GET TO GO TO KENTUCKY KINGDOM.

BRANDON HAD HIS SURGERY AT BRANDON BELT, THEY GOT THE TUMOR OUT AND SENT IT FOR TESTING.

THE LAB AT VANDERBILT SAID THEY HADN'T SEEN THIS TYPE OF TUMOR BEFORE, IT'S VERY RARE.

THEY SAID THEY SENT IT TO NEW YORK, IT'S BEING TESTED THERE, WE ARE SUPPOSED TO GET RESULTS BACK THIS WEEK.

IT COULD GO EITHER WAY, WE DON'T KNOW.

AFTER BRAIN SURGERY, YOU COULD BE DEPRESSED.

BRANDON HAS ALWAYS, ALWAYS WANTED TO PLAY BASEBALL AND HE HASN'T BEEN ABLE TO.

SO HE HAS A TEAMMATE NAMED BRENDAN MCKINLEY AND HE GOES TO HIS SCHOOL.

THE ALL-STARS WERE COMPETING IN THE STATE TOURNAMENT AND THEY TALKED ABOUT IT AT ONE OF THEIR GAMES AND SAID WE SHOULD HAVE HIM COME OUT AND THROW OUT THE FIRST PITCH, IF HE CAN.

THIS IS 10 DAYS AFTER HE HAD SURGERY.

AND HE PERKED UP AND WAS READY TO GO.

WANTED TO GO.

HE THREW OUT THE FIRST PITCH.

THESE KIDS AND COACHES GOT TOGETHER AND MADE THEM A SPECIAL JERSEY AND GAVE HIM A BALL AND INVITED HIM TO EVERY GAME.

IT COMPLETELY CHANGED BRANDON'S ATTITUDE AND IT

BROUGHT BACK HIS CONFIDENCE THAT PEOPLE CARED ABOUT HIM AND

MY NAME IS BRANDON.

AND I'M 11 YEARS OLD.

AFTER I HAD MY SURGERY, I THOUGHT I WASN'T EVER GOING
TO DO ANYTHING AGAIN LIKE RUN CROSS COUNTRY OR SHOOT ARCHERY OR
SWIM, OR PLAY ANYTHING, OR PLAY OUTSIDE.

AND THEN I THOUGHT, THEN MY DOCTORS TOLD ME I WOULD BE HEALED IN SIX MONTHS.

AND THEN AFTER SIX WEEKS I WAS RUNNING IN A CROSS COUNTRY RACE AND IT MADE ME REALLY HAPPY.

EVERYONE WAS CHEERING FOR ME.

AND THEY WERE CLAPPING.

IT MIGHT INTEREST YOU TO KNOW THAT ACCORDING TO THE 2010 CENSUS, MORE THAN HALF OF OUR LOUISVILLE POPULATION IS FEMALE.

IN FACT, 52% OF LOUISVILLE RESIDENTS ARE GIRLS AND WOMEN.

TODAY I'M ASKING ALL OF YOU TO COMMEMORATE, CELEBRATE ALL THE WOMEN IN OUR LIVES, IN APPRECIATION OF ALL THEY HAVE DONE, AND CONTINUE TO DO.

ON THIS WOMEN'S EQUALITY DAY, WE RECOGNIZE THE WOMEN ARE STRONG, VITAL, TALENTED INDIVIDUALS WHO SHOULD HAVE EVERY OPPORTUNITY TO REALIZE WHAT THEY ARE TRULY CAPABLE OF.

THAT THERE ARE NO LIMITS ON WHAT THEY CAN ACCOMPLISH.

AND THEY CAN REALIZE THEIR GOALS AND DREAMS.

I KNOW WHEN MR. ART WALTERS WAS A VERY YOUNG MAN, LONG BEFORE FLIGHTS OF ANGELS CAME AND SWEPT HIM AWAY AND TOOK HIM TO HIS LIFE EVERLASTING.

I KNOW HE WOULD HAVE BEEN RECOGNIZED AS A SMALL CHILD MANY TIMES.

DEDICATING A CORNER OF SOUTH 16th AND WEST BROADWAY TO BE NAMED ARTHUR M. WALTERS WAY IN HIS HONOR.

WHEREAS HE SERVED THIS COMMUNITY FOR NEARLY 50 YEARS AS ONE OF LOUISVILLE'S MOST EFFECTIVE LEADERS FOR JUSTICE AND OPPORTUNITY AND WAS RESPECTED FOR HIS SINCERITY, HONESTY AND UNWAVERING COMMITMENT.

WHEREAS MR. WALTERS WAS BORN NOVEMBER 9th, 1918 IN MAGNOLIA KENTUCKY AND DIED IN 2010.

WHEREAS HE GRADUATED AS VALEDICTORIAN, WHILE ATTENDING KENTUCKY STATE COLLEGE HE WAS DRAFTED IN THE ARMY WHERE HE FOUGHT IN BOTH WORLD WAR II AND KOREAN WAR.

BECAME ONE OF THE FIRST AFRICAN AMERICAN OFFICERS TO LEAD INTEGRATED TROOPS AND EARNED THE BRONZE STAR OF HEROISM, MEDAL OF MERIT AND SOLDIERS MEDAL OF BRAVERY.

WHEREAS AFTER RETIRING FROM HIS MILITARY CAREER FROM
ARMY CORPS OF ENGINEERS IN 1962 HE ATTENDED THE UNIVERSITY OF
LOUISVILLE WHERE HE EARNED HIS MASTERS OF EDUCATION.

WHEREAS IN 1963 MR. WALTERS JOINED THE LOUISVILLE URBAN LEAGUE AS DIRECTOR OF JOB DEVELOPMENT AND EMPLOYMENT.

LATER NAMED EXECUTIVE DIRECTOR AND SERVED IN THAT

CAPACITY UNTIL 1987 AND WORKED TIRELESSLY CREATING EMPLOYMENT

HOUSING AND EDUCATIONAL OPPORTUNITIES PREVIOUSLY DENIED

MINORITIES.

WHEREAS MR. WALTERS WROTE THE NATIONALLY RECOGNIZED ON-THE-JOB TRAINING PROGRAM FOR THE LOUISVILLE URBAN LEAGUE TO ASSIST THE UNDER SKILLED AND UNDER PRIVILEGED IN FINDING EMPLOYMENT AND PERSUADED KENTUCKY AND LOCAL AREA COMPANIES TO HIRE, TRAIN AND RECRUIT AFRICAN AMERICAN WORKERS AND IN 1969 HE WAS INSTRUMENTAL IN PLACING 345 MINORITY WORKERS IN JOBS AT THE CITY'S FOURTH STREET GALLERIA PROJECT PAYING THEM A COMBINED PAYCHECK OF MORE THAN \$2 MILLION.

WHEREAS UPON RETIRING FROM THE LOUISVILLE URBAN LEAGUE
IN 1987 THEN MAYOR JERRY ABRAHAMSON HIRED HIM TO HEAD
DESTINATION LOUISVILLE TO RELOCATE THE PRESBYTERIAN HEADQUARTERS
TO THE CITY WHICH HELPED BOOST LOUISVILLE'S ECONOMY.

WHEREAS IN ADDITION TO HIS MILITARY MEDAL, MR. WALTERS
HAS RECEIVED MORE THAN 100 HONORS AND ACCOLADES INCLUDING ADULT
BLACK ACHIEVER OF THE YEAR, FREEDOM AWARD, CIVIL RIGHTS
LEADERSHIP AWARD, LOUISVILLE DEFENDERS COMMUNITY AWARD,
RECOGNITION AS ONE OF EBONY MAGAZINE'S 1,000 SUCCESSFUL BLACKS,
NAMED AS ONE OF 54 PIONEERING LOUISVILLE LEADERS CHOSEN TO BE
HIGHLIGHTED AND PASSING A TORCH.

A COLLECTION OF ONE-ON-ONE CONVERSATIONS WITH THOSE WHOSE VISION AND ACTION SHAPED THE COURSE AND DESTINY OF MODERN DAY LOUISVILLE.

AND POSTHUMOUSLY WAS INDUCTED AS 53rd HONOREE.

HE HAS A SCHOLARSHIP NAMED IN HIS HONOR AND LOUISVILLE URBAN LEAGUE HAS AN AWARD PRESENTED ANNUALLY NAMED IN HIS HONOR CALLED THE ARTHUR M. WALTERS CHAMPION OF DIVERSITY AWARD.

WHEREAS MR. WALTERS HAS ALSO SERVED THE COMMUNITY BY
FUNCTIONING ON NUMEROUS BOARDS INCLUDING BEING THE FIRST AFRICAN
AMERICAN MEMBER OF THE LOUISVILLE ROTARY CLUB AND HELPED
ORGANIZE THE METRO UNITED WAY LEADERSHIP ROUND TABLE WHICH WAS
DESIGNED TO BE THE STANDARD FOR EFFECTIVE LEADERSHIP IN
LOUISVILLE.

WHEREAS THROUGHOUT MR. WALTER'S MANY YEARS OF SERVICE TO LOUISVILLE HE WAS KNOWN AS A BRIDGE BUILDER.

SERVED AS A CATALYST FOR CHANGE.

AND DESEGREGATION, HOUSING, INNOVATION AND PROGRAM SERVICES AND WAS A CHAMPION FOR RACE RELATIONS AND COLLABORATIVE PARTNERSHIPS.

AND WHEREAS THE METRO COUNCIL IS GRATEFUL FOR MR.

WALTERS UNWAVERING COMMITMENT TO THIS COMMUNITY THEREFORE BE IT

WHEN SOMEONE DOES HAVE A CHILD OR A LOVED ONE THAT IS DYING OR FIGHTING THIS TERRIBLE DISEASE, AND THEY LOSE THEIR HOME, THEY LOSE THOSE THINGS THAT IS NOT ONLY A TERRIBLE THING.

THE MONEY THAT IS GIVEN TO THIS, I THINK THERE IS A MULTIPLIER APPROACH.

IT GOES TO MAKE SURE THE PEOPLE MOST IN NEED.
