Pre-Meeting with Highview Fire Department Representatives: Gerry Boston, Tammy Boston and J. Gregory Joyner met at the Barn at 5:45 p.m. July 2, 2018 with Bill Renninger, Highview Fire District Fire Inspector (502) 239-3561, brenninger@highviewfire.com and Rob Dwyer, also of Highview Fire Department. The fire department personnel advised that emergency lighting needs to be installed – four emergency exit signs with lighting is needed. The fire inspector recommended LED lights. They also recommended fire extinguishers at all exits. If the Bostons' CUP application is approved, two inspections will be required – the first at six months and the second inspection one year after the permit is issued.
