NOW, THEREFORE, BE IT RESOLVED BY THE BOARD MEMBERS OF THE LOUISVILLE AND JEFFERSON COUNTY LANDBANK AUTHORITY, INC.,

SECTION 1. That the Board Members of the Louisville and Jefferson County Landbank Authority, Inc. hereby authorize the sale of the following described properties:

SECTION 3. That the four (4) single-family residences shall be constructed within eighteen (18) months of acquiring the properties; and the applicant shall return the subject properties to the Authority if the single-family residences are not constructed within eighteen (18) months; such requirements being included and recorded as a deed restriction.
