AN ORDINANCE APPROPRIATING \$5,001 \$8,251 \$12,751 FROM NEIGHBORHOOD DEVELOPMENT FUNDS IN THE FOLLOWING MANNER: \$3,501 FROM DISTRICT 25; \$2,000 FROM DISTRICT 14; \$1,500 FROM DISTRICT 26; \$1,000 EACH FROM DISTRICTS 13 AND 15; \$500 EACH FROM DISTRICTS 1, 3, 6, 10, 12, 13, 17, 20, AND 22; AND \$250 FROM DISTRICT 9; THROUGH THE OFFICE OF MANAGEMENT AND BUDGET, TO SHIRLEY'S WAY, INC. FOR PROGRAM EXPENSES ASSOCIATED WITH SHIRLEY'S WAY FINANCIAL ASSISTANCE PROGRAM (AS AMENDED).

BE IT ORDAINED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT (THE COUNCIL) AS FOLLOWS:

SECTION I: The sum of \$5,001 \$8,251 \$12,751 is hereby appropriated from Neighborhood Development Funds in the following manner: \$3,501 from District 25; \$2,000 from District 14; \$1,500 from District 26; \$1,000 each from Districts 13 and 15; \$500 each from Districts 1, 3, 6, 10, 12, 13, 17, 20, 22; and \$250 from District 9; through the Office of Management and Budget, to Shirley's Way, Inc. for program expenses associated with Shirley's Way Financial Assistance Program.

SECTION II: The Council has determined the funds requested in this Ordinance will be expended for a public purpose.

SECTION III: This grant is subject to the Council's Policies and Procedures as adopted and effective at the date of passage of this Ordinance.

SECTION IV: This Ordinance shall take effect upon its passage and approval.
