Appeal. The Board, in hearing an appeal, shall recommend to the administrating agency that the agency's action be inocified, upheld, or dismissed of that a fine or penalty livined upon a cersion to violation of any provision of this ordinance be soll askid, inocified or left infact.

The Busid, upon an HMPC Plan apmed, may recommend to the administering agency exemptions or modifications in the content of the HMPC Plan coor requirements for reporting hazardoos materials reteases, provided that such exemption or modification is based on the preventive physical aspects of the seclety including containment structures and automatic monitors, and the recognized and documented good performance of the inclusiver remaining transfers undersals.

Adjustments to reportable quantity list. The Appeals and Overseer Board upon recommendation of a local regulatory agoncy dropon request for review by a regulated bazardous materials user may adjust upward or downward the reportable quantity on the most ourself applicable list.

Appeals. Any rejection or denial of approval of a HMPC Plan may be appealed to the Appenin and Overseer Board pursuant to § 95.11.

QUALIFICATION OF MEMBERS	Representative of industry, regulatory agency and general public.  The Mayor shall appoint 9 memoris: four of whom shall be representatives of regulated industry appointed from a list of at least ten manies submitted by Greater Louisville. Inc., three of whom shall be representative of regulatory agencies, and two of whom shall be representative of the general public.
PURPOSE	An Appeals and Overseer Board, composed or representatives of industry, regulatory agencies and the general public appointed by the Mayor, shall be established to more that an appeal is available to those persons aggreeved by an action of the administering agency regarding the adequacy of a HMPQ Plant to

those persons fined or penitized pursuant to this ordinance, and to coordinate and integrate the policies and procedures of the regulating agencies and person related to the HMPC Plan. Any recommendation of the Appenis and Overseer Board shall be advisory only and shall not be finding in any manner wantsoover upon the Board of the Administering Agency.
