## Notes from the Sept. 4, 2018 Neighborhood Meeting for Proposed Airbnb at 110 West Ormsby Avenue.

The meeting was attended by 4 neighbors.

Doug Humble, who is the next door neighbor at 112 W Ormbsy;

Christopher White, who lives across the street at 119 W. Ormsby, and

Lonnie and Karen Fink, who live behind the property, at 1317 S 2<sup>nd</sup> Street.

The meeting proceeded with concerns about Parking, Number of people (noise), keeping the property clean and then just basic questions concerning Airbnb. The Parking concern was addressed with the fact that we have off street parking off the alley as well as in front of the house & Church property (we plan on utilizing the off street parking). We informed them of the 10 people limit and also that we plan to build a privacy fence in the rear (we already have the COA) and that any Airbnb guests will sit in the back and that would minimize any noise. The concern for trash was addressed – I currently go out every morning and clean the sidewalk & front of our property and most of our side of the street (garbage from people walking along the street). I will continue to clean the street along W. Ormsby and 1st street as I always have since purchasing the property.

The neighbors from 2<sup>nd</sup> street discussed that their neighbor is operating an airbnb and that the guests are MUCH more conscientious than the renters. With less people coming in and out and less noise than a previous renter. We discussed the fact that Airbnb has a rating system that helps make sure that both parties – the home owner and the renter – behave in an appropriate manner in order to stay active on Airbnb.

Overall it was a very positive meeting and many concerns and questions were answered.
