The S 4th St project is approximately \$200,000 over budget. The engineer's estimate was \$1,617,478 with 10% contingency. Pace, the sole bidder, submitted a bid for \$1,869,000 which needs \$2,055,900 to cover the 10% contingency. However, we currently only have \$1,880,322 of unencumbered funds.

Please advise if we should seek more funding or if we should rebid the project. It's likely that the bid would be more competitive if construction started in the spring.
