No, the cost was only for the tree removal work. It was my understanding that CD21 was to have the property owners replace the trees. The cost for a 1.5" caliper tree for replacement with contractor installation is \$312.00. The extra cost for a water bag is \$15.00 but not a requirement for the replacement. Also, a root barrier is not needed to be installed because the green verge is greater that 6 feet in width.

If CD21 will fund the replacements, the costs will change to:
